MORGAN, Ruffin Smith, PA (000102401) Lexington, NC	08/12/13	PA's care of a patient who PA treated on seven occasions for costochondritis may have been substandard. PA treated the patient with two five-day oral prescriptions of Ketorolac in a seven day period without considering alternative causes of her persistent symptoms and without involving PA's supervising physician. The patient was subsequently diagnosed with a duodenal ulcer and later died from complications of an intra-abdominal abscess.	Public letter of concern
OVERS, Shannon Nicole, MD (201301727) Charlotte, NC	08/06/2013	MD failed to respond accurately to the question on the license application. MD disclosed that she had been arrested and charged with DUI and Failure to Display Lamps When Requested but failed to disclose that she was also charged with possession of marijuana and possession of drug paraphernalia. MD was convicted of DWI on 6/22/07. In addition, MD failed to disclose that the Oregon Board issued a private letter of concern when MD failed to provide with adequate information about the circumstances and criminal charges surrounding the 2007 arrest and conviction.
