MINUTES

Jack A. Koontz, M.D., President, convened this meeting of the Board of Medical Examiners of the State of North Carolina at 8:45 p.m., Thursday, August 7, 1986, at the Greenville Sheraton in Greenville, North Carolina. Board members present included: Charles H. Duckett, M.D., Secretary; Eben Alexander, Jr., M.D.; David S. Citron, M.D.; John T. Daniel, M.D.; Harold L. Godwin, M.D.; and Mrs. Martha Kirkland Walston. Simmons Patterson, M.D., Board member-elect also attended this meeting. Staff members present included: Bryant D. Paris, Jr., Executive Secretary; Michael E. Weddington, Attorney; Don Pittman, Investigator; William H. Breeze, Jr., Investigator; and Sibyl Lamoreaux, Secretary.

Martin, Jeffrey, M.D.

The Board of Medical Examiners of the State of North Carolina held a Hearing on charges preferred against Jeffrey Martin, M.D., at 4:30 p.m., Friday, August 8, 1986, at the Greenville Sheraton, Greenville, North Carolina. Neither Dr. Martin nor his counsel appeared at this Hearing. The Board of Medical Examiners unanimously adopted a motion made by Dr. Citron and seconded by Dr. Alexander that the Board finds the charges preferred against Jeffrey Martin, M.D., to be true. The Board unanimously adopted a further motion made by Dr. Koontz and seconded by Dr. Alexander that the Board of Medical Examiners revokes Dr. Martin's license to practice medicine in the state of North Carolina.

Coleman, Peter Richard, M.D.

The Board unanimously adopted a motion made by Dr. Citron and seconded by Dr. Duckett that the Board of Medical Examiners issue Dr. Coleman a resident's training license effective August 12, 1986; that he comply with the conditions placed on his licensure in Virginia; that he furnish the North Carolina Board with copies of all reports provided to the Virginia Board; and that he appear for interviews at the Board's request. The Board unanimously adopted a further motion that the attorney for the Board of Medical Examiners prepare a letter to the Dean of the Medical School at the University of North Carolina with copies to Board members stating:

Evidence has come to the Board's attention indicating North Carolina Memorial Hospital has misinterpreted the Medical Practice Act by allowing individuals to perform medical acts prior to obtaining residents training licenses and by allowing residents who do not hold full North Carolina medical licenses to issue prescriptions outside the scope of their training

programs.

Collins, F. Farrell, M.D.

The Board adopted a motion made by Dr. Citron and seconded by Dr. Alexander that the Board of Medical Examiners secure Dr. Collins' written permission for the Board to notify the Board of Nursing of the Board of Medical Examiners' action, for the Board to publicize this action in the Board Bulletin as a formal reprimand without stating the reason for this action, and for the Board to deem Dr. Collins authorization a public document. Dr. Duckett voted in opposition to the portion of the motion concerning publishing the action in the Board Bulletin.

Manly, James Hollowell, Jr., M.D.

The Board unanimously adopted a motion to reinstate Dr. Manly's license previously suspended for failure to register and to send all future correspondence to this physician registered, return receipt requested.

Stanley, Karl Harvey, M.D.

The Board of Medical Examiners unanimously adopted a motion made by Dr. Citron and seconded by Dr. Koontz that the Board advise Dr. Stanley both verbally and in writing to sign a Consent Order agreeing:

1. to submit to psychiatric evaluation and follow-up treatment as the psychiatrist deems necessary from a physician designated by the Board of Medical Examiners;
2. to submit to physical evaluation and follow-up treatment as the doctor deems necessary from a physician designated by the Board;
3. to permit the Board to make these arrangements for psychiatric and physical evaluations with Eugene Douglas, M.D., and David Richardson, M.D.;
4. to refrain from the use of any controlled substances except for those which may be prescribed by another physician or dentist;
5. to submit to random drug screens at the Board's request;
6. to appear before the Board at its October, 1986, meeting;
7. to surrender his license and receive, contingent upon his compliance with these six conditions, a temporary license for a period of ninety days.

Impaired Physicians

Mrs. Walston commented that she believed North Carolina should have a better way to help impaired physicians. Dr. Duckett reported that the Executive Council of the Medical Society is aware of this problem and that there are plans to improve the situation. Dr. Citron stated that Brian Nahey, M.D., a Psychiatrist who started an impaired physicians program in another state, is available if the Board wants to ask him questions regarding methods to improve the existing North Carolina program. Dr. Koontz directed that Dr. Duckett as the Board's representative to the Executive Council of the North Carolina Medical Society introduce this subject at the next Council meeting and that the Executive Secretary discuss the matter with Mr. Moore.

Reece, Donald Brooks, M.D.

The Board of Medical Examiners of the State of North Carolina held a Hearing on charges preferred against Donald Brooks Reece, M.D., at 3:45 p.m., Friday, August 8, 1986, at the Greenville Sheraton, Greenville, North Carolina. Dr. Reece attended this Hearing without counsel. At the conclusion of the Hearing, the Board of Medical Examiners unanimously adopted a motion made by Dr. Koontz and seconded by Dr. Duckett that the Board finds the charges to be true and orders that Dr. Reece receive a severe reprimand admonishing him that, if he fails to comply with the statutory requirements, rules, and regulations of this Board, it will deal severely with such infractions.

Khatri, Sat Dev, M.D.

The Board of Medical Examiners of the State of North Carolina held a Hearing on charges preferred against Sat Dev Khatri, M.D., on Friday, August 8, 1986, at 11:30 a.m., at the Greenville Sheraton, Greenville, North Carolina. Dr. Khatri and his counsel attended this Hearing. Dr. Duckett did not participate in this Hearing. At the conclusion of the Hearing, the Board unanimously adopted a motion made by Dr. Koontz and seconded by Dr. Godwin that the Board finds the charges to be true, revokes Dr. Khatri's license, and suspends the revocation provided Dr. Khatri complies with the following probationary conditions:

1. Obeys all state and federal laws.
2. Is and remains of good moral character.
3. Surrenders Schedule 2 and 2N prescribing privileges and refrains from prescribing all anorectics.
4. Maintains adequate records including substantive data on

histories, physical examinations, diagnoses, and management.

5. Submits records for monitoring at the Board's request.
6. Notifies the Board prior to moving from the state of North Carolina.
7. Takes and passes Component II of FLEX not later than June 1987.

The Board indicated that Dr. Khatri may take FLEX prior to June, 1987, and, if he does not pass the examination, may take it again in June, 1987. The Board further indicated that a cover letter to Dr. Khatri accompanying this order may advise him concerning the educational rehabilitation program in Maryland.

Martin, Howard, M.D.

The Board of Medical Examiners of the State of North Carolina held a Hearing on charges preferred against Dr. Martin at 9:00 a.m., Friday, August 8, 1986. Dr. Martin and his counsel attended this Hearing. At the conclusion of the Hearing, the Board unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Citron that the Board of Medical Examiners finds the charges to be true, revokes Dr. Martin's license, and stays the revocation provided that for a period of three years Dr. Martin obeys all laws; is and remains of good moral character; upholds the medical profession's standard of ethics; refrains from consuming any controlled substances not prescribed by another physician or dentist; and appears before the Board of Medical Examiners annually during the month of August.

Kej, Gary H., M.D.

The Board unanimously adopted a motion made by Dr. Koontz and seconded by Dr. Duckett that the Board of Medical Examiners summarily suspend Dr. Kej's license immediately as the safety of his patients is in jeopardy.

Hearing on Clinical Clerkships

The President suggested that this Hearing be held in Greenville on October 15, 1986, and volunteered to serve as Hearing

Officer.

Grace, Eugene Vernon, M.D.

The Board unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Duckett that the Board of Medical Examiners request Dr. Grace to sign a Consent Order stipulating he will:

1. surrender Schedule 2 and 2N prescribing privileges;
2. issue no further prescriptions outside the scope of his normal medical practice;
3. issue no further prescriptions at someone else's request.
4. examine all patients he treats and maintain records on these patients;

The Board unanimously adopted a further motion made by Dr. Godwin and seconded by Dr. Duckett that, if Dr. Grace fails to sign this Consent Order, the Board of Medical Examiners will hold a Hearing on charges preferred against this physician at its October, 1986, meeting. The President instructed that the Board's attorney send Dr. Grace a Consent Order to be signed together with a cover letter.

Regional Perinatal Associates, P.A.

The Board unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Daniel that the Board of Medical Examiners defer action on this corporation until the attorney for the Board studies this matter and reports his findings.

The Board also unanimously adopted a motion made by Dr. Godwin and seconded by Dr. Daniel that, if there is a conflict of law, the Board of Medical Examiners will refer this matter to the appropriate authority.

Hearings for October, 1986

The President stated that he will preside at the clinical clerkship hearing and at any other administrative hearing, to include Bee Sting, which may be scheduled for October. He instructed that the staff schedule all hearings which are pending, including Dr. Magee, for the October, 1986, meeting of the Board of Medical Examiners.

Branly, Louis Phillip, M.D.

The Board unanimously adopted a motion made by Dr. Citron and seconded by Dr. Duckett that the staff compile physician extender policies in a hard bound cover; that the staff make this bound copy of policies available at each Board meeting; and that, after the staff has compiled these policies, the Board of Medical Examiners consider sending this material to all primary supervising physicians.

Dr. Citron stated that the countersigning interval for

PA/patient contact should be changed from twenty-four hours to up to three working days.

Appiah, Augustine, M.D.

In accordance with the terms of a Consent Order, Dr. Appiah appeared for an informal interview with the Board. The President informed Dr. Appiah that the North Carolina Board of Medical Examiners licensed him on the basis of endorsement of his Pennsylvania license and further informed Dr. Appiah that, if the Pennsylvania Board of Medical Examiners should revoke his license to practice medicine in Pennsylvania, no basis would exist for licensure in North Carolina. However, the President of the Board advised Dr. Appiah that, at the present time, he may work in North Carolina under the provisions of the Consent Order.

Watson, Susan Austin, M.D.

The Board unanimously adopted a motion made by Dr. Citron and seconded by Dr. Koontz that Dr. Watson furnish the Board with a written statement explaining the difference in her answer to the controlled substance question; that the Board issue Dr. Watson a two year dated license; that the Board either interview Dr. Watson or obtain reports concerning this physician prior to the expiration of this dated license; and that, if all goes well, the Board of Medical Examiners consider issuing Dr. Watson a full license at the end of this two year period.

Emergency Medical Services Report

Dr. Daniel presented this report to the Board. The Board of Medical Examiners unanimously adopted a motion made by Dr. Daniel and seconded by Dr. Citron that the Board approve 99 EMT-I applications, 23 MICN applications, 15 EMT-P applications, and 47 EMT-AI applications.

The Board unanimously adopted a motion made by Dr. Daniel and seconded by Dr. Citron that the Board of Medical Examiners approve 388 Bee Sting applications.

The Board unanimously adopted a further motion made by Dr. Citron and seconded by Dr. Alexander that the Board of Medical Examiners authorize the Executive Secretary to screen EMS and Bee Sting applications, present his recommendations for approval to the Board, and present any problem applications for

the Board's consideration.

The Board's investigators stated that they would inquire in different areas of the state about the use of Bee Sting kits.

Increasing Investigative Staff

The Board unanimously adopted a motion that the Board of Medical Examiners, at its October, 1986, meeting consider dividing the state into areas and adding one or two investigators to its staff.

Case, David Lawrence, M.D.

The Board unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Citron (1) that the Board obtain written evaluations on Dr. Case from the physicians in charge of his training programs; (2) that it obtain statements concerning his performance from McLaurin General Hospital in Flint, Michigan; (3) that the Board consider requesting Dr. Case to submit to psychological evaluation prior to approving him for continued licensure; (4) that, at this time, the Board of Medical Examiners issue Dr. Case a dated license expiring December 31, 1987; (5) that the Board of Medical Examiners instruct Dr. Case to inform the Board of his North Carolina practice address; (6) that the Board advise Dr. Case, if he engages in the practice of medicine in this state, the Board of Medical Examiners will subpoena records for its review; and (7) that the Board further advise Dr. Case, if he is practicing in this state, the Board of Medical Examiners of the State of North Carolina will request him to appear for an interview prior to the expiration of his dated license.

Roberge, Raymond Joseph A., M.D.

The Board unanimously adopted a motion that it defer action on Dr. Roberge's application pending receipt of a properly certified photograph from his medical school.

Stamler, Arthur Alan, M.D.

The Board unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Koontz that the Board of Medical Examiners issue Dr. Stamler a dated license expiring December 31, 1988; and that it advise Dr. Stamler, if he wishes licensure in North Carolina after this expiration date, he must contact the Board and furnish additional information.

Thomas, Francis Thornton, M.D.

The Board unanimously adopted a motion made by Dr. Koontz and seconded by Dr. Duckett that the Board of Medical Examiners defer action on Dr. Thomas pending further investigation. The Board authorized Dr. Koontz to proceed with charges if he thinks such further investigation warrants.

Jones, Anthony Leland, M.D.

The Board unanimously adopted a motion made by Dr. Koontz and seconded by Dr. Duckett that an investigator present an up-dated report concerning this physician to the Board of Medical Examiners prior to its determining whether to drop the charges preferred against Dr. Jones.

Weintraub, Harvey, M.D.

Dr. Koontz informed Dr. Weintraub that the Board has established he engaged in the practice of medicine at the Bryn Mawr Hospital in North Carolina prior to receiving a medical license in this state. Dr. Koontz also informed Dr. Weintraub that the North Carolina Board of Medical Examiners has a report from the Soldiers and Sailors Hospital in Pennsylvania indicating Dr. Weintraub dictated admission histories and physicals without examining patients. The Board unanimously adopted a motion made by Dr. Koontz and seconded by Dr. Duckett that the Board of Medical Examiners not approve Dr. Weintraub for licensure.

Emergency Medical Services

Fred Glass, M.D., and Ed Browning, representing the Office of Emergency Medical Services met with the Board of Medical Examiners to discuss matters of mutual concern. The Board unanimously adopted a motion made by Dr. Daniel and seconded by Dr. Koontz that the Board of Medical Examiners approve the proposed regulation changes providing for air ambulance services in North Carolina.

The Board adopted a motion that it not approve the addition of Ophthalmic solution to the EMT-P drug formulary.

The Board adopted a motion that the Board of Medical Examiners approve the following additions to the EMS Formulary:

Heparin Drip IV when transferring patients from one physician to another

Nitroglycerine Drip IV

All Nitrates requested as Formulary additions

Thiamine IM

Glucogen IM or Subcutaneous

Blood and Blood components

The Board adopted a motion made by Dr. Citron and seconded by Dr. Daniel that, although the Board does not endorse, it has no objection to the implementation of a proposed study project on Nitrous Oxide from October 1, 1986, through September 30, 1987, provided MICN's do not issue orders in connection with this project. Dr. Godwin voted in opposition to this motion.

The Board unanimously adopted a motion made by Dr. Daniel and seconded by Dr. Koontz that the Board of Medical Examiners approve an additional EMS application.

Adjournment

As there was no further business to be considered by the Board at this meeting, the President declared the meeting adjourned at 1:10 p.m., Monday, August 11, 1986.
