HEARING: 8/16/2006

On May 15, 2006, the Board charged Dr. Petitt based on a Stipulated Settlement and Disciplinary Order entered by the California Board reprimanding Dr. Petitt and ordering him to successfully complete a physician assessment and clinical education course, a prescribing practices course and a medical records keeping course.

BOARD ACTION: 30 day stayed suspension

PULEO, Joel Gregg, MD - Pinehurst, NC

On May 26, 2006, the Board charged Dr. Puleo with unprofessional conduct for practicing below the standard of care by performing in an office setting a surgical procedure on a patient who had risk factors that should have caused Dr. Puleo to perform the procedure in a hospital with appropriate support staff and failing to notify the ER of patient's imminent arrival or being available by telephone for ER personnel.

On May 5, 2006, the NC Medical Board charged Dr. Rasalingam based on the New York Department of Health Office of Professional Medical Conduct's Consent Agreement and Order with Dr. Rasalingam wherein the New York Board issued a letter of reprimand, placed his New York license on probation, and fined him \$5,000 due to findings of negligence on more than one occasion and failure to maintain adequate medical records.

LEGISLATIVE UPDATE

Brian Blankenship and Thom Mansfield updated the Board on changes adopted by the General Assembly to the Medical Practice Act effective October 1, 2006. The changes provided for additional disciplinary options, re-entry provisions, immunity from liability for doctors reviewing cases for the Board, hearing panels, reporting changes in staff privileges, reporting malpractice insurance payments, cooperation with law enforcement, and duty to report certain arrests.
