## MINUTES

## CALL TO ORDER

Charles H. Duckett, M.D., President, called this meeting to order at 9:00 p.m., Sunday, November 30, 1986. Board members present were: John T. Daniel, Jr., M.D., Secretary; Eben Alexander, Jr., M.D.; David S. Citron, M.D.; Harold L. Godwin, M.D.; Hector H. Henry, II, M.D.; F.M. Simmons Patterson, Jr., M.D. Mrs. Martha Kirkland Walston, Public Member, was absent due to illness.

Staff members present were Bryant D. Paris, Jr.; Don R. Pittman; William H. Breeze, Jr.; and Kathy Burke.

## THOMAS, FRANCIS THORNTON, M.D.

On December 1, 1986, as a result of the hearing held on October 10, 1986, on charges preferred against Francis Thornton Thomas, M.D., the Board of Medical Examiners of the State of North Carolina adopted a motion made by Dr. Citron and seconded by Dr. Godwin that the Board finds that charges preferred against Dr. Thomas are not sustained by the evidence but that his conduct is unprofessional within the meaning of G.S. 90-14 (a)(6). The Board adopted a motion that it enter an Order of formal reprimand with an admonishment regarding sobriety. (Dr. Patterson abstained.)

## ROGERS, CHARLES WILBURN, M.D.

The Board of Medical Examiners of the State of North Carolina held a hearing on charges preferred against Charles Wilburn Rogers, M.D., at 1:00 p.m., Monday, December 1, 1986, at the Raleigh Hilton, Raleigh, North Carolina. Dr. Rogers attended with counsel.

The Board of Medical Examiners adopted a motion made by Dr. Duckett and seconded by Dr. Godwin that the Board finds the charges to be true, finds that Dr. Rogers has a mixed personality disorder, and, as a result, enters the following order:

that the previous revocation be suspended for a period of five years based on compliance with the following probationary conditions:

that Dr. Rogers continue under the care of a psychiatrist during the probationary period;

that the psychiatrist submit annual reports to the Board;

that the Board issue Dr. Rogers a dated license for one year;

that he meet with the Board annually;

that he obey all laws;

that he notify the Board of any change of practice site, of any change in treating psychiatrist, and of any problems he might have with any law enforcement agency; and

that he notify any current or future employer regarding the status of his license.

STUELKE, RICHARD GAYLORD, M.D.

The Board of Medical Examiners of the State of North Carolina held a hearing on charges preferred against Richard Gaylord Stuelke, M.D., at 3:00 p.m., Monday, December 1, 1986, at the Raleigh Hilton, Raleigh, North Carolina. Dr. Stuelke attended with counsel.

The Board of Medical Examiners adopted a motion made by Dr. Duckett and seconded by Dr. Citron that the Board finds the charges not to be substantiated and, as a result, enters the following order:

that the Board extend Dr. Stuelke's dated license for one year;

that he submit to periodic drug testing at his expense at the random requests of the Board's investigator;

that he not dispense any controlled substances from his office;

that he relinquish all current office stocks of controlled substances according to legal methods;

that he not prescribe controlled substances in Schedules 2, 2N, 3 and 3N;

that he obey all laws including those relating to controlled substances.

ROGERS, RICHARD LIONEL, M.D.

The Board of Medical Examiners of the State of North Carolina held a hearing on charges preferred against Richard Lionel Rogers, M.D., at 1:00 p.m., Tuesday, December 2, 1986, at the Raleigh Hilton, Raleigh, North Carolina. Dr. Rogers attended without counsel.

The Board of Medical Examiners adopted a motion made by Dr. Duckett and seconded by Dr. Henry that the Board finds the charges to be true and enters the following order:

that the Board revoke Dr. Rogers' license to practice medicine in North Carolina and that it suspend the revocation for a period of five years to run concurrent with his probation with the South Carolina Board of Medical Examiners based on compliance with the following conditions:

that he obey all laws;

that he notify the Board prior to returning to North Carolina to practice medicine;

that he appear before the Board at such times as it may require.

#### REGULATION HEARING REPORT CLINICAL CLERKSHIPS

On December 1, 1986, the Board of Medical Examiners adopted a motion that it accept the recommendation of Jack A. Koontz, M.D., who acted as Hearing Officer, to adopt the proposed amendments regarding clinical clerkships and that the Board file these amendments as required by the State Office of Administrative Hearings to become effective January 1, 1987. The Board of Medical Examiners made one change in the proposed amendment to add an "s" to the last word "clerkship."

The adopted amendment adds paragraph 3 under Rule 32B .0101 (written examination regulations) and Rule 32B .0201 (license by endorsement regulations) regarding MEDICAL EDUCATION as follows:

- (3) if graduated from a medical school not approved by the LCME or AOA, and if clinical clerkships are taken in the U.S.A., the applicant must:
  - (a) furnish evidence that he has satisfactorily completed clinical clerkships at teaching hospitals in the U.S.A. with ACGME (Accreditation Council for Graduate Medical Education) or AOA-approved graduate medical education and training programs in the

areas of the specific clerkships;

(b) if clerkships do not meet the above requirement, deficiencies may be remedied as follows:

- A. re-apply to medical school so that the school may arrange for the applicant to complete approved clinical clerkships as required, or
- B. apply for admission to advanced standing at a medical school approved by the LCME or AOA to repeat one year of clinical clerkships.

#### LICENSURE INTERVIEWS

FERNANDO, WEWALAGE JUSTIN, M.D.

On December 2, 1986, Dr. Fernando appeared as requested. As a result of the interview, the Board adopted a motion made by Dr. Duckett and seconded by Dr. Henry that the Board of Medical Examiners advise Dr. Fernando the Board cannot act on his application for licensure at this time.

LEIBOLD, WERNER, M.D.

On December 2, 1986, Dr. Leibold appeared for his licensure interview. The Board adopted a motion made by Dr. Duckett and seconded by Dr. Citron that it advise Dr. Leibold is not eligible for licensure at this time since does not meet the graduate medical education requirements of the Board of Medical Examiners of the State of North Carolina.

NADLER, ELISABETH BARRETT, M.D.

On December 2, 1986, Dr. Nadler appeared for her licensure interview. As a result of the interview, the Board adopted a motion made by Dr. Daniel and seconded by Dr. Duckett, as follows:

that the Board of Medical Examiners issue Dr. Nadler a dated license for one year geographically limited to her training program, specifically indicating no moonlighting;

that she request the director of her residency program to submit a report to the Board at the end of her academic year in June 1987;

that she agree to submit to random drug screens;

that she continue in AA; and  
that she meet with the Board in one year.

COTTON, PETER BENJAMIN, M.D.

On December 2, 1986, Dr. Cotton appeared for his licensure interview. The Board adopted a motion made by Dr. Citron and seconded by Dr. Alexander that it issue Dr. Cotton a dated license limited to the practice of Gastroenterology at Duke University Medical Center and its affiliated hospitals for a period of two years.

BOUTROS, SAMIR B.G., M.D.

On December 2, 1986, Dr. Boutros appeared for his licensure interview. The Board adopted a motion made by Dr. Godwin and seconded by Dr. Henry that the Board cannot act on Dr. Boutros' application at this time because he does not meet the requirements of North Carolina law regarding the FLEX examination.

#### AGENDA ITEMS FOR DISCUSSION

##### MINUTES OF THE OCTOBER 1986 MEETING

On December 2, 1986, the Board of Medical Examiners unanimously adopted a motion that the Board approve these minutes as written.

##### FUTURE BOARD MEETINGS

On December 2, 1986, the Board of Medical Examiners requested changes be made, if possible, in the Board meeting dates to allow the meetings to start on Wednesday or Thursday and continue through the weekend instead of starting the first of the week. Suggested changes are as follows:

Change June 12-17, 1987, to June 10-14, 1987.

Change October 7-11, 1987 to Sept. 30-October 4, 1987.

Set up December 1987 for December 2-6, 1987.

The Board members indicated they would like to hold the meetings at the North Raleigh Hilton, when possible, and requested the staff to check on the possibility of meeting at the new Pickett Suite Hotel at Research Triangle Park as an alternate site.

CLAPP, HUBERT LEE, M.D.

On December 2, 1986, the Board unanimously adopted a motion made by Dr. Citron to accept as information the letter from Dr. Clapp and thank him for his response to the Board's inquiry.

WALDEN, BURT M. N., M.D.

On December 2, 1986, the Board unanimously adopted a motion made by Dr. Citron and seconded by Dr. Duckett that a letter be written to Dr. Walden asking him to verify his current DEA status and requesting him not to apply for DEA prescribing privileges.

COLLINS, ANNE FLAGLER, M.D.

On December 2, 1986, the Board unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Patterson that it send the following letter to Dr. Collins:

As a result of the Board's review of your file at its recent meeting in December, the Board requests that at least forty-five days prior to any future request for continuation of your "dated license," expiration date: June 30, 1987, that you request Edward Robinson, M.D., to send a status report to the Board of Medical Examiners. Further, the Board requests that you notify its office if you practice in North Carolina.

VERWOERDT, ADRIAAN, M.D.

On December 2, 1986, the Board reviewed a letter from Ms. Olive, attorney for the North Carolina Psychiatric Association. The Board unanimously adopted a motion made by Dr. Citron and seconded by Dr. Duckett that the Board of Medical Examiners send a letter requesting that the Association provide documentation that it has completed monitoring Dr. Verwoerd, so that the Board of Medical Examiners may review this information at its January, 1987, meeting.

WALLER, LOUIS CLINTON, M.D.

On December 2, 1986, the Board unanimously adopted a motion to accept the surrender of Dr. Waller's license to practice medicine in North Carolina effective October 15, 1986.

FRY, HAROLD H., JR., M.D.

On December 2, 1986, the Board unanimously adopted a motion to accept the surrender of Dr. Fry's license to practice medicine in North Carolina effective November 24, 1986.

BROWN, ERNEST HYDE, JR., M.D.

On December 2, 1986, the Board unanimously adopted a motion to accept as information a report from the Executive Secretary concerning this physician.

HANHAM, WILLIAM JAMES, M.D.

On December 2, 1986, the Board unanimously adopted a motion to accept as information the report from the Executive Secretary that the staff was unable to issue a "dated license for a period of one year" as instructed at its October 1986 meeting since Dr. Hanham has not previously surrendered the permanent license issued to him in 1979 nor has the Board previously restricted the license in any way. The Board's attorney indicated that the appropriate method of restricting Dr. Hanham's licensure is to accept a surrender of this physician's permanent license or for Dr. Hanham to accept a "dated license" by Consent Order.

BOYD, ARTHUR B., JR., M.D.

On December 2, 1986, the Board unanimously adopted a motion that, since Dr. Boyd has declined the opportunity to take the North Carolina FLEX in December, should he apply to take FLEX in the future, he must appear for a personal interview with the full Board prior to taking this examination.

CLAY, GERALD LAMONT, M.D.

On December 2, 1986, the Board unanimously adopted a motion that, since Dr. Clay has declined the opportunity to take the North Carolina FLEX in December, should he apply to take FLEX in the future, he must appear for a personal interview with the full Board prior to taking this examination.

EXAMINATION LIST FOR AGENDA

On December 2, 1986, the Board asked that an agenda item be added at each Board meeting indicating physicians

licensed as a result of passing FLEX. The list should include "Passed FLEX with and without PGT" after each examination and "Passed FLEX completed PGT" at each meeting.

MANN, JOHN ROBERT, M.D.

On December 2, 1986, the Board accepted as information a report from the Board's attorney that, on Dr. Fitz's recommendation, he sent a proposed Consent Order to Dr. Mann's attorney on November 13, 1986, to which Dr. Mann and his attorney have no objection. The Board of Medical Examiners has made one change in the conditions contained in this proposed Consent Order. It contains a reprimand for poor record-keeping and requires probationary status for twelve months with the following conditions:

that Dr. Mann keep and maintain legible and current medical records on all persons to whom he renders medical services of any kind;

that he use the SOAP or some other recognized format for record-keeping;

that he provide medical services to no more than forty-five persons on the average on any day, excluding legitimate emergencies; (The Board instructed that the words "on the average" be deleted.)

that he participate in fifty hours of Category 1 continuing medical education;

that he provide for review, at the request of the Board, copies of his records; and

that failure to comply shall constitute grounds, after notice and a hearing, for revocation of Dr. Mann's license.

#### FLEX DEADLINE FOR IN-STATE MEDICAL STUDENTS

On December 2, 1986, the Board unanimously adopted a motion made by Dr. Alexander and seconded by Dr. Henry to authorize the staff to propose regulations on an administrative basis allowing a graduate of one of the North Carolina medical schools to be included on the FLEX list upon receipt of a letter from the Dean of his or her medical school stating that the school expects this applicant to graduate prior to the date of the examination, but after the FLEX deadline, provided that all other credentialing requirements are complete.

## FEDERATION NOMINATIONS

On December 2, 1986, the Board unanimously adopted a motion that Dr. Citron write a letter, for Dr. Duckett's signature, recommending Mr. Paris for an appointment to the Federation Board of Directors representing Executive Secretaries.

## DATED LICENSES

On December 2, 1986, the Board unanimously adopted a motion made by Dr. Citron and seconded by Dr. Henry that there be a distinction between full, unrestricted licenses and the limited, dated licenses. The Board instructed that licenses granted by the Board less than unrestricted be prepared by the staff and be smaller than the full licenses drawn by the calligrapher.

The Board adopted a motion made by Dr. Godwin and seconded by Dr. Alexander that Dr. Guthrie be issued a full license to practice medicine in North Carolina. Dr. Henry, Dr. Patterson, and Dr. Daniel voted in opposition to this motion.

The Board adopted a further motion made by Dr. Godwin and seconded by Dr. Patterson that Dr. Guthrie be sent the routine letter regarding prescribing for family members.

SKAGGS, WILLIAM BROCK, M.D.

On December 2, 1986, the Executive Secretary reported to the Board that he interviewed Dr. Skaggs prior to the meeting and that Dr. Skaggs answered "no" to questions on the application form but answered "yes" to the malpractice question during his interview. He indicated to Mr. Paris that he had several malpractice suits which he said he overlooked when answering the question on the application.

The Board unanimously adopted a motion made by Dr. Duckett and seconded by Dr. Godwin that Dr. Skaggs be given the opportunity to withdraw his application since he has falsified his application form. If he wishes to proceed with the application, he must submit all required information regarding his malpractice suits and then appear before the full Board for a personal interview.

LICENSURE INTERVIEWS BEFORE FULL BOARD

On December 2, 1986, the Board unanimously adopted a motion to make it a policy that applicants for licensure who apply ten years after completion of training programs must appear before the full Board for licensure interviews.

The Board discussed the possibility of requiring applicants for licensure who have not passed either a licensure or specialty board examination within twenty years to take FLEX in North Carolina.

#### MECHAEL, SHAWKY F., M.D. - POSTGRADUATE TRAINING QUESTION

On December 2, 1986, the Board unanimously adopted a motion made by Dr. Henry and seconded by Dr. Patterson that Dr. Mechael be advised that he does not meet the Board's requirement for three years of postgraduate training and, therefore, is not eligible at this time for licensure in North Carolina.

On December 3, 1986, the Board adopted a motion made by Dr. Henry and seconded by Dr. Daniel that, upon staff review of the proposed name for the satellite clinic, the Board of Medical Examiners approve this request.

## FORMAL ACTIONS PENDING REPORT

On December 2, 1986, the Board of Medical Examiners unanimously adopted a motion to accept as information the Formal Actions Pending Report.

MAGEE, ARCHIBALD C., M.D.

On December 2, 1986, the Board's attorney reported that the Court held a hearing on the morning of December 2, 1986, in Fayetteville. The judge entered an order that the Board must pay attorney's fees for Dr. Magee based on a statute that says that, in any type of action brought by a body contesting state action, the court may in its discretion allow the prevailing party to have fees paid. The judge based his decision on the fact that the Board did not have specific regulations regarding reinstatement of license and hearing procedures. The Court Order requires the Board to adopt regulations regarding reinstatement and hearing procedures after which the Board must hold another hearing if Dr. Magee requests a hearing on the matter.

The attorney informed the Board that he had filed a Notice of Appeal with the Court because the Court's Order says the Board was acting without substantial justification against Dr. Magee.

Regarding the payment of attorneys' fees, there is some concern about the precedent this sets for all licensing boards. If the Board just pays this fee, it would not become a precedent; but, if the Board appeals it, the case goes into the law books and sets a precedent. Dr. Duckett requested that the attorneys reflect upon this matter and report back to the Board about the possibility of appeal.

The Executive Secretary reported that Dr. Halleck has reviewed Dr. Magee's file and has an appointment scheduled with him.

GUESS, GEORGE, M.D.

On December 2, 1986, the Board's attorney reported that this matter is still pending judicial review.

WHITE, STEVEN MERLE, M.D.

On December 2, 1986, the Board's attorney reported that there is a Court hearing scheduled for December 8, 1986.

unrestricted license and appear again for an informal interview in October 1988.
