

MEETING OF THE BOARD OF MEDICAL EXAMINERS  
OF THE STATE OF NORTH CAROLINA

The Velvet Cloak Inn and The North Carolina  
Medical Society Building  
Raleigh, North Carolina

December 3-6, 1973

The Board of Medical Examiners of the State of North Carolina met at The Velvet Cloak Inn and The North Carolina Medical Society Building in Raleigh, North Carolina, December 3-6, 1973, for the purpose of interviewing applicants for license by endorsement of credentials, administering the examination to applicants for license in North Carolina and other business.

Monday, December 3, 1973  
8:00 p.m.

The Board convened for business and reviewing credentials. Drs. Joseph W. Hooper, Jr., President, Charles B. Wilkerson, Jr., Secretary-Treasurer, Frank Edmondson, Bryant L. Galusha, Cornelius T. Partrick, E. Wilson Staub and Vernon W. Taylor, Jr. were present. Mr. Bryant D. Paris, Jr., Executive Secretary, Mrs. Betty Joe Cooke, and Mrs. Diane Freeman were present.

RE: Dr. G. J. Ashley, Sparta, N. C. -- Board reviewed file.

ACTION: Dr. Partrick moved that Dr. Ashley be requested to come to the January, 1974 Board meeting . Seconded by Dr. Galusha and duly passed.

RE: Dr. David E. Graham, Charlotte, N. C. -- Board reviewed file.

ACTION: Dr. Edmondson moved that Dr. Graham be requested to appear before the Board at its January, 1974 meeting. Seconded by Dr. Partrick and duly passed.

RE: Reinstatement -- Biennial Registration --

The following physicians' licenses were suspended for failure to register as required by North Carolina General Statutes 90-15. They have now registered:

ACTION: Dr. Taylor moved that if all fees and penalties have been paid, the above physicians be duly registered. Seconded by Dr. Edmondson and duly passed.

RE: Dr. Abdullah Fattah, Greenville, N. C. -- Board reviewed Dr. Fattah's correspondence with the attorney for the Board and the President of the Board in regard to his use of "M.D." after his name, although he has not received this degree.

ACTION: Dr. Wilkerson moved that the Board of Medical Examiners inform Dr. Fattah that this Board does not confer degrees, but grants licenses to practice medicine in this state. Seconded by Dr. Staub and duly passed.

RE: Revision of Application for Licenses by Endorsement of Credentials Form --

The Board reviewed Dr. Staub's previous motion at the October, 1973 Board meeting that citizenship requirements for license in North Carolina be deleted from the policies of the Board, which motion was tabled for further study at this meeting.

ACTION: Dr. Galusha moved that the citizenship requirements be retained as they stand now in the policies and rules and regulations of the Board for license in North Carolina and that same be retained on the application form. Seconded by Dr. Wilkerson and discussion followed. Following discussion, Dr. Galusha amended his motion to allow Canadian citizens to apply for license in North Carolina with no U.S. citizenship requirements. Amendment accepted by Dr. Wilkerson and motion carried.



RE: August, 1974 Board meeting -- Dr. Galusha moved that the Board meet in Winston-Salem, North Carolina at The Hyatt House if same looks appropriate to the Executive Secretary. Seconded by Dr. Partrick and motion carried by vote of five to one.

RE: October, 1974 Board meeting -- Previous motion made and carried at the October, 1973 meeting that the October, 1974 Board meeting be held at The Blockade Runner Motor Hotel, date to be set so as not to coincide with other medical meetings during that time. The President informed the Board that the most suitable week-end would be October 11-13, 1974 and same accepted as date for that meeting.

RE: Conversion of limited licenses to full licenses -- Dr. Partrick moved that all applicants for conversion of limited to full license be approved for same if all credentials are in order. Seconded by Dr. Edmondson and duly passed. Those physicians are:

RE: Dr. Horace Ethan Allen appeared applying for license by endorsement of credentials. He is a graduate of the University of Michigan in 1940 and is licensed in Minnesota, Michigan, Ohio.

Dr. Hooper: Dr. Allen plans to move to Black Mountain; what do you plan to do up there, doctor?

A: Sort of a semi-retired basis. I'll be doing part-time consultation work and thought I would get a license in the event of doing some work.

Q: What field are you in, Dr. Allen?

A: Internal medicine.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you had any difficulty with any medical licensing boards? A. No, sir

Q: Have you had any difficulty, personally, with narcotics or alcohol or other habit forming drugs? A. No, sir

VERDICT: Dr. Horace E. Allen approved for license by endorsement.

RE: Dr. Nasser Agha Askary appeared applying for license by endorsement of credentials. He is a graduate of Gondi Shapoor University of Iran in 1966 and is licensed in Maine by FLEX in 1973.

Dr. Hooper: You plan to locate in Richmond County, doctor, doing Ob-Gyn? Will you be by yourself or in with someone?

A: No, sir, by myself in the county.

Q: Do you have your alien registration receipt card, sir?

A: Yes, sir.

Dr. Askary presented same, Number A 18 076 258, and the picture compared with the individual present.

Dr. Taylor: Where will you be in Richmond County?

A: Rockingham, sir.

Dr. Hooper: You do understand that until you obtain citizenship your license will be limited to a certain county where you will be practicing, but if you want to move, just let the Board's office know about it so an extension can be granted.

A: Yes, sir, I understand.

Q: Have you had any difficulty with a medical licensing board? A. No

Q: Have you ever been convicted of a crime? A. No

Dr. Hooper: Dr. Atkins is a resident in Family Practice at Chapel Hill and wishes a full license. Is your program for two years?

A: Three years, sir. And then I'll have my military service--don't know if I will settle in North Carolina though, yet.

RE: Dr. Thomas Berner appeared applying for license by endorsement of credentials. He is a graduate of Johns Hopkins University in 1968 and is licensed in Florida and Ohio and also holds National Board certification.

- Dr. Hooper: Dr. Berner is finishing a residency in Emergency Medicine in Ohio and is planning to go to Asheville in March, 1974. His application is complete.  
 Q: Have you ever been convicted of a crime? A. No  
 Q: Have you had any difficulty with medical licensing boards? A. No, I haven't  
 Q: Have you had any difficulty with alcohol, narcotics or other habit forming drugs? A. No, I haven't

VERDICT: Dr. Thomas Berner approved for license by endorsement.

RE: Dr. James Atwood Brennan appeared with incomplete credentials applying for license by endorsement of credentials. He is a graduate of the University of Vermont in 1971 and is a diplomate of the National Board.

- Dr. Galusha: Dr. Brennan is presently in the Army at Fort Bragg and wants to do some part-time work in the area. You do know what your file is lacking?  
 A: Yes, sir, one letter of recommendation, which should be here soon.  
 Q: Have you ever been convicted of a crime? A. No  
 Q: Have you had any personal problems with alcohol? A. No  
 Q: Have you ever personally used narcotics or barbiturates? A. No, sir  
 Q: Have you had any difficulty with medical licensing boards? A. No

VERDICT: Dr. James A. Brennan approved for license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Dr. Bruce Rogers Brodie appeared applying for license by endorsement of credentials. He is a graduate of Washington University in 1970 and is a diplomate of the National Board and licensed in Florida.

- Dr. Hooper: Dr. Brodie is presently a cardiology resident at Chapel Hill and wishes a full license. How much longer will you be in training?  
 A: About another year and a half.  
 Q: Do you plan to remain in North Carolina?  
 A: We haven't decided yet, but do like the state.  
 Q: Have you ever been convicted of a crime? A. No  
 Q: Have you had any difficulty with any medical licensing board? A. No  
 Q: Have you ever used alcohol, narcotics or other habit forming drugs, personally, to excess? A. No

VERDICT: Dr. Bruce R. Brodie approved for license by endorsement.

RE: Dr. H. Gunther Bucheleres appeared on October 13, 1973 with incomplete credentials applying for license by endorsement. He was approved for license contingent upon satisfactory completion of those credentials, which has been done.

RE: Dr. Dorryl Lee Buck, Jr. appeared applying for license by endorsement of credentials. He is a graduate of the University of Iowa in 1970 and is licensed in Iowa, Indiana and Pennsylvania.

 A: Can't say, sir, really. We haven't given it too much thought.  
 Q: How much time do you have left in training?  
 A: Well, I just started this year, and have four more years.  
 Q: Have you had any difficulty with any medical licensing boards? A. No  
 Q: Have you ever been convicted of a crime? A. No  
 Q: Have you ever used narcotics, other habit forming drugs or alcohol to excess? A: I use alcohol somewhat.  
 Q: Has it ever interfered with your work? A. No, only use it socially.

VERDICT: Dr. Dorryl L. Buck, Jr. approved for license by endorsement.

RE: Dr. Samuel Francis Burke, Jr. appeared with incomplete credentials applying for license by endorsement. He is a graduate of the Medical College of Georgia in 1972 and is licensed in Virginia by FLEX in 1973.

Dr. Galusha: Dr. Burke is planning on working some week-ends at Elizabeth City, is that correct?

A: Yes, sir, I am in a residency program at Norfolk and would like to do some extra work here in North Carolina.

Dr. Galusha: You do know what is missing in your credentials?

A: Yes, I believe your secretary said it was a photo from my medical school.

Q: Have you ever been convicted of a crime? A. No, sir

Dr. Hooper: Dr. Burton is in the Department of Pediatrics at Charlotte Memorial Hospital presently. His application is complete. Are you a resident there--how much longer do you have?

A: Yes, sir, I'll be completed in June and am planning to locate in the Charlotte area after that.

Q: Have you ever been convicted of a crime? A. No

Q: Have you had any difficulty with any medical licensing board? A. No

Q: Have you ever used alcohol, narcotics or other habit forming drugs personally, excessively? A. No

VERDICT: Dr. Edward M. Burton approved for license by endorsement.

RE: Dr. John Davis Butts, Jr. appeared applying for license by endorsement of credentials. He is a graduate of Duke University in 1972 and is a diplomate of the National Board.

Dr. Edmondson: Dr. Butts holds a residency training license to Duke and is applying for a full license and his credentials are complete.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No

Q: Have you had any difficulty with any medical examining board? A. No

Q: Have you ever personally used narcotics or barbiturates? A. No, sir

VERDICT: Dr. John D. Butts approved for license by endorsement.

RE: Dr. Nancy J. Tribley Butts appeared applying for license by endorsement. She is a graduate of Duke University in 1972 and is a diplomate of the National Board.

Dr. Edmondson: Dr. Butts holds a training license to Duke--what department?

A: Psychiatry.

Q: And why do you wish a full license in North Carolina?

A: Well, I am a native of North Carolina and probably will be staying here to practice.

Dr. Galusha: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

Dr. Galusha: Dr. Ferguson is now at Duke in the Cardiovascular Division. His credentials are all complete.

Dr. Galusha moved that Dr. Cole be approved for a Certificate of Registration as a Visiting Professor. Seconded by Dr. Wilkerson and duly passed.



RE: Dr. Merton Olson, Dr. Rex Lagrange and Dr. Horacio Pena, Clarkton, N.C. --

The attorney for the Board reported on his and the Executive Secretary's trip to Clarkton to investigate the report that Dr. Olson possibly was practicing medicine with Drs. LaGrange and Pena in Whiteville.

ACTION: Dr. Partrick moved that Dr. LaGrange and Dr. Pena be advised that the activities of Dr. Olson are illegal and should cease immediately, and that the letter be approved by the attorney for the Board. Seconded by Dr. Wilkerson and passed unanimously.

RE: Dr. Joseph L. Johnson, Graham, N. C. -- appeared at request of Board.

ACTION: Dr. Galusha moved that the Board request that Dr. Johnson retire or relinquish his license, and assure the Board that he will, and if he will not agree to this, the Board take the legal steps to recall his license on the basis that the Board does not feel the public is safe under his medical management. Seconded by Dr. Staub and motion carried by vote of four for the motion and two abstaining from the vote.

RE: Dr. Edward L. Oleen, Raleigh, N. C. -- application complete for Donna E. Patton. Dr. Staub moved that Ms. Patton be approved for use as an assistant to a physician. Seconded by Dr. Taylor and duly passed.

RE: Dr. Alonza D. Rice, Durham, N. C. -- application complete for Mary L. S. D'Errico. Dr. Staub moved that Ms. D'Errico be approved for use as an assistant to a physician. Seconded by Dr. Partrick and duly passed.

RE: Physician's Assistant -- addition to notification letter.

The Board instructed the Executive Secretary to add to the notification letter that is mailed to all physicians in regard to assistants to physicians' approval a statement that he, as the physician, is completely responsible for the assistant and all of his activities.

RE: Nurse Practitioner -- Dr. Partrick reviewed his latest discussions with the Board of Nursing in regard to approval of the Rules and Regulations for the Nurse Practitioner.

ACTION: Dr. Partrick moved that Paragraph (f) of Section 1 under Rule III be deleted. Seconded by Dr. Galusha and duly passed.

ACTION: Dr. Edmondson moved that the application fee be \$25.00 and re-registration fee be \$10.00. Seconded by Dr. Staub and discussion followed. Substitute motion: Dr. Galusha moved that the application fee be \$10.00 and the annual re-registration fee be \$10.00. Seconded by Dr. Partrick and carried by vote of 5 for and 1 opposed.

ACTION: Dr. Taylor moved that the University of North Carolina Program for Nurse Practitioners be approved as meeting the requirements of Rule II, Section 1, Paragraph (c). Seconded by Dr. Wilkerson and duly passed unanimously.

ACTION: Dr. Galusha moved that Dr. Partrick and the attorney for the Board be authorized to change the application blank if needed. Seconded by Dr. Wilkerson and duly passed unanimously.


