## MEETING OF THE BOARD OF MEDICAL EXAMINERS OF THE STATE OF NORTH CAROLINA

Carolina Hotel, Pinehurst, North Carolina

January 21 - 23, 1972

The Board of Medical Examiners of the State of North Carolina met at the Carolina Hotel, Pinehurst, North Carolina, for the purpose of interviewing applications for license by endorsement of credentials, certifying examination grades, and other business.

### Friday, January 21st 6:30 P. M.

The Board convened for dinner. Drs. Cornelius T. Partrick, President, Joseph J. Combs, Secretary-Treasurer, Frank Edmondson, Bryant L. Galusha, Joseph W. Hooper, Jr., H. Lee Large, Jr. and Vernon W. Taylor, Jr. were present. Mrs. Louise J. McNeill, Administrative Secretary, and Mrs. Diane G. Freeman attended.

Credentials for license by endorsement of credentials were reviewed by the members of the Board.

RE: <u>Dr. James O. Bailes</u>, Chiropractic Physician, Greensboro, North Capolina - The secretary presented letter from the Pharmacy Board alleging that Dr. Bailes had procured legend drugs from a drug hose.

VERDICT: Dr. H. Lee Large, Jr. moved that the matter of Dr. James O. Bailes, chiropractic physician, purchasing legend drugs be turned over to the attorney for the Board. This motion was duly seconded and passed.

RE: Office Records - State Record Center - The secretary presented a report made of records of this office with the following directions:

That copy of Minutes be sent to Record Center; that copy of names of all licentiates be sent to the Record Center; that case files of records relating to physicians before the Board for disciplinary action be kept 20 years, then transfer to the State Record Center; that non-licensed correspondence of applicants who failed to be licensed for lack of credentials or who failed to complete application, keep in agency 30 years, then destroy.

VERDICT: Dr. Bryant L. Galusha moved that the Board of Medical Examiners follow the directions of the State Department of Archives and History. This motion was duly seconded by Dr. Frank Edmondson and passed.

RE: Audit - The secretary advised that direction of the Finance Committee at the December, 1971 meeting had been carried; that the figure referred to in the audit was a typographical error.

VERDICT: Dr. Joseph W. Hooper, Jr. moved that this be accepted as information. This motion was duly seconded and passed.

RE: MEETING OF THE Board - Dr. Joseph W. Hooper, Jr. moved that the Board stay at the Velvet Cloak Inn, Raleigh, on December 4-7th, 1972 and that the examination be held at 222 North Person Street, Raleigh. This motion was seconded and passed.

January, 1973 - Dr. Joseph W. Hooper, Jr. moved, if practical, that the Board meet at the Carolina Hotel, Pinehurst, at the same time the State Committee meets. This motion was duly seconded and passed.

RE: Expenses - The secretary reported that flowers were sent for the funeral of Dr. Clark Rodman's mother and a floral arrangement to Mrs. Betty Joe Cooke in the hospital.

WERDICT: Dr. Joseph W. Hooper, Jr. moved that the secretary pay these expenses. This motion was duly seconded and passed.

VERDICT: Dr. H. Lee Large, Jr. moved that the licensed of the above physicians be converted to full license, provided all requirements have been met. This motion was duly seconded and passed.

The secretary was requested by the Board to formulate a letter to have at Board meetings to possibly use in the case of physicians who had violated the Narcotic law. The said letter was presented as follows:

"Following a conference with the North Carolina Board of Medical Examiners I voluntarily relinquish my right to apply for the privilege of prescribing schedule II (narcotic drugs).

"I respectfully request you to cancel my present BNDD permit and reissue in accordance with the enclosed application with schedule II (narcotics) not applied for."

VERDICT: Dr. Frank Edmondson moved that this be adopted as procedure. This motion was duly seconded by Dr. Joseph W. Hooper, Jr. and passed unanimously.

The secretary presented the following letter from Dr. L. C. Ogburn of Winston-Salem:

"Two years ago the Board issued a 'Roster of Registered Physicians' and, I assume mailed one to each physician in North Carolina as well as to other people. Since the 'N. C. Journal' contains practically all of the information contained in the Roster, I would suggest that the Roster (if it has to be printed at all) be made available only on a 'return the attached request card' basis."

VERDICT: The Board directed that this be received as information.

Foster, Eden, North Capolina - The secretary reported that he had been informed by the State Bureau of Investigation that Dr. Foster had been indicted on nine counts involving felonies, obtaining drugs by fraud, deceit and mis representation; that he is out on bond and the trial date has not been set.

RE: <u>Dr. William M. Bethune</u>, Cherry Hospital, Goldsboro, North Carolina - Dr. Bethune appeared at the request of the Board as he had applied for narcotic tax stamp. He stated that he is psychiatric director of the Wilson-Green Unit and of the Halifax Unit and director of the Adolescent Services for the eastern part of the state; that he is doing some consultant work for the Air Force at the Seymour Johnson Air Force Base. He stated that he was doing well and asked that he be given an unrestricted license to practice medicine and unrestricted BBND number. He said he felt he had rehabilitated himself.

On July 26th, 1969, Dr. Bethune's license, which had been revoked, was reinstated and restricted to the limits of a hospital or institution approved by the Byard of Medical Examiners, with the conditions that he refrain from the use of alcoholic beverages, narcotics, barbiturates or other drugs, except under the prescription of another licensed doctor of medicine, and that he violate no State or Federal Laws and that he otherwise remain of good behavior, not to exceed one year. In July, 1970, this was extended for one year.

After a free discussion the following motion was made.

VERDICT: Dr. Bryant L. Galusha moved that Dr. William M. Bethure be given full, unrestricted license to practice medicine in the State of North Carolina and that the Board of Medical Examiners approve his BNDD number without restriction and that he be seen a minimum of once a year.

Substitute motion; That he be given full, unrestricted licenseto practice medicine in the State of North Carolina for BNDD number and delete hard narcotics; that he be seen in one year. This motion was seconded by Dr. Frank Edmondson and failed by a vote of two to four.

Vote on the original motion carried with a vote of four to two. Drs. Joseph W. Hooper, Jr. and Frank Edmondson voted against this motion.

The President, Dr. Cornelius T. Partrick advised Dr. Bethune that the Board had rendered a great expression of confidence and pride in him and agreed to support his application for an unrestricted BNDD number and full, unrestricted North Capplina license; that it was a manifestation of confidence the Board had in him and the great strides he had made.

RE: <u>Biennial Registration</u> - <u>Reinstatement</u> - The license to practice medicine of Dr. Alton Everette James, Jr. was suspended for failure to register as required by General Statute of North Carolina 90-15.00 and he is now registered.

RESOLVED: That the medical license of Dr. Alton Everette James, Jr. be reinstated.

#### RE: Flex Examination, December, 1971

VERDICT: Dr. Joseph W. Hooper, Jr. moved that all physicians with weighted average of 75% be granted license to practice medicine in this state. This motion was seconded and passed.

RE <u>Dr. Jerko Poklepovic</u>, who took the Flex examination in December, 1971, failed to return for a part of the examination on the first day, which he said was a misunderstanding. Notwithstanding this Dr. Poklepovic received a weighhted average of 83.6%.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Jerko Poklepovic be granted license. This motion was duly seconded and passed.

**EE:** Flex Examination - Dr. H. Lee Large, Jr. moved that the Flex examination papers be sent to this Board each year.

Dr. H. Lee Large, Jr. moved that this motion lay on the table until the next meeting of the Board. This motion was seconded and passed.

RE: Dr. Albert Kodack was originally called before the Board because of his treating an addict. In October, 1971, he appeared and stated that his patient was attempting to provide care of her school age son in order to enter Broughton Hospital for treament. Dr. Kodack advised by letter that his patient had not co-operated with him and he felt no further obligation to treat her and did not intend to do so. He appeared at this time and reiterated this statement and said he had so advised the patient. He said he did not expect to have any similar problems and that he felt the Board had treated him very fairly.

RE: Meetings of the Board - Dr. Joseph W. Hooper, Jr. moved that a committee be appointed to consider the number of meetings held by this Board. This motion was duly seconded by Dr. V. W. Taylor, Jr. and passed.

The meeting was adjourned.
