

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF THE STATE OF NORTH CAROLINA

The Pinehurst Hotel, Pinehurst, North Carolina

January 25-27, 1974

The Board of Medical Examiners of the State of North Carolina met at The Pinehurst Hotel, Pinehurst, North Carolina, January 25-27, 1974, for the purpose of interviewing applicants for license by endorsement of credentials and other business.

Friday, January 25
8:00 P. M.

The Board convened for business and reviewing credentials. Drs. Joseph W. Hooper, Jr., President, Charles B. Wilkerson, Jr., Secretary-Treasurer, Frank Edmondson, Bryant L. Galusha, E. Wilson Staub and Vernon W. Taylor, Jr. were present. Dr. Cornelius T. Partrick was absent. Present also were Mr. Bryant D. Paris, Jr., Executive Secretary, Mrs. Betty Joe Cooke, Assistant Executive Secretary and Mrs. Diane Freeman.

RE: Conversion - Limited to full license -- Dr. Taylor moved that all applicants for conversion of limited to full license be approved for same if all credentials are in order. Seconded by Dr. Wilkerson and duly passed. They are:

RE: Reinstatement - Biennial Registration -- The following physician's license was suspended for failure to register as required by North Carolina General Statutes 90-15. He has now registered:

Dr. Frederick Dunham McFalls

Dr. Galusha moved that if all fees and penalties have been paid, the above physician be duly registered. Seconded by Dr. Wilkerson and duly passed.

RE: Assistants to Physicians --

RE: Dr. Floyd Alan Fried, Chapel Hill, N. C. -- application incomplete for William S. Biddle, lacking fee. Dr. Hooper moved that Mr. Biddle be approved for use as an assistant to a physician if and when fee is received. Seconded by Dr. Galusha and duly passed. (fee received and application completed)

RE: Dr. William Joseph Spencer, Winston-Salem, N. C. -- application complete for Gale Lynn Harkness. Dr. Hooper moved that Ms. Harkness be approved for use as an assistant to a physician. Seconded by Dr. Galusha and duly passed.

RE: Dr. Zae Dong Rho, Wilson, N. C. -- request to take second available examination rather than first, as required by rules and regulations. Following Board discussion, Dr. Galusha moved that the Board abide by their regulation adopted at the June, 1973 Board meeting regarding foreign medical graduates in state institutions applying for full licensure. Seconded by Dr. Wilkerson and duly passed.

RE: Board Policies -- Dr. Edmondson moved that the updated compilation of the Policies of the Board be accepted and filed with the Office of the Secretary of State. Seconded by Dr. Taylor and duly passed.

RE: Candidates for licensure by examination - plans for practice. The Executive Secretary reviewed the present policy of the Board regarding asking candidates for FLEX in North Carolina their plans for practice in this state. Dr. Edmondson moved that the Board approve the Executive Secretary's recommendation that the policy of asking FLEX candidates their plans for practice in the State remain the same. Seconded by Dr. Wilkerson and discussion followed. Motion duly passed on vote of five for and one opposed. The Executive Secretary was further instructed not to deny anyone the privilege of taking the examination if he would not be planning to come to North Carolina and if it appears that FLEX is becoming a service in this state, he is to so advise the Board and present a recommendation to avoid this.

RE: Composition of Minutes of Board meetings -- The Executive Secretary reviewed procedures for recording minutes of the Board meetings. Dr. Wilkerson moved that the minutes of the Board of Medical Examiners' meetings on matters of a confidential nature regarding an individual shall be kept in that individual file, this being in compliance with North Carolina General Statute 143-318.4. Seconded by Dr. Edmondson and passed unanimously.

RE: December, 1974 Board meeting -- Dr. Edmondson moved that if space is adequate, the examination and meeting be held at the North Carolina Medical Society Building in Raleigh, to coincide with the dates of the FLEX examination, and if this is not advisable, the Executive Secretary bring it to the Board's attention. Seconded by Dr. Wilkerson and duly passed.

RE: January, 1975 Board meeting -- Dr. Edmondson moved that the January, 1975 Board meeting be held the week-end before the Federation meeting at The Pinehurst Hotel, Pinehurst, North Carolina. Seconded by Dr. Wilkerson and discussion followed. Substitute motion offered: Dr. Taylor moved that the January, 1975 Board meeting be held on the week-end prior to the Federation meeting, the place to be decided at the March, 1974 Board meeting. Seconded by Dr. Edmondson and duly passed unanimously.

RE: Dr. Tjiep T. Liem, East Orange, N. J. -- Dr. Liem has requested an unrestricted license following his naturalization as an American citizen, although he is not living and practicing in North Carolina. Following Board discussion, Dr. Galusha moved that Dr. Liem be granted an unrestricted license. Seconded by Dr. Wilkerson and duly passed.

RE: Assistants to Physicians - certification of supervising physician. The Executive Secretary reviewed an inquiry regarding certification of supervising physicians in regard to assistants to physicians when the physicians would be changing continually through rotation through the hospital service. Dr. Edmondson moved that in order for the physician to comply with the rules and regulations for an assistant to a physician, the Board must have some practicing physician certified as supervisor for the assistant and so indicated on the application form, even though this may mean furnishing an updated certification of each supervising physician periodically. Seconded by Dr. Staub and duly passed. The Executive Secretary was instructed to so advise the inquiring physician and advise him to furnish an updated certification of each supervising physician for the assistant to the Board's office.

RE: Audit, 1972-1973 -- Dr. Edmondson, Chairman of the Audit Committee, consisting of Dr. Staub, Dr. Wilkerson and Dr. Edmondson, reported on that committee's review of the Audit for the fiscal year November 1, 1972 through October 31, 1973. The Audit Committee recommended that a committee be appointed to make a study for the use of the Board's funds with a view toward facilitating the efficiency of the Board's work. Dr. Taylor moved that this recommendation of the Audit Committee be accepted. Seconded by Dr. Staub and duly passed unanimously.

RE: Dr. Robert Stephen Adelaar appeared applying for license by endorsement of credentials. He is a graduate of the University of Pennsylvania in 1971 and is a diplomate of the National Board in 1972.

Dr. Hooper: You do not hold a state license at the present time?

A: No, sir.

Q: Dr. Adelaar does hold a resident's training license at Duke in Orthopaedic Surgery--how much longer do you have in training?

A: Two years, sir.

Dr. Galusha: Dr. Aylsworth will be on the staff at Memorial Hospital in Chapel Hill. You do know what you lack, Dr. Aylsworth?

Dr. Hooper: Dr. Cunningham is presently at Stanford University Medical Center in California. He hopes to join the staff at Bowman Gray in 1974 and his application is complete.

Dr. Hooper: What is your field?

A: Radiology.

VERDICT: Dr. Robert R. M. Gifford approved for license by endorsement of credentials if and when his credentials are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Dr. Bernice Aurelia Grant, (married name: Latham), appeared before the Board on January 27, 1973 applying for license by endorsement with incomplete credentials and was approved for same contingent upon satisfactory completion of those credentials, which has now been done.

VERDICT: Dr. Bernice A. Grant approved for license by endorsement.

RE: Dr. Ralph Leon Greene, Jr. appeared applying for license by endorsement of credentials. He is a graduate of West Virginia University in 1970 and is a diplomate of the National Board.

Dr. Wilkerson: Dr. Greene, I believe, is a resident at Charlotte Memorial, in Medicine, and his credentials are all in order.

VERDICT: Dr. Ralph L. Greene approved for license by endorsement.

RE: Dr. Anna Bauhofer Gulyn appeared applying for license by endorsement of credentials. She is a graduate of Innsbruck University Medical School in Austria in 1957 and is licensed in Illinois, Ohio and Wisconsin.

Dr. Wilkerson: Dr. Gulyn, what are your plans for North Carolina?
 A: My husband works for the Federal government and he will be in Salisbury, and I would like to practice there.
 Dr. Galusha: Have you ever been convicted of a crime? A. No
 Q: Have you had any difficulty with any medical licensing board? A. No
 Q: Have you ever used alcohol to excess? A. No
 Q: Have you ever personally used narcotics or barbiturates? A. No
 Q: What is your citizenship status, Dr. Gulyn?
 A: I am a naturalized American citizen.

VERDICT: Dr. Anna B. Gulyn approved for license by endorsement.

RE: Dr. James Saville Hannum appeared with incomplete credentials applying for license by endorsement. He is a graduate of the University of Michigan in 1970 and is licensed in Michigan by FLEX and in Washington by endorsement with the National Board.

Dr. Galusha: Dr. Hannum, have you practiced medicine--private practice?
 A: Well, I had my year of internship and then spent two years in the Public Health Service, so, I guess I've never really been in private practice.
 Dr. Galusha: Well, we are waiting for a couple of routine inquiries to be returned and then we can let you know about your license.
 Q: Have you ever been convicted of a crime? A. No
 Q: Have you ever used alcohol to excess? A. No
 Q: Have you had any difficulty with any medical licensing board? A. No
 Q: Have you ever personally used narcotics or barbiturates? A. No

Dr. Hannum, cont'd.

VERDICT: Dr. James S. Hannum approved for license by endorsement of credentials if and when same are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Dr. Thomas Arnett Haymond appeared applying for license by endorsement with incomplete credentials. He is a graduate of Harvard University Medical School in 1951 and is licensed in Illinois and West Virginia.

Dr. Wilkerson: Dr. Haymond's file lacks one letter of recommendation and his fee. What are you doing now in Kingwood?

A: Well, they needed an internist there, and I wanted to set up in that area. In Beulaville, they needed a doctor there, and I thought I'd do consultation work.

Q: Have you had any problems with narcotics, barbiturates or habit forming drugs?

A. No, I haven't

Q: What are your habits with regard to the use of alcohol?

A. Well, I drink socially.

Q: Have you ever had a problem with alcohol that would keep me from practicing.

A. Not a problem

Q: Have you ever had any problems with any board of licensure? Well, I've only tried the two boards, Illinois and West Virginia. I was in Texas with the Veterans. Then I took the Illinois examination and then I got reciprocity through just meeting with the Board in West Virginia. The only two I've tried.

A. No, I haven't--

Dr. S: Pardon me, Dr. Haymond, but what did you say you are doing now?

A: Well, I've been doing family practice, although I trained for Internal Medicine and I haven't really been happy with just the family practice.

Dr. Wilkerson: What are your plans for North Carolina?

A: Well, I understand they need, have need of a doctor there in Duplin County, and I thought I'd do consultation work.

VERDICT: Dr. Galusha moved that the Board withhold granting Dr. Haymond a license in North Carolina until further information is obtained that would allow the Board to make a better decision. Seconded by Dr. Staub and duly passed. See file.

RE: Dr. A. Williamson Huff appeared applying for license by endorsement of credentials with incomplete application. He is a graduate of Hahnemann Medical College in 1961 and is licensed in Pennsylvania by examination.

Dr. Galusha: I believe we are waiting on your application and your photograph and a couple of other things?

A: Yes, sir, that's right, but I hope to have them in your office within the week.

Q: You are planning to go to Reidsville to practice Obstetrics?

A: Yes, with a physician who is already there--should move sometime next month.

Q: Have you ever been convicted of a crime?

A. No

Q: Have you ever used alcohol to excess?

Dr. Wilkerson: Why are you giving up your practice in Pennsylvania?

A: Well, we've always liked this part of the country and so thought we'd move down here and give it a try.

RE: Dr. Trevor Hughes appeared applying for license by endorsement of credentials. He is a graduate of the University of Manchester in England in 1960 and is licensed in California by examination in 1967.

Dr. Wilkerson: Dr. Hughes is in the Department of Anesthesiology at Chapel Hill-- you are on the staff?

A: Yes, sir, that's correct.

Dr. Wilkerson: Dr. Hughes did not send his application to England for certification, but has presented us with a letter from his dean with his certified photograph, which I believe is sufficient. All his other credentials are complete. Dr. Hughes' alien registration receipt card number is A 30 936 983 and the photograph compares.

Dr. Galusha: Have you ever been convicted of a crime?

Q: Have you had any difficulty with medical licensing boards? A. No

VERDICT: Dr. Edward J. Tapper approved for license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary.

RE: Dr. George S. Weinstein appeared with incomplete credentials applying for license by endorsement. He is a graduate of Georgetown University in 1940 and is licensed in New York and Pennsylvania by endorsement with National Boards.

Dr. Taylor: Dr. Weinstein is planning to go to work in Greensboro at the University there around the first of next month in student health, and I believe he knows what is lacking in his file.

Dr. Hooper: Have you ever been convicted of a crime? A. No, sir

Q: Have you had any difficulty at any time with a licensing board? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

Q: Have you ever personally used narcotics or habit forming drugs? A. No, never

See file.

VERDICT: Dr. Galusha moved that Dr. Weinstein be granted license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary, but it is incumbent upon this Board to relate this information to the University at Greensboro, but emphasize there is no medical incompetency. Seconded by Dr. Edmondson and duly passed.

RE: Dr. David Wesley White appeared applying for license by endorsement with incomplete credentials. He is a graduate of the University of Virginia in 1958 and is licensed in Virginia by examination in 1958 and is licensed in Florida by examination in 1972.

Dr. Taylor: Where are you located now, Dr. White?

A: In Miami--South Miami, Florida.

Dr. Taylor: Dr. White will be doing locum tenens for about a month for Dr. Pace in Greenville and will be joining him there permanently later.

Dr. Hooper: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

Q: Have you ever personally used narcotics or habit forming drugs? A. No, sir

Q: Have you had any difficulty with any medical licensing boards? A. No, sir

Dr. Hooper: When do you want to start practice there?

A: I would like to start tomorrow as he wants me to do some surgery with him. I think everything is complete now.

VERDICT: Dr. David W. White approved for license by endorsement.

RE: Dr. Edgar Harold Willard, III appeared applying for license by endorsement of credentials. He is a graduate of West Virginia University in 1968 and is a diplomate of the National Board.

Dr. Wilkerson: Dr. Willard holds a resident's training license here in North Carolina--at Charlotte Memorial?

A: Yes, sir, that's right.

Dr. Galusha: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever personally used narcotics or barbiturates? A. No

Q: Have you had any difficulty with any medical licensing board? A. No

Q: What department are you in?

A: Internal Medicine.

VERDICT: Dr. Edgar H. Willard, III approved for license by endorsement.

RE: Dr. William Martin Wyatt appeared applying for license by endorsement of credentials. He is a graduate of the University of Kansas in 1945 and is licensed in Kansas, California, Texas and Kentucky.

Dr. Wilkerson: Dr. Wyatt is certified by the American Board of Pathology and is now at Oteen, North Carolina, with the VA, doctor?

Dr. Wyatt, cont'd.

Dr. Wyatt: Yes, that's right.

Dr. Galusha: Dr. Wyatt, we would like to ask you about some information we received in regard to some use of drugs. It concerned a Mr. William Wyatt of Falmouth, Kentucky obtaining prescriptions of Morphine Sulfate. Have you ever been involved with drugs of this type?

A: I did take some cough syrup for a while?

Q: Have you ever been accused of using drugs promiscuously?

A: No, sir.

Q: Is your home in Kentucky?

A: Yes, sir, Somerset.

Q: Why did you use the cough syrup?

A: I used it for sometime, mainly for an allergy and sensitivities I had--still have occasionally--have had it for years.

Q: Have you ever taken any drugs in excess of what was prescribed?

A: No, sir.

Q: Exactly what did you take and for what length of time?

A: Well, intermittently, for years--Robitussin, but I have never abused it, or any drugs.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

Q: Have you ever used narcotics or barbiturates personally? A. No, sir

Q: Have you had any difficulty with any medical licensing boards? A. No, sir

Dr. Galusha: Are you going with the VA?

A: I have been with them for about a year and a half now.

Q: Do you plan to move if you are licensed?

A: Well, if the right opportunity arises, I might move and practice pathology.

Q: Have you been in private practice?

A: Yes, before I went with the VA I was in private practice.

VERDICT: Dr. William M. Wyatt approved for license by endorsement.

RE: Dr. Virgil Howard Wynia appeared applying for license by endorsement of credentials with incomplete file. He is a graduate of Harvard University in 1972 and is a diplomate of the National Board.

Dr. Hooper: Do you hold any state licenses?

A: I have a resident's license at UNC.

Q: You do realize what is lacking in your file?

A: Yes, I had hoped it would have been here by now.

Q: Have you ever been convicted of a crime? A. No

Q: Have you ever used alcohol to excess? A. No--one beer every two weeks.

Q: Have you ever personally used narcotics or habit forming drugs? A. No

Q: Have you had any difficulty with any medical licensing board? A. No

Q: Do you plan to stay in North Carolina

A: I'll be here for another three years, but after that I'm not sure.

VERDICT: Dr. Virgil H. Wynia approved for license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Dr. Lee Kruidenier Buchanan appeared with incomplete credentials applying for license by endorsement. He is a graduate of the University of Iowa in 1952 and is licensed in Wyoming, Maryland and Colorado.

Dr. Galusha: Dr. Buchanan is living in Bath, North Carolina, and what are your plans for practicing here, Dr. Buchanan?

A: Well, I am presently retired--disability retirement--but thought I might work some in the emergency rooms around that area. My wife is from Bath originally.

Dr. Galusha: You do know what is lacking in your file?

A: Yes, some letters of recommendation, and I need to send in my unmounted photograph.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever personally used narcotics or barbiturates? A. No

Q: Have you ever had any difficulty with any medical licensing boards? A. No, sir

VERDICT: Dr. Lee K. Buchanan approved for license by endorsement of credentials if and when his credentials are completed satisfactory to the Executive Secretary.

RE: Dr. G. J. Ashley, Sparta, N. C. -- appeared at request of Board.

RE: Dr. David E. Graham, Charlotte, N. C. -- appeared at request of Board.

RE: Dr. Henry O. Williams, Durham, N. C. -- appeared at request of Board.

RE: Dr. John R. Kernodle, Burlington, N. C. -- Board discussed file.

RE: Dr. Stanton V. Huffman, Elon College, N. C. -- Board reviewed follow-up report and received this as information.

RE: Dr. Samuel W. Fleming, Elm City, N. C. -- Board reviewed file and recent information received.

ACTION: Dr. Galusha moved that the Board order that charges be preferred against Dr. Fleming and that a hearing be held before the Board, at a time to be set later, on whether or not his license should be revoked. Seconded by Dr. Wilkerson and duly passed unanimously.

RE: Dr. K. E. Neese, Monroe, N. C. -- Board reviewed file.

RE: Dr. Walter G. Lewis, Gibsonville, N. C. -- Board reviewed file.

ACTION: Dr. Galusha moved that Dr. Lewis be requested to appear before the Board at the March, 1974 Board meeting. Seconded by Dr. Edmondson and duly passed.

RE: Nurse Practitioner -- The Board reviewed most recent correspondence received from the North Carolina Board of Nursing in regard to the Nurse Practitioner, and reviewed the rules and regulations adopted at the December, 1973 Board meeting.

ACTION: Dr. Edmondson moved that the letter prepared in answer to the letter from the N. C. Board of Nursing dated January 10, 1974 and proposal of October 4, 1973 be mailed to the office of the Board of Nursing, along with the two-page, point-by-point answer sheet and that copies of same be mailed to all members of the Board of Nursing and that the letter request that the North Carolina Board of Medical Examiners committee meet with a representative group from the Board of Nursing to make an effort again to settle the in-hospital situation on the Nurse Practitioner. Seconded by Dr. Galusha and duly passed unanimously.

RE: Reimbursement of expenses -- out-of-town Board business.

Dr. Wilkerson moved that any Board member or member of the Board's staff, when on Board business, out-of-town, be reimbursed for mileage expenses, to be reimbursed at the present level of North Carolina State government mileage reimbursement expenses. Seconded by Dr. Edmondson and duly passed.

RE: Office procedures -- The Board discussed utilization of more data processing equipment for the procedures in the Board office and recommended that Mrs. Grissom make a study of the various data processing and computerization programs that would be feasible for the next three years, in steps of twelve months, and that it be presented to the Board at the March, 1974 meeting, if possible.

RE: John Z. Schmidt, D.O. -- Request to apply for license by endorsement. The Board discussed Dr. Schmidt's request and advised the Executive Secretary to forward an application, with requirements, for applying for license by endorsement of credentials to Dr. Schmidt and advise him in a letter of the educational requirements for licensure in this state.

RE: Dr. Robert G. Crummie, Fayetteville, N. C. -- Board reviewed report.

RE: Dr. Frank J. Brown, Blowing Rock and Morganton, N. C. -- Board reviewed file.

ACTION: Dr. Galusha moved that Dr. Brown be requested to appear before the Board at the March, 1974 Board meeting. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Bailey G. Weathers, Jr., Stanley, N. C. -- Board reviewed report.

RE: Approval of minutes -- Dr. Wilkerson moved that the minutes of the December, 1973 Board meeting be approved. Seconded by Dr. Hooper and duly passed.

RE: North Carolina Drug Authority -- request for approval from the Board of Medical Examiners in regard to the Drug Authority's investigating physician's records.

ACTION: Dr. Edmondson moved that the North Carolina Board of Medical Examiners endorse the recommendation that the Drug Authority will make ^{to} the General Assembly in regard to discrepancies uncovered in controlled substances in connection with a physician and approve the Drug Authority's request for approval and so advise the Director of the N. C. Drug Authority. Seconded by Dr. Wilkerson and duly passed unanimously.

RE: Certification of FLEX grades, December, 1973 -- Dr. Galusha moved that the Board approve all physicians obtaining at least 75.0% FLEX Weighted Average for license in North Carolina and that those physicians obtaining less than 75.0% FLEX Weighted Average be advised that they have failed the examination. Seconded by Dr. Edmondson and duly passed.

RE: Certification of applicants for license by endorsement of credentials --

Dr. Taylor moved that all applicants applying for license by endorsement with complete credentials interviewed by the two groups of Board members be approved for license in North Carolina, and that those applicants with incomplete credentials interviewed by the two groups of Board members be approved for license by endorsement if and when their credentials are completed satisfactory to the Executive Secretary, unless advised otherwise. Seconded by Dr. Edmondson and duly passed.

RE: Dr. Harold R. Hoke, Charlotte, N. C. -- Board reviewed file.

RE: Dr. Ian D. Duncan, Durham, N. C. -- Request of extension of time for Certificate of Registration as a Visiting Professor, until June 30, 1974, at Duke University School of Medicine.

ACTION: Dr. Galusha moved that the Board grant Dr. Duncan an extension of his Certificate of Registration until June 30, 1974 and emphasize that this is an exception to Board policy, and no such exceptions will be made in the future. Seconded by Dr. Taylor and duly passed. Dr. Duncan so advised.

RE: Dr. R. Herbert Wiebe, Durham, N. C. -- Request of extension of time for Certificate of Registration as a Visiting Professor. Dr. Wiebe is planning to stay on the staff at Duke University School of Medicine and take the June, 1974 written examination in North Carolina.


ACTION: Dr. Galusha moved that Dr. Wiebe's Certificate of Registration be extended until the results of the June, 1974 FLEX examination have been obtained. Further, that a letter be written to the dean's of both medical schools explaining that these are exceptions to the Board's policy and that the Board has no intention of making these exceptions again and include in this letter that personal interviews will be required in the future of all applicants for Certificate of Registration as a Visiting Professor. Seconded by Dr. Edmondson and duly passed.

RE: Visiting Professor status requirements -- Dr. Taylor moved that all applicants for a Certificate of Registration as a Visiting Professor be required to make a personal appearance before the Board in regular session at a time mutually convenient. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. David J. Delany, Chapel Hill, N. C. -- Request of extension of time for Certificate of Registration as a Visiting Professor. Dr. Delany is planning to remain on the staff at the University of North Carolina School of Medicine and take the June, 1974 FLEX written examination in North Carolina.

ACTION: Dr. Galusha moved that Dr. Delany's Certificate of Registration be extended until the results of the June, 1974 examination have been obtained and that a follow-up letter be written to the dean at the University of North Carolina as indicated in the previous motion.

Dr. Wilkerson moved that the meeting be adjourned. Seconded by Dr. Taylor and duly passed. Meeting adjourned.
