

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Mid Pines Club, Southern Pines, North Carolina

January 5- 8th, 1961

- - - -

The Board of Medical Examiners of the State of North Carolina met January 5-8th, 1961, for the purpose of certifying the grades of the written examination for medical licensure given December 19-22nd, 1961, to interview applicants for licensure by endorsement and for special limited license, and for other business.

Thursday, January 5th

The Board convened for dinner at 7 P. M. Drs. Edwin A. Raspberry, Jr., President, J. B. Anderson, Thomas W. Baker, L. R. Doffermyre, Thomas G. Thurston, Carl V. Tyner, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present. Dr. J. J. Combs, Secretary-Treasurer, was absent due to illness.

Credentials for license by endorsement of credentials and special limited license were reviewed by the members of the Board.

RE: Dr. Robert Dean Phillips was granted special limited license to the University of North Carolina School of Medicine as a resident in plastic surgery and has applied for reinstatement of his special limited license.

VERDICT: The Board ruled that the special limited license of Dr. Robert Dean Phillips be reinstated to cover him as a resident at the University of North Carolina School of Medicine, provided he furnish a letter of recommendation from his previous location and pay the fee of \$10.00 for the same.

RE: Written Examination December, 1960 - Certification - The Board canvassed the grades of the written examination given December 19-22nd, 1960. All applicants made a passing average of 75% or more and the grades were certified.

RE: Per Diem for Special Written Examination - Dr. Anderson moved that the members of the Board be paid a per diem of \$50.00 for this examination. This motion was duly seconded by Dr. Thomas W. Baker and passed unanimously.

RE: History of the Board of Medical Examiners - The Board was advised that the printing firm had held the type for this history for one year free of charge; that there are 240 copies on hand.

VERDICT: Dr. Thomas W. Baker moved that the type of the History of the Board of Medical Examiners be destroyed. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. Franklin B. Wilkins - (See previous Minutes) - Dr. L. R. Doffermyre reported that he had been advised by personal communication that Dr. Wilkins is doing well in surgical pathology at Bowman Gray School of Medicine.

The copy of report required by Dr. Wilkins to the California Board of Medical Examiners was presented to the Board.



RE: Written Examination June, 1961 - Letter from Dr. Manson Meads, Executive Dean of the Bowman Gray School of Medicine, was presented to the Board, in which he requested consideration as to scheduling the annual written examination of the Board of Medical Examiners at an earlier date due to a change in the medical school curriculum. The Board was advised that the secretary had ascertained from the Sir Walter Hotel that the ballroom in which the examinations are held would not be available for another date.

The Board directed that Dr. Manson Meads be advised that the schedule has been set for 1961, and that this requested be placed on the June, 1960 agenda with regard to the 1962 examination.

RE: Dr. George W. Melchior - The Board was advised that Dr. Melchior had returned to Mississippi to practice medicine in Pascou-goula; that his license was in effect there.

RE: Expenses Dr. Edwin A. Raspberry, Jr. - Meeting of the American Medical College Association - The Board approved payment of Dr. Raspberry's expenses in the sum \$165.23.

RE: State Medical Society - Resolution as to treatment of drug addiction - Information received from Mr. James T. Barnes, executive Director, was received as information.

RE: May 5 - 10th, 1961 Meeting - The Board was advised that reservations for this meeting had been made at the Battery Park Hotel.

RE: October, 1961 Meeting - Dr. J. B. Anderson moved that the Board hold its October, 1961 meeting at the Sedgefield Inn; that the same be arranged by the president and secretary, the dates to be at their discretion. This motion was duly seconded and passed unanimously.

RE: January, 1962 Meeting - Dr. J. B. Anderson moved that the Board meet at Mid Pines Club, Southern Pines, January 11-14th, 1962. This motion was duly seconded and passed unanimously.

RE: Dr. Willard W. Griggs - The Board was advised that Dr. Griggs expired November 1st, 1960.

Dr. Thomas W. Baker reported that he wrote Mrs. Griggs after Dr. Griggs died; that she replied and stated he died of congestive heart failure; that she was very grateful to the Board for what it had done for Dr. Griggs.

The Minutes for the October, 1960 meeting were approved as read.

The meeting was adjourned.

Friday, January 6th
9 A. M.

Applicants for license by endorsement of credentials were interviewed as follows:

RE: Dr. Robert B. Hodgson appeared applying for license by endorsement of credentials.

Dr. Baker: You are going to Reidsville? What position will you have there?

A. They have two doctors who take care of the plant of the American Tobacco Company. I will be assistant medical director.



Dr. Robert B. Hodgson continued

Dr. Baker : Have you done industrial medicine before?

A. Yes sir. The first couple of years I practiced with TWA.

Dr. Rasberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with any board of medical examiners or Narcotics Bureau? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

Dr. Hodgson stated that he was ready to begin practice.

VERDICT: Dr. Robert B. Hodgson was approved for license by endorsement of credentials.

RE: Dr. Joseph Lee Sedwitz appeared applying for license by endorsement of credentials.

Dr. Rasberry: Where are you going to practice?

A. I am interested in going to Zebulon.

Q. Do you know someone in Zebulon?

A. Dr. Thomas

Dr. Doffermyre: When will you be discharged?

A. I would like to get out in three months and barring a national emergency I can get out and go in active reserve. I have been in 17 years. I have been on active duty since 1956. My time before that was World War II and then I went to medical school. My time was in the active reserve. I have nine years towards retirement.

Dr. Rasberry : Have you ever been convicted of a crime? A.No sir

Q. Have you ever had any trouble with any board of medical examiners or Narcotic Bureau? A. No sir

Q. Have you ever been addicted to narcotic drugs or alcohol?

A. No sir

Dr. Sedwitz stated he would do surgery at the new hospital.

Dr. Rasberry: We do not usually give license until you have made definite arrangements.

A. I promised the people at Zebulon that I would give them a decision in one week. We have been thinking about it six months. This will affect the community, they would start looking for someone else.

VERDICT: Dr. Joseph Lee Sedwitz was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary and if and when he comes into the state for practice.

RE: Dr. Callis Jensen Anderson appeared with incomplete credentials applying for license by endorsement of credentials. He stated that he planned to go into practice March 1st and is looking very seriously at Gastonia. He will do ophthalmology. He said that he interned in Charlotte.

Dr. Rasberry : Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with a board of medical examiners or the Narcotics Bureau? A. No sir

Q. Have you ever been addicted to alcohol or narcotics? A. No sir

Dr. Rasberry: We have a policy that the applicant has to have a location and be ready to practice before a license can be issued.



Dr. Callis Jensen Anderson continued

VERDICT: Dr. Callis Jensen Anderson was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary and when he comes into the state for practice.

RE: Dr. Maurice Kamp appeared with incomplete credentials applying for license by endorsement of credentials. He stated that he is negotiating with the Health Department in Mecklenburg County as to a position as city-county health officer.

Dr. Raspberry: What type of work do you do?

A. Public health.

Dr. Baker: When do you plan to come to Charlotte?

A. In about a month. I assume it would be around March 15th.

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with any board of medical examiners or Narcotic Bureau? A. No sir

Q. Have you ever been addicted to alcohol or narcotic drugs?

A. No sir

VERDICT: Dr. Maurice Kamp was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary and when he comes into the state for practice.

RE: Dr. Joe Alexander Bain appeared applying for license by endorsement of credentials. He is a retired United States Army officer and is currently in the School of Public Health at Chapel Hill. He plans to go to Goldsboro as county health officer in June, 1961.

Dr. Raspberry: Have you ever been convicted of a crime? A. I have not.

Q. Have you had any trouble with any board of medical examiners or the Narcotic Bureau? A. No, I have not.

Q. Have you ever been addicted to drugs or alcohol? A. No, I have not

VERDICT: Dr. Joe Alexander Bain was approved for license by endorsement of credentials, when he locates in the State for practice.

RE: Dr. James Young Bryson appeared with incomplete credentials, applying for license by endorsement of credentials.

Dr. Doffermyre: What are your plans?

A. Public health

Q. Where?

A. I am figuring on Kinston. I have my master's in Public Health from the University of North Carolina in 1959.

Dr. Raspberry: Do you really know whether you are coming to North Carolina?

A. No

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you had any trouble with an examining board or the Narcotic Bureau? A. No

Q. Have you had any trouble with or addicted to drugs or alcohol?

A. No sir



Dr. James Young Bryson continued

Dr. Raspberry explained the policy of the Board in regard to issuing a license only when the applicant is ready to locate in the state.

VERDICT: Dr. James Young Bryson was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary and when he locates in the state for practice.

RE: Dr. Edwin Lawrence Coffman appeared with incomplete credentials applying for license by endorsement of credentials, limited to Duke University School of Medicine, where he is a resident in Anesthesiology.

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with a Narcotic Bureau or any medical examining board? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

VERDICT: Dr. Edwin Lawrence Coffman was approved for license by endorsement of credentials, limited to Duke University School of Medicine, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Wilfred Qualls Cole, Jr. appeared applying for license by endorsement of credentials, limited to Duke University School of Medicine, where he is a resident in Pediatrics.

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with a board of medical examiners or Narcotic Bureau? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

VERDICT: Dr. Wilfred Qualls Cole, Jr. was approved for license by endorsement of credentials, limited to Duke University School of Medicine.

RE: Dr. Floyd Wolfe Denny, Jr. appeared applying for license by endorsement of credentials. He stated that he is chairman of the Department of Pediatrics at the University of North Carolina School of Medicine.

Dr. Raspberry: Have you ever been convicted of a crime? A. No, I have not.

Q. Have you ever had any trouble with any board of medical examiners or Narcotic Bureau? A. No, I have not.

Q. Have you ever been addicted to drugs or alcohol? A. No, I have not.

VERDICT: Dr. Floyd Wolfe Denny, Jr. was approved for license by endorsement of credentials.

RE: Dr. Vincent Lawrence DiRienzo appeared applying for license by endorsement of credentials. He stated that he planned to locate in Rockingham.

Dr. Baker: What will you do?

A. Surgery

Dr. Anderson: Where did you practice?

A. I am practicing in Franklin, Tennessee, 9½ years.

Q. In surgery?

A. Surgery and general practice. You have to in a small town.

- Dr. Raspberry: Have you ever been convicted of a crime? A. No sir
- Q. Have you ever had any trouble with a board of medical examiners or Narcotic Bureau?
- A. No sir
- Q. Have you ever been addicted to drugs or alcohol? A. No sir
- Q. When will you go to Rockingham?
- A. One week from Monday.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Vincent Lawrence DiRienzo be approved for license by endorsement of credentials. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Jack Erwyn Dunlap appeared applying for license by endorsement of credentials. He stated that he was going to Lumberton.

- Dr. Anderson: Are you going with the group in Lumberton?
- A. Yes^s sir

- Dr. Raspberry: Where have you been practicing?
- A. I have not been in practice.

- Dr. Anderson: Do you have your boards?
- A. I have the first part.

- Dr. Raspberry : Have you ever been convicted of a crime? A. No sir
- Q. Have you ever had any trouble with an examining board or Narcotic Bureau? A. No sir
- Q. Have you ever been addicted to drugs or alcohol? A. No sir
- Q. When do you plan to begin work?
- A. To-day

VERDICT: Dr. Jack Erwyn Dunlap was approved for license by endorsement of credentials.

RE: Dr. Marion Edmonds appeared applying for license by endorsement of credentials, limited to Duke University School of Medicine, where she is a resident in Anesthesiology. Her credentials are incomplete.

- Dr. Raspberry: Have you ever been convicted of a crime? A. No sir
- Q. Have you ever had any trouble with a board of medical examiners or Narcotic Bureau?
- A. No sir
- Q. Have you ever been addicted to drugs or alcohol? A. No sir

VERDICT: Dr. Marion Edmonds was approved for license by endorsement of credentials, limited to Duke University School of Medicine, if and when her credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Charles Phillip Ford, Jr. appeared with incomplete credentials applying for license by endorsement of credentials. He has been with DuPont Company in Richmond, Virginia, and is transferring to DuPont Company in Kinston.

Dr. Baker: When are you planning to go to Kinston?

A. January 16th

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with a board of medical examiners or narcotic bureau? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

Dr. Anderson: How long have you been associated with DuPont?

A. Six years

Q. What is your capacity?

A. Industrial physician.

VERDICT: Dr. Charles Phillip Ford, Jr. was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Ernest M. Freedle, Jr. appeared with incomplete credentials applying for license by endorsement of credentials limited to Duke University School of Medicine, where he is a resident in Orthopedics. He is a native of North Carolina.

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with a board of medical examiners or narcotic bureau? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

VERDICT: Dr. Ernest M. Freedle, Jr. was approved for license by endorsement of credentials, limited to Duke University School of Medicine, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Shattuck W. Hartwell, Jr., resident at Duke University School of Medicine in Plastic Surgery, appeared October 7th, 1960, with incomplete credentials, applying for license by endorsement of credentials, limited to Duke University School of Medicine. At that time the Board approved Dr. Hartwell for license by endorsement, limited to Duke University School of Medicine, if and when his credentials were completed satisfactory to the secretary. Dr. Hartwell's credentials are now in order.

VERDICT: Dr. Shattuck W. Hartwell, Jr. was approved for license by endorsement of credentials, limited to Duke University School of Medicine.

RE: Dr. George W. Hoffman appeared with incomplete credentials applying for license by endorsement of credentials, limited to Duke University School of Medicine, where he is a resident in Plastic Surgery.

VERDICT: Dr. George W. Hoffman was approved for license by endorsement of credentials, limited to Duke University School of Medicine, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)



RE: Dr. William A. Hunter, Jr., resident, appeared October 7th, 1960, with incomplete credentials applying for license by endorsement of credentials, limited to Duke University School of Medicine. At that time the Board approved for Dr. Hunter for license by endorsement of credentials, limited, if and when his credentials were completed satisfactory to the secretary. Dr. Hunter's credentials are now in order.

VERDICT: Dr. William A. Hunter, Jr. was approved for license by endorsement of credentials, limited to Duke University School of Medicine.

RE: Dr. John Payne Jimenez appeared before the Board on October 7th, 1960, applying for license by endorsement of credentials. At that time the Board Dr. Jimenez for license by endorsement of credentials, contingent upon his locating in the state for practice. Dr. Jimenez has now located in Pleasant Garden with Dr. F. B. Nowlan. He was advised on December 21st, 1960, by the secretary that he might begin practice.

VERDICT: Dr. John Payne Jimenez was approved for license by endorsement of credentials.

RE: Dr. Paul Maynard Lerner appeared applying for license by endorsement of credentials.

Dr. Tyner: You intend to practice urology where?

A. I hope Asheville.

Dr. Anderson: Solo or with someone?

A. I hope with Dr. Gilbert.

Dr. Raspberry: Where are you now?

A. Massachusetts Memorial finishing my residency.

Q. Have you ever been convicted of a crime? A. No, I have not.

Q. Have you ever had any trouble with a board of medical examiners or narcotic bureau? A. No

Q. Have you ever been addicted to drugs or alcohol? A. No, I have not.

Q. Have you ever been addicted to drugs or alcohol? A. No, I have not

Dr. Anderson: When do you anticipate coming to Asheville?

A. The early part of July. I finish June 30th.

Dr. Raspberry: We will pass on your application to-day, but the situation is that the license itself would await your giving us your address in the state.

A. I will be living with my in-laws in Asheville.

Q. Your appearance is mandatory. Do you think it is definite for Asheville?

A. Yes I do.

VERDICT: Dr. Paul Maynard Lerner was approved for license by endorsement of credentials, if and when he locates in the state for the practice of medicine.

RE: Dr. Russell Ramsey Mellette appeared with incomplete credentials applying for license by endorsement of credentials, limited to the University of North Carolina School of Medicine, where he is a resident in Child Psychiatry.



Dr. Russell Ramsey Mellette continued

Dr. Baker: Where have you practiced since 1950?

A. I interned at Wayne County General Hospital, went back to Orangeburg, clinical and medical director at Edgewood, in the Army. I transferred to the Navy as a psychiatrist. I then transferred to Charleston and was transferred on account of polio in 1955. I went to the Medical College of South Carolina and took a year of residency in Medicine. They did not have a residency in Psychiatry there. I then went to Michigan and took two years of residency in Psychiatry, instructor there one year, then went to the Medical College as assistant professor in Child Psychiatry. I am on a year's leave of absence. I am board eligible in regular Psychiatry, but lacked a year in Child Psychiatry.

Dr. Raspberry: Have you ever been convicted of a crime? A. No

Q. Have you ever had any trouble with a board of medical examiners or narcotic bureau? A. No

Q. Have you ever been addicted to alcohol or drugs? A. No

VERDICT: Dr. Russell Ramsey Mellette was approved for license by endorsement of credentials, limited to the University of North Carolina School of Medicine, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Albert James Paine appeared with incomplete credentials applying for license by endorsement of credentials.

Dr. Tyner: Where are you now?

A. Bluefield

Q. You expect to locate with Dr. Cloninger in Newton?

A. Yes

Dr. Raspberry: You do nose and throat?

A. Yes

Dr. Baker: You are doing that at the present time in Bluefield?

A. Yes sir

Dr. Tyner: When do you plan to go there?

A. I have anticipated going there right soon, but things have happened in our area and there is no one there but me. That will put it off.

Dr. Raspberry: Have you ever been convicted of a crime?

A. No

Q. Have you ever had any trouble with a board of medical examiners or narcotic bureau? A. No

Q. Have you ever been addicted to drugs or alcohol? A. No

Dr. Anderson: How soon do you anticipate you could move?

Q. Six months?

A. I would hope so.

Dr. Baker: Are you definitely committed?

A. No sir. I doubt that I will remain in West Virginia. I have not looked with anybody else. This is the only thing I have considered.

VERDICT: Dr. Albert James Paine was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary and he locates in the state for practice, within one year.

RE: Dr. Ronald Anthony Pruitt appeared applying for license by endorsement of credentials. He is an assistant resident in Orthopedics. He stated that his wife is from Graham and that he plans to remain in North Carolina for practice.

Dr. Baker: How long will you be at Duke?

A. 4½ years

Q. I would not advise you to apply for full license at this time as your plans might change.

A. That will be all right.

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any trouble with a board of medical examiners or narcotic bureau? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No

VERDICT: Dr. Ronald Anthony Pruitt was approved for license by endorsement of credentials, limited to Duke University School of Medicine.

RE: Dr. Luis Enrique Remus, Jr. appeared applying for license by endorsement of credentials. He is a graduate of Duke University School of Medicine and a native of Puerto Rico. He was granted a special limited license to Charlotte Memorial Hospital in October, 1953.

Dr. Tyner: What were you doing from 1950 to 1960?

A. I practiced in Puerto Rico one or two years, went into interneship and residency, then I did pathology training, which I just finished.

Q. How long were you at Charlotte Memorial?

A. One year

Dr. Baker: What service there?

A. I started in Medicine and I did five months in Pathology.

Dr. Tyner: What are your plans now?

A. Right now I have a job with the Veterans Administration. I had an offer to start earlier than I would have been able to in Goldsboro.

Dr. Baker: How did you happen to take the boards in New Hampshire?

A. I wrote the Board. This was right after the examinations had been given in North Carolina and you advised me to take another state board. That was the earliest one.

Q. There was no question about them accepting you in New Hampshire?

A. They asked me why I wanted to take the examination because I had the National Boards.

Dr. Doffermyre: Did you go to Puerto Rico after you graduated from Duke?

A. I did my interneship there.

Dr. Thurston : Have you had any serious illness in the past few years?

A. No

Q. You have worked every year since you finished?

A. Yes

Dr. Luis Enrique Remus, Jr. continued

Dr. Raspberry: Just prior to getting the examinations off in New Hampshire, where have you been?

A. I finished in August at the Veterans Administration Research Hospital in Chicago. I was there 18 months.

Dr. Baker: What type of position do you wish to accept in Goldsboro?

A. I have given that up. I have a job with the Veterans Administration in Jackson, Mississippi.

Q. Are you planning to come to North Carolina to practice?

A. I may.

Q. Why did you want a North Carolina license?

A. It was that I took the examinations in New Hampshire for the purpose of taking North Carolina license. Since I had gone to the trouble.

Q. Why did you want North Carolina license if you are not coming to the state to practice?

A. The way I think, I may want to work here say 10 years from now. In the meantime you may change your regulations.

Dr. Doffermyre: When you took the New Hampshire license, was your job in Goldsboro then pending on securing North Carolina license?

A. Yes. I had job with the Veterans Administration to start earlier.

Dr. Raspberry: Have you ever been convicted of a crime? A. No sir

Q. Have you ever been before any board of medical examiners for any trouble? A. No sir

Q. Have you ever been before any bureau of narcotics for any trouble?

A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

VERDICT: Dr. Tyner moved that Dr. Luis Enrique Remus, Jr. be declined license to practice medicine. This motion was duly seconded by Dr. Thomas G. Thurston and passed unanimously.

RE: Dr. Thomas A. Smith appeared with incomplete credentials applying for license by endorsement of credentials, limited to the University of North Carolina School of Medicine, where he is a resident in Psychiatry.

Dr. Raspberry: Have you ever been convicted of a crime.? A. No sir

Q. Have you ever had any trouble with a board of medical examiners or Bureau of Narcotics? A. No sir

Q. Have you ever been addicted to alcohol or narcotics? A. No sir

Dr. Raspberry advised Dr. Smith if his credentials were not completed within two weeks he might have to cease work.

VERDICT: Dr. Thomas A. Smith was approved for license by endorsement of credentials, limited to the University of North Carolina School of Medicine, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)



RE: Dr. William Byrd Stryker appeared applying for license by endorsement of credentials. He stated that he retired from the Army Medical Corps two months ago.

Dr. Baker: Were you in the Army the entire time?

A. I practiced in Minnesota for six years before I went into the Army.

Dr. Anderson: What are your plans as to North Carolina?

A. I have moved to Asheville and bought a home there and I am seeking full or part-time employment, probably in the public health field or industrial medicine, probably in the Asheville area. I have been to see Dr. Higgins with the State Board of Health and I am considering various jobs and am considering some training in Public Health. I have had experience in preventive medicine, but not education in that field.

Dr. Raspberry: Have you ever been convicted of a crime? A. I have not sir.

Q. Have you ever had any trouble with a board of medical examiners or a narcotic bureau? A. No sir

Q. Have you ever been addicted to drugs or alcohol? A. No sir

Dr. Anderson: Were you discharged on a medical discharge?

A. No, on my application.

RE: Dr. Nicholas Pediditakis, graduate of the University of Solonica, Greece in 1954 and a staff physician at the John Umstead Hospital, Butner, appeared petitioning to take the written examination in June, 1961. Dr. Pediditakis is an immigrant and expects to become naturalized in the near future. He has received the permanent certificate of the Educational Council for Foreign Medical Graduates.

Dr. Pediditakis is applying for special limited license to cover him as a staff physician until he becomes licensed by written examination, which was approved to August 1st, 1961.

VERDICT: Dr. Nicholas Pediditakis was approved to take the written examination in June, 1961.

Dr. Alton Lane Bullard - (See Minutes October, 1960) - Pursuant to notice from the California Board of Medical Examiners that Dr. Bullard's license to practice medicine had been revoked in that state because of alcoholism and failure to comply with the terms of a suspended judgment, he was requested to appear before the Board and was advised that he would be placed under the surveillance of the Board for five years.

On November 11th, 1960, the Board received reports from Newton Grove alleging that Dr. Bullard had acted in a manner unbecoming a physician, an investigation was made by the State Bureau of Investigation at the request of the Board, and the following charges were brought:

"1. That before March 5th, 1958 you were addicted to the use of alcoholic beverages, and you consumed intoxicating liquor to the extent and in such manner as to impair your ability to practice medicine and surgery with safety to the public.

"2. That on or about July 10th, 1959 you were intoxicated and under the influence of intoxicating liquor in Grover City, County of San Luis Obispo, State of California, to the extent and in such manner as to be dangerous to yourself, to other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public.



Dr. Alton Lane Bullard continued

"3. That on or about October 24th, 1959 you were intoxicated and under the influence of intoxicating liquor in Grover City, County of San Luis Obispo, State of California, to the extent and in such manner as to be dangerous to yourself, to other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public.

"4. That during the month of May, 1959 you were intoxicated and under the influence of intoxicating liquor in Grover City, State of California to the extent and in such manner as to be dangerous to yourself, to other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public.

"5. That on or about December 24th, 1959 you were intoxicated and under the influence of intoxicating liquor in Grover City, State of California to the extent and in such manner as to be dangerous to yourself, to other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public.

"6. That in April, 1960 you were intoxicated and under the influence of intoxicating liquor in California at various times to such an extent that you were dangerous to yourself, to other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public and that during said month you were convicted of operating a motor vehicle under the influence of intoxicant.

"7. That in September, October and November, 1960 at Newton Grove N. C. and vicinity you were intoxicated and were under the influence of intoxicating liquor to the extent and in such manner as to be dangerous to yourself, to other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public.

"8. That on November 6th, 1960 while attempting and purporting to be attending patients and holding yourself out for the practice of medicine, you were intoxicated and were under the influence of intoxicating liquor to the extent and in such manner as to be dangerous to yourself, to the other persons and to the public and to the extent that such use impaired your ability to practice medicine and surgery with safety to the public; that at said time and place you drew a gun on and threatened to shoot a patient, you refused to attend a patient and to deliver a baby for a patient, namely Mrs. David Sport, you refused to leave your clinic or office to examine a patient who needed and required your attention, you drew a gun upon and threatened to shoot one Robert Allen Barefoot, you engaged in an affray with one Sherrill Knowles, and that you refused to treat and pulled a gun on another patient at said time and place.

"9. That your present mental condition renders you incapable of safely practicing medicine and impairs your ability to practice medicine and surgery with safety to the public.

"10. That in the foregoing respects you have been guilty of dishonorable conduct unworthy of and affecting the practice of your profession and grounds exist for the revocation of your license to practice medicine issued by this Board.



"11. You are further notified that on January 6th, 1961 at 2:30 P. M. at the Mid Pines Club, Southern Pines, N. C. a hearing will be held before the Board of Medical Examiners of the State of North Carolina concerning and with respect to the foregoing charges and accusations, at which time you will be given an opportunity to be heard concerning the same, with or without counsel, to present evidence on your own behalf and to cross-examine witnesses and that in the meantime you may file a written answer to these charges, although you are not required to do so. Following such hearing the Board of Medical Examiners will make such findings and will take such action respecting the revocation of your license to practice medicine as the findings and circumstances may warrant or require.

"By Order of the Board of Medical Examiners of the State of North Carolina, this 29th day of November, 1960."

After Dr. Bullard left Newton Grove he was treated for alcoholism at the John Umstead Hospital, Butner.

Dr. Bullard appeared and the Board reserved its judgment for a later session. (See PP. 145 these Minutes)

RE: Dr. James Arthur Brown, Cleveland, North Carolina - Dr. Brown came in for a routine interview. He stated that he sees his psychiatrist monthly; that he is doing well and practicing. Dr. Thomas G. Thurston stated that he was doing a good medical practice.

VERDICT: The Board directed that Dr. James Arthur Brown be seen in one year.

RE: Dr. John Samuel Hooker, Carrboro, North Carolina. - Dr. Hooker came in for a routine interview. He stated that he was getting along all right; that his psychiatrist discharged him a year ago. Dr. Thomas G. Thurston stated that from all reports he is doing well and he recommended that Dr. Hooker be seen in one year.

VERDICT: The Board directed that Dr. John Samuel Hooker be seen in one year.

RE: Dr. Rayford Lee Weinstein, Fairmont, North Carolina - The Board received copy of report of joint investigation made by the Federal Narcotic Bureau and the State Bureau of Investigation in October, 1960. This investigation was precipitated by a report that narcotic addicts were alleged to visit Dr. Weinstein.

It was found on the investigation that Dr. Weinstein did not have records of dispensation. He had a large amount of narcotic drugs on hand, which did not appear in his inventory of June 13th, 1960 and he had made no purchases since that time. Dr. Weinstein was unable to account for this discrepancy. He said that the morphine sulfate tablets were purchased when he had the Weinstein Clinic in Fairmont seven to eight years ago and that when he discontinued the clinic he had kept all of the narcotic drugs for office use and had purchased only a few narcotics during the past few years, chiefly demerol.

Upon receipt of this report Dr. Weinstein was requested to appear before the Board. He appeared (See file for interview) and stated that he had kept the drugs when he closed the Fairmont Clinic; that he used very little drugs; that he did not sell narcotic drugs; that he did not personally use narcotic drugs. He admitted having written prescriptions for two women who claimed to have kidney colic. He said he dispensed drugs and wrote prescriptions. Dr. Weinstein gave very vague answers with no explanation as to the discrepancy in his June, 1960 inventory and the amount of drugs on hand when the investigation was made.



Dr. Rayford Lee Weinstein continued

VERDICT: Dr. Thomas W. Baker moved that Dr. Rayford Lee Weinstein be requested to surrender his narcotic license, order blanks and narcotics on hand to the Federal authorities. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

Dr. Weinstein was advised the action by the Board.

The meeting was adjourned.

RE: Dr. Granville F. Knight appeared before the Board of Medical Examiners July 24th, 1959, applying for license by endorsement of credentials and was approved contingent upon completion of credentials satisfactory to the secretary and upon locating in the state for practice, within one year. Dr. Knight has been granted extension of time for one year and has asked for further extension until August, 1961.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Granville F. Knight be granted an extension of time to locate in the state for practice until August, 1961. This motion was duly seconded by Dr. Carl V. Tyner and passed unanimously.

RE: Audit 1960 - The Finance Committee consisting of Dr. Thomas W. Baker, Chairman, and Drs. L. R. Doffermyre and Carl V. Tyner, reported on the annual audit and approved the same.

VERDICT: Dr. J. B. Anderson moved that the Board accept the report of the Finance Committee. This motion was duly seconded by Dr. Thomas G. Thurston and passed unanimously.

RE: Dr. Michel Bourgeois-Gavardin was granted license on the basis of written examination June 23rd, 1955, limited to Duke University School of Medicine, to Mecklenburg County and then to Durham County, until citizenship could be obtained. He has now advised that he has become a naturalized American citizen as of December 9th, 1960.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Michel Bourgeois-Gavardin be granted full license upon presentation of his naturalization paper. This motion was duly seconded and passed unanimously. (Naturalization paper presented to the secretary and license converted.)

RE: Special Limited License Renewal - The following physicians were granted special limited license to their respective hospitals to December 31st, 1960, with the understanding that the same would be extended to complete the year provided they obtained the certificate of the Educational Council for Foreign Medical Graduates in the interim:

The Board directed that Dr. J. B. Anderson report on Drs. W. A. Hoover and George Ashby Winstead at its next meeting.

RE: January, 1962 Meeting - The Board will meet January 11-14th, 1962 at Mid Pines.

RE: Dr. John M. Gambill - To summarize, on January 9th, 1960, the license to practice medicine of Dr. Gambill was revoked, judgment suspended. Conditions of the said suspension were violated by Dr. Gambill and his license was revoked May 16th, 1960. On July 23rd, 1960, Dr. Gambill appeared before the Board to ask for help and advice and he was advised to report to a neuropsychiatrist and be admitted for institutional treatment. Dr. Gambill was admitted to the Veterans Administration Hospital in Salisbury on August 23rd, 1960, as a voluntary patient.

Dr. Gambill appeared at this time, stated that he had been doing well at the Veterans Administration Hospital; that he had week-ends off for the past three months; that on the 15th day of this month he would go on leave of absence, which would terminate his stay there. He said that he had been working Dr. Thomas G. Thurston to obtain a position at the State Hospital; that Dr. John S. McKee, Jr., Superintendent of the Broughton Hospital at Morganton, had said he would give him a position if he could get a permit, which would begin January 15th, 1961. He said that he had not had any trouble on his week-ends off. Dr. Thurston reported that Dr. Gambill had apparently done well with his work at the Veterans Administration Hospital.

VERDICT: Dr. J. B. Anderson moved that Dr. John M. Gambill be given a special permit on an annual basis to work at the State Hospital in Morganton, with periodic reports at each meeting of the Board of Medical Examiners from the medical director and that Dr. Gam-

bill report personally to a member of the Board prior to each meeting of the Board and that probation be continued for a period of five years. This motion was duly seconded and passed unanimously.

RE: Dr. Harold Preston Burbage was declined license by endorsement of credentials in June, 1960 (See Minutes). He had accepted a position with the State Board of Health and started work as county health officer located in Oxford, North Carolina.

Dr. Burbage appeared at this time to petition to be heard again with regard to license by endorsement of credentials. He stated that he denied having had trouble, being addicted to narcotics previously, as no one wanted to admit that. He stated that he did not want to do general practice, but was interested in public health work.

The Board has received several letters from citizens in regard to Dr. Burbage.

VERDICT: Dr. J. B. Anderson moved that Dr. Harold Preston Burbage be given a permit on an annual basis limited to the State Public Health Department, contingent upon the fact that he is given a job with the State Health Department, and that we inform him that he can lose this with any difficulty anywhere in this state. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. Samuel A. Pope, Beulaville, North Carolina - (See previous Minutes) - On January 8th, 1960, Dr. Pope's license to practice medicine in the State of North Carolina, following conviction in the Superior Court for criminal abortion, was revoked.

Dr. Pope has appeared at this time, with his attorneys, E. Walker Stevens and Henry L. Stevens III, to petition the Board for reinstatement of his medical license. He presented representatives from his community, including two physicians, stating that his services were needed and desired. He said that he had been taking courses at the University of North Carolina School of Medicine and attended a symposium at Bowman Gray School of Medicine.

VERDICT: Dr. J. B. Anderson moved that we postpone judgment of the Board for a later session. This motion was duly seconded and passed unanimously. (See P. 145 these Minutes)

RE: Dr. Oliver Wayne Williamson, Waggner, South Carolina - Dr. Williamson's license to practice medicine in the State of North Carolina was evoked on July 26th, 1958, following conviction in the Federal Court for conspiracy to violate the narcotic laws and revocation of his South Carolina medical license to practice medicine on June 24th, 1958.

A. Yes

Q. Your interest in getting your North Carolina license is a matter of record?

A. It is more than that. I took the written examination in North Carolina.

VERDICT: Dr. Thomas W. Baker moved that the medical license of Dr. Oliver Wayne Williamson be restored; that recommendation not be made that his narcotic license be restored. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. Julian Lynn Harris, Winston-Salem, North Carolina - Dr. Harris was indicted for assault with intent to commit rape, which charge was changed by the presiding judge of the Superior Court in Forsyth County to assault on a female, as the evidence was not sufficient for the original charge to go to a jury. Dr. Harris was acquitted in this court for assault on a female.

Dr. Harris was asked by the Board to come in so that they might discuss the matter with him. He stated that he was a victim of blackmail; that he was approached by a friend of the accusing family with regard to paying money to keep out of court; that he emphatically declined to do so; that he had a witness to testify, who was in his waiting room at the time of the alleged assault; that he was guilty of poor judgment in seeing the patient at night and not having a nurse in attendance, and would never be put in that position again. (See file for complete interview)

The interview with Dr. Julian Lynn Harris was accepted as information.

RE: Dr. James Virgil Blazek appeared applying for license by endorsement of credentials, limited to Bowman Gray School of Medicine, where he is a resident in Radiology. Dr. Blazek did not appear at the appointed time due to the fact that he made a mistake in the time scheduled.

Dr. Raspberry: Have you ever been convicted of a crime? A. No

Q. Have you ever had any trouble with any state board of medical examiners or Bureau of Narcotics?

A. No

Q. Have you ever been addicted to narcotics or alcohol? A. No

Dr. Thurston : You intend to stay at Bowman Gray how long?

A. Three years.

VERDICT: Dr. James Virgil Blazek was approved for license by endorsement of credentials, limited to Bowman Gray School of Medicine.

RE: Dr. Bienvenido E. Davao, resident at St. Agnes Hospital, has failed to pass the examination of the Educational Council for Foreign Medical Graduates. He appeared at this time to petition the Board to allow him to remain there until the hospital is closed. Letter from

Dr. George W. Paschal, Jr., Chief of Surgical Service at St. Agnes Hospital was presented to the Board supporting Dr. Dayao's appeal and stating the need for his services. Mr. Ralph C. Bartlett, Director of St. Agnes Hospital, appeared with Dr. Dayao and stated that since the hospital will close about April 1st, 1961, when the new hospital is completed, he is asking that Dr. Dayao be allowed to stay on until that time; that his services are greatly needed. Dr. Dayao stated that he planned to take the examination of the Educational Council for Foreign Medical Graduates again in April.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Bienvenido E. Dayao be allowed to remain at St. Agnes Hospital until it closes. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Otto Heinrich Spoerl, graduate of the University of Erlangen, Germany, in 1957, and a resident in Psychiatry at Duke University School of Medicine, appeared to petition the Board for the privilege of taking the written examination in June. Dr. Spoerl has the permanent certificate of the Educational Council for Foreign Medical Graduates and is an immigrant. He stated that he had two more years of training at Duke; that he desired to take the examination as it had been several years since graduation; that he would not practice until training was completed.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Otto Heinrich Spoerl be allowed to take the written examination in June, 1961, contingent upon recommendation from Duke University School of Medicine. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Anthony Peter Slewka, graduate of the University of Western Ontario, Canada, 1954, and a resident in Pathology at Duke University School of Medicine, appeared to petition the Board for the privilege of taking the written examination in June. He is in the process of obtaining an immigration visa, which he expects in the near future. He stated that he is considering practicing in the State of Virginia, but wishes to take this examination and his plans are uncertain.

VERDICT: The Board of Medical Examiners approved Dr. Anthony Peter Slewka for written examination in June, 1961, provided he has obtained his immigration visa.

The meeting was adjourned.

RE: Dr. Franklin Stith Kincheloe, Jr., Selma, North Carolina- Following receipt of a report from the Virginia State Medical Examiners, Dr. Kincheloe was requested to appear at this time. (See interview on file)

VERDICT: Dr. L. R. Doffermyre moved that Dr. Franklin Stith Kincheloe be informed that the Board of Medical Examiners is fully cognizant of all his activities both in North Carolina and Virginia; that his appearance here to-day is to further inform him that he will remain under close observation of the Board and that it shall be his duty to report to one member of the Board at three months intervals as to how he is getting along in his practice and that any discrepancy in the same will be taken up before the full Board for disposition. This motion was seconded by Dr. Thomas G. Thurston and passed unanimously.

The meeting was adjourned.

RE: Dr. Alton Lane Bullard - (See pp. 129-133 these Minutes -
After deliberation the following findings and order were made by the Board:

"At a regular meeting of the Board of Medical Examiners of the State of North Carolina, on January 6th, 1961, at Mid Pines Club, Southern Pines, North Carolina, pursuant to notice to Alton Lane Bullard, M. D., a hearing was held upon the charges and accusations presented against him.

"After full consideration of the evidence and the statements of Alton Lane Bullard, M. D. concerning the charges and accusations made at the hearing as appear in the record, the Board of Medical Examiners of the State of North Carolina found and concluded that the respondent, Alton Lane Bullard, M. D., was guilty of dishonorable conduct unworthy of and affecting the practice of his profession and that grounds existed for the revocation of his license to practice medicine in the State of North Carolina.

"WHEREUPON, it was ordered and is hereby ordered that the license of Alton Lane Bullard, M. D. to practice medicine in the State of North Carolina be revoked, and that he surrender his certificate of licensure issued by the Board of Medical Examiners of the State of North Carolina to the secretary of this Board, but that this order and revocation be suspended and not be put into effect upon the following conditions and provided:

"1. That for a period of three years he refrain from practicing medicine in any respect except in employment in and by an institution operated by the State of North Carolina or the Federal Government;

"2. That for a period of three years he be and remain of good behavior and not violate any state or Federal laws;

"3. That during said time he obtain psychiatric therapy for such period or periods of time as may be advised by a psychiatrist, and

"4. That for a period of three years he personally report to the Board of Medical Examiners of the State of North Carolina or one of its members every six months to show his compliance with the conditions upon which the order of revocation has been suspended.

"Entered by order of the Board this the 6th day of January, 1961."

RE: Dr. Samuel A. Pope - (See p. 139 these Minutes) - After due consideration the following was the verdict of the Board: Dr. J. B. Anderson moved that the medical license of Dr. Pope not be reinstated at this time. This motion was duly seconded by Dr. Thomas W. Baker and the same passed by a vote of three to one. Dr. Doffermyre abstained from voting.
