CALL TO ORDER

F. M. Simmons Patterson, Jr., M.D., President of the Board of Medical Examiners of the State of North Carolina, called the meeting to order on Wednesday, July 17, 1991, at 7:00 p.m., at the Marriott Crabtree, Raleigh, North Carolina.

LEUNG, Joseph, W.C., M.D. - wl

On July 19, 1991, the Board of Medical Examiners unanimously adopted a motion made by Dr. Patterson and seconded by Dr. Roufail that after going through the application process, Dr. Leung be issued a 5 year VIP registration with the requirement that he must take and pass FLEX. Also, the Board suggested that if Dr. Leung stays permanently at Duke or in North Carolina, that he apply for the Boards of Gastroenterology.

On July 19, 1991, the Board of Medical Examiners unanimously adopted a motion made by Dr. Patterson and seconded by Dr. Henry that the request for data be denied.

MEDICAL MUTUAL - PROCEDURES IN A DERMATOLOGY PRACTICE - wl

On July 19, 1991, the Board of Medical Examiners unanimously adopted a motion made by Dr. Roufail and seconded by Dr. Nance that the Board send Medical Mutual a copy of the Medical Practice Act indicating that only doctors, PAs and NPs may perform the medical acts listed in their letter.

KRONINGER, David, O.D. - wl

On July 19, 1991, the Board of Medical Examiners after reviewing information regarding a public contact lens distributor unanimously adopted a motion made by Dr. Henry and seconded by Dr. Nance that the Board send a letter to Dr. Kroninger indicating that this is not in the Board's jurisdiction but we are interested and to please keep us informed.

PEDIATRIC INTRAOSSEOUS INFUSIONS: NCEMS TRAINING PROGRAM - wl

On July 19, 1991, the Board of Medical Examiners adopted a motion made by Dr. Nance and seconded by Dr. Henry (HG opposed)(NS, KW were not present) that the Board approve the activation of the training program for intraosseous infusion.

EMS CERTIFICATION PROCESS - wl

On July 19, 1991, during the EMS REPORT, the Board of Medical Examiners unanimously adopted a motion made by Dr. Nance and seconded by Dr. Stratas that the Board approve the process recommended by the Office of EMS.

On July 20, 1991, the Board adopted a motion made by Dr. Roufail and seconded by Dr. Patterson that the Board of Medical Examiners approve Dr. Gallucci for licensure.

ELLIOTT, William Gavin, M.D. - Pittsburgh, PA-wl

On July 20, 1991, the Board adopted a motion made by Dr. Patterson and seconded by Dr. Roufail that the Board of Medical Examiners approve Dr. Elliott for licensure.

WARD, John Thomas, M.D. - Hillsboro, OH-wl

On July 20, 1991, the Board adopted a motion made by Dr. Roufail and seconded by Dr. Patterson that the Board of Medical Examiners approve Dr. Ward for licensure upon receipt of the letter Dr. Ward's attorney wrote him instructing him to answer certain questions on the application.

MEMULA, Narayana, M.D. - Germantown, TN-wl
