

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Atlantic Beach Hotel, Morehead City, North Carolina
July 30 - August 1st, 1947

The Board of Medical Examiners of the State of North Carolina met at the Atlantic Beach Hotel, Morehead City, North Carolina, July 31st, 1947, for consideration of licensure by endorsement of credentials and on August 1st, 1947, for the purpose of reviewing the grades of examinees at the written examination on June 23-26, 1947, and other business.

On Thursday, July 31st, 1947, at 10 A. M., the meeting was called to order by Dr. Paul G. Parker, President. Drs. Charles W. Armstrong, M. D. Bonner, Thomas Leslie Lee, R. B. McKnight, Malory A. Pittman, and Ivan Procter, Secretary-Treasurer, were present.

The agenda for the meeting was discussed and credentials of applicants for reciprocity were studied by the members of the board.

Dr. G. P. Dillard, Sr. of Draper, N. C., appeared with his son, Dr. G. P. Dillard, Jr., who is a graduate of Chicago Medical School, requesting local, limited license by the Board of Medical Examiners of the State of North Carolina, the limit on the license to expire as soon as the Chicago Medical School has qualified before the Council on Medical Education of the American Medical Association. At that time it is proposed that young Dr. Dillard will re-enter the school and graduate from a grade A medical school.

The meeting was adjourned.

The board convened at 10 A. M. Friday, August 1st, 1947, at 10 A. M. The meeting was called to order by the president and all members were present.

The matter of request for duplicate license by Dr. J. W. Foster was considered. Dr. Foster requested duplicate license due to the fact that the original was stored in a lock box in a distant city and it would entail considerable inconvenience to procure the same. The board instructed the secretary not to issue a duplicate license while the original was in existence.



The matter of Dr. Thomas L. Gore seeking licensure in the State of Tennessee from the State of North Carolina was considered by the board. Dr. Gore was granted license to practice medicine in the State of North Carolina on July 11th, 1921, by reciprocity with the U. S. Army. Dr. Gore was advised by the Tennessee Board of Medical Examiners that it could not issue a license unless a statement was procured from the North Carolina Board that his examinations before that board were satisfactory in the basic sciences. The secretary interviewed Dr. K. P. B. Bonner, Secretary of the North Carolina Board of Medical Examiners in 1921, who stated that license was granted to Dr. Gore upon the basis of his having presented to the board at that time complete and satisfactory evidence that he had adequate study and experience, as well as knowledge of all the basic sciences, to permit the granting of a North Carolina license to practice medicine. The board instructed the secretary to so advise the Tennessee Board of Medical Examiners.

Dr. Paul G. Parker reported that Dr. Wiley Royster Young had not reported to him as was instructed by the board at its June, 1947 meeting.

The secretary presented to the board the matter of conviction and parole of Dr. M. F. Whichard. Extenuating circumstances which seemed to surround the crime committed, the incarceration in the State's prison followed by early parole, and now the retirement of Dr. Whichard, were all taken into consideration. There was no action taken by the board.

The secretary read the report from the Council on Medical Education of the American Medical Association relative to the standardization of foreign medical schools. (See file)

Dr. R. B. McKnight moved that the next meeting of the Board of Medical Examiners be held at the Grove Park Inn, Asheville, N. C., the month of October, 1947. This motion was duly seconded and passed unanimously. Dr. McKnight was instructed to make the arrangements.

The minutes of the meeting of the board for June 22-26, 1947, were approved as read.

The Board of Medical Examiners reviewed all grades and the following physicians were granted license:


