

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 12 - 16th, 1966

- - - -

The Board of Medical Examiners of the State of North Carolina met at the Sir Walter Hotel, Raleigh, North Carolina, for the purpose of giving the annual written examination, interviewing applicants for license by endorsement of credentials and special limited license, and other business.

Sunday, June 12th
3:00 P. M.

The Board convened for business and Drs. Clark Rodman, President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, Frank Edmondson, H. Lee Large, Jr., W. Boyd Owen, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present. Dr. Ralph G. Templeton was absent from the meeting because of illness.

The following physicians appeared to petition for the privilege of taking the written examination:

RE: Dr. Assad Meymandi-Nejad, graduate of George Washington University School of Medicine, who is on immigrant status, appeared and presented his immigrant card. Photograph favorably compared with that on his card. He received residency training at Dorothea Dix Hospital and stated that he planned to go to the Cumberland Health Clinic, Fayetteville, upon completion of his training July 1st, 1966. He stated that he would have duties in connection with Dorothea Dix Hospital and the medical schools in Wake, Durham, and Orange Counties. His credentials are in order.

VERDICT: Dr. Assad Meymandi-Nejad was approved for the written examination and his license to be limited to Cumberland, Wake, Orange, and Durham Counties, North Carolina, until citizenship obtained within six years.

RE: Dr. James Tsung-tsun Chen was approved to take the written examination on May 2nd, 1966, provided he received his immigration card. He appeared at this time and presented letter from the Immigration Service stating that processing of application for Dr. Chen for permanent residence was complete except for routine report from the American Embassy in Taiwan.

Dr. Davis: Will it require an act of Congress to get immigration card?

A. No, I have passed all that. The second step is permanent residence to get the green card. They told me I have no problem, is a matter of processing.

Dr. Edmondson: When are you going to get it?

A. Do not know, anytime I guess.

Dr. Davis: This would be the first definite act, when you get the green card? A. Yes

Q. So far you do not know what is going to happen until you get the green card?

A. I am certain now because they told me I just wait for this green card to come and they won't force me out or anything. They agreed I had permanent status. As soon as I get the green card I will start to apply. I have no doubt I am going to get it as soon as I get the green card.

Q. If you wait until you get the green card and then take the examination, how will that effect you?

A. I am holding a staff position and my work will have something to do with clinical examinations.

Q. You are not doing it now?

A. No, nothing to do with patients now. I like to be involved with clinical work.

Q. You have no date in mind when you will get the green card?

A. According to the letter it sounds soon.

Dr. Combs: They first requested it back in February, that is not pretty soon.

A. It is the American Embassy. If you would let me take this examination so I could save one year's time and should I pass, hold the certificate until I get the green card to satisfy your requirement. If I wait and get the card, I will have to wait a year and will have to do only research.



Dr. Chen continued

Dr. Davis: Do you think you are prepared to take the examination? A. Yes sir

Q. How long were you in Richmond with Dr. Lester? A. One year

Q. Where were you before then?

A. University of Pennsylvania one year, seven months, went back to Taiwan, came back there for two years residency and fellowship.

Dr. Combs: What type of visa on your first visit? A. Exchange visa

Q. What did you come back on? A. Exchange visa

Q. What is your present status? A. Permanent visa

Q. Do you have anything to show that? A. It is changing.

Q. You are on an exchange visa now?

A. No more exchange visa I will not have any card until the green card.

Dr. Davis: Where is your passport?

A. Back home

VERDICT: Dr. James E. Davis moved that Dr. James Tsun-tsun Chen be granted permission to take the written examination; that grades not be put in the record until such time as immigrant card be received; that if this does not come in this next year, that his paper be destroyed. This motion was duly seconded by Dr. W. Boyd Owen and it was passed by a vote of five. Dr. Joseph J. Combs abstained from voting.

RE: Dr. Joyce Maclean Williamson, graduate of the University of Edinburgh, Scotland, in 1958, appeared petitioning for the privilege of taking the written examination. She is an American citizen. She had residency training at Charlotte Memorial Hospital.

Dr. Rodman: You have maintained your United States citizenship? A. Yes

Dr. Davis: What is your interest in this state?

A. I have relatives here. That is why I came to Charlotte Memorial Hospital.

Q. When will you finish your training?

A. At the end of this month. I am then going home to Scotland, then return in one year.

Dr. Edmondson: Have you plans as to North Carolina?

A. Nothing definite as yet, probably around Charlotte.

Q. Do you have any state license? A. Massachusetts

VERDICT: Dr. Joseph J. Combs moved that Dr. Joyce Maclean Williamson be granted the privilege of taking the written examination. This motion was duly seconded by Dr. H. Lee Large and passed unanimously.

RE: Office Space and Equipment - The secretary advised the Board that the office had been in need of extra space and the same had become available next door to the present office (216 square feet). The Board was also advised that certain equipment would be necessary to furnish this office space.

VERDICT: Dr. H. Lee Large, Jr. moved that the Board of Medical Examiners obtain the available office space. This motion was duly seconded and passed unanimously.

VERDICT: Dr. H. Lee Large, Jr. moved that the secretary be authorized to make necessary expenditures for office equipment. This motion was duly seconded and passed unanimously.

RE: Written Examination - The secretary advised that the following applicants for Part I of the examination had conditioned certain subjects, which they were to make up prior to entering the junior class in September:

VERDICT: Dr. H. Lee Large, Jr. moved that the above applicants be permitted to take the examination and that their grades be withheld until they satisfactorily complete the sophomore year. This motion was duly seconded and passed unanimously.

The following have applied for conversion of limited to full license:

RE: Dr. Lewis Elisha Barbee, who has completed one year of residency training at Kate B. Reynolds Hospital stated that he planned to practice full-time at that hospital. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Lewis Elisha Barbee be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. George Weston Doss, who has completed his training in Psychiatry at the University of North Carolina School of Medicine, stated that he planned to go on the staff at Highland Hospital, Asheville. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. George Weston Doss be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Allen Edward Grippo, who has completed his training in Psychiatry at Dorothea Dix Hospital, stated that he planned to work part-time at the Tideland Mental Health Center and private practice. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Allen Edward Grippo be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Richard Janeway, who has completed his training in Neurology, stated that he had joined the staff of Bowman Gray School of Medicine. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Richard Janeway be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Walter Carroll Ray, who has completed his training in Obstetrics-Gynecology, stated that he planned to practice in Greensboro. He has not met all the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Walter Carroll Ray be approved for conversion of limited to full license upon meeting all requirements of the Board of Medical Examiners. This motion was duly seconded and passed unanimously.

RE: Dr. Brunson M. Salley, Jr., who has completed his training in General Practice, has applied for conversion to full license, but has not made the final decision as to location. He has met all the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Brunson M. Salley, Jr. be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Ben Sullivan Tatum completed his training in Obstetrics-Gynecology in 1964, since which time he has been in military service. He has applied for conversion of limited to full license and stated that he planned to move to Laurinburg in July, 1966. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Ben Sullivan Tatum be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Julian Luke Davis Weaver, who has completed his training, has applied for conversion to full license and stated that he will locate in Thomasville to do General Practice. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Julian Luke Davis Weaver be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Margaret Jane Willhide, who has completed training in Pediatrics, has applied for conversion to full license and stated that she planned to enter practice in Stateville. She has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Margaret Jane Willhide be approved for conversion of limited to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Ian Clarke Wilson was granted limited license in June, 1959, until citizenship obtained. He has presented evidence of citizenship, certificate number 8854736, dated November 17th, 1965.

VERDICT: Dr. James E. Davis moved that Dr. Ian Clarke Wilson's application for conversion be approved. This motion was duly seconded and passed unanimously.

RE: Dr. Angus Sinclair Dunn was granted license limited to Gaston, Mecklenberg and Lincoln Counties in 1965, until citizenship obtained. He has petitioned that his limitation be extended in order that he might move to Lenoir to begin practice due to economic conditions. On May 30th Dr. Verne H. Blackwelder wrote that the community of Lenoir was greatly in need of assistance at this time due to a shortage of physicians. The secretary on June 7th extended the limitation of Dr. Dunn's license to Caldwell County.

VERDICT: Dr. James E. Davis moved that the action of the secretary in extending limitation of the license of Dr. Angus Sinclair Dunn to Caldwell County be approved. This motion was duly seconded and passed unanimously.

RE: Dr. James Kenneth Fancher, Atlanta, Georgia - In June, 1949, Dr. Fancher was granted license limited to Jackson County, where he had a summer home. The secretary presented letter from Dr. Fancher stating that he was building a permanent home in Montreat; that he had no desire to practice except in Atlanta, but that he desired license to the area in which Montreat is located. This is to be considered at the July, 1966 meeting.

RE: Written Examination - The Board discussed the critical condition of Dr. Ralph G. Templeton, who sent in his examination questions. The secretary was instructed to contact Dr. Thomas W. Baker with regard to grading the examination papers. He immediately called Dr. Baker and he agreed to assist the Board.

VERDICT: Dr. W. Boyd Owen moved that Dr. Thomas W. Baker be paid \$400.00 for grading the examination papers. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

Dr. James E. Davis moved that Dr. Ralph G. Templeton be paid \$100.00 for preparation of the written examination questions. This motion was duly seconded and passed unanimously.

RE: PHOTOGRAPH - The secretary was directed to the Board to make arrangements for a composite photograph of the Board.

RE: Dr. James Valentine Thomas - To summarize Dr. Thomas' license to practice medicine was revoked October 11th, 1963. After an illness he spent six months at the Bethel Colony endeavoring to rehabilitate himself and on January 14th, 1966 he appealed to the Board to assist him getting back into medicine. He seemed to be doing well and the Board reached the following decision: That he be granted special limited license to Cherry Hospital, to be renewed in six months on confirmation from Dr. M. M. Vitols, Director, that he had a job there.

On May 16th, 1966 Dr. Vitols advised that Dr. Thomas had been requested to resign from his position at Cherry Hospital due to alcoholism. He stated that he was sent to a private institution in April of this year and returned to work on May 2nd; that he had been admitted to Dorothea Dix Hospital for a second episode. Records at Dorothea Dix Hospital revealed that he was admitted there for alcoholism on a voluntary commitment May 16th, 1966; that he would be discharged 28 days after admission.

VERDICT: Dr. H. Lee Large, Jr. moved that the report on Dr. James Valentine Thomas be received as information.

RE: Dr. Bennie Brooks Ward - The secretary presented report from Dr. Robert N. Harper, Psychiatrist, that during the past three months he had seen Dr. Ward for regularly scheduled psychotherapy; that he had complete co-operation and all seemed to be well.

VERDICT: Dr. Joseph J. Combs moved that this be received as information. This motion was duly seconded and passed unanimously.



RE: Written Examination - It was ruled that the grades on the written examination be in the office of the secretary not later than July 11th.

RE: License by Endorsement of Credentials for Physicians in Residency Training - It has been the policy of the Board to grant license by endorsement limited to medical school when a physician came in to this state for training and upon completion of training, if he remained in the state license to be converted to full license.

The Board has reviewed this policy and the following motion was made:

Dr. H. Lee Large, Jr. moved that a candidate seeking license by endorsement of credentials in order to do a residency in an approved residency training program in North Carolina be given the privilege of petitioning for either limited or full license. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Dr. Manuel E. Abella, graduate of the University of Havana in 1953 - The secretary presented application for special limited license from Dr. Abella to accept a position at the Caswell Center, a state institution, where there is only one physician on the staff with four vacancies. The superintendent of the institution has made a plea for his services.

VERDICT: Dr. James E. Davis moved that the secretary be instructed that Dr. Manuel E. Abella be permitted to begin work on July 1st, 1966, and appear at the next meeting thereafter. This motion was duly seconded and passed unanimously.

The meeting was adjourned.

Monday, June 13th
8:30 A. M.

Registration of applicants for Part I and Parts I and II of the written examination, following which the examination was begun.

The members of the Board reviewed credentials for license by endorsement of credentials and special limited license.

RE: Dr. Carl Casper Warren - (See previous Minutes) - He appeared at the request of the Board for an interview. He advised he had completed his residency training and had been in the Department of Anesthesiology at Mercy Hospital, Charlotte, since February; that he had been doing well; that he had an attack of kidney colic in November, 1965, was given narcotics and had no trouble. He asked about his narcotic tax stamp.

VERDICT: Dr. Joseph J. Combs moved that the president be instructed to advise Dr. Casper Carl Warren he would not be asked for further routine interviews. This motion was duly seconded and passed unanimously. He was so advised.

Dr. James E. Davis moved that the Board ask Dr. Casper Carl Warren to give it some thought as to obtaining narcotic tax stamp; that there must be some doubt in his mind, to give it six months to think it over, whether he is really capable of handling it. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed by a vote of four to two. He was so advised.

RE: Dr. J. R. Medlin - (See previous Minutes) - He came in for routine interview at the request of the Board. He said he was doing well in his practice and personally; that his psychiatrist had said he would see him one more time if he desired and that he had an appointment the next day. He asked the Board to think about his getting his narcotic tax stamp since it has been five and one-half years.

VERDICT: Dr. Frank Edmondson moved that Dr. J. R. Medlin be seen annually. This motion was duly ~~passed~~ ^{seconded}, unanimously.

Dr. W. Boyd Owen moved that the Board of Medical Examiners not recommend reinstatement of his narcotic tax stamp. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously. He was asked to have report of his psychiatrist sent to the office of the secretary.



RE: Dr. Franklin S. Kincheloe, Jr. - (See previous Minutes) - Dr. Kincheloe was requested to appear for a routine interview. He stated that he had not had any problems; that he had not used any soporofics or barbiturates personally; that he had no trouble personally with narcotics or alcohol; that his practice was going well and that he would have no difficulty in staying out of the same type of trouble he had been in before.

VERDICT: That Dr. Frank Edmondson moved that Dr. Franklin S. Kincheloe, Jr. be seen routinely in one year; that he be told he would continue under surveillance. This motion was duly seconded and passed unanimously.

The meeting was adjourned.

June 13th - 2:30 P. M.

RE: Dr. William Murphy Bethune, Jr. - (See previous Minutes) - Dr. Bethune appeared for a routine interview. He related that he was doing well in his private practice; that he was assisting the surgeons at the State Prison and had contracted to cover the emergency room every other night and every other week-end; that he was seeing his psychiatrist regularly and that he would continue to do so. A satisfactory report was received from his psychiatrist.

The Board of Medical Examiners commended Dr. Bethune.

RE: Dr. Allan H. Lee, Selma, North Carolina - Pursuant to report from the State Bureau of Investigation alleging that Dr. Lee had prescribed drugs excessively to patients and his wife, who was said to be addicted, Dr. Lee was requested to appear before the Board.

Dr. Lee admitted that he was taking demerol following an illness; that he was treated at Duke in February, 1965, and had taken no drugs since that time. He stated that he had given demerol to his wife over a period of years and presented record which revealed that he had prescribed the same excessively. He stated that he does not have any demerol on hand at this time. Dr. D. H. Jones, Jr. of Princeton came in on behalf of Dr. Lee and stated he and Dr. Wayne H. Stokedale had intervened and sent him to Duke and that there had been no indication he was taking drugs since that time; that he was interested in him practicing in that area as his services were needed. Dr. Stokedale also appeared in his behalf.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Allen H. Lee be requested to voluntarily surrender his narcotic tax stamp, order forms and any supplies on hand to the Federal narcotic agent and explain to him that he could not get it back when he wanted it without the recommendation of the Board of Medical Examiners. This motion was duly seconded and passed unanimously. Dr. Lee was so advised by the president.

RE: Dr. Alton Lane Bullard - To summarize, his license was revoked in January, 1963, reinstated in January, 1964, and voluntarily surrendered, at the request of the Board in June, 1965. Dr. Bullard appeared at this time and stated he wanted to know if there were any manner in which he might get back into medicine. He said he had not had any difficulty since July, 1965, when discharged from John Umstead Hospital; that he had been clerking in a motel.

VERDICT: Dr. W. Boyd Owen moved that Dr. Alton Lane Bullard not be granted license to practice medicine at the the present time. This motion was duly seconded and passed unanimously. Dr. Bullard was so advised by the president.

RE: Dr. Thomas O. Wheless - The Board requested routine interview since he had surrendered his narcotic tax stamp March, 1966, due to the fact that he had again started taking drugs. He stated that no treatment was required; that he was getting along as well as could be expected.

RE: Dr. James B. Wheless appeared for routine interview at the request of the Board. To summarize, he voluntarily surrendered narcotic tax stamp on account of personal use of narcotics in July, 1963. In May, 1965, the Board approved his petition for reinstatement of narcotic tax stamp. Dr. Wheless stated he was doing well and no adverse reports have been received. He was commended by the Board.

The meeting was adjourned.

RE: Dr. Gerson Asrael appeared applying for license by endorsement of credentials and stated that he planned to go with the Nalle Clinic, Charlotte. He is on active duty, military.

Dr. Rodman: When do you plan to start work?

A. I start the first week in July.

Dr. Combs: It is your intention to locate in Charlotte permanently?

A. Yes

Dr. Rodman: What have you done since 1959?

A. Interned and one year General Surgery in Chicago, Houston Urological training. Since January, 1964, I have been at the Naval Hospital, Bethesda.

A. July 1st

Q. Have you ever had any difficulty with any examining board in medicine? A. No sir

Q. Have you ever been convicted of a crime? A. No sir

VERDICT: Dr. Gerson Asrael was approved for license by endorsement of credentials.

A. Interned at Jefferson Davis Hospital, Houston and the Air Force since.

Dr. Owen: Will you be associated?

A. Yes sir, with Dr. Joseph Kahn.

Dr. Rodman: Have you ever been convicted of a crime? A. No

Q. Have you ever used narcotics? A. No sir

Q. Have you ever used barbiturates or alcohol to excess? A. No sir

Q. Have you ever had any difficulty with any examining board? A. No sir

VERDICT: Dr. Edgar Davis Baker was approved for license by endorsement of credentials.

RE: Dr. Harold Dean Belk appeared applying for license by endorsement of credentials and stated that he planned to do Occupational Medicine with Western Electric Company.

Dr. Rodman: How are you doing physically?

A. Fine

Q. What have you done from 1960 to the present?

A. After finishing medical school I interned one year, 1961 Greenville, South Carolina. Because draft status was not clear I obtained civil service appointment with the Air Force in Greenville, worked in Pediatrics 18 months. During this period I decided to do a residency in Occupational Medicine, which was done at Ohio State. I was research assistant three months, began residency July, 1963, for two years. The third year was in-plant training with Western Electric.

Q. Have you ever been convicted of a crime? A. No

Q. Have you ever used barbiturates or alcohol to excess? A. No

Q. Have you ever had any difficulty with any examining board in medicine? A. No

Q. Have you ever used narcotics? A. No

Q. Are you to go to work July 1st? A. Yes

Dr. Large: Where will you be?

A. Winston-Salem

VERDICT: Dr. Harold Dean Belk was approved for license by endorsement of credentials.



RE: Dr. Eugene Borack appeared with incomplete credentials applying for license limited to Wake County Memorial Hospital. He is on active military duty stationed in Raleigh.

Dr. Rodman: What are your plans?

A. To work at Wake County Memorial Hospital.

Q. How much longer will you be in service?

A. One year from this September, 15 months.

Q. Dr. Borack has permission from his commanding officer to cover the Medical Clinic at the Wake County Memorial Hospital on off duty hours, out-patient.

Are your off duty hours at night mainly?

A. Late afternoon 4 - 6

Q. Have you ever been convicted of a crime? A. No sir

Q. Have you ever been addicted to the use of narcotics? A. No sir

Q. Have you ever used barbiturates or alcohol to excess? A. No sir


