

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 15 - 18th, 1964

- - - - -

The Board of Medical Examiners of the State of North Carolina met at the Sir Walter Hotel, Raleigh, North Carolina, for the purpose of giving the annual written examination, interviewing applicants for license by endorsement of credentials and special limited license and other business.

Sunday, June 14th
3:00 P. M.

The Board convened for business and Drs. Ralph G. Templeton, President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, Frank Edmondson, H. Lee Large, Jr., W. Boyd Owen, Clark Rodman, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present.

RE: Students from the University of North Carolina School of Medicine - Written Examination - The secretary presented letter from Dr. W. R. Berryhill, Dean of the University of North Carolina School of Medicine, stating that the following students would have to complete additional work in Pharmacology before they could be promoted to the third year:

Daniel Malloy Calhoun, Jr.
George Wheeler Cox
John Wilder Southard
Elizabeth Harrison Spiver

Dr. Berryhill recommended that the above students be allowed to take Part I of the written examination due to the fact that the subject in which they were deficient was not included in Part I of the state board examinations.

VERDICT: Dr. Frank Edmondson moved that the above listed students be allowed to take Part I of the examination and that their grades be withheld until notified by the medical school that they had satisfactorily completed the required work to begin the junior year. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Dr. Henry Remy, graduate of the Greater National University of San Marcos, Peru, South America - Dr. Remy appeared applying for the privilege of taking the written examination for licensure.

Dr. Combs: What are your plans as to North Carolina?

A. Dr. McGuffin, plan to go to work with him as soon as possible, I told him to write you a letter. He was on vacation.

Dr. Combs: Where did you first contact me from?

A. Franklin, Dr. Angel gave me an offer, which I wrote him back I wanted to work with Dr. McGuffin in Asheville.



Dr. Remy continued

Dr. Combs: You talked to me from Franklin and told me you wanted to go to Franklin.

A. No, I asked you for the requirements. I wrote Dr. Angel I turned down the offer and I wanted to go to work with Dr. McGuffin.

Q. Did you tell Dr. McGuffin that you had been in conference with and been offered a position by Dr. Angel?

A. No, I have not.

Q. I told him when he called me.

A. I do not if I brought the letter. I wrote Dr. Angel I had an offer in Asheville and wanted to work with him.

Q. Suppose you get an offer in Atlanta, you won't need a North Carolina license.

A. No sir

Q. How long have you been at Milledgeville?

A. Two years

Q. Why do you want to leave there?

A. - - -

Q. Did you express to Dr. McGuffin because there were so many Cubans there?

A. One thing I am not putting in the time doing Pediatrics I want to.

Q. When did you take the examination in Virginia?

A. In December, 1963

Q. Have you worked in Virginia at all?

A. I have not.

Q. Why?

A. Because I was more interested in this offer?

Q. You have not looked in Virginia?

A. I do not intend to either. I have definite plans to work with Dr. McGuffin.

Q. What degree did you get from your medical school ?

A. Doctor in Medicine and Surgery

Dr. Templeton: Have you signed a contract?

A. No sir, he said he wanted to put me on a salary, but wanted to clear up my situation with the Board.

Q. Have you obtained a home?

A. Dr. McGuffin was supposed to get me an apartment.

Q. When was the last time you talked to Dr. McGuffin?

A. The 10th of this month when he got back on vacation.

Dr. Combs: We have no letter from Dr. McGuffin.

A. He said he talked to you and I said to write a letter.

Q. You did not tell him about the other.

A. I did not think it necessary, I had turned it down.

Dr. Edmondson: What are you doing where you are?

A. Psychiatric work and Pediatric work. That is not a place for Pediatrics, it is retarded children essentially Psychiatric. There is a prison close to it. Some of the inmates have babies. Some-



Dr. Remy continued

Dr. Remy: Sometimes they call me for Cesarean sections or new borns or prematures.

Dr. Combs: What would you do with Dr. McGuffin?

A. Pediatrics essentially; that is one of the reasons I want to leave Milledgeville.

Dr. Combs: Are these photostatic copies?

A. They are originals.

Q. Whatever you present us, we keep for our records.

A. That is all right.

Q. Does your school not give M. D., it says Doctor of Surgery?

A. That is the translation, Doctor in Medicine and Surgery.

Q. Do you hold the M. D. Degree?

A. Yes sir

Dr. Remy presented naturalization paper #8485645 dated January 30th, 1964.

Dr. Combs: You say you have been in contact with him after his return June 10th?

A. Yes, to remind him to write you. He promised me he would write the letter. I am surprised he has not.

VERDICT: Dr. W. Boyd Owen moved that Dr. Henry Remy be allowed to take the written examination, provided Dr. W. C. McGuffin advise that he has made a definite committment to Dr. Remy to practice medicine with him. This motion was duly seconded by Dr. Clark Rodman and passed unan-
imously. (See p. 115 these minutes)

RE: William Arthur Busse appeared petitioning for the privilege of taking Part II of the written examination. He presented letter from Dr. Robert L. Tuttle, Associate Dean of the Bowman Gray School of Medicine advising that Dr. Tuttle had encountered some academic difficulty, which work he would make up this summer, to be completed August 4th, 1964; that the school had allowed him to graduate but that he turned his degree in until this work is completed.

The Board discussed this problem in detail with Mr. Busse and after discussion in executive session arrived at the following verdict: Dr. H. Lee Large, Jr. moved that William Arthur Busse be advised the requirement of the Medical Practice Act that the applicant must hold the M. D. degree and urge him to come back next year. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Written Examination - Dr. J. J. Combs moved that the grades for the examintions be in the office of the secretary by July 13th, 1964. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously

RE: United States Public Health Service Hospital, Lexington, Kentucky - Dr. H. Lee Large, Jr. reported on his trip to this hospital where he went for information as to treatment of narcotic addicts. He recommended that periodically a member of this Board go there.

VERDICT: Dr. Frank Edmondson moved that the secretary be directed to write a letter of appreciation to the medical director and to advise that the Board of Medical Examiners stands ready to co-operate in any way. This motion was duly seconded and passed unanimously.

RE: Written Examination 1965 - Dr. J. J. Combs moved that the Board convene June 13th, 1965, and hold the written examinations June 14-17th, 1965. This motion was duly seconded and passed unanimously.

RE: Dr. Adolphus Bray - See Minutes January, 1964 - Dr. Bray holds a special limited license to Bowman Gray School of Medicine, where he is a resident in Psychiatry. The secretary presented letter from Dr. Richard C. Proctor, Chairman of the Department of Psychiatry, stating that Dr. Bray remains on the resident staff and has been reappointed in the same capacity for next year; that his work is considered good and his health remains good. This was received as information.

RE: Dr. Carl Casper Warren - See Minutes May, 1964 - The secretary presented report from the medical director at St. Albans Hospital, which report had been requested prior to Dr. Warren's appearance in May, 1964. This was accepted as information and will become a part of his record.

RE: Dr. Preston C. Stringfield, Jr. - The secretary presented report from the Veterans Administration Hospital, Salisbury, where Dr. Stringfield was a patient, that he had accepted employment at the Cherry Hospital, Goldsboro, as of June 1st, 1964. This was received as information.

RE: Dr. A. E. Perry - See previous Minutes - The secretary presented newspaper report that Dr. Perry had been charged with abortion by Charlotte police.

VERDICT: Dr. James E. Davis moved that this be received as information and await possible action by the court before instituting any action. This motion was duly seconded and passed unanimously.

RE: Dr. Edward E. Low, staff physician at Broughton Hospital, who has not taken the written examination for license, has been unable to obtain immigrant status. In October, 1963 Dr. Low's special limited license was renewed until such time as he could take the 1964 written examination and the results determined and he was so advised; also that he would be required to have immigrant status before he would be eligible to take the examination and if this was not accomplished by the time for the examination in June, 1964, it would be necessary that his service at Broughton Hospital be terminated.

The secretary reported that he has received a letter from Senator Sam J. Ervin, Jr. that he has been unable to obtain immigrant status for Dr. Low, which letter was presented to the Board at the May, 1964 meeting. Since that time the secretary has received other letters from interested persons in Morganton with regard to Dr. Low at Broughton Hospital. There has been no further appeal from Dr. Low or the Broughton Hospital.

VERDICT: Dr. H. Lee Large, Jr. moved that the situation with regard to Dr. Edward E. Low has not been changed since its previous action and, therefore, the Board feels such previous action should not be changed. This motion was duly seconded by Dr. James E. Davis and passed unanimously.



APPLICANTS FOR CONVERSION OF LIMITED TO FULL LICENSE

RE: Dr. Ronald Anthony Pruitt was granted license to cover him as a resident limited to Duke University School of Medicine in January, 1961. He has now completed his residency and plans to locate with the Kernodle Clinic July 1st, 1964. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that Dr. Ronald Anthony Pruitt be approved for conversion from limited to full license. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.

RE: Dr. Richard Dean Tester was granted license to cover him as a resident, limited to Duke University School of Medicine, in July, 1961. He has now completed his residency and plans to practice Radiology in High Point, to be associated with Dr. C. L. Gray at High Point Memorial Hospital, beginning July 1st, 1964.

VERDICT: Dr. James E. Davis moved that Dr. Richard Dean Tester be approved for conversion from limited to full license. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.

RE: Dr. John Morris Wallace was granted license to cover him as a resident, limited to Charlotte Memorial Hospital, in July, 1961. He has now completed his residency and has accepted the position as pathologist at the Stanly County Hospital, Albemarle, as of July 1st, 1964.

VERDICT: Dr. James E. Davis moved that Dr. John Morris Wallace be approved for conversion from limited to full license. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.

Physicians who have obtained citizenship:

RE: Dr. Roy V. Berry was granted license limited to the State Institutions until citizenship obtained. He has furnished evidence of having obtained Naturalization Certificate No. 855574 on June 5th, 1964.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Roy V. Berry's limited license be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Robert Hickman Cole was granted license limited to Mecklenburg County, North Carolina until citizenship obtained. He has furnished evidence of having obtained Naturalization Certificate No. 8492116 on April 10th, 1964.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Robert Hickman Cole's limited license be converted to full license. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.

RE: Dr. John Brian Reckless was granted license limited to Duke University School of Medicine until citizenship obtained. He has furnished evidence of having obtained Naturalization Certificate Number 9555779 on June 5th, 1964.

VERDICT: Dr. J. J. Combs moved that Dr. John Brian Reckless' limited license be converted to full license. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.

RE: Dr. John Anthony Rozsfalvi was granted license limited to Cherry Hospital until citizenship obtained. He has furnished evidence of having obtained Naturalization Certificate Number 8661562 on May 13th 1964.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. John Anthony Rozsfalvi's limited license be converted to full license. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.



RE: Electric Seal - The secretary reported that he had purchased a seal of the Board of Medical Examiners operated electrically, for the price of \$106.09, which action the Board approved.

RE: Dr. Lytle John Powell was approved for license by endorsement in May, 1963, contingent upon locating in the state for practice, within one year. He has not yet made plans to come into the state.

VERDICT: Dr. H. Lee Large moved that Dr./John Powell be refunded fee for license by endorsement, less 50%. This motion was duly seconded by Dr. Joseph J. Combs and passed unanimously.

RE: Dr. Charles Wright MacMillan was approved for license by endorsement of credentials in May, 1963, contingent upon locating in the state for practice, within one year. He has not yet made plans to come into the state.

VERDICT: Dr. H. Lee Large moved that Dr. Charles Wright MacMillan be refunded fee for license by endorsement, less 50%. This motion was duly seconded by Dr. Joseph J. Combs and passed unanimously.

RE: Dr. William C. Rhangos, who held special limited license to Duke University School of Medicine and who has been at The Shriners Hospital for Crippled Children, Greenville, South Carolina, has advised that he will return to Duke Hospital to continue his training on July 1st, 1964, and requested renewal of his special limited license.

VERDICT: Dr. James E. Davis moved that the special limited license of Dr. William C. Rhangos be renewed on an annual basis. This motion was duly seconded and passed unanimously.

The Board, with its attorney, Mr. John H. Anderson, Jr., discussed the questionnaire propounded by the general counsel of the American Medical Association with regard to a model medical practice act.

VERDICT: Dr. W. Boyd Owen moved that the legal counsel send an answer to the questionnaire of the legal counsel of the American Medical Association and sign the same. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.

The meeting was adjourned.



June 15th

8:30 A. M. - Registration of applicants for Part I and Parts I and II of the written examination.

RE: Dr. Henry Remy (See pp. 103-107 of these Minutes) - Dr. Ralph G. Templeton advised he had talked with Dr. W. C. McGuffin, who informed him he was financing Dr. Remy's trip here; that he had no contract, but that if he passed the examinations given by the Board of Medical Examiners, he would give him a two months' trial; that he was not too much interested after he learned he had gone to see Dr. Ed Angel.

VERDICT: Dr. Clark Rodman moved that Dr. Henry Remy be allowed to take the written examination. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.

The members of the Board of Medical Examiners checked credentials for license by endorsement of credentials and special limited license.

The meeting was adjourned.

June 15th

2:30 P. M.

RE: Dr. Gilbert B. Davis - Charges and Accusations were served upon Dr. Davis and upon his guardian, Waccamaw Bank and Trust Company, and notice was given that a hearing would be held at 2:30 P. M., June 15th 1964, at the Sir Walter Hotel, Raleigh, North Carolina.

At the appointed time, 2:30 P. M. and thereafter, Dr. Gilbert B. Davis, nor anyone representing Dr. Davis, appeared. Attorney John H. Anderson, Jr. represented the Board.

The Charges and Accusations were read as follows:

"That by order of the Clerk of the Superior Court of Robeson County, North Carolina dated November 19, 1963, Gilbert B. Davis, M. D. was adjudged and found to be an incompetent person, and the Waccamaw Bank and Trust Company was appointed guardian of said Gilbert B. Davis, M. D.

"2. That by reason of his mental condition Gilbert B. Davis, M. D. is not now capable of practicing medicine with safety.

"3. That by reason of the foregoing grounds exist for the revocation or suspension of the license to practice medicine heretofore issued to said Gilbert B. Davis, M. D. by this Board."

Evidence was introduced and made a part of the record as follows:

Exhibit A: Certificate of Incompetency by the Director of the Veterans' Administration Hospital dated October 25th, 1963

Exhibit B: Order of the Clerk of Superior Court of Robeson County, North Carolina, appointing The Waccamaw Bank and Trust Company as guardian for Dr. Gilbert B. Davis on the basis of being an incompetent.

Thereupon, the Board of Medical Examiners took the following action:

Charge #1. Dr. Joseph J. Combs moved that Dr. Gilbert B. Davis be found guilty. This motion was duly seconded by Dr. Frank Edmondson and the same was passed unanimously.

Dr. Gilbert B. Davis continued:

Charge #2. Dr. Frank Edmondson moved that Dr. Gilbert B. Davis be found guilty. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

VERDICT: Dr. James E. Davis moved that the license to practice medicine of Dr. Gilbert B. Davis be suspended. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Biennial Registration- Dr. Clark Rodman moved that this Board direct and order the reinstatement of the medical license of any physician whose license has been suspended on the grounds of failure to register, upon payment to the secretary of the fees and penalties required to be paid by law. This motion was duly seconded and passed unanimously.

RE: Dr. Thomas O. Wheless - (See previous Minutes) - Dr. Wheless surrendered his narcotic tax stamp in April, 1960 and appeared at this time to petition for recommendation of reinstatement of his narcotic tax stamp. He stated that he had taken no drugs in over four years.

VERDICT: Dr. James E. Davis moved that the Board of Medical Examiners recommend to the Narcotic Bureau that the narcotic tax stamp of Dr. Thomas O. Wheless be reinstated. This motion was duly seconded and passed unanimously.

RE: Dr. John Buren Crow - See p. 147-A

RE: Dr. Allison M. Alderman, Jr. - As a result of report by the State Bureau of Investigation alleging prescribing of barbiturates to an addict, Dr. Alderman was requested to appear. Dr. Alderman stated that he inherited this patient in 1951, who is an alcoholic and drug addict and has cirrhosis of the liver; that he has been treated time and time again in institutions; that no one can do anything for him; that he can hold him very well with barbiturates. He also advised that in 1961 he discussed this case with the State Bureau of Investigation.

VERDICT: Dr. James E. Davis moved that the Board of Medical Examiners convey to Dr. Allison M. Alderman its appreciation for his good work and that no disciplinary action is contemplated. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. Ann Fierro Wolfe applied to take the written examination in order that she might take a staff position at Murdoch Center. She was unable to take this examination due to illness. At this time Drs. S. O. Cornwell and Dorothy Blackwell Shearin appeared to petition that Dr. Wolfe be granted the privilege of going to Murdoch Center as a staff physician.

Dr. Davis: Does she want to work only at Butner?

Dr. Shearin: Yes sir, in Pediatrics.

Dr. Large: Full-time staff physician?

A. Yes sir, full-time staff Pediatrics.

Dr. Edmondson: How long does she contemplate being there?

A. The thought is five years.

Her husband plans four to five years at Duke and she plans to be at Murdoch Center during that time.

Q. Would all of it be at Murdoch?

A. Yes sir, they have participated in some work at Duke and the University of North Carolina. She will probably be down in August.

Dr. Ann Fierro Wolfe continued

Dr. Davis: Could this position be considered possible training in Pediatric Psychiatry? Would this position qualify as training even though getting a salary comparable to staff?

Dr. Cornwell: This could be explored that she might have some training.

Dr. Shearin: Our Pediatrics is 6 to 86. All the medical people are Pediatricians but we work with all ages. We have medical consultation.

Dr. Cornwell: She could work under supervision.

Dr. Davis: Does she have boards?

A. She is not eligible since she is just finishing residency.

VERDICT: Dr. James E. Davis moved that the advice be given that it is conceivable a special limited license might be granted Dr. Ann Fierro Wolfe contingent upon a satisfactory interview with the Board.

The Minutes of the May 3-5th, 1964 meeting were approved as read.

VERDICT: Dr. Glenn Wilson Bowers, Jr. was approved for license by endorsement of credentials.



RE: Dr. Paris Bransford appeared applying for license by endorsement of credentials limited to Kate B. Reynolds Hospital, where he will be a resident in Surgery.

Dr. Templeton: Have you ever had any difficulty with any examining board? A. No sir

VERDICT: Dr. James Brown was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary. (Credentials complete)

RE: Dr. George Franklin Brumback appeared applying for license by endorsement of credentials, limited to John Umstead Hospital and McPherson Hospitals. He said he would be discharged from the service July 1st, 1964; that he has a residency in January, 1965, in Ophthalmology at McPherson Hospital; that he would accept a staff position with John Umstead Hospital in the interim from discharge July 1st, 1964, and the beginning of his residency January, 1965.

A. I am going into the Army August 1st. I have to complete three more years of Neurology training.

Dr. Templeton: Have you ever had any difficulty with any medical examining board? A. No

Dr. Davis: Why are you requesting endorsement now?

A. I am going to be in service. If possible the last two weeks in July, I am going to cover a practice in the state.

Dr. Owen: Where do you plan to practice?

A. I do not know, either Charlotte or Greensboro.

VERDICT: Dr. Kenneth Lee Cloninger was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

This license is for one year and can be renewed by an application from you and letter of recommendation from your chief. No further appearance is required.

APPLICANTS FOR SPECIAL LIMITED LICENSE - Hospital Residents - Graduates Foreign Medical Schools

RE: Dr. Norman Cooper appeared with incomplete credentials applying for special limited license to Duke University School of Medicine, where he is a resident in Surgery. He is a graduate of the University of Zurich, Switzerland and an American citizen. Dr. Cooper was approved for special limited license contingent upon completion of credentials, satisfactory to the secretary.

RE: Dr. Marcia C. Ramirez appeared with incomplete credentials applying for special limited license to James Walker Memorial Hospital, where she is a resident in Medicine and Pediatrics. She is graduated by the University of St. Tomas, Philippines. Dr. Ramirez was approved for special limited license contingent upon completion of credentials satisfactory to the secretary.

Dr. Templeton: The special limited license is granted for one purpose only and that is for training. This does not give you the privilege of the use of narcotic tax stamp. This special limited license is renewable annually with letter of recommendation from your chief of service.

RE: Dr. John Buren Crow appeared at the request of the Board of Medical Examiners with reference to his narcotic addiction. He furnished letter from his physician, Dr. C. M. McMurray of Shelby, who stated that he was treated at the United States Public Health Service Hospital, Lexington, Kentucky, February 6-24th, 1964. Dr. McMurray said he voluntarily admitted his addiction to demerol January 2nd, 1964, at which time he was taking 30 cc of demerol; that withdrawal symptoms were minimal that he had been under medical care since returning from the hospital in Lexington; that he returned to work May 1st and since then has had no problem. Dr. Crow confirmed the information given by Dr. McMurray. He said he was seriously injured in an automobile accident in June, 1962, and developed complications; that he has been overworked and long hours for the past 10 years; that he contributed his trouble mainly to exhaustion. He said he felt he had his addiction under control.

Dr. Ralph G. Templeton, President, advised that the Board of Medical Examiners wanted to interview him to help him; that it would desire a progress report from his physician every six months; that he would probably be asked to appear before the Board at intervals.

RE: Dr. Grayson B. Waldrop, whose license to practice medicine in this state was revoked in January, 1964, appeared to petition for special limited license to cover him as a staff physician at Broughton Hospital, where he stated that he had a position if he could be covered by a license. He stated that he had been a residency in Psychiatry at the South Carolina State Hospital, but the hospital was coming up for approval and he could not remain there without having a license. He stated that he hoped to later continue his training in Psychiatry.

VERDICT: Dr. James E. Davis moved that Dr. Grayson B. Waldrop be granted special limited license to Broughton Hospital for a years. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.


