

MEETING OF THE BOARD OF MEDICAL EXAMINERS  
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 15- 19, 1958

- - - -

The Board of Medical Examiners of the State of North Carolina convened at 7 P. M. at the Sir Walter Hotel, Raleigh, North Carolina, Sunday, June 15th. The following members were present: Drs. Carl V. Tyner, President, Joseph J. Combs, Secretary-Treasurer, J. B. Anderson, Thomas W. Baker, L. R. Doffermire, Edwin A. R. sberry, Jr., Thomas G. Thurston, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer. The following were guests of the Board: Dr . and Mrs. John S. Rhodes, Dr. and Mrs. George W. Paschal and Mr. and Mrs. John H. Anderson, Jr.

The Board convened for interviews at 8:30 P. M.

RE: Dr. John David Earle Cowan, graduate of Dalhousie University, Canada, in 1951, appeared for the privilege of taking the written examination.

Dr. Combs: Do you have any plans as to coming to North Carolina?

A. The situation was I applied to several different people in practice in the south. I got replies that they had openings; that they would be glad to do business with me. I replied I did not have a state license. For instance, Shreveport, Louisiana, was one. I got a reply they had filled the position because they could not wait. They advised me to get a state license. In other words, you can not get a job without a license.

Dr. Combs: Why did you pick North Carolina?

A. I had to pick some state.

Q. Where were you born?

A. New York State. My parents are Canadians. They took me back when I was about seven years old.

Q. Where is your home?

A. Philadelphia.

Q. How long have you been living there?

A. 10 months

Q. You are a citizen by virtue of having been born here? A. Yes

Q. Your family was Canadian? A. Yes

Dr. Baker: Have you practiced here?

A. I did three years general practice in Newfoundland. My reason was to go to medical school and borrowed from the Government and they attached a condition that I do three years practice and pay them back, which I did.

Dr. Tyner: You do not have a license in the United States? A. No

Dr. Anderson: You had a residency?

A. Residency in Orthopedics.

Dr. Baker: Do you want to be affiliated with an institution or in solo practice?

A. I want to go in solo. I would like to be associated for a few years or in an institution.

Dr. Combs: You are going to take the best proposition whether institution or private practice? A. Yes

Dr. Anderson: You prefer orthopedics or general practice?

A. Orthopedics

Dr. Combs: Are you eligible for the Orthopedic Board?

A. I have taken Part I.

Q. To be certified in this country? A. Yes

Dr. Baker: When do you take the other part?

A. In two years. After I have been in practice two years.

Dr. Doffermyre: You have no connections in North Carolina?

A. No

Dr. Tyner: Are you married?

A. I have three children, the fourth on the way.

Dr. Doffermyre: Have you made application to take any other board?

A. No sir, I have not.

Dr. Combs; Have you ever taken any other board examination?

A. In Canada I took the Council.

Dr. Anderson: And passed? A. Yes

Dr. Doffermyre: Was your training in orthopedics all in the United States?

A. Yes, in Norfolk and Erie, Pennsylvania, and took nine months course at the University of Pennsylvania.

VERDICT: Dr. J. J. Combs moved that Dr. John David Earle Cowan be approved to take the written examination. This motion was duly seconded and passed unanimously.

RE: Dr. Ladislav Peter, graduate of the University of Bebeson, Hungary, M. D., 1934, immigrant, granted special limited license to the State Hospitals October 12th, 1957. He has been certified by the Educational Council for Foreign Medical Graduates.

RE: Dr. Xaver Hertle, graduate of the University of Munich, Germany, M. D., 1950, immigrant, was granted special limited license to the State Hospitals January 14th, 1957. He has been certified by the Educational Council for Foreign Medical Graduates.

Drs. Peter and Hertle were interviewed together.

Dr. Combs advised that both doctors' license would be limited to the State Hospitals until such time as citizenship was obtained. You understand you are given six years to obtain citizenship and if not, it is the prerogative of the Board as to whether to take up your license.

Dr. Hertle: Yes

Dr. Peter: Yes

Dr. Anderson: Neither of you have had any difficulty with the  
 Narcotic Bureau?

Dr. Hertle: No

Dr. Peter: No

Dr. Doffermyre: Are you both happy at Butner?

Dr. Hertle: Yes

Dr. Peter: Yes

VERDICT: Dr. Ladislav Peter was approved to take the  
 written examination.

VERDICT: Dr. Xaver Hertle was approved to take the writt-  
 en examination.

RE: Dr. Dietrich W. Heyder, graduate of the University  
 of Frankfurt, Germany, M. D., 1954, immigrant, was granted spe-  
 cial limited license to Duke University School of Medicine. He  
 has been certified by the Educational Council for Foreign Medi-  
 cal Graduates.

Dr. Doffermyre: How long have you been in this country?

A. Four years

Q. Graduate of the University of Frankfurt? A. Yes

Q. Did you have any hospital training before coming to this  
 country?

A. Yes, University of Frankfurt, approximately four months.

Q. Since you came to this country, what has your medical train-  
 ing consisted of?

A. I came to the City Hospital at Danbury, Connecticut, rotat-  
 ing internship, one year to June, 1955. Then I came to  
 Duke and have been there since in Psychiatry.

Dr. Doffermyre: You are still at Duke?

A. I am still at Duke, a resident in Psychiatry. I have taken  
 the Virginia Boards and passed the Educational Council for  
 Foreign Medical Graduates.

Dr. Tyner: You have license in Virginia?

A. That is true.

Dr. Combs: What are your plans as to North Carolina if you are  
 permitted to take the examination and are licensed?

A. My interest is mental health clinic--- in Elizabeth City,  
 which I have set up. I want to stay in mental clinic  
 health work.

Dr. Combs: Under whose supervision are you working in Elizabeth City?

A. Dr. Fowler

Q. You think you will stay in North Carolina?

A. My plans right now.

Dr. Doffermyre: You understand, should you take and pass our ex-  
 amination, your license would be limited geographically  
 until you have obtained citizenship?

A. I do not understand.



Dr. Dietrich W. Heyder(continued)

Dr. Doffermyre: We have a rule which makes it mandatory before full license can be issued that you have citizenship. We give six years to get it. If citizenship has not been acquired after six years, the license is null and void.

A. In what way would this influence my place?

Q. It would not influence it at all. You would make selection and notify the Board.

Dr. Combs: We will keep your license limited until you become a citizen. We would limit to the counties in which you were located. If you wanted to go somewhere else, you would have to appeal to the Board and we could change the limitation.

Q. How much family do you have?

A. A North Carolina wife and daughter, wife from Sylva.

VERDICT: Dr. Thomas W. Baker moved that Dr. Dietrich W. Heyder be allowed to take the examination. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Adrian Verwoerd, graduate of the University of Amsterdam, Holland, Doctoral Exams, 1952, immigrant, was granted special limited license to Duke University School of Medicine January 10th, 1955. He has served in the United States Army and has been certified by the Educational Council for Foreign Medical Graduates.

Dr. Combs: You finished what school?

A. University of Amsterdam.

Q. How many years?

A. Six, the Dutch system is such that high school is followed by medical school, first two years college included in high school.

Q. What degree do you get when you finish medical education in Holland, what do you have to get?

A. The Arts Exam

Q. Did you leave Holland immediately after getting the Doctoral Degree?

A. No, I left one year after. We have two years internship to get the Arts Exam. My visa came up and I had to utilize it.

Q. You had one year? A. Yes

Q. What training have you had in this country?

A. 1953, one year rotating internship at Touro Infirmary, 1954 at Duke one year in Psychiatry, 1955 United States Army, medical officer two years. In February I returned to Duke and am in the second year of Psychiatry.

Q. February of this year? A. Yes

Q. Does service in the American Army give you citizenship?

A. I will be eligible for citizenship in August.

Q. What are your plans as to North Carolina, if you are permitted to take our examination and pass?

A. I plan to stay on the staff at Duke.

Q. You have been offered a position at Duke? A. Yes

Q. Did you have to declare intention to get in the American Army?

A. No, but I did.



Dr. Adrian Verwoerd (continued)

Dr. Verwoerd presented immigration visa.

Dr. Tyner: You are married? A. No

Dr. Verwoerd: I have Maryland and Hawaiian licenses.

VERDICT: Dr. J. J. Combs moved that Dr. Adrian Voerwerdt, in view of the fact that he has Doctoral Degree in Holland, and in view of the fact that he has had training in one of our medical centers in North Carolina and passed the examination of the Educational Council for Foreign Medical Graduates, be allowed to take our written examination. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Felice Manfredi, graduate of the University of Rome in 1949, immigrant, appeared applying for the privilege of taking the written examination. Dr. Manfredi's credentials were incomplete in that he had not received the certification of graduation from his dean, together with certified photograph, which are required by the Board. He has been certified by the Educational Council for Foreign Medical Graduates.

Dr. Combs: You are a graduate of Rome? A. Yes

Q. What degree?

A. We have different classification, from 66 - 110, my degree was 99.

Q. Did that entitle you to doctor of medicine?

A. Yes, any degree above 66 entitles you.

Q. You finished in 1949?

A. Yes - 1949-50 internship in Florence, Italy; residency the following year, 1950-53 Hospital of Rome; 1953-55, University of Rome; 1955-56 Emory University, Atlanta, Georgia, 1956-57 Ottawa General Hospital; 1957-58 Research Fellow at Duke University.

Dr. Combs: You have not been given any recognition by this Board. You communicated and we did not think it necessary because you were not seeing patients? A. Yes

Q. Who suggested that you take the evaluating examination?

A. Dr. Penrod.

Q. Why are you asking us to take these examinations?

A. The program given out - I have been guaranteed a fellowship by the American Heart Association and for this kind of research we will be dealing with patients.

Q. Where?

A. At Duke. Since Duke requirements have taking care of patients, doing experiments, requires license.

Q. We could take care of you as a resident with a special limited license. Is that all you would desire?

A. No, as I say, I do not know what I am going to do after two years. I may need to take care of patients. So would like license.



Dr. Felice Manfredi (continued)

Dr. Combs: Do you have any plans when you finish at Duke?

A. I would like to stay in academic medicine.

Q. Have you any intimation of staying at Duke?

A. No. I will be appointed as instructor in medicine from July, 1958.

Dr. Anderson: What degree did he actually receive?

A. He said he got 09, that anybody above 66 would get the M. D. Degree. We require certain credentials. One is certification from your dean that you received the M. D. Degree. How much family, are you married?

A. Yes, my wife is American, from Georgia.

Q. Have you made enough to be self-supporting in this country?

A. When I was at Emory I did not make enough.

Q. Did your family in Italy help you out? A. Yes

Q. On fellowship at Duke you made enough to live on? A. Yes

Q. You think with letter you received, you will have credentials we have asked for in a week or two?

A. If not, I will never be able to get them.

Dr. Doffermyre: Do you think the University of Rome is jealous of your coming to America? Is that the reason they do not co-operate?

A. Not the University. The institution I was working for has nothing to do with the University as far as administration is concerned. As far as the secretary is, they do not care. Dr. Manfredi presented his immigration visa.

VERDICT: Dr. J. B. Anderson moved that Dr. Felice Manfredi be allowed to take the written examination and withhold grading paper until he meets the requirements of the Board, by July 23rd, 1958. This motion was duly seconded by Dr. T. W. Baker and passed unanimously. (Credentials were completed);

Dr. Manfredi was advised of limitation until citizenship obtained, within six years.

RE: Dr. Richard Dennis Hill, graduate of Howard University in 1953, a Panamanian on an immigration visa, appeared applying for the privilege of taking the written examination. Dr. Hill was granted a special limited license to the Good Samaritan Hospital July 26th, 1957.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Richard Dennis Hill be granted the privilege of taking the written examination; that if he is licensed, that said license be limited geographically until citizenship obtained; that he be allowed six years in which to obtain the same. This motion was duly seconded by Dr. E. A. Raspberry, Jr. and passed unanimously.

RE: Dr. Oliver Wayne Williamson, Wagner, South Carolina. At the May, 1958 meeting of the Board, upon presentation of court records that Dr. Williamson had been convicted in Federal Court of unlawfully purchasing and selling narcotic drugs, the Board directed that charges be preferred by the Board against Dr. Williamson and that the case be heard at the June, 1958 meeting.

The secretary advised that the attorney for the defendant, Mr. G. T. Carswell of Charlotte, on June 10th, 1958 requested

that this case be continued in regard to Dr. Oliver Wayne Williamson due to illness on his part. A letter from Mr. Carswell's physician was forwarded to the secretary confirming his physical condition.

VERDICT: Dr. E. A. Rasberry, Jr. moved that the trial of Dr. Oliver Wayne Williamson be postponed, to be set at the discretion of the president and secretary of the Board, upon the advice of the Board's attorney. This motion was duly seconded and passed unanimously.

RE: Dr. Shirley Marilyn Gallup - (See previous Minutes) -

Dr. Gallup was granted limited license by endorsement to Graylyn on January 19th, 1953 and on account of information on file at the time, with the stipulation that she have no privilege of permanent license without reappearance and no approval by the Board for narcotic stamp. At the May, 1958 meeting the secretary presented evidence that Dr. Gallup had been convicted in the State of South Carolina of conspiracy to violate the Narcotic Drugs Act and had been committed to the United States Public Health Service Hospital, Lexington, Kentucky for treatment. At that time the Board directed that Graylyn be notified of the above information in writing; that it would not be desirable to have a hearing in this state since she had a limited license; that she not be allowed to go back to Graylyn and that the Board should be notified if she should go back there.

The secretary presented at this meeting letter from Dr. Gallup dated June 12th, 1958 stating that she was hoping to begin work at the State Hospital in Morganton in July and wanted information with reference to her North Carolina license.

VERDICT: Dr. J. B. Anderson moved that the geographical limitation of Dr. Shirley Marilyn Gallup's license not be extended. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

The meeting was adjourned.

Monday, June 17th, 8:30 A. M. - Registration for the examination.

RE: Biennial Registration - The secretary reported that 4800 physicians had registered; that approximately 200 physicians had registered late and paid the penalty.

RE: Dr. James O. Wynn, Jr., resident in Medicine at Duke, who is taking the examination, has applied for extension of his special limited license to cover him until he receives license by examination.

VERDICT: Dr. J. J. Combs moved that the special limited license of Dr. James O. Wynn, Jr. be extended. This motion was duly seconded and passed unanimously.

RE: Dr. Herman Wetzel Hawkins appeared before the Board June 18th, 1957 applying for license by endorsement of credentials. He was approved for license contingent upon completion of arrangements to establish himself for the practice of medicine in the State and that he take his class picture to Dr. Thomas W. Baker for a comparison. Dr. Hawkins has not to date complied with the stipulations of the Board and no further word has been heard from him.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Herman Weitzel Hawkins be refunded fee for license by endorsement, with the usual deduction. This motion was duly seconded and passed unanimously.



RE: Dr. Nathaniel Fulford Rodman, Jr. was granted limited license on the basis of endorsement October 31st, 1955, limited to the University of North Carolina School of Medicine. He is now applying for conversion to full license as he has accepted a position as instructor at the University of North Carolina School of Medicine. His credentials are in order.

VERDICT: Dr. L. R. Doffermyre moved that the license of Dr. Nathaniel Fulford Rodman, Jr. be converted to full license. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. Paul Stevens O'Brien was granted limited license on the basis of endorsement October 31st, 1955, limited to Bowman Gray School of Medicine. He is now applying for conversion to full license in order to begin practice in Roanoke Rapids, North Carolina July 1st, 1958. His credentials are in order.

VERDICT: Dr. L. R. Doffermyre moved that the license of Dr. Paul Stevens O'Brien be converted to full license. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. Charles Fisher Carroll, Jr. was granted limited license on the basis of endorsement July 27th, 1956, limited to the University of North Carolina School of Medicine. He is now applying for conversion to full license in order to begin practice in Concord, North Carolina July 1st, 1958. His credentials are in order.

VERDICT: Dr. L. R. Doffermyre moved that the license of Dr. Charles Fisher Carroll, Jr. be converted to full license, provided he has registered his license. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. A. E. Perry (See previous Minutes) - The secretary reported that the case of Dr. Perry was remanded by the Supreme Court of North Carolina to the Superior Court of Union County, on a technicality.

RE: October, 1958 Meeting - Dr. Combs moved that the Board meet at the Morehead-Biltmore Hotel, Morehead City, October 2-5th, 1958. This motion was duly seconded and passed unanimously.

RE: June, 1959 Meeting - - June 13-18th, 1959 was set for this meeting.

RE: Dr. S. W. Fleming - (See previous Minutes) - Satisfactory reports from Dr. John McCain, Secretary of the Wilson County Medical Society and from the sheriff of Wilson County were presented.

A letter under date of May 30th, 1958 from Dr. Fleming was presented to the Board petitioning the Board to recommend reinstatement of his narcotic license and that the geographical limitation of his license be removed.

VERDICT: Dr. T. W. Baker moved that the restrictions on Dr. S. W. Fleming remain status quo; that the geographical limitation be continued and that reports be received by the Board once a year instead of every six months. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

The meeting was adjourned.



June 16th, 1958

RE: Dr. P. H. Lee, Concord, North Carolina - As per the direction of the Board Dr. Lee was served with charges and accusations by the Board by the sheriff of Cabarrus County on May 15th, 1958, and was directed to appear at this time. The defendant failed to appear, and effort was made to locate him to no avail and after waiting until 3:00 o'clock P. M., the charges were presented to the Board as appears in the record. A certified copy of the record of the Superior Court of Cabarrus County, North Carolina showing a plea of not guilty upon the charge of attempting to produce an abortion and the judgment of the court, and certified copy of the judgment of the Supreme Court of North Carolina Spring Term, 1958, to the effect that the judgment of the lower court was affirmed was presented to the Board of Medical Examiners, as appeared in the record therein. That a copy of the record in the case of State vs Lee, Supreme Court, North Carolina, Spring Term, 1958, was reviewed by the Board of Medical Examiners.

Dr. Tyner: What is the verdict of the Board?

VERDICT is as follows:

1. Guilty
2. Not voted on
3. Not voted on

Dr. T. W. Baker moved that the medical license of Dr. P. H. Lee be revoked on the basis of conviction of a felony by the Superior Court of Cabarrus County, North Carolina, and affirmation of the North Carolina Supreme Court. This motion was duly seconded by Dr. L. R. Doffermyre and passed by a vote of five to one.

RE: Dr. George W. Melchior (See previous Minutes) - Dr. Melchior appeared to petition for reinstatement of his license to practice medicine, which was revoked in June, 1957. Dr. E. T. Beddingfield, Jr. appeared representing Dr. Melchior in submitting his plea and in presenting persons from the Town and County of Wilson supporting Dr. Melchior's petition. A number of citizens from that community appeared in a body and delegated a spokesman on their behalf. The interviews were recorded and are on file in the secretary's office.

The meeting was adjourned.

Monday, June 16th

RE: Dr. George W. Melchior - Dr. J. B. Anderson moved that Dr. George Melchior's license to practice medicine not be restored. This motion was duly seconded by Dr. T. W. Baker and passed by a vote of four to one.

The members of the Board reviewed credentials for applicants for license by endorsement and special limited license.

RE: Social Security - The secretary was directed by the Board to ascertain information with reference to social security for the members of the Board.



RE: Salary of the Executive Secretary - Dr. J. B. Anderson moved that the salary of the executive secretary be raised to \$6,000.00 per annum. This motion was duly seconded and passed unanimously.

The meeting was adjourned.

Tuesday, June 17th

Applicants for license by endorsement interviewed.

RE: Dr. Walter T. Anderson appeared with incomplete credentials and stated that he wanted to go to Pittsboro, North Carolina about September, 1958.

Dr. Thurston: You do surgery? A. Yes

Q. You are planning to practice with Dr. C. S. Fuller in Pittsboro? A. Yes

Q. Surgery? A. No, I think general practice.

Q. You are doing Surgery now?

A. I am more or less limited, general surgery, mainly thoracic. I had a coronary in 1949 and have not done too much since.

Q. How did you get in touch with Dr. Fuller?

A. My daughter lives on a farm near Pittsboro. I have known him socially about 10 years.

Dr. Baker: Is it semi-retirement?

A. Yes, that is the idea.

Q. You plan to be a full time resident? A. Yes

Q. You have no other disabilities? A. No

Q. How active have you been during the past year?

A. Very active. In fact very active since the latter part of 1949.

Dr. Tyner: Have you ever had any trouble with any examining board?

A. None whatsoever.

Q. Have you ever been convicted of a crime? A. N

Q. Have you ever had any difficulty with the Narcotic Bureau?

A. No

Q. Have you ever been addicted to narcotics?

A. No sir. I prescribe very few narcotics.

VERDICT: Dr. Walter T. Anderson was approved for license by endorsement of credentials, if and when his credentials are approved satisfactory to the secretary. (Credentials completed)

RE: Dr. Herbert Marvin Baker appeared with incomplete credentials applying for license by endorsement of credentials.

Dr. Thurston: Are you still planning to locate in the Rockwell area to do general practice?

A. Faith, North Carolina.

Dr. Baker: Will you be associated with Dr. Oliver there?

A. Not directly. He has agreed to help me whenever he can. I plan to go to work as soon as I can complete my credentials.



Dr. Tyner: Have you ever had any difficulty with an examining board? A. No sir

Q. Have you ever been convicted of a crime? A. No sir

Q. Have you had any difficulty with the Narcotic Bureau? A. No sir

Q. Have you been addicted to the use of narcotics or barbiturates?

A. No sir

VERDICT: Dr. Herbert Marvin Baker was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Burton Blaksley Barmore, Jr. appeared applying for license by endorsement of credentials.

Dr. Thurston : You plan to locate in Franklin, North Carolina with Dr. Ed Angel?

A. Yes

Q. You are Board qualified in Pediatrics?

A. Asfar as academic is concerned.

Q. You will not limit to pediatrics?

A. Probably not all.

Q. When do you want to begin practice?

A. July 1st.

Dr. Tyner: Have you had any difficulty with an examining board?

A. No sir

Q. Have you had any difficulty with the Narcotic Bureau? A. No sir

Q. Have you ever been convicted of a crime? A. No sir

Q. Have you been addicted to the use of Narcotics or barbiturates?

A. No sir

Dr. Thurston: You plan to be full time?

A. Yes, I am planning to stay indefinitely.

VERDICT: Dr. Burton Blaksley Barmore, Jr. was approved for license by endorsement of credentials.

RE: Dr. Hewlette Collier Connell appeared with incomplete credentials applying for license by endorsement of credentials.

Dr. Thurston: You are planning to work -- ?

A. At the State Hospital this summer, then go in service and then come back to North Carolina to do obstetrics and gynecology.

Dr. Anderson: For two years service?

A. Yes. I am thinking about doing a residency and do not know where I will locate. I married a Raleigh girl.

Dr. Tyner: Have you had any difficulty with an examining board?

A. No sir

Q. Have you been convicted of any crime? A. No

Q. Have you been addicted to the use of narcotics or barbiturates?

A. No sir

VERDICT: Dr. Hewlette Collier Connell was approved for license by endorsement of credentials.



RE: Dr. James Robert Dineen appeared applying for license by endorsement of credentials. Dr. Dineen is presently stationed at Camp Le Jeune, North Carolina and has been asked to assist in clinics in Orthopedics and consultation.

Dr. Dineen furnished recommendations from the local medical society and his commanding officer.

Dr. Baker: How much time would the service allow you to put in civilian practice?

A. If an orthopedic man came into the area I would discontinue as that would be competition. I teach at the University of North Carolina School of Medicine.

Dr. Dineen stated that he was sold on this state but did not know yet.

Dr. Tyner: Have you had any difficulty with any examining board?

A. No sir

Applicants for Part II of the written examination were registered.

RE: Dr. C. F. Ridge, High Point, North Carolina - Upon presentation of SBI reports under date of April 4 and 22nd, 1958, alleging excessive prescribing of narcotics irregularities, the Board directed that Dr. Ridge be requested to appear before the Board. Dr. Ridge appeared at this time and the Board questioned him at length with reference to the allegations made against him. He stated that he had given papine to one Robert Watson for the relief of ulcer pain over a long period of time; that he realized he had become addicted and discontinued giving it to him. That he had not prescribed excessively for any other patient. That he had never charged Mr. Watson for any professional services. He stated that he did not obtain his drugs by order form; that he wrote prescriptions and used drugs in his office purchased for other patients. Mr. and Mrs. Robert Watson appeared on Dr. Ridge's behalf. Mr. Watson corroborated Dr. Ridge's statements and said he had become addicted to drugs, but had been under treatment of another doctor and was not at the present time taking any narcotics. (See file for complete interview)

VERDICT: Dr. J. J. Combs moved that Dr. C. F. Ridge be reprimanded; that he buy his narcotics on requisition; that he be informed his record would be on file in the secretary's office and it was hoped he would have no further trouble. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

The president advised Dr. C. F. Ridge as instructed by the Board.



RE: Dr. J. R. Medlin, Rural Hall, North Carolina - (formerly of Asheboro) appeared petitioning for recommendation of restoration of his narcotic stamp. (See previous Minutes) He stated that he had moved to Rural Hall, where he is in practice with his brother; that he had considered moving sooner, but wanted to clear his record; that he is doing a country practice; that he has not had any narcotic drugs in two years, which he took for a period of about three months. He said he has been made to realize more clearly his duty to his fellow man. Report of investigation by the SBI on April 28 and 30th, 1958, failed to reveal any information of a derogatory nature.

VERDICT: Dr. L. R. Doffermyre moved that the Board of Medical Examiners recommend restoration of Dr. J. R. Medlin's narcotic stamp; that he keep adequate records and report back to this Board in June, 1959 to give a personal report. This motion was duly seconded by Dr. T. G. Thurston and passed by a vote of four to one.

RE: Dr. Randall C. Smith, Ayden, North Carolina - (See previous Minutes) - At the May, 1958 meeting of the Board the secretary presented evidence that Dr. Smith had violated the provisions of judgment of the Board of Medical Examiners rendered September 24, 1956, a report that he had been a patient at the State Hospital for treatment for taking phenobarbital. The secretary also advised that Dr. Smith had been notified on April 26th, 1958 that the Board would consider on May 5th, 1958 the question of whether or not it should put into effect the judgment of the Board revoking his license to practice medicine, rendered on September 24th, 1956, upon the grounds that the terms and conditions of the judgment had been violated and that he was given an opportunity to appear at that time. Dr. Smith did not appear. The Board directed that he be requested to appear at the June, 1958 meeting.

Dr. Smith appeared at this time and he denied having taken phenobarbital or morphine; that he had been taking medrol. RE: Dr. Louis V. Avioli, graduate of Yale University School of Medicine, appeared with incomplete credentials, applying for special limited license to the University of North Carolina School of Medicine, where he is a resident in Medicine. Dr. Avioli was approved for special limited license upon completion of credentials satisfactory to the secretary.

RE: Dr. Vincent Horace Bono, Jr., graduate of Columbia University College of Physicians and Surgeons, appeared applying for special limited license to Duke University School of Medicine, where he is a resident in Medicine, for which he was approved.

RE: Dr. Harold Joseph Fallon, Jr., a graduate of Yale University School of Medicine, appeared applying for special limited license to the University of North Carolina School of Medicine, where is a junior resident in Medicine, for which he was approved.

RE: Dr. Bryce Templeton, graduate of Western Reserve University School of Medicine, appeared applying for special limited license to the University of North Carolina School of Medicine, where he is a resident in Psychiatry, for which he was approved.

RE: Dr. Edward Peter O'Hanlon, graduate of the University of Rochester School of Medicine, appeared applying for special limited license to the University of North Carolina School of Medicine, where he is a resident in Medicine, for which he was approved.

Dr. Tyner: The special limited license entitles you to practice medicine in the area specified. It does not imply that you would at anytime receive a full license. It does not carry with it the privilege of obtaining a narcotic stamp or the prescribing of narcotics.

Dr. Combs: This was set up to give you the privilege of getting training if you did not have means of obtaining license by endorsement.

RE: Dr. Martha Leas, graduate of Western Reserve University appeared applying for license by endorsement of credentials, limited to the University of North Carolina School of Medicine where she is a resident in Medicine. She had no credentials.

VERDICT: Dr. Martha Leas was approved for license by endorsement of credentials, limited to the University of North Carolina School of Medicine, if and when her credentials are completed satisfactory to the secretary.

RE: Dr. Flotilla Watkins appeared May 5th, 1958 with incomplete credentials applying for license by endorsement of credentials, limited to Lincoln Hospital. His credentials are complete at this time.

VERDICT: Dr. Flotilla Watkins was approved for license by endorsement of credentials, limited to Lincoln Hospital.



RE: Federation of State Medical Boards Meeting 1959 =  
 Dr. T. G. Thurston moved that all members of the Board go to Chicago for the meeting in February, 1959. This motion was duly seconded by Dr. L. R. Doffermyre by a vote of four.

RE: Dr. John Martin Johnson, Jr. of Bristol, Virginia appeared to answer to charges that his medical license in the State of North Carolina be suspended for failure to register as required by General Statutes of North Carolina 90-15.1. The interview with Dr. Johnson is on file.

Dr. John Martin Johnson, Jr. paid fee for biennial registration and penalty, and charges to suspend his license were withdrawn.

The meeting was adjourned.

RE: Dr. Miriam Naomi Muldrow, colored, Whiteville, North Carolina - Dr. Muldrow appeared at this time, having been subpoenaed and served with charges following conviction in the Superior Court of Columbus County, North Carolina. The charges and accusations of the Board, which are as follows, were read by Mr. John H. Anderson, Attorney for the Board:

"1. That at the November, 1957 Criminal Term of the Superior Court of Columbus County, North Carolina, you pleaded guilty to the charge and indictment of violating the General Statutes of North Carolina, Chapter 90, Section 98, and in failing to maintain records of narcotic drugs administered and dispensed by you, following which you were sentenced to be confined in the Women's Prison of North Carolina for a period of from two to three years, but sentence was suspended upon the several conditions stated in the judgment of the Court.

"2. That you violated the General Statutes of North Carolina, Chapter 90, Section 94, by obtaining narcotic drugs, to-wit: demerol on written prescription not in good faith and not in the course of your professional practice on the occasions and in the name of persons as follows:

(Contained in charges but not copied for Minutes)

"3. That you violated the General Statutes of North Carolina, Chapter 90, Section 106, in that you obtained and attempted to obtain a narcotic drug, to-wit; 30 vials of demerol by fraud, deceit, misrepresentation and subterfuge by the concealment of a material fact in that while in the State of Florida on or about June 27th, 1954, you executed a written prescription in the name of Mrs. L. Johnson, 203 West Virgil Street, Whiteville, North Carolina for demerol, which prescription you mailed to said Mrs. L. Johnson, with instructions to have it filled and in turn mail the said demerol to you in Florida, which was done, and which said drugs were used and consumed by you.

"4. That you violated the General Statutes of North Carolina, Chapter 90, Section 98, in that you failed to keep a record of the narcotic drugs administered, dis-

pensed and professionally used by you, otherwise than by prescription, involving 642 30cc vials of demerol, 120  $\frac{1}{2}$  grain codeine sulfate tablets, and 20  $\frac{1}{3}$  grain pantapone tablets, purchased by you between July 18th, 1955 and September 14th, 1956.

"5. That you have been and are habitually addicted to the use of narcotic drugs.

"6. That in the above respects you have been guilty of dishonorable and unprofessional conduct unworthy of and affecting the practice of your profession and grounds exist for the revocation of your license to practice medicine in the State of North Carolina.

"7. You are further given notice that a hearing will be held upon the foregoing charges and accusations before the Board of Medical Examiners of the State of North Carolina on January 11th, 1958, at 11 o'clock at the Mid Pines Club, Southern Pines, North Carolina, at which time you will be given an opportunity to be heard, either personally or through counsel of your choice, to cross-examine witnesses and to present on your own behalf evidence in the matter, if you so desire, and that in the meantime the Board will receive any written answer or reply to the foregoing charges which you may wish to file although you are not required to make such written reply or answer. Following this hearing the Board will make such findings and will take such action regarding a suspension or revocation of your license to practice medicine as to the Board appears warranted and justified.

Note: This case was continued until this date.

Mr. Ozmer L. Henry, Attorney, represented Dr. Muldrow. He stated that the plea is not guilty as to the charges as drawn; that there was a technical plea, which was submitted to the Court of a failure to keep an adequate record.

Mr. Anderson presented certified copy of indictment and judgment of the Superior Court of Columbus County, which were as follows:

"SUPERIOR COURT - JUNE TERM 1957

THE JURORS FOR THE STATE UPON THEIR OATH PRESENT, That Dr. Miriam Naomi Muldrow, M. D., 131 W. Virgil St, Whiteville, a licensed physician late of the County of Columbus, on the 27 day of June, in the year of our Lord one thousand nine hundred and fifty-four, with force and arms, at and in the county aforesaid, unlawfully, willfully and feloniously, did, obtain and did attempt to obtain a narcotic drug, to wit: 30ccs demerol, 50 mg. per cc, by fraud, deceit, misrepresentation and subterfuge, and by the concealment of a mate-

"As indicated in our correspondence to you of January 9, 1958, we are informing you that the above-named patient was released from this hospital on 3-20-58, as "hospital treatment completed!"

"At the time of admission, the patient was not physically dependent upon any opiates, and there was no evidence of recent drug use. While in the hospital, the patient suffered from an upper respiratory infection, which required her hospitalization on the Infirmary Ward. She made an excellent institutional adjustment on our Continued Treatment Ward, and also in her work as an aide on our Female Ward. At the time of discharge, the patient indicated that she was returning to Whiteville, N. C., where she will resume the general practice of medicine.

Mr. Henry stated there was no guilty intent, no felonious intent in any of the violations; that Dr. Muldrow had left the keeping of records to her nurse because of her physical condition; that the records had not been kept; that there was a technical violation; that Dr. Muldrow had denied addiction to narcotics. It was under agreement that the technical violation of failure to keep records was submitted and it was under agreement that sentence would not be other than a suspended sentence; that a plea of not guilty was entered on all but the technical violation of the failure to keep records.

Dr. Muldrow does not have a narcotic license.

Dr. Muldrow stated that her history of ulcer went back to medical school days; that in 1948 she had an intestinal hemorrhage and has had 33 transfusions since that time, the last one being in March, 1958; that she had a gastrectomy in 1955. She also stated she has a hypertension. She said that she suffers a great deal of abdominal pain; that she has had no narcotics since April, 1957. Dr. Muldrow admitted not having a government order form book for narcotics and having used narcotics belonging to one patient for another. She said that she is able to do a limited amount of work and has seen a maximum of 10 patients a day since returning from the United States Public Health Service Hospital. That on days she is suffering pain, she does not go to her office.

Mr. Henry submitted letters from Dr. Muldrow's physicians corroborating her statements as to her physical condition and testimonial letters from citizens in her community. Dr. Muldrow alleged that she had never been connected with any racket, had never received financial gain nor prescribed narcotics to any person whom she did not feel was



deserving or medically required.

VERDICT: Dr. L. R. Doffermyre moved that the judgment of the Board of Medical Examiners is that the medical license of Dr. Miriam Naomi Muldrow be suspended and that this sentence is suspended upon condition that she remain of good behavior and not violate any of the laws of the State of North Carolina or use or dispense narcotic drugs for a period of five years. That she report to this Board in person at 12 month intervals during said period so that the Board might determine in person that she is carrying out the provisions of this judgment. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

RE: Biennial Registration of Physicians - Following notice given by mail to those who failed to register as required by law that they appear before the Board of Medical Examiners at 9 A. M. June 18th, 1958, at the Sir Walter Hotel, the secretary reported to the Board that those physicians listed upon the attached list had failed to register as required by law. None of the said persons appeared before the Board. After discussion and upon motion of Dr. J. J. Combs and seconded by Dr. L. R. Doffermyre, it was resolved that the license of the physicians listed upon the attached list, and listed below, be suspended for failure to register as required by General Statutes of North Carolina 90-15.1:


