

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 17-21st, 1962

- - - -

The Board of Medical Examiners of the State of North Carolina met at the Sir Walter Hotel, Raleigh, North Carolina, for the purpose of giving the annual written examination, interviewing applicants for license by endorsement of credentials and special limited license and other business.

The Board had as its guests for an orientation meeting the following physicians, who are the newly elected members of the Board of Medical Examiners and will take office November 1st, 1962: Drs. James Evans Davis, Frank Edmondson, Hiram Lee Large, Jr., W. Boyd Owen, Clark Rodman, and Ralph Gordon Templeton.

RE: Students from the University of North Carolina School of Medicine - Written Examination - The secretary presented letter from Dr. W. R. Berryhill, Dean, stating that the following students would have to complete additional work either in Introductory Medicine or Pharmacology before they could be promoted to the third year:

Dr. Berryhill recommended that the above students be allowed to take Part I of the written examination due to the fact that the subjects in which they were deficient are not included in Part I of the State Board examinations.

VERDICT: Dr. J. B. Anderson moved that the above listed students be allowed to take Part I of the written examination and grades be withheld until the Board receives information from the dean of the University of North Carolina School of Medicine that they have completed the required work to be promoted to the third year; that provided they fail to pass such subjects this summer, they receive no grade. This motion was duly seconded by Dr. E. A. Rasberry, Jr. and passed unanimously.

RE: Written Examination - Dr. Leon D. Robinson, a diplomate of the National Board of Medical Examiners was granted special limited license to Duke University school of Medicine July 25th, 1958, and later transferred to John Umstead State Hospital, where he is on the staff. He has failed to make a passing average on Part II of the written examination on three attempts. Dr. James L. Cathell, Superintendent of

Dr. Leon D. Robinson continued

John Umstead Hospital, advised that Dr. Robinson has been an excellent physician; that for the past year he has worked in the geriatric service and has developed an outstanding program, both from a service standpoint as well as research; that his services are considered of great value. Dr. Cathell asked the Board at the time he appeared before it in May, 1962, that Dr. Robinson be allowed to remain there on the special limited license.

Dr. Robinson appeared at this time to petition to be allowed to remain at John Umstead Hospital on special limited license, to be renewed annually.

VERDICT: Dr. J. B. Anderson moved that Dr. Leon D. Robinson be required to take the written examination on Part II again; that if he fails, we renew his special limited license for a year. This motion was duly seconded by Dr. T. W. Baker and passed unanimously.

RE: Dr. Daniel W. Rader - Dr. Rader attempted to take the written for licensure in June, 1958, but was unable to complete the same. He was sent by the Board to North Carolina Memorial Hospital for observation. Following that Dr. Thomas E. Curtis, Director of the Psychiatric Outpatient Clinic reported that he was not hospitalized; that he was suffering from an acute situational reaction resulting from considerable stress, both in his home situation and in connection with taking the examinations; that he was seen the following day at which time he seemed to have satisfactorily reintegrated his previous defenses. No further word was heard from Dr. Rader until he applied to take this examination. He was requested to appear at this time.

Dr. Rader appeared at this time and stated that following his attempt in 1958 to take the written examination he went to Grady Hospital for an internship; that he did not receive credit for the same as he did not finish it; that he wasn't too well and his work was not satisfactory. That he then went in service and received an honorable discharge; that this situation was the same as at Grady Hospital. That he then remained at home four months, then went to Booth Memorial Hospital in Flushing, New York, for an internship, which was accredited; that he did six months of residency there in Internal Medicine. He said that he does not have a residency at this time, but desires further training before going into practice. He said that when he left the service, he was advised by an analyst to undergo analysis, but that he had not to date been able to afford the same and he said he wished to do this before going into practice. He said that he felt he was sturdy enough to take the examination at this time, though he had not had much time to study.

VERDICT: Dr. J. B. Anderson moved that Dr. Daniel W. Rader be granted the privilege of taking the written examination; that the Board obtain reports from Grady Hospital and the service before granting license. This motion was duly seconded by Dr. Carl V. Tyner and passed unanimously.

RE: Dr. Vamik Bombatepe, graduate of Ankara University, Turkey in 1951, was granted special limited license to the State Sanatoria July 26th, 1957, where he remained until June 30th, 1958. Dr. Bombatepe, who is now on an immigration visa and is married to an American, has accepted a position on the staff of the Eastern North Carolina Sanatorium. Dr. W. H. Gentry, Medical Director of the North Carolina Sanatorium, has recommended him for the written examination. He has furnished letters of recommendation to cover the interim since leaving North Carolina and has obtained the permanent certificate of the Educational Council for Foreign Medical Graduates. He is now applying to take the written examination.

Dr. Bombatepe continued

Dr. Thurston: You have been with Dr. Easom?

A. That is right

Q. You are there now?

A. That is right

Q. How long were you in North Carolina?

A. McCain 1957-58 and went back to New York to Triboro Hospital.

Q. Were you doing chest work at Triboro?

A. That is right

Q. Do you have certification of your boards, American College of Chest Physicians?

A. I do not apply for that, did internship at St. Marys Hospital, Brooklyn, then worked as house physician at Mercy Hospital, Rockville Centre, Long Island.

Q. From there you came back to North Carolina?

A. Then I got my permanent visa and came here. He presented his immigration visa.

Q. You intend to stay in chest work in North Carolina?

A. Yes

Q. You are currently employed?

A. Yes

Q. You are prepared to sit the Board?

A. Sofar as I know

VERDICT: Dr. J. B. Anderson moved that Dr. Vamik Bombatepe be approved to take the written examination and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years. This motion was duly seconded by Dr. E. A. Rasberry, Jr. and passed unanimously.

RE: Dr. Jose O. Castellanos, graduate of the University of Havana, Cuba, in 1949, appeared applying to take the written examination.

Dr. Thurston: You have been working for Parke, Davis and Company for 10 years?

A. I was working in Cuba and here too. I was medical director.

Dr. Baker: When did you come to the States?

A. October 17th, 1960

Dr. Thurston: What have you done since then?

A. I came with \$5.00 in my pocket. I came to Detroit and they gave me a job there. I have been in the Promotion Department.

Q. Have you done medical work in this country?

A. No

Dr. Anderson: What are your plans as to the State of North Carolina?

A. My plan is to become a doctor and work here as a doctor. In Cuba I have my own practice. I feel that I have to see patients again.

Q. Do you have any place or institution in North Carolina that you anticipate practicing?

A. No

Dr. Thurston: How did you pick North Carolina?

A. I prefer the people from the south and the weather.

Dr. Castellanos continued

Dr. Thurston: You have had no personal contact in North Carolina?

A. No

Dr. Baker: What were you doing for Parke-Davis in Cuba?

A. Medical director eight years in Cuba.

Dr. Thurston: You looked around at states that would allow you to take the license?

A. I saw in the Journal of the American Medical Association.

Dr. Tyner: What type of practice?

A. Internest. We had begun to establish boards in Cuba and we were ready to prepare.

Dr. Anderson: You want to do Internal Medicine in North Carolina?

A. I know I can not do Internal Medicine.

Q. General practice?

A. Yes

Dr. Castellanos presented his immigration visa.

VERDICT: Dr. J. B. Anderson moved that Dr. Jose O. Castellanos be approved to take the written examination, and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years.

RE: Dr. Renatp M. Freire, graduate of the University of Minas Gerais Medical School, Brazil, 1956, appeared applying for the privilege of taking the written examination. He was granted special limited license to the State Hospitals to cover him on a staff position at Cherry Hospital on January 6th, 1961, where he remained until June 25th, 1961. He has obtained the permanent certificate of the Educational Council for Foreign Medical Graduates. Dr. Vitols has recommended that Dr. Freire be granted license to return to Cherry Hospital and has highly recommended him.

Upon interview Dr. Freire stated that he only wishes to remain at Cherry Hospital and planned to return to Brazil.

VERDICT: Dr. T. W. Baker moved that Dr. Renato M. Freire's special limited license be reinstated for six months to Cherry Hospital. This motion was duly seconded and passed unanimously.

RE: Dr. Ingeborg Seifert Gibson, graduate of the University of Freiburg, Germany in 1952, appeared applying for the privilege of taking the written examination. She is on an immigration visa and is married to an American physician.

Dr. Thurston: Bring us up to date on your medical training.

A. I graduated December, 1950 from the University of Freiburg, Germany. After one year of internship and three months general practice I got permanent license. It is required to get permanent license.

Dr. Combs: You got the M. D. degree?

A. Yes, you get it when you finish, but full license to practice after one year and three months. I worked until 1953 in Urology Clinic and two years surgical residency. In 1959 I came to America and had rotating internship at Miami Beach. I stayed there until Decem-

ber, 1960, last month residency in obstetrics-gynecology. I then married and have not worked.

My husband works in the Veterans Administration Hospital in Salisbury. I would like to work in the county hospital or the Veterans Administration Hospital.

Q. You do not have a state license at present?

A. No

VERDICT: Dr. Carl V. Tyner moved that Dr. Ingeborg Seifert Gibson be permitted to take the written examination and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. Janis V. Klavins, graduate of the University of Kiel, Germany in 1948, appeared applying for the privilege of taking the written examination. Dr. Klavins is an associate professor of Pathology at Duke University School of Medicine.

Dr. Thurston: You worked with Dr. Thomas D. Kinney?

A. Yes, 10 years.

Q. You passed the Ohio Board by examination?

A. Yes

Q. You have been in Pathology this past 10 years?

A. Yes

Q. You came to Duke with Dr. Kinney?

A. Yes, in 1960. It was indicated to me at that time I could get license by reciprocity.

Q. What title do you hold at Duke?

A. Associate professor of Pathology at Duke and chief of laboratory at the Veterans Administration Hospital.

Q. You feel to get things straightened away you would like to take the examination?

A. I would be happy to take it.

Q. The main thing we require is the certificate of the Educational Council for Foreign Medical Graduates. We were considering waiving it since you are established. That would not mean we would waive it for everybody.

Dr. Baker: You are not planning to take the Educational Council for Foreign Medical Graduates?

A. No

Q. From 1948?

A. I went to Cleveland in 1952 and did a residency in Pathology, then took state boards in Ohio. In 1957 I took the Pathology Anatomy Boards and 1959 Clinical Pathology.

Dr. Anderson: You are certified by the Board of Pathology?

A. Yes

Dr. Klavins presented naturalization paper and photo compared with photo on that document.



Dr. Klavins continued

VERDICT: Dr. T. W. Baker moved that in view of applicant's special attainments that the requirement as to the certificate of the Educational Council for Foreign Medical Graduates be waived and that Dr. Janis V. Klavins be allowed to take the written examination and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Eladio Ochoa, graduate of the National University of Columbia, South America in 1950, appeared applying for the privilege of taking the written examination. He has completed residency at City Memorial Hospital, for which he had special limited license.

Dr. Thurston: Where do you plan to practice in North Carolina?

A. I like a small town, perhaps not far away from Winston-Salem.

Q. Will you have your boards in Surgery?

A. I have a letter from the American Board in Surgery that they consider me eligible for the first of July. However, they say the last word will come from the Examinations Committee meeting June 22-23rd. They ask for surgical work and I send it.

Q. Do you plan to take further training?

A. If they tell me, I will take it, probably research.

Q. What state is your wife a native of?

A. Medford, Massachusetts

Dr. Ochoa presented his immigration visa.

Q. When did you come to this country?

A. In 1955 under the exchange visa. I have been under permanent visa since 1960.

Q. Where have you been since 1955?

A. St. Joseph Infirmary, Atlanta, one year in Pathology, one year Surgery at Emory, and the last three years at City Memorial Hospital.

VERDICT: Dr. Carl V. Tyner moved that Dr. Eladio Ochoa be approved for the written examination and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Felix J. Pircher, graduate of the University of Innsbruck, Austria in 1939, appeared applying for the privilege of taking the written examination. (See May, 1962 Minutes) Dr. Pircher has been certified by the Michigan Board as to screening examination for foreign medical graduates.

Dr. Thurston: You are in Radioactive Isotopes at Duke?

A. I have been offered the position by Dr. Reeves.

Q. Where are you now?

A. Indiana

Q. Where did you graduate?

A. Innsbruck, Austria. I came to this country in 1956, had one year of internship at the University of Michigan, took the screening board there for foreign graduates my second year. I went one year as research associate at Oakridge. Then I came back and stayed until December, 1960.



Dr. Pircher continued

Dr. Pircher presented his naturalization paper and photograph on file compared favorably with that on this paper.

Q. Our Board is so constituted that we can not accept examinations from othere states for foreign graduates, without sitting our examination. When will you go there?

A. The first of July.

Q. We will not certify grades until the last of July, but you could do research. You finished school when?

A. 1939 - I was medical officer in the army and prisoner of war, then took training for three years in Salsberg. I worked part time for the United States Public Health Service Hospital.

VERDICT: Dr. J. J. Combs moved that Dr. Felix J. Pircher be approved to take the written examination and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Rosario F. Zinna, graduate of the University of Naples, Italy in 1948, appeared applying for the privilege of taking the written examination.

Dr. Thurston: You plan to come to Duke?

A. They have told me I have an appointment at the Veterans Administration if everything else falls into place.

Q. Do you have license in any state?

A. No

Q. Where did you graduate?

A. Naples, Italy, December, 1948.

Q. Bring us up to date medically?

A. I worked one year in City Hospital in Salerno, general practice until 1951. I moved to England, wife English, worked seven months in hospital, doing Medicine. Then I went to the Royal College of Surgeons and was there eight months as full time student. I took course in basic science and Anesthesia, then senior house officer in Anesthesia in London, then clinical assistant in Anesthesia. I then went to Canada in 1955, took course in Psychiatry at McGill, worked at Montreal Children's Hospital two years and that allowed me to take the last years at Worcester, Massachusetts. I have been there ever since, 1958.

VERDICT: Dr. E. A. Rasberry, Jr. moved that Dr. Rosario F. Zinna be approved for the written examination and if successful in passing the same, that his license be limited geographically until citizenship obtained, within six years. This motion was duly seconded and passed unanimously.

RE: Dr. Henry Clyde O'Roark appeared applying for license by endorsement of credentials. He has been appointed to the staff in the Department of Obsetrics-Gynecology at Bowman Gray School of Medicine. His grades on Part I of the written examination of the Ohio Board of Medical Examiners do not meet the requirements of this Board.

Dr. Thurston: Have you moved to Winston-Salem?

A. We are moving next week.

Q. Bring us up to date.

A. I graduated from the medical school in 1957, interned at Cincinnati General 1957-58, and Obstetrics-Gynecology for the last four years.

Dr. O'Roark continued

I am supposed to start with Dr. Lock July 1st.

Dr. Thurston: Did you take Part I or all of it at one time?

A. All in the latter part of 1957.

Q. Have you taken board examinations?

A. No, I can't take that for two years.

Dr. Baker: Were you aware of your grades?

A. No, this is the first opportunity I have had for a need for them.

Dr. Thurston: Are you prepared to take those examinations?

A. Of course, I have had the courses. It has been seven or eight years. I could take the examinations.

VERDICT: Dr. J. J. Combs moved that Dr. Henry Clyde o'Roark be required to take the two subjects in which he is deficient in the first part and that the examiners give the grades before the meeting adjourns. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously. (See p 173 these Minutes)

The meeting was adjourned.

Monday, June 18th

Registration Part I and Parts I and II of the written examination.

Credentials for licensure by endorsement of credentials and special limited license were reviewed by members of the Board.

RE: Dr. W. A. Hoover, Murphy, North Carolina - Dr. Hoover was requested to appear before the Board at this time, which he failed to do. Dr. J. B. Anderson stated that he had talked with people in his community; that he had ascertained he was working every day and did not obtain any derogatory information.

RE: Dr. George Ashby Winstead (See previous Minutes) Dr. Winstead appeared for a routine visit, at the request of the Board. Dr. J. B. Anderson advised that he had talked with people in his community, who stated he was working every day; that he did not obtain any derogatory information. Dr. Winstead said he was doing all right; that a little over a year ago his wife was at Broughton Hospital for a month; that he has no desire for the return of his narcotic tax stamp; that he was depressed and taking two evil tablets a day. It was the consensus of the Board that he is still an emotional problem and it directed that he be seen in May, 1963.

VERDICT: Dr. J. B. Anderson moved that Dr. George Ashby Winstead be continued under surveillance. This motion was duly seconded and passed unanimously.

RE: Dr. Elizabeth Veeder, graduate of Albany Medical College in 1946, applied for license by endorsement of credentials, however, she is a diplomate of the National Board of Medical Examiners, with no state medical license by which she can obtain endorsement. She has accepted a position at Duke University as physician for Duke Woman's College. Dr. Veeder was sent requirements for written examination, but due to the inadequate period of time she was unable to avail herself of this opportunity.



Dr. Veeder continued

Drs. E. L. Persons and Eugene Stead appeared to make an appeal to the Board. Dr. Persons stated that the present incumbent is retiring and that it had been a problem to get a suitable replacement; that this physician seems ideal for the position. He said if an arrangement could be made for a limited license she would essentially be doing only work delegated to her as director of Student Health; that he was responsible to the University and to Dr. Stead for all student care on both campuses. Dr. Stead stated that he would be able to classify her as a resident. He also stated, upon inquiry, that it would be his idea if she stayed on that she would take the written examination of the Board for licensure in 1963. They were advised that this arrangement would not give her the privilege of prescribing narcotics nor joining the medical society. Dr. Persons stated that she would not need narcotic license.

VERDICT: Dr. L. R. Doffermyre moved that Dr. Elizabeth Veeder be granted special limited license to Duke University School of Medicine, with the understanding that she take the written examination of this Board in June, 1963, provided all credentials are complete and after a personal appearance. This motion was duly seconded by Dr. E. A. Raspberry, Jr. and passed unanimously.

RE: Dr. George A. Mears, Asheville, North Carolina, was requested to appear for a routine appearance, which he failed to do. Dr. J. B. Anderson advised that he had closed his office in 1960; that both he and his wife were in very bad condition. The Board directed that he be requested to appear at the October, 1962 meeting in Asheville.

RE: Dr. Dean Tester - The secretary presented letter from Dr. Robert E. Sandy, Radiologist of Washington, North Carolina, advising that he was attempting to obtain coverage for his Radiological practice in the Beaufort County Hospital during the week of August 13-18th; that Dr. Robert J. Reeves had advised he had one resident, Dr. Dean Tester, resident available. Dr. Tester is on a limited license to Duke University School of Medicine on the basis of endorsement of credentials.

VERDICT: It was moved, seconded and passed unanimously that the Board would extend the geographical limitation of Dr. Dean Tester's limited license to the Beaufort County Hospital for one week August 13-18th, 1962, provided Dr. Tester meets the requirements and that he will be under Dr. Robert J. Reeves' responsibility.

The secretary presented letter from James T. Barnes, Executive Director of the State Medical Society announcing the election of the incoming Board of Medical Examiners beginning January 1st, 1963. This was received as information.

RE: Dr. Doralea R. Harmon, Highlands, North Carolina -The secretary advised that the State Medical Society felt that due to the unfavorable publicity that the Board received in the newspapers that a letter written by Dr. Harmon to the Asheville Citizen-Times and published by it, should be circulated among legislators and county medical societies. It was not the concensus of the Board of Medical Examiners that this be done.

VERDICT: Dr. L. R. Doffermyre moved that the secretary pass the feeling of the Board of Medical Examiners on to the executive director and Executive Council of the State Medical Society. This motion was duly seconded by Dr. Carl V. Tyner and passed unanimously.



RE: Dr. W. C. Perry, Louisburg, North Carolina - Dr. Perry appeared before the Board in June, 1960, with regard to narcotic addiction. He was requested to make a routine appearance at this time. The secretary reported that he had received letter from Dr. Bernard L. Patterson, Dr. Perry's physician, under date of June 14th, 1962, that on April 2nd, 1961, Dr. Perry suffered a second cerebral accident; that he has been continuously under his care since discharge from North Carolina Memorial Hospital April 23rd, 1961. This was received as information.

RE: Dr. James Valentine Thomas (See previous Minutes) The secretary reported he had been advised by Broughton Hospital that Dr. Thomas began work there on May 17th, 1962.

RE: Dr. Jacqueline C. Hijmans was granted license by written examination in June, 1956, limited geographically until citizenship obtained. It is the policy of the Board in such case that a physician be given six years to obtain citizenship or license to become null and void. However, in reviewing the minutes in regard to Dr. Hijmans this stipulation was not spelled out.

Dr. Hijmans has advised that she is in the process of obtaining citizenship and has asked for an extension of time to obtain the same.

Dr. E. A. Rasberry, Jr. advised that she is associated with Dr. J. T. Sessioms at the University of North Carolina School of Medicine and is married to Dr. Jerome Harris of the Department of Pediatrics, Duke University School of Medicine.

VERDICT: Dr. J. B. Anderson moved that the secretary obtain definite statement from Dr. Jacqueline C. Hijmans as to when she expects to obtain citizenship and report to the Board at its next meeting in July. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. Harry D. Riddle, Gastonia, North Carolina - The secretary reported letter of May 31st, 1962, from Dr. Jesse Caldwell, Chairman of the Medico-Legal Committee of the Gaston County Medical Society as to Dr. Riddle's medical practice status, since he is under indictment for first degree murder. The secretary also reported that he had replied that no action was pending before the Board of Medical Examiners in regard to Dr. Riddle; that under the legal procedure a man is innocent until proven guilty. This was received as information by the Board.

The meeting was adjourned.

RE: Dr. John M. Gambill (See previous Minutes) Dr. Gambill appeared for a routine visit. He stated that he was doing well and he asked when he might expect to get his license back, to which the Board did not give him an opinion. He was told that the main thing for him was to keep his good record. A favorable letter was presented from Broughton Hospital and recommendation that his special limited license be reinstated. The Board directed that he be seen in May, 1963.

RE: Dr. Victor H. Prusa, Taylorsville, North Carolina, was requested to appear at this time for a routine appearance, which he failed to do. Dr. T. G. Thurston advised that he was no longer on the staff of the hospital there.



RE: Dr. John W. Straughan, Warsaw, North Carolina - Dr. Straughan appeared for a routine visit. He first appeared before the Board of Medical Examiners in 1957 on account of drug addiction. Since that time he has been under the surveillance of Dr. M. R. Doffermyre, who has given favorable reports on him. Dr. Doffermyre reported that he had visited Dr. Straughan a number of times when he was not expected and his condition at all times appeared good.

Dr. Doffermyre advised the Board that Dr. Straughan is having and has for some years had a great deal of difficulty with his wife, who is addicted to drugs; that she is continuously in and out of institutions; that she is now at Bowman Gray; that Dr. Straughan has been advised by his physician friends to surrender his narcotic tax stamp on account of the problem with his wife. Dr. Straughan stated that his wife will take his drugs; that he has found it impossible to hide from her; that he wishes to surrender his narcotic tax stamp without prejudice. He said that he had no personal problem with drugs.

The Board instructed the secretary to write the Narcotic Bureau that Dr. John W. Straughan desired to surrender his narcotic tax stamp without prejudice to him.

RE: Dr. Franklin B. Wilkins (See previous Minutes) - Dr. Wilkins made a routine appearance before the Board. He said that he was doing well and would complete his training at Bowman Gray School of Medicine in January, 1963; that Dr. R. P. Morehead had offered him to join the staff there. The Board received a favorable report from Dr. R. P. Morehead, Professor of Pathology at Bowman Gray School of Medicine. The Board directed that Dr. Wilkins be seen in one year.

RE: Dr. J. R. Medlin (See previous Minutes) Following trial in the superior court in February, 1961, Dr. Medlin was placed on probation for five years. On June 19th, 1961, the Board ruled that it would allow him to continue the practice of medicine in the State of North Carolina, provided he continues his employment at the John Umstead Hospital under the supervision of Dr. James L. Cathell. Reports received from Dr. Cathell have been favorable. However, in May, 1962, Dr. Cathell reported to the Board that Dr. Medlin was doing good work, but that he had no insight into himself; that he had received rumors of some misconduct on his part on week-ends, which he spends at his home in Rural Hall.

Dr. Medlin requested that he be allowed to appear at this time and he appealed to the Board to allow him to return to general practice; that he is not happy at Butner. He stated that he had 2 cc of demerol administered to him by a physician for headache Thanksgiving, 1961. He denied the use of demerol since that time. He stated that he only drank alcoholic beverages socially on occasion. He said that he had gained a great deal of insight.

VERDICT: Dr. J. B. Anderson moved that Dr. J. R. Medlin be advised that he should remain at John Umstead Hospital a minimum of one year from this date. This motion was duly seconded and passed unanimously.

RE: Dr. Alton Lane Bullard (See previous Minutes) In January, 1961, following hearing Dr. Bullard's license to practice medicine was revoked, judgment suspended for a period of three years, provided he obtain employment in a state of Federal institution, remain of good behavior and not violate any state or Federal laws; obtain psychiatric therapy for such period as may be advised to by a psychiatrist, and personally report to the Board of Medical Examiners or one of its members every six months.

Dr. Raspberry reported that Dr. Bullard had been found in the Sanatorium hall with whiskey on his person; that his behavior around the town is odd; that he went to Pinebluff Sanatorium for treatment, and has returned to the Eastern Sanatorium; that Dr. Easom is not at present giving him any responsibility; that Dr. Easom would like to see him trans-

ferred to a mental hospital for supervision and work.

Dr. Bullard appeared at the request of the Board. He stated that he had been to North Carolina Memorial Hospital and Pinebluff; that he had only consumed any alcoholic beverages just prior to being admitted to both of the hospitals above referred to; that he has had considerable domestic difficulty; that he had been seeing Dr. Lee in the Mental Health Clinic.

VERDICT: Dr. E. A. Rasberry, Jr. moved that Dr. Alton Lane Bullard be advised to see Dr. Willard Lee once or twice a week and have a report at the July Board meeting as to his opinion as to his competency to practice medicine and that the Board reach a decision in July; also that we get information from Pinebluff Sanatorium and North Carolina Memorial Hospital. This motion was duly seconded and passed unanimously.

RE: Dr. S. W. Fleming, Elm City, North Carolina - Dr. Fleming appeared for a routine appearance at the request of the Board. Dr. Rasberry reported that he had been admitted to Tucker Sanatorium around Christmas; that he did not drink in Elm City, but left town; that he was very interested in getting his narcotic tax stamp reinstated. Dr. Fleming on being questioned stated that he went to Tucker Sanatorium for treatment for acute alcoholism. He stated he was doing well in his practice; that he would like to have his narcotic tax stamp reinstated.

VERDICT: Dr. Thomas W. Baker moved that the present action be continued; that recommendation not be made for reinstatement of Dr. S. W. Fleming's narcotic tax stamp. This motion was duly seconded by Dr. J. B. Anderson and passed by a vote of five to one.

RE: Dr. F. S. Kincheloe, Jr. appeared as a routine visit. Dr. Rasberry reported that he had talked with the mayor; that there are no derogatory reports; that the chief of police had asked why he worked in his office at two and three A. M. Dr. Kincheloe stated that his practice was going well; that he was doing all right without his narcotic tax stamp. The Board directed that Dr. Kincheloe be seen in six months.

The meeting was adjourned.



RE: Dr. Anne Sagberg was granted license limited to Buncombe County, North Carolina on the basis of written examination on June 19th, 1958, until citizenship obtained. She has furnished proof of citizenship and has applied for conversion of limited to full license.

VERDICT: Dr. J. B. Anderson moved that Dr. Anne Sagberg be granted full license. This motion was duly seconded and passed unanimously.

RE: Dr. Liang Yee Soo was granted license limited to Bowman Gray School of Medicine and extended to the University of North Carolina School of Medicine on the basis of written examination on June 19th, 1958, until citizenship obtained. He has furnished proof of citizenship and has applied for conversion of limited to full license. Dr. E. A. Raspberry, Jr. stated that he was doing well in Neurosurgery.

VERDICT: Dr. J. B. Anderson moved that Dr. Liang Yee Soo be granted full license. This motion was duly seconded and passed unanimously.

RE: Dr. A. E. Perry - The secretary presented a satisfactory report from Dr. Joseph L. Butler, Chief of Staff of the Good Samaritan Hospital, Charlotte, with regard to Dr. Perry under date of May 7th, 1962. This was received as information.

RE: Dr. S. A. Pope - The secretary presented a satisfactory report from the chief of police of the Town of Beulaville under date of June 9th, 1962, with regard to Dr. Pope, which was received as information.

RE: Dr. Robert Dean Phillips - To summarize Dr. Phillips was declined the privilege of taking the written examination in 1961. (See file) He has been employed as Health Director of the Johnston County Health Department. The secretary reported that Dr. Phillips came in to his office June 26th, 1962, for a conference and stated that he was getting on well in his position; that he was under the care of Dr. Wilmer C. Betts, Psychiatrist. He stated that he would prefer to wait to take the written examinations. Letter was presented from Dr. Wilmer C. Betts under date of June 8th, 1962. This was received as information.

The meeting was adjourned.

RE: Biennial Registration - Reinstatement - The licenses of the following physicians were suspended for failure to register as required by General Statutes of North Carolina 90-15.1 and have now registered:

Dr. B. O. Choate
Dr. Wallace Alexander Clyde, Jr.
Dr. Charles Douglas Maynard

VERDICT: RESOLVED that the medical licenses of the above physicians be reinstated.

RE: Dr. Wallace Alexander Clyde, Jr. was granted limited license in July, 1955 to Bowman Gray School of Medicine, where he was a resident in Pediatrics. He has been appointed to the permanent staff at the University of North Carolina School of Medicine and has applied for conversion of limited to full license. He has met the requirements of the Board. Dr. Clyde made a personal appearance at this time due to the length of time that had transpired since he had been granted limited license.

VERDICT: Dr. J. J. Combs moved that Dr. Wallace Alexander Clyde be granted full license. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Charles L. Hunsucker, Hickory, North Carolina - (See previous Minutes 1955-56) - The secretary presented from the State Bureau of Investigation under date of May 12th, 1962, advising that inspection was made of his narcotic records on May 11th, 1962; that he did not keep any records of his dispensations. That one man on interview admitted that he was addicted to narcotics and had on numerous occasions obtained morphine-sulfate from Dr. Hunsucker by pretending he had a kidney ailment.



Dr. Hunsucker continued

Dr. Hunsucker on May 29th, 1962 was requested by the secretary to appear before the Board at this meeting. On June 14th a letter was received from Dr. Glenn R. Frye that Dr. Hunsucker had suffered a cerebral vascula accident and was critically ill in the hospital there.

VERDICT: Dr. J. B. Anderson moved that this matter be postponed until further developments. This motion was duly seconded and passed unanimously.

RE: Dr. Irvin K. Bass (See previous Minutes) - Dr. Bass appeared to petition for reinstatement of his medical license, which was revoked in October, 1961.

VERDICT: Dr. J. B. Anderson moved that Dr. Irvin K. Bass appear at the October, 1962, meeting of the Board with the plan that if his behavior is good, that his license to practice medicine probably will be reinstated at that time. This motion was duly seconded by Dr. Thomas W. Baker and passed by vote of four to one, Dr. Tyner dissenting.

Minutes for the May, 1962 meeting were approved as read.

The meeting was adjourned.

Wednesday, June 20th

RE: Dr. Henry Eugene Barnes, Jr. - Report of the State Bureau of Investigation under date of May 26th, 1962, was presented stating that Dr. Barnes on investigation had admitted narcotic addiction since 1946 and that he surrendered his narcotic tax stamp, order forms and narcotics on hand.

Dr. Barnes appeared at the request of the Board. He admitted narcotic addiction and said that he takes only dolophin; that he had no narcotics on hand; that he was being treated by Dr. Glenn R. Frye of Hickory, who was administering dolphin and decreasing the amount. He said that he felt he could get off drugs in this manner. The Board advised him that it would probably be necessary for him to submit to hospital treatment, which he agreed to do, if it were necessary.

VERDICT: Dr. E. A. Rasberry, Jr. moved that Dr. Henry Eugene Barnes, Jr. be seen at the July, 1962 meeting and to invite Dr. Glenn R. Frye. This motion was duly seconded and passed unanimously.

Dr. Barnes was given the verdict of the Board; also that he should have a physical examination by Dr. David Cayer and have him submit report to the office of the secretary; that his wife should also appear with him.

RE: Dr. Humphrey Theodore Bond, colored, Henderson, North Carolina - State Bureau of Investigation report under date of May 17th, 1962 related that investigation was made on information that Dr. Bond was addicted to narcotics and furnishing drugs to an addict; that investigation did not substantiate information received.

Dr. Bond appeared at the request of the Board. He stated that he had six major operations in three years, beginning in January, 1950, as a result of automobile accident; that he had ruptured intestine; that he had a herniated disc in 1955. He said that his operations were in such succession that he voluntarily went to Lexington, where he stayed for treatment about four months; that the drug was demerol. He denied

having taken any narcotics since he went to Lexington. He denied using alcohol to excess; that he drank only beer and not over three a day. He said that he did not keep narcotics on hand, but wrote prescriptions for patients when indicated and also said that he understood how to keep narcotic records.

The Board advised him he would be kept under a surveillance and he would probably be requested to appear again in six months to a year.

RE: Dr. John A. Parrott, Kinston, North Carolina - In May, 1957 Dr. Parrott surrendered his narcotic tax stamp at the request of the Board of Medical Examiners on account of narcotic addiction. On January 10th, 1958, the Board recommended to the Narcotic Bureau that Dr. Parrott's narcotic tax stamp be reinstated.

Dr. Parrott appeared at this time and stated that he had had some trouble and desired to surrender his narcotic tax stamp and order forms; that he had no narcotics on hand. He said that he had no other source of narcotics. He advised that he had gone along all right for about three years. Upon inquiry he said he would enter an institution for treatment if necessary.

VERDICT: Dr. L. R. Doffermyre moved that the Board of Medical Examiners accept Dr. John A. Parrott's narcotic tax stamp and order blanks and that he be seen in July, 1962. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. William James Wheeler, colored, Wilmington, North Carolina - The Board of Medical Examiners was presented data from the solicitor, through the Board's attorney, that Dr. Wheeler had operated on a negro child; that this child had remained in the hospital for an excessive period of time; that the grandfather had many insurance policies on this child and had collected an exorbitant amount of insurance. A number of companies have not paid the claims.

Dr. Wheeler was requested to appear before the Board and he denied any collusion in this matter and stated that the child was abandoned there; that the family was advised when the child was ready for discharge; that they did not communicate with the hospital nor visit the child during his hospitalization.

Dr. Wheeler was advised the seriousness of collusion between a physician and a policy holder to collect insurance.

This was received as information.

The meeting was adjourned.
