 ELECTED AT PINEHURST, NORTH CAROLINA, MAY 3rd, 1950

An organization meeting of the 1950-1956 State Board of Medical Examiners was held on June 19th, 1950 at the Sir Walter Hotel, Raleigh, North Carolina, and the following members were present:
