MINUTES

Call to Order

Thomas E. Fitz, M.D., President, called this meeting to order at 9:30 p.m., Friday, June 7, 1985. Board members present included Eben Alexander, Jr., M.D.; David S. Citron, M.D.; Charles Howard Duckett, M.D.; Rose Pully, M.D.; and Mrs. Martha Walston.

Staff members present included Bryant D. Paris, Jr., Executive Secretary; Mrs. Betty Joe Barick, Assistant Executive Secretary; Don Pittman, Investigator; William H. Breeze, Jr., Investigator; Kathy Burke, Administrative Secretary; and Sibyl Lamoreaux, Secretary.

Zweig, Sherrie Elizabeth, M.D.

The Board adopted a motion that the Board of Medical Examiners not approve this physician's application to take the June, 1985, FLEX because, on the deadline, her file was incomplete. The Wake County Superior Court issued an injunction requiring the Board to permit this physician to take the June, 1985, examination in North Carolina.

Edens, Clarence, M.D.

The Board adopted a motion that Dr. Edens be requested to appear for an informal interview at the August, 1985, meeting and that, during this interview, the Board determine the continuing medical education in which Dr. Edens has participated since he surrendered his license to practice medicine in this state.

Sibert, Scott Lee, M.D.

The Board adopted a motion that the following letter be sent to Dr. Sibert.

At the June, 1985, meeting of the Board of Medical

Examiners of the State of North Carolina, the Board advised that it will not consider your request for licensure reinstatement until you have complied with the recommendations of the New Jersey Board.

The Board adopted a further motion that the Board's Work Notes indicate that Dr. Sibert should receive a new list of requirements and another application form if he re-applies for medical licensure in this state.

Frenette, Francis Flo, M.D.

The Board adopted a motion that Dr. Frenette be issued a temporary license for a period of six months limited to office practice; that Dr. Clemmons and Dr. Council furnish letters concerning Dr. Frenette's progress prior to the expiration of this temporary license; and that the Board request Dr. Frenette to appear for an informal interview prior to the expiration of this license.

Boehm, Raphael, M.D.

The Board adopted a motion that the Board of Medical Examiners approve a request to extend Dr. Boehm's license through May, 1986.

December, 1985, Meeting

The Board decided that this meeting will begin with dinner and a short meeting on Sunday night, December 1, 1985. The meeting will continue on Monday, December 2, 1985, through December 4, 1985.

The Board decided that this meeting will coincide with the meeting of the Medical Society in Asheville, North Carolina. A Board member recommended abbreviating this meeting as much as possible with an agenda including meeting with the Deans of North Carolina Medical Schools, meeting with representatives of the Physician Assistants organization, and consideration of PA and NP applications.

June, 1986, Meeting

The Board decided that this meeting will begin on Friday night, June 6, 1986, and conclude on Thursday, June 12, 1986.

Retreat

Dr. and Mrs. Duckett have invited the Board and the staff routinely attending Board meetings, to include secretarial, investigative, and the Board's attorney, to meet for a Retreat in Bath. This retreat will begin with dinner on Friday, September 13, 1985, and will conclude on Sunday afternoon, September 15, 1985.

The Board members discussed having an agenda which is not too heavy. They mentioned two documents which might be discussed: the Medical Practice Act and the Manual of Disciplinary Procedures.

Regulation Hearing

The Board adopted a motion that the Board of Medical Examiners authorize the staff to set the hearing time and date and to appoint a hearing officer once the legislature adopts the three year postgraduate training requirement so that changes can be effected as soon as possible.

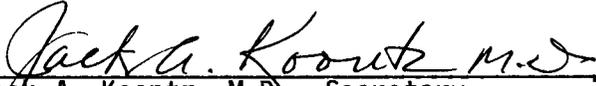
