

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Battery Park Hotel, Asheville, North Carolina

May 1-2nd, 1966

- - - - -

The Board of Medical Examiners of the State of North Carolina met at the Battery Park Hotel, Asheville, North Carolina, for the purpose of interviewing applicants for license by endorsement of credentials and special limited license and other business.

Saturday, May 1st

The Board convened for dinner and Drs. Clark Rodman, President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, Frank Edmondson, W. Boyd Owen and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present. Dr. Ralph G. Templeton was absent because of illness.

8:00 P. M.

The Board reviewed the credentials for license by endorsement of credentials and special limited license; also of foreign medical graduates who were to appear to petition to take the written examination.

RE: "Dr." Jerome Sylvers - The secretary reported that this man, who is a so-called psychoanalyst, has been under investigation by the State Bureau of Investigation because of complaints of questionable practice, and report of said investigation is at hand.

VERDICT: Dr. Joseph J. Combs moved that the Board instruct the attorney to turn over report of investigation on "Dr." Jerome Sylvers to the Attorney General for whatever action he may deem proper. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: The secretary reported that the president of the Board, Dr. Clark Rodman, attended the meeting of the National Board of Medical Examiners and that his expenses amounted to \$155.40, which he as secretary had paid.

VERDICT: Dr. James E. Davis moved that the Board of Medical Examiners approve the action of the secretary in paying expenses of the president to the meeting of the National Board of Medical Examiners. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. James Robert Howerton, formerly of Columbia, North Carolina and now residing in Virginia - (See previous Minutes) As a matter of record, Dr. Howerton admitted to taking kickbacks in drugs for a short period of time after going to Columbia, but that the practice was stopped. Dr. Clark Rodman, who is from that district stated that the Grievance Committee of the State Medical Society would write Dr. Howerton; that the local society did not wish to take any action in the matter now that he is a resident at the Medical College of Virginia.

VERDICT: Dr. H. Lee Large, Jr. moved that this report be accepted as information. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Mr. Jacek Jan Stasikowski is a third year medical student, who is an immigrant from Poland, has petition to take Part I of the written examination this year, which petition was approved.

RE: Dr. Victor Simon Constantine, who is a graduate of Duke University School of Medicine in 1961, took Part I of this Board's written examination and is an immigrant from Iran, has petitioned to take Part II of the examination, for which he was approved.

RE: Dr. Hideki Samuel Imamura, graduate of Bowman Gray School of Medicine in 1965, and an immigrant from Japan, has petitioned to take Parts I and II of the written examination this year, which petition was approved.



RE: Dr. Gordon Klintworth, immigrant from South Africa and a member of the Department of Pathology at Duke University School of Medicine, was licensed to practice medicine in this state on the basis of written examination in 1963, and given license limited geographically until citizenship obtained.

The secretary presented letter from a professor of Pathology at Duke University to Dr. H. Lee Large, Jr. setting out that Dr. Klintworth is not eligible to take the examinations of the American Board of Pathology because of the limitation of his license to practice medicine in this state and intimated that this problem lay with the American Board of Pathology, to which Dr. Large agreed in his reply.

VERDICT: Dr. James E. Davis moved that this be received as information. This motion was duly seconded by Dr. Joseph J. Combs and passed unanimously.

RE: Dr. Herbert Emanuel Malmquist, who is a graduate of a foreign medical school and an immigrant was granted limited license to Granville County following written examination as he was on the staff at John Umstead Hospital. Dr. Malmquist has now decided to move to Durham for the practice of medicine and has requested that the geographical limitation be extended to Durham County.

VERDICT: Dr. Frank Edmondson moved that the license to practice medicine of Dr. Herbert Emmanuel Malmquist be extended to Durham County, North Carolina. This motion was duly seconded and passed unanimously.

RE: Dr. Peter Paul Gebel petitioned for conversion of limited license to full license and stated that he planned to be associated in practice with Drs. Seavey and Miller in Durham in the practice of Internal Medicine and Cardiology.

VERDICT: Dr. James E. Davis moved that the limited license to practice medicine of Dr. Peter Paul Gebel be converted to full license.

RE: Dr. Bennie Brooks Ward -(See previous Minutes) - On September 16th, 1965 Dr. Ward was placed on a suspended sentence by the Board of Medical Examiners. In October, 1965 it was reported that Dr. Ward had been charged with driving under the influence and at the meeting of the Board October 15th, 1965 a decision was postponed.

The secretary submitted report from the attorney of Dr. Ward dated January 25th, 1966, that the court entered a nolle prosequi, which as he stated meant "no further prosecute". He stated that at that time Dr. Ward was meeting all his problems in a satisfactory manner.

VERDICT: Dr. James E. Davis moved that this report be accepted as information. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. Winston Arthur Young Sargent was interviewed January 14th, 1966 with regard to violation of the narcotic laws, at which time he was requested to surrender his narcotic tax stamp to the Narcotic agent.

The secretary reported that Dr. Sargent surrendered his narcotic tax stamp to the Federal Narcotic agent on February 10th, 1966.

VERDICT: Dr. H. Lee Large, Jr. moved that this report be received as information. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. Thomas O. Wheless - In June, 1960 Dr. Wheless appeared before the Board of Medical Examiners on account of his personal use of narcotics. He had surrendered his narcotic tax stamp in April, 1960 and had treatment in a private sanatorium. Dr. Wheless remained under the observation of the Board for sometime. In June, 1964, the Board approved his petition for recommendation of reinstatement of his narcotic tax stamp.

The secretary reported to the Board that Dr. Wheless came to his office on March 23rd, 1966, after having been encouraged to do so by a colleague, and admitted that he was again taking narcotics; that at that time he was advised by the secretary to surrender his narcotic tax stamp to the Federal Narcotic agent, which Dr. Wheless did on March 24th, 1966. (See file for report of interview between secretary and Dr. Wheless.)

VERDICT: Dr. H. Lee Large, Jr. moved that this report on Dr. Thomas O. Wheless be received as information; that Dr. Wheless be seen at the meeting of the Board of Medical Examiners in June, 1966. This motion was duly seconded and passed unanimously.



RE: Dr. Paul Lambrecht, graduate of the University of Louvain, Belgium, was granted special limited license to Bowman Gray School of Medicine to cover him as a resident in July, 1964. He returned to his home after one year and now has applied for reinstatement of special limited license in order to return to Bowman Gray School of Medicine on a fellowship one year and now has applied for reinstatement of special limited license in order to return to Bowman Gray School of Medicine on a fellowship.

VERDICT: The Board of Medical Examiners approved Dr. Paul Lambrecht's petition for reinstatement of special limited license on an annual basis to Bowman Gray School of Medicine, when all requirements were met. (Requirements met)

RE: Dr. Allen Henry Lee, Jr., Selma, North Carolina - The secretary presented report of the State Bureau of Investigation dated February 17th, 1966, reporting possible violation of the narcotic laws.

VERDICT: Dr. James E. Davis moved that Dr. Allen Henry Lee, Jr. be requested to appear before the Board of Medical Examiners at the June, 1966 meeting for an interview. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.

RE: Biennial Registration- Reinstatement - The license to practice medicine of the following physicians was suspended for failure to register as required by General Statutes of the State of North Carolina 90-15.00 and they have now registered:

RESOLVED THAT the medical license of the above listed physicians be reinstated.

The following special limited licenses were renewed on an annual basis.

Dr. Harry Davis Lloyd - Charlotte Memorial Hospital
 Dr. Samuel Fletcher Elder, Jr. - University of North Carolina School Medicine

RE: Endorsement of Credentials from other State Medical Boards - A discussion was held by the Board in this connection. The credentials from all state medical boards and the District of Columbia are now accepted for medical licensure in this state except Florida, Hawaii, and Alaska.

VERDICT: Dr. Joseph J. Combs moved that the North Carolina Board of Medical Examiners establish a policy of recognizing the written examination given by all medical licensing boards of the Union, the District of Columbia and Puerto and grand license by endorsement of credentials, provided the applicant meets all requirements of the Board. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

The secretary reported that Dr. Anthony Joseph DiCroce took the written examination in 1965 and failed to make a passing grade on Pathology and Bacteriology; that he has applied for New Jersey license, but is not eligible for endorsement of credentials as that board's requirement is that no grade can be under 75%. Dr. DiCroce has requested that he be allowed to repeat this examination.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. DiCroce be allowed to repeat this examination in the office of the secretary. Dr. Joseph J. Combs seconded this motion and the same was passed unanimously.

The meeting was adjourned.

The following applicants were interviewed for license by endorsement of credentials:

RE: Dr. Wilbur Oscar Brazil, Jr. appeared with incomplete credentials applying for license by endorsement of credentials. He stated that he planned to be associated with Drs. Belcher and Shook, Asheville, in the practice of Urology, as of July 1st, 1966.

- Dr. Rodman: Have you ever been convicted of a crime? A. No sir
 Q. Have you ever had any difficulty with any examining board? A. No sir
 Q. Have you ever been addicted to narcotics? A. No
 Q. Have you ever used barbiturates or alcohol to excess? A. No

VERDICT: Dr. Wilbur Oscar Brazil, Jr. was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary, within one year.

RE: Dr. Joseph Franklin Borg appeared on May 5th, 1958 applying for license by endorsement of credentials and was approved contingent upon becoming a permanent resident of the state for practice, within one year. Dr. Borg has not as yet located in the state and he has requested to appear at this time.

- Dr. Rodman: What are your plans for North Carolina?
 A. I plan to move in October, the latest the first of January. I have a home in Tryon at the present time.
 Q. Do you plan to do full-time practice there?
 A. I can not say how full-time. I will confine my work to Cardiology.

- Dr. Davis: What is your age?
 A. 69

- Dr. Rodman: Do you intend to practice by yourself or join a group?
 A. I am not certain, I will join a group or I can practice by myself.

- Q. You have a house and have made your plans to practice?
 A. Yes

- Dr. Combs: If you do not join a group, will you open an office for the practice of medicine?
 A. That is what I plan to do. It depends upon my situation, I have group, three practice together. I have a family in North Carolina urging me to come and many good friends. That is my reason for coming. I am going to be retiring from the faculty of the University of Minnesota in another year and I think this is a good time to come to North Carolina to make my home.

- Dr. Large: When is your retirement?
 A. June of next year.

- Q. Do you plan to move before or after you retire?
 A. I am planning to move before that because my activity at the University is only part-time, very flexible, matter of teaching. My residence is in St. Paul and we take students to St. Paul and teach besides. Most of the teaching there is done by full-time men now. In years past I have lectured, I am a member of the College of Physicians. I am planning to do very little in the way of teaching after this quarter. I think after July 1st my plans will be such I can make a move almost anytime after that.

- Q. It might be well to advise the Board gives license when the doctor arrives, within one year.
 A. That I am acquainted with.

- Dr. Rodman: Have you ever had any difficulty with any medical examining board? A. No
 Q. Have you ever been convicted of a crime? A. No sir
 Q. Have you ever had any difficulty with barbiturates or alcohol? A. No sir
 Q. Have you ever been addicted to narcotics? A. No sir

- Q. This will constitute your re-appearance and we will let you hear from us.

VERDICT: Dr. James E. Davis moved that Dr. Joseph Franklin Borg be approved for license by endorsement of credentials, if and when he moves to North Carolina to set up practice, within one year. This motion was duly seconded and passed unanimously.

RE: Dr. Nathan Leslie Burkhardt, Jr. appeared applying for license by endorsement of credentials. He plans to locate in Asheville July 1st, 1966, for the practice of Orthopaedics.

Dr. Rodman: Where have you been since 1960?

A. Grady four years, in service two years.

Q. Are you out of service?

A. I will be June 30th.

Q. Are you going to do solo practice or group?

A. I am going with Drs. Watts, Montgomery and Callison.

Dr. Combs: Have definite arrangements been made with this firm to begin July 1st.

A. Yes

Dr. Rodman: Have you ever had any difficulty with an examining board in medicine? A. No

Q. Have you ever been convicted of a crime? A. No sir

Q. Have you ever been addicted to narcotics? A. No sir

Q. Have you ever had any trouble with barbiturates or alcohol? A. No sir

VERDICT: Dr. Nathan Leslie Burkhardt was approved for license by endorsement of credentials.

RE: Dr. Philip E. Christopher appeared with incomplete credentials applying for license by endorsement of credentials. He is a native of Asheville and will enter into partnership, to do surgery, with Dr. Glenn R. Frye of Hickory, July 1st, 1966.

Dr. Rodman: When will you start?

A. The second week in July.

Dr. Davis: What type of practice?

A. General Surgery

Dr. Rodman: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any difficulty with an examining board in medicine? A. No sir

Q. Have you ever been addicted to narcotics? A. No sir

Q. Have you ever had any difficulty with barbiturates or alcohol? A. No sir

VERDICT: Dr. Philip E. Christopher was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Joseph Homer Dimon III appeared applying for license by endorsement of credentials.

Dr. Rodman: What are your plans for practice?

A. I am practicing in Atlanta. I do not have specific plans to practice in North Carolina. We will be doing Orthopaedics with the Falcons. They will be training in Asheville and I hope I will be here some of the time.

Q. This Board does not look with favor on physicians getting license who are not planning to practice.

Q. I do not know how much we will come. One of the partners is a North Carolina boy and he has a license. I would like to feel free to come and have it above board.

Dr. Davis: This would be the only time you would anticipate using North Carolina license when the Falcons are here?

A. The only other time, I was asked to come to be a doctor for a week. My son goes to Camp Seagull. They are the only two reasons.

Dr. Rodman: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any difficulty with an examining board in medicine? A. No sir

Q. Have you ever been addicted to narcotics? A. No sir

Q. Have you ever had any difficulty with barbiturates or alcohol? A. No sir

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Joseph Homer Dimon III be granted license limited to Buncombe County, the county in which the Falcons are to train. This motion was duly seconded by Dr. Frank Edmondson and passed by a vote of four in favor, two against.



RE: Dr. Roger Lee Engelbert appeared applying for license by endorsement of credentials and stated that he planned to locate at Mountain Sanatorium, Fletcher.

Dr. Rodman: What will you be doing there?

A. General practice with a group of two, Drs. Moore and Pearson.

Q. When do you want to go to work?

A. The last week in May.

Dr. Edmondson: How much arrangement has been made insofar as going to work. Do you have a home?

A. I leased a home yesterday and made a deposit. Dr. Joyner was killed in an accident and his office has been setting empty.

Dr. Rodman: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any difficulty with any examining board in medicine? A. No sir

Q. Have you ever been addicted to narcotics? A. No

Q. Have you ever used barbiturates or alcohol to excess? A. No sir

VERDICT: Dr. Roger Lee Engelbert was approved for license by endorsement of credentials.

RE: Dr. Luther George Bell appeared applying for license by endorsement of credentials in order that he may do industrial medicine in Laurinburg.

Dr. Rodman: Where have you practiced most recently?

A. I spent 30 years in the Navy, got out and did Surgery for the California Youth Authority five years. For family and personal reasons I came back (native of South Carolina).

Dr. Rodman: When were you separated from the Navy?

A. 1961

Q. Is your field Surgery?

A. Yes, I am a board diplomate.

Dr. Edmondson: What will be your position?

A. I won't be practicing medicine in the strictest sense of the word. We will be trying to keep as many people in as many positions as possible. Injuries will be taken care of. We will refer most everything to the private physician.

Q. Will you be employed by an industrial group?

A. Springs Cotton Mill.

Q. Will there be any other physician, will you do any other work than industrial?

A. No, there are six plants including the parent plant. We will have first aid stations manned by a nurse. These people have never had an industrial physician.

Q. How are they taken care of at the present time in this area?

A. Local, first aid, anything referred went out in town to the family physician.

Dr. Rodman: Have you ever been convicted of a crime? A. No sir

Q. Have you ever been had any difficulty with any examining board in medicine? A. No

Q. When do you want to go to work?

A. Wednesday morning

Q. We have information that you were in a hospital for a little while.

A. I went in on my own initiative. I had a little trouble with my wife. I stayed in there until I came here.

Q. What was the diagnosis?

A. I never had a diagnosis so far as I know. I told Dr. Tate. I was in communication with Dr. Tate in December.

Dr. Large: Are your difficulties resolved?

A. I am divorced. I am living at Banner Elk. I took residence there in February.

Dr. Rodman: Have you ever been convicted of a crime? A. I never have.

Q. When will you finish training?

A. One year from now, perhaps Uncle Sam may interfere.

VERDICT: Dr. Gilbert Silverman was approved to take the written examination for licensure.

VERDICT: Dr. Gittfried R. Kaestner was approved to take the written examination for licensure, to be limited geographically until citizenship obtained, within six years.

RE: Dr. Johannes Kylstra, graduate of the University of Leiden, The Netherlands, in 1952, appeared applying to take the written examination. He has been given the position of assistant professor of Medicine and Physiology. He presented immigrant card.

Dr. Davis: How long have you been at Duke?

A. Nine months

Q. What are your duties there, any clinical?

A. Yes, in the Pulmonary Clinic.

Q. You see patientd there?

A. Yes

Q. You have no license to treat.

A. No

Q. Does this concern you ?

A. Yes, it does, I think one should have a license.

Q. This Board feels that you should have had a license when you first got there.

A. May I say I did not until I got the certificate of the ECFMG.



Dr. Kylstra continued

Dr. Davis: You have been treating patients a couple of months?

A. That is right.

Q. What are your ultimate plans?

A. My plans are not to go out and practice, but continue my academic career.

Q. At Duke?

A. For the time being.

Dr. Rodman: This is a violation of the law of the State of North Carolina for you to take care of patients regardless of the ECFMG and I would suggest that you stop that immediately until such time you have license.

A. Yes, I did not realize, I was informed by the hospital authorities, they told me the ECFMG certificate gave me the right to see patients.

Dr. Davis: Who was this, you say the hospital? Dr. Stead did not tell you, I am sure.

A. Yes, immediately when I got this certificate I notified Dr. Stead.

Q. He said this gave you regular license?

A. It was my understanding he said this gave me authority to work in the hospital.

Dr. Large: Do you write orders prescribing for patients?

A. No, I primarily am not involved, in Hyperbaric chamber. I supervise the fellows working there.

Dr. Rodman: You are open to liability suits.

VERDICT: Dr. James E. Davis moved that Dr. Johannes Kylstra was approved to take the written examination for licensure, to be limited geographically until citizenship obtained, within six years, and that Dr. Eugene A. RE: Dr. Edwin Sims Mize, Jr. - Dr. Mize first came to the attention of the Board when he came to the office of the secretary on December 23rd, 1964 and stated that he had taken demerol, for which he was hospitalized the month before; that he was then under the care of a psychiatrist. At that time he agreed to surrender his narcotic tax stamp to the Federal Narcotic Agent, which he did on December 28th, 1964. He was requested to appear for an interview before the Board at its May, 1965, meeting, but at that time was a patient at the United States Public Health Service Hospital.

Dr. Mize appeared at this time at his request and stated that he wanted to convey his thanks to the Board of Medical Examiners for its consideration; that he was practicing in Charlotte; that he had profited by his experience; that he had had no drugs from November, 1964 to April, 1965 prior to his admission. He said he was taking no drugs of any kind and alcohol was no problem. Dr. Mize's attorney appeared with him as a friend and confirmed his statements.

Dr. Mize was commended by the Board and advised that he would have to continue to guard against this problem.

RE: Dr. Richard Robert Henderson was granted limited license to the University of North Carolina School of Medicine to cover him as a resident in Dermatology. He appeared at this time to request conversion of limited to full license in order that he might practice for Dr. Thomas Cheek in Smithfield while he is on a trip to Europe.

Dr. Rodman: Where are you in residency now?

A. Chapel Hill

Q. You have two more years?

A. Yes, I had one year in Medicine, went in service two years, now in Dermatology.

Dr. Owen: What did you do in service?

A. Internal Medicine

Dr. Rodman: You contemplate covering for Dr. Cheek, is that vacation?

A. Yes, if I could.

Q. Does your chief know it?

A. He knows and is in agreement.

Q. Does he feel this will be any benefit other than financial?

A. I think so, of course, it will supplement the income.

Q. From training point?

A. I do not know, practice primarily Internal Medicine. Actually I consider it experience as well as helping out financially.

Dr. Davis: Would you do any Obstetrics?

A. None at all, strictly Internal Medicine, no Pediatrics, no Obstetrics.

Dr. Rodman: Staff privileges?

A. That has been arranged. I have visited on two or three occasions at the hospital.

Q. Staff privileges extended by local staff?

A. Yes

Dr. Combs: Has Dr. Cheek left yet?

A. One of the residents is taking two weeks and I two weeks.

Q. Does that resident have a license?

A. Yes



Dr. Henderson continued

Dr. Rodman: Have you made long range plans as far as North Carolina is concerned?

A. Yes, I can not say 100%, but when I finish my residency my wife and I think we will stay in North Carolina. We have thought of Greenville, have talked to a doctor there, tentative plans.

Dr. Large: When did you start working on this plan?

A. Four-five months ago, actually I had this in mind and Dr. Warren, one of the instructors, had been talking to some of the residents and I was told Dr. Cheek was looking for someone to cover the practice. Once it was agreeable I wrote Dr. Combs.

VERDICT: Dr. James E. Davis moved that the limited license of Dr. Richard Robert Henderson be converted to full license upon payment of balance of fee due. This motion was duly seconded and passed unanimously.

RE: Dr. William Cleveland McAfee was granted limited license to Duke University School of Medicine July 26th, 1963. He appeared at this time to request conversion of limited to full license in order that he might practice for Dr. Emmett Lupton in Greensboro while he is on a trip to Europe.

Dr. Rodman: You are presently a resident in Dermatology at Duke?

A. Yes

Q. You want to cover for Dr. Lupton in Greensboro while he is in Europe?

A. Yes

Q. How long?

A. Three weeks

Q. Vacation time?

A. Yes

Q. This is all the time you have for the year?

A. Yes

Q. Do you feel this will be of any value other than financial?

A. Yes, definitely so.

Q. He is a Dermatologist?

A. Yes

Dr. Combs: When you will complete your residency?

A. June 30th this year

Q. Where do you plan to practice?

A. I have three offers, I am waiting, two in Greensboro, one in Tennessee.

Dr. Edmondson: Is there some possibility you might go in with Dr. Lupton?

A. He has made an offer and so has Dr. Barefoot and a General Practitioner in Tennessee.

Dr. Combs: Do you have license in Tennessee?

A. Yes, this is home.

VERDICT: Dr. James Davis moved that the limited license of Dr. William Cleveland McAfee be converted to full license upon payment of balance of fee due. This motion is duly seconded and passed unanimously.

RE: Dr. Numa Richardson Carter, Shelby, North Carolina - The Board received report from the Pharmacy Board alleging excessive writing of narcotic prescriptions by Dr. Carter and he was, therefore, requested to appear for an interview.

A colleague of Dr. Carter's came in and stated that Dr. Carter had inherited these patients from former physicians and had been acting in good faith; that he had been diligent, conscientious, had excellent relationship with his family, community and physicians; that as far as he knew the other doctors were one hundred per cent behind him.


Dr. Carter stated that he had attempted to treat patients who were addicts when he acquired them. He was told by the Board that he should acquaint himself with both Federal and state Narcotic Laws and report any patients for whom he is prescribing large amounts of narcotics to the State Board of Health; that the course had been following might lead to criminal prosecution.



RE: Dr. Grayson Waldrop appeared and requested that the Board reinstate his license, which was revoked on January 11th, 1964. He now has a special limited license to cover his work at Broughton Hospital. The Board declined to reinstate Dr. Waldrop's license at this time.

The Minutes of the January 13-15th, 1966 meeting were approved as read.
