

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Carolina Hotel, Pinehurst, North Carolina

May 16 - 17, 1971

- - - -

The Board of Medical Examiners of the State of North Carolina met at the Carolina Hotel, Pinehurst, North Carolina, May 16-17, 1971, for the purpose of interviewing applications for license by endorsement of credentials and for other business.

Sunday, May 16th

6:00 P. M. - The Board convened for dinner. Drs. H. Lee Large, Jr., President, Joseph J. Combs, Secretary-Treasurer, Frank Edmondson, Bryant L. Galusha, Joseph W. Hooper, Jr., Cornelius T. Partrick, William H. Sprunt III, Mrs. Louise J. McNeill, Administrative Secretary, and Mrs. Betty Joe Cooke were present.

The members of the Board reviewed credentials for license by endorsement of credentials.

RE: Dr. Neil Raymond Nason appeared before the Board of Medical Examiners March 20th, 1971, with incomplete credentials and was approved if and when his credentials were completed satisfactory to the secretary. Dr. Nason did not submit sufficient character references and his check to cover fee was returned for insufficient funds.

VERDICT: Dr. Frank Edmondson moved that Dr. Neil Raymond Nason be denied license by endorsement of credentials until further information procured and credentials completed. This motion was duly seconded and passed.

RE: Minutes March, 1971 meeting were approved as read. The president directed that a review be made of the notes on Dr. David Allen Fredstrom, page 291, with regard to the narcotic question. (This correction was made.) The president also directed that cross index be made for correction of Minutes on pages 259 and 283, which has been done.

RE: Resignation of Dr. William H. Sprunt III, member of the Board of Medical Examiners - The following letter of March 30th, 1971, from Dr. Sprunt to Dr. H. Lee Large, Jr., President of the Board, was read:

"You received a copy of my request for resignation from the Board to Louis Shaffner. Joe Combs phoned today and said that I should have written you. Apologies. I don't even know how to resign properly.

"Please accept my resignation. I find that I am not willing to give the required time to the Board and that I lack the interest, temperament and philosophy for such work. Will serve until November, or until after the June examination, whichever is most convenient.

"I regret the inconvenience my action causes the Board, but I believe this action is in the best interests of all."

VERDICT: Dr. Joseph W. Hooper, Jr. moved that the request of Dr. William H. Sprunt III to be relieved of his duties and his resignation be accepted after the June, 1971 examination and those grades are certified. This motion was duly seconded by Dr. Cornelius T. Partrick and passed.

RE: December, 1971 meeting - Dr. Joseph J. Combs moved that the examination and interview of applicants for the December, 1971 meeting be held in the building of the North Carolina Medical Society. This motion was duly seconded by Dr. Bryant L. Galusha and passed.



RE: New Regulations Narcotic Bureau and Dangerous Drugs - The new regulations were discussed with regard to practicing physicians without narcotic license. The secretary advised the Board that he had reviewed the same with Special Agent James W. Madden and he had stated that physicians could apply for NBDD stamp for separate categories.

RE; Dr. William Arthur Young Sargent, Burnsville, North Carolina - On February 10th, 1966, Dr. Sargent surrendered his narcotic tax stamp as per the request of the Board of Medical Examiners due to the fact that he had become involved in prescribing narcotics for addicts. The secretary this date presented to the Board letter under date of May 10th, 1971, from Dr. Garland W. Wampler, President of the Mitchell-Yancey County Medical Society, as follows:

"It is with deep concern that I write you, the Examiners Board of the State of North Carolina, about the above named physician. Dr. Sargent is dedicated, christian physician, who has always worked long hard hours providing medical care to the people of Yancey County for the last 15 years. He has always provided care to the needy indigent people regardless of their financial status and without any selfish motives. It is my feeling that any previous errors on his part were never planned. It was somehow a complete lack of comprehension at the time that he was jeopardized by the out of county and out of state federal offenders of the drug laws.

"As a fellow citizen of Yancey County and an associated family physician of the same area I feel that no purposeful neglect or knowledgeable oversight on his part was committed. There is a dire need to have more physicians in our area to render care to the needful mountain folks. Dr. Sargent has always been a civic minded community leader in the community of Burnsville and still is same. However with the absence of his license and with the oncoming new narcotic laws that are now being passed (presently enforced as of May 1), his working capacity will be greatly retarded. It is my strong feeling that consideration should be given to the return of his narcotic license in the near future in order for him to continue to render service as a Family Physician of Yancey County."

VERDICT: Dr. Joseph W. Hooper, Jr. moved that Dr. Garland E. Wampler be advised that if Dr. W. A. Y. Sargent applies under the new narcotic law, the Board will endorse his receiving approval of drugs under classification 3, 4 and 5. This motion was duly seconded by Dr. Bryant L. Galusha and passed.

RE: Reports on Physicians - Dr. Cornelius T. Partrick moved that henceforth files on cases with reports be copied and sent to each member of the Board for consideration prior to the meeting in order to make better decisions. There was a vote of three in favor and the minority vote carried.

The meeting was adjourned.

Monday, May 17th
9:00 A. M. - The following physicians were interviewed for license by endorsement of credentials.

RE: Dr. Ernest Maxey Abernathy appeared applying for license by endorsement of credentials. He is a resident in the Department of Radiology, applying for full license.

Dr. Large: Have you ever had any difficulty with a medical examining board? A. No sir

RE: Dr. John H. Thompson, Trenton, North Carolina, appeared at the request of the Board of Medical Examiners, which request was made subsequent to report from the Department of Social Services alleging over utilization of the drug program by Dr. Thompson and discrepancies. It was also alleged that using the percentage base determined by a month's overcharge, the amount of overcharges to the agency was \$18,052.90, which Dr. Thompson refunded; also frequently there was no registry number on his narcotic prescriptions.

Dr. Thompson stated that there is no pharmacy in Jones County and that he had dispensed drugs ever since he went there to practice; that if the drug bills were high he lowered his fee; that for Social Service prescriptions, if he wrote the same for non-legend drugs his clerk changed to legend drugs so he would be paid. He said he was audited, the auditors took a month and estimated that as a basis and fined him 15% of everything he had been paid. He was told that there would be no further action if he would refund the \$18,000, which they estimated he had been overpaid. He stated that he did not feel that he had been treated fairly, but wanted to get it settled. He did not have legal counsel.

VERDICT: Dr. Frank Edmondson moved that this Board table any action on this case until the August, 1971 meeting and see if the Attorney General pursues the evidence that has been submitted to them by the State Bureau of Investigation. This motion was duly seconded by Dr. Joseph W. Hooper, Jr. and passed.

RE: Membership on the Board of Medical Examiners - Dr. Bryant L. Galusha moved that Dr. Vernon Williams Taylor, Jr. Be appointed to fill the vacancy created



by the resignation of Dr. William H. Sprunt III, effective at the termination of the August, 1971 meeting of the Board. This motion was duly seconded and motion carried.

RE: Dr. William Alton Moody appeared at the request of the Board. He stated that he stopped practicing in October because of taking drugs; that he started orally, then intramuscularly, then intravenously. He said he had been to Chapel Hill to the hospital and requested that the report be sent (not received at this time), then Cherry Hospital; that he is under the care of Dr. Walter P. Savage, Director of the Coastal Plain Mental Health Clinic; that he had at one time had suicidal idea. He said he is only on probanthin now; that he has made some inquiries about procuring a job..

VERDICT: Dr. Frank Edmondson moved that the Board recommend to Dr. William Alton Moody to try to find employment either with the Veterans Administration, state institution or emergency room or some sheltered position; that the Board go on record not to extend his narcotic tax stamp to hard narcotics; that it be limited to categories 3, 4 and 5; that he be seen at regular intervals of three to six months. This motion was duly seconded and passed.
