The May 1993 meeting of the North Carolina Board of Medical Examiners was held at Embassy Suites, Creedmoor Road, Raleigh, North Carolina. The meeting was called to order at 7:30 p.m. May 19, 1993, by Nicholas E. Stratas, M.D., President. Board members in attendance were: Dr. Stratas, Dr. Nance, Dr. Roufail, Mrs. Willis, Dr. Spangler, Dr. Barrett, Dr. Godwin and Dr. Johnson.

MINUTES - March 1993 meeting

The first order of business was the adoption of the minutes from the March 1993 meeting of the Board. The Board adopted a motion made by Dr. Johnson and seconded by Dr. Spangler to approve the minutes as presented with no corrections.

EXECUTIVE SECRETARY'S REPORT

Mr. Paris reported that Dr. Stratas, Dr. Barrett, Ms. Meelheim and himself attended the Annual Federation meeting in San Francisco which was held April 21 - 24, 1993. The by-laws of the Federation were amended to permit one staff person to be appointed as a Designated Associate member. As a result, the Board adopted a motion made by Dr. Nance and seconded by Dr. Barrett to appoint Mr. Paris as the Designated Associate Member. If he is unable to attend the Assistant Executive Secretary or any other staff person may be appointed.

Mr. Paris also reported that the Investigative staff attended workshops in San Francisco regarding quality of care cases and sexual misconduct cases.

Mr. William Breeze reported on the status of the Legislative bills and continues to keep the Board members updated with weekly status reports.

Mr. Paris reported that the USMLE rules have been filed as a result of the Public Hearing. It was also reported that the PA Rule Hearing will be rescheduled after the PA Rule Task Force makes its recommendations.

A final draft of the proposed rule changes for Sections .0801, .0802, .0803, .0804, .0805, .0806, .0807, and .0808 were presented. Also, submitted was an additional proposal from Dr. Snyderman. As a result the Board adopted a motion made by Dr. Johnson and seconded by Dr. Godwin to affirm the regulations as presented to the Board contingent on approval by each of the Deans.

Mr. Paris also went over the process for amending rules for clarification.

Mr. Paris reported that following changes in office personnel:

1. Julie Suggs has resigned
2. Alan Evans was hired as an investigator for Central NC
3. Terresa Wrenn transferred from receptionist to PA/NP Coordinator
4. Anne Goding was hired for the receptionist in a temp to perm position.
5. Bill Breeze is now staff counsel and reports to Mr. Paris.

Mr. Paris reported that staff meetings are being held monthly with the following topics to be addressed:

April	Educational program - using the modem data connection to main data base
May	EEOC - Shirley Quarles - to discuss impermissible discrimination pertaining to race, sex, age and disability
June	CPR/BLS training for all staff

The BME employee manual was recently updated and a copy was available for Board members review during the meeting.

It was reported that the Hardware for the Board's new computer system was installed and working well. The WANG equipment will be disposed of through the NC State Surplus. Additionally, it was reported that the customizing and data conversions are complete. Temporary help will be hired to complete the data base designed by the staff. Also, accounting software, is to be added no later than the end of the fiscal year.

Mr. Paris also reported that a new chart of accounts has been developed to provide more detail, financial statements have been mailed and investments timetables for maturation of TBills and CD's are available at the Board's office. Budget requests for fiscal year 1994 were presented at the Administrative Committee meeting - Board member's request are to be submitted this month, balance sheets from month end are being mailed to all Board members. An example of the reimbursement form was presented. Additionally, Mr. Paris reported that the Board members will be invoiced for all non-reimbursable expenses. At the instruction of the CPA these amounts will not be deducted from amounts owed. Payment for interviews is being processed by receipt of interview sheets. All Board members were encouraged to make sure they submit all interview sheets to insure proper payment.

Mr. Paris reported that the files have been centralized and combined. The purchasing procedure have been updated to allow for more accountability and to reduce costs.

Mr. Paris reported that the Licensure department has relocated within the building. Additionally, a Licensing Assistant I position was created and Michelle Lee was transferred into the position from the receptionist position.

The Fiscal Year 1992 statistical report was presented as well as a draft of the proposed bulletin. Mr. Paris reported that the information brochure has been ordered. Also, the that the roster has been targeted for publication in May 1994.

The issue of Board Leadership Continuity was addressed and letters from George Johnson, M.D. and Mary Williams, as well as a memo from Mr. Paris regarding this issue were presented. As a result, Dr. Stratas recommended that this topic would be worthy of an 1 or 1 1/2 hour discussion of the Board on a future agenda.

The Board adopted a motion made by Dr. Roufail and seconded by Dr. Spangler that the staff identify what quality assurance parameters the Board has available. The staff is to develop a system to improve the Board's quality assurance.

The Charge to the PA Task Force is as follows:

The PA Task Force has been charged with developing rules which will govern the approval to practice and rules for the monitoring of PA's, to be approved by the Board of Medical Examiners. The goal of this rule making is to assure that the citizens of North Carolina receive quality health care from PA's approved for practice in North Carolina by providing proper guidelines for granting approval and the ongoing monitoring of practice standards.

Care should be taken to assure that the rules are comprehensive and understandable as well as easily applied in all circumstances.

The Task Force should complete its study and have a finished set of rules no later than November 1, 1993 which then can be processed according to the North Carolina Administrative Procedures Act.

MISCELLANEOUS

Dr. Barrett recommended that the Board's name should be changed to reflect what it really does. It was suggested that the Board name might be NC Medical Board. As a result, the Board adopted a motion made by Dr. Johnson and seconded by Dr. Godwin to turn the issue over to the staff for research and proposal brought back at the 7/93 meeting for review.

The Board adopted a motion made by Dr. Spangler and seconded by Dr. Roufail that the Board as a whole to be a Legislative Committee with an appointed member of the Board to work with the Legislative person of the staff.

ADMINISTRATIVE COMMITTEE

The Administrative Committee met on May 7, 1993, 10:00 a.m., at the Board's office. Present were Ernest Spangler, M.D., Chairman, John Nance, M.D., Kathryn Willis (via phone), Walter Roufail, M.D. (via phone at 11:00 a.m.), Bryant D. Paris, Jr., and Diane Meelheim.

The following information was discussed and presented to the Board on May 20, 1993, for approval:

Dr. Spangler reported that a designated portion of the class room in the Board's office is being used as a library for use by Board members and staff. The materials will be kept up to date by a staff person who will have knowledge of what books are available.

Fax machines are to be purchased for Mrs. Willis and Dr Roufail for Board business.

Items addressed at the Board's Retreat will be updated at each meeting with a time line and completion dates. Additions of other issues identified by the Board will be added as necessary.

The Committee recommended that Dr, Stratas and Mr. Paris meet with Mary Williams and bring recommendations back before the Board regarding her audit of the Board.

A projected budget for the next three years was presented. Projections were made with a registration fee increase and without the increase.

Concern was expressed regarding the excessive amount being paid to the Board's CPA for monthly reviews. Diane Meelheim is contacting other CPA's to obtain more sufficient support.

It was reported that auto insurance is through Georgia Pacific and the Board has a fleet rate.

Dr. Spangler questioned if the Board pays for meals when a Board member is on the road. The Board does and is in compliance with IRS and the State Budget manual regarding meals. The staff has been given very strict guidelines to follow.

Diane Meelheim reported that the BOARD EXPENSES - OTHER category will include miscellaneous expenses such as Mary Williams' consulting fees. Also regarding BOARD EXPENSES - MEETING ROOMS AND FOOD that the Board spends approximately \$15,000 per Board meeting. This includes individual rooms, meeting rooms, set-ups, etc. Additionally, that OFFICE INSURANCE is called Errors and Omissions and covers both the Board and staff for up to a million dollars per incident.

MALPRACTICE COMMITTEE

The Malpractice Committee chaired by Dr. Spangler and including Mrs. Willis and Dr. Barrett reported on 48 malpractice reports. A written report was presented for the Board's review. After discussion the Board adopted the Committee's motion to approve the written report.

COMPLAINT COMMITTEE

The September 1993 meeting of the North Carolina Board of Medical Examiners was held at the Embassy Suites, 4700 Creedmoor Road, Raleigh, North Carolina. The meeting was called to order at 7:30 p.m., July 28, 1993, by Nicholas E. Stratas, M.D., President. Board members in attendance were: Dr. Stratas, John W. Nance, M.D., President-Elect; Ernest B. Spangler, M.D., Secretary-Treasurer; Walter M. Roufail, M.D.; Mrs. Kathryn H. Willis, George C. Barrett, M.D.; Harold H. Godwin, M.D.; and George Johnson, M.D. Charles Trado, M.D. was also present in preparation for his anticipated appointment to the Board.

Minutes - July 1993 meeting

The first order of business was the adoption of the minutes from the July 1993 meeting of the Board. The Board adopted a motion made by Dr. Roufail and seconded by Dr. Godwin to approve the minutes as presented with the correction on page 2 adding that the brochure will also be sent with the application and deleting "a memo from the staff which will include who the letters of recommendation are from."

EXECUTIVE SECRETARY'S REPORT

Bryant D. Paris, Jr., Executive Secretary, reported the following items to the Board:

Director continue to meet each Monday morning at 9:00 a.m. A copy of the minutes from these meetings was presented for review. Also presented was a quality assurance chart which outline areas identified by the Director of each department.

In response to the Inspector General's Report, Approaches to Quality of Care Cases, a chart was presented which identified the items which North Carolina does in comparison to other State Boards. The Board instructed the staff to identify the areas which the North Carolina Board does not address. The areas identified will be presented as an agenda item for the Board to determine which areas it may wish to implement.

Mr. Paris presented a proposal from the staff regarding an in-house attorney and areas identified by the staff to fund this position. A motion made by Dr. Roufail and seconded by Mrs. Willis instructing the staff to develop a detailed job description and salary range for the proposed position was adopted by the Board. The job description will be presented to Mr. Weddington to see if his law firm may be able to provide support as described in the job description. Additionally, the position will be advertised.

Mr. Paris reported that he had been conducting on-going conversations with the NC Hospital Association to determine whether or not the Hospital Association could develop a system for hospitals to verify doctors' licensure status through data that the Board of Medical Examiners would supply to the Hospital Association, thereby relieving the volumes of requests from the various hospitals to verify the licensure status of physicians. Some requests require that the staff verify the physicians license number, date of licensure, etc. Some require that the staff indicate only that the physician is licensed and currently registered. Some physicians are verified by telephone. In order to relieve pressure at the switchboard, the verification of three

names at a time has been allowed. The Board receives an average of 750 verification requests each week from: (within NC) - County Medical Societies, Health Departments, media, medical liability insurance companies, health insurance companies, Medicaid programs, other health related Boards, DEA and the general public. (outside of NC) -National medical organizations, various specialty boards, state licensing board, liability insurance companies, hospitals, health insurance companies and the general public. The staff was instructed to generate information in whatever manner best works for the office and to charge accordingly.

Mr. Paris presented a draft of the following position statements for review by the Board: Fee Splitting, Access to Physician Records, and How to Close a Practice. These items will be put on the November agenda for action by the Board.

Mr. Paris reported that Senate Bill 422 establishing an Acupuncture Board, passed during the recent Legislative Session. As a result, the Board adopted a motion made by Dr. Godwin and seconded by Dr. Nance to rescind the Board present position on acupuncture.

At the request of Dr. Stratas, Mr. Paris presented the Washington State Sexual Misconduct Policy and the AMA 1992 Ethical position, for the Board's information.

At a previous meeting, there was some discussion regarding the Board's access to Peer Review information. As a result, Mr. Paris made available copies of the signed Memorandum of Understanding between Medical Review of North Carolina, Inc. and the North Carolina Board of Medical Examiners, for the Board's information.

POST GRADUATE TRAINING REQUIREMENT

The Board discussed issues raised as a result of an inquiry made of the deans from the major Medical schools, by the Board, requesting their views on requiring more than one year of training prior to granting a license. The Deans were not in favor of the change. The Board will revisit this issue in one year.

STATE HEALTH DEPARTMENT

Thad Wester, M.D., of the State Health Department met with the Board at its July 1993 meeting to discuss the issue of health care providers with the HIV virus. As a result of that meeting, Dr. Wester submitted information regarding who may report an infected health care worker, contents of the report from the Task Force and the State Health Departments authority to report this information of other State Health Departments.

INVESTIGATIVE SEMINAR FOLLOW-UP

As a follow-up to the Investigative Seminar attended by the Investigators, a report was submitted which identified the following areas of interest: Quality of Care vs. Quality of Service; Key to winning Quality of Care Case; Medical Record Acquisition; Experts Report; Sexual Misconduct Case; and After Obtaining Patient Record from MD. This report was accept as information and no further action was taken. Tapes of the meeting were available for Board members and staff.

NOTIFICATION TO OTHER STATES WHEN PHYSICIAN MOVES OUT OF THE STATE DURING AN INVESTIGATION - PROCEDURAL POLICY

The Staff recommended that the following policy be implemented:
Any physician who is or has been under investigation and is known to have relocated to another state may be reported to that State's Medical Board. Determination of whether to report will be made in conference

with at least 2 of the following: Director of Investigative Department, Executive Secretary, or Board Member. If reported, Gen.Stat. 90-14(d) will be followed. The Board adopted a motion made by Dr. Godwin and seconded by Dr. Barrett to approve the recommendation of the staff.

FELLOWSHIP REVIEW

The Board reviewed a letter from Dr. Bob Rollins requesting that the Board consider allowing Bruce Welch, M.D., to attend and observe the Board's meetings. The Board adopted a motion made by Dr. Roufail and seconded by Dr. Godwin that the Board will look at the application of Bruce Welch, M.D. as a trainee for the year of 1994 provided clearance is given by the legal counsel. Dr. Rollins and Dr. Trado are to prepare a proposal which provides some structure for this request.

RECORDING PHYSICIAN'S AREA OF PRACTICE OR SPECIALTY

The Board adopted a motion made by Dr. Nance and seconded by Dr. Roufail to ask the following information regarding specialties (primary and secondary) on the upcoming doctor registration:

INVESTIGATIVE COMMITTEE

Dr. Stratas recommended that the Board consider appointing an Investigative Committee like the Oregon board to handle complaints, malpractice, hospital reports, informal interviews and investigative reports. The Board adopted a motion made by Dr. Barrett and seconded by Dr. Roufail to have the staff develop a proposal to be presented to the Board for consideration.

The Administrative Committee is to work with Mr. Paris to obtain a management consultant.

REVISED APPLICATIONS FOR RESIDENTS

A draft of a proposed application package which will be typeset, printed and provided to the house staff offices of the teaching universities was provided for information. Recommendations from the Board members were encouraged.

DIRECT PAYMENT OF PHYSICIAN EXTENDERS

Dr. Spangler raised concerns regarding direct payment to physician extenders and physician extenders owning a corporation. Dr. Spangler and Dr. Godwin were appointed to form an ad hoc committee to develop a position paper for the Board on the financial relationship of physician extenders with their patients and their contractors.

DISABILITY INSURANCE

Ms. Meelheim gave a description of the disability plan proposed for purchase by the Board for the staff. The Board adopted a motion made by Dr. Spangler and seconded by Mrs. Willis that the Administrative Committee be authorized to proceed with the implementation of a disability plan for the Board's employees.

ADMINISTRATIVE COMMITTEE

The Administrative Committee met on September 8, 1993, at 10:00 a.m. Present were Dr. Spangler, Mrs. Willis, Ms. Meelheim, Mr. Paris and Dr. Nance via telephone.

The following information was discussed and presented to the Board on September 16, 1993, for approval:

Follow-up items from the July 1993 meeting were reviewed. A Quality Assurance plan has been implemented. The staff has addressed the printing of the Roster of registered physicians. The issue of a fee increase for physician extenders has been referred to the PA Task Force. A tracking system for action items has been implemented and is working well.

At the July 1993 meeting it was recommended that the Board's name be changed to better reflect its function. This issue has been put on the Board's agenda for items to be addressed during the next long session of the Legislature.

At the July 1993 meeting of the Board, the Board voted to request that the Governor consider staggering the addition of more Board members until the Board is granted a fee increase. Consideration must be given to the additional cost of mailings, meeting expenses, hotel expenses, etc.

The Board instructed at its July 1993 meeting that a management consultant be obtained. As a follow-up to that instruction, it was reported that Mrs. Mary Williams will meet with the Department Directors regarding her possible role as a consultant and that Brent James was scheduled to meet with the Administrative Committee to evaluate the financial system and handling internal affairs.

It was also reported that the November meeting of the Board is scheduled to be held at the Board's office as part of the orientation for new Board members. The present orientation notebooks are being revised. Additionally, the new Board members will be requested to participate in activities in between meetings.

The transfer of PHP funds, in accordance with the Board's action at the July 1993 meeting, has been completed, however, will not be reflected on the books at this time because Quickbooks is not adequate for this type of manipulation. The Board adopted a motion made by Dr. Nance and seconded by Dr. Roufail for the staff to look at the unexpended funds with a view toward purposing other more important uses for full time personnel and that the Board delegate the authorization for the transfer of funds to the Administrative Committee.

The Administrative Committee presented the current budget for the Board's review. Also presented was a cost analysis of having the June 1993 meeting at the Board's office.

It was reported that the Administrative Committee accepted the offer of Bobbi Furr, CPA to terminate the contract for services. Additionally, it was reported that Dr. Stratas met with Brent James and urged the

Board to hire him as a consultant.

Dr. Spangler recommended that the staff should be looked at as an entire organization and tasks should be prioritized. He also recommended that the budget should be looked at with an eye for invading some areas to relieve others. Mr. Paris will look at this issue and some recommendations will be made.

It was reported that November 15, 1993 has been set for the target date to mail registration forms. The Administrative Committee also reported that the PE registration forms are being returned and are ready to be scanned. The scanner is to be installed in the office on September 17, 1993.

The Administrative Committee addressed its concerns regarding the Board receiving the information it needed from the committee. It was recommended that the Committee meet at least three weeks prior to the Board meeting.

A meeting was held on August 27, 1993 with key persons from the State's major medical schools to brief them on the RTL process, in an effort to alleviate problems in the future. All persons invited attended with the exception of Bowan Gray and Forsyth representatives.

As a result of the meeting between the Administrative Committee and the staff, the need for a network manager was brought to the attention of the Administrative Committee. Ms. Meelheim indicated that there are no funds available to create this position and that there are other needs more important at this time.
