The May 21-23, 2008, meeting of the North Carolina Medical Board was held at the Board's Office, 1203 Front Street, Raleigh, NC 27609. Executive Committee Report

The Executive Committee of the North Carolina Medical Board was called to order at 10:35 am, Wednesday May 21, 2008 at the offices of the Board. Members present were: Janelle A.

Rhyne, MD, Chair; Ralph C. Loomis, MD; Harlan A. McCulloch, MD; and George L. Saunders, MD. Also present were R. David Henderson (Executive Director), Thomas W. Mansfield (Director of Legal Department), Hari Gupta (Director of Operations), Jean B. Fisher (Director of Public Affairs), and Peter T. Celentano, CPA (Comptroller).

Financial Statements

Mr. Celentano, CPA, presented the March 2008 compiled financial statements. March is the end of the first five months of fiscal year 2008.

Mr. Celentano reviewed with the Committee our current cash position and the amount on the Balance Sheet as of March 31, 2008. The Statement of Cash Flows was reviewed and accepted as presented. Mr. Celentano also reviewed with the Committee the results of operations for the first five months of fiscal year 2008. Dr. Loomis made a motion to accept the financial statements as reported. Dr. McCulloch seconded the motion and the motion was approved unanimously.

Mr. Eugene Raymond, Senior Vice President and Senior Portfolio Manager at BB&T, gave a presentation to the Committee on our Investment Portfolio as of May 15, 2008. The Committee reviewed with Mr. Raymond our current portfolio and investment performance over the past year. The Committee considered the timing of future meetings with BB&T and agreed Mr. Raymond should return in November 2008 to review the Boards investments for fiscal year 2008.

Old Business

<u>Posting of Malpractice Payment History Online</u>: Pursuant to G.S. 90-5.2, the Board has approved proposed rules for comment that would, if adopted, require the Board to publish all malpractice payments or judgments within the past seven years. The Committee discussed the status of the rule-making process and implementation of the proposed rules.

New Business

<u>Proposed Change to Registration Question:</u> The Committee considered the possibility of revising one of the annual renewal questions. The question currently asks whether, during the past year, the licensee has had a malpractice claim/lawsuit filed against them. The Committee considered whether the Board should expand the current question to ask licensees whether they have been sued in the past year and not limit the question to malpractice suits. The purpose of this question would be to collect information of concern to the Board not related to malpractice lawsuits. Dr. Rhyne made a motion to allow the staff to draft possible changes to the question and to put this item on the agenda for the July Executive Committee Meeting. Dr. Loomis seconded the motion and the motion was approved unanimously.

<u>Continuing Education:</u> One of the recommendations from the Board retreat last year was that the Board do a better job of informing licensees of areas of concern. The Committee discussed whether this could be done through Board-sponsored CME regarding Board laws, rules and position statements. The course would be approved for category 1 CME credit. Dr. Saunders made a motion to allow staff to develop an online course that would be a requirement for all new license applicants as well as those licensees coming before the Board as a result of an informal interview or other disciplinary action. Dr. Loomis seconded the motion and the motion was approved unanimously.

This Position Statement is to be published in the Forum for comments.

PROPOSED POSITION STATEMENT:

ADVERTISING AND PUBLICITY*

It is the position of the North Carolina Medical Board that physician advertising or publicity that is deceptive, false, or misleading is unprofessional conduct. The key issue is whether advertising and publicity, regardless of format or content, are true and not materially misleading.

Information conveyed may include:

- a. the basis on which fees are determined, including charges for specific services;
- b. methods of payment;
- c. any other non-deceptive information.

Advertising and publicity that create unjustified medical expectations, that are accompanied by deceptive claims, or that imply exclusive or unique skills or remedies must be avoided. Similarly, a statement that a physician has cured or successfully treated a large number of patients suffering a particular ailment is deceptive if it implies a certainty of results and/or creates unjustified or misleading expectations. If patient photographs are used, they should be of the physician's own patients and demonstrate realistic outcomes.

Consistent with federal regulations that apply to commercial advertising, a physician who is preparing or authorizing an advertisement or publicity item should ensure in advance that the communication is explicitly and implicitly truthful and not misleading. Physicians should list their names under a specific specialty in classified telephone directories and other commercial directories only if they are board certified or have successfully completed a training program in that specialty accredited by the Accreditation Council for Graduate Medical Education or approved by the Council on Postdoctoral Training of the American Osteopathic Association. Furthermore, physicians should only advertise themselves as board certified if they identify the

area of board certification and have received their certification from a specialty board recognized by the American Board of Medical Specialties or the American Osteopathic Association.

*Business letterheads, envelopes, cards, and similar materials are understood to be forms of advertising and publicity for the purpose of this Position Statement.

PROPOSED STATEMENT

Project Lazarus

The Board is concerned about the three-fold rise in overdose deaths over the past decade in the State of North Carolina both by means of prescription and non-prescription drugs. The Board is encouraged by the efforts of Project Lazarus, a pilot program in Wilkes County that is attempting to reduce the number of drug overdoses by making the drug naloxone and an educational program on its use available to those persons at risk of suffering a drug overdose, their families and peers. Naloxone is the antidote used in emergency medical settings to reverse respiratory depression due to opioid toxicity.

The goals of Project Lazarus are consistent with the Board's statutory mission to protect the people of North Carolina. The Board therefore encourages its licensees to abide by the protocols employed by Project Lazarus and to cooperate with the program's efforts to make naloxone available to persons at risk of suffering drug overdose.

REVIEW OF POSITION STATEMENT:

Departure from or Closing of Medical Practices

Issue: Review Committee referred this issue to Policy Committee to determine if the current position statement should be amended to cover nurse practitioners physician assistants.

5/2008 – It was pointed out that not all physician extenders work in the same circumstances. Many physician extenders are at-will employees; others work in practice environments in which they are the owner and/or the sole practitioner. The statement should cover both extremes. It was suggested that the layout of the statement could be similar to the Physician Supervision position statement, which lists circumstances to be considered on a case by case basis. Additionally, it was stated that continuity of care for patients must be the ultimate concern.

COMMITTEE ACTION: Todd Brosius and Dr. Walker will prepare an amended version of the Position Statement for the Committee's consideration.

CONTINUED COMPETENCE COMMITTEE REPORT

The Continued Competence Committee of the North Carolina Medical Board was called to order at 1:00 p.m., Thursday, May 22, 2008, at the office of the Board. March Minutes

Motion to approve the March minutes was approved.

OLD BUSINESS

FSMB Maintenance of Licensure Model Policy

A discussion was held discussing the Licensure Model Policy. It was noted that at its annual meeting on May 3, FSMB's House of Delegates adopted both the guiding principles and the board of directors' recommendation to conduct impact studies. Over the next 12 months FSMB will be working closely with member boards and partner organizations to carry out this charge. Dr. Sheppa commented that it is important for us to continue to give guidance to our licensees. As it stands 80% of the people in the process will not be affected by this. It is the remaining 20% that are not ABMS certified that will have a more rigorous process.

CME Audits

Mr. Gupta updated everyone on the January and April CME letters that went out. Of the 250 letters from January, 239 have complied. The April batch of letters was much lower as most have already complied.

NEW BUSINESS

FSMB PLAS Program

Dr. Sheppa reviewed the handout from the FSMB on PLAS. He noted that this program will be for the 20% noted above. This will be used to access the competence of doctors.

Coalition for Physician Enhancement Meeting Debrief

Mr. Mansfield reviewed the Coalition for Physician Enhancement meeting he attended in Dallas from April 10-11, 2008. It was discussed that the NCMB have Dr. Pohl, from Albany NY, come and tell us about the program. This program is being compared to CPEP and PACE. The Committee supported the idea that Mr. Mansfield and Dr. Sheppa should go to Albany to visit the site for a better understanding of what they offer.

Dr. Rhyne's Article on *Trends in Maintaining Clinical Medical Expertise* and the Response Letter to Dr. Masters

The committee reviewed Dr. Rhyne's article and the letter from Dr. Masters. It was felt that Dr. Rhyne completely answered all of Dr. Master's questions.

Reentry Agreement Contents

Dr. Sheppa reviewed items for consideration to include in Reentry Agreements. He listed three items for the licensees and eight or so for the mentors. A discussion of the items then followed. It was then decided that Dr. Sheppa would take the current NCMB licensing reentry agreement and modify it with his suggestions and put it on the agenda for July consideration.

A motion was approved to adopt the skeleton outline and for Dr. Sheppa to mold the new outline.

The next regular meeting of the Continued Competence Committee is tentatively set for Thursday, July 17, 2008.

LICENSE COMMITTEE REPORT

Acceptable Photos for the application process

Catchline: The Board has always required photographs for medical school certification to be of durable quality. Recent technology now allows scanning of photograph and printing on regular copy paper. Will the Board accept this type of photo. An "original" example will be shared at the May meeting.

BOARD ACTION: For now, stay with requiring an actual photograph.

Immigration Status of Applicants

Catchline: It has been suggested that NCMB require proof of US citizenship or legal residence for foreign-born applicants as part of the license process.

BOARD ACTION: The Board agreed that licensees should be legal immigrants. Staff tasked to research how to accomplish and report back to the Board.

Proposed 10-Year Rule amendment

Catchline: As a result of discussion at the May 2008 Board meeting it is recommended that NCAC 32B .0315 (2) be amended.

BOARD ACTION: Amend NCAC 32B .0315 to read: The SPEX requirement may be waived by the Board upon receipt of a **current 3 year** AMA Physician's Recognition Award or equivalent AOA CME. If the AMA/PRA is submitted to satisfy this requirement, copies of the CME documentation used to obtain the award must be included as part of your NC medical license application **showing the majority of the PRA CME to be clearly relevant to your specialty or area of practice.**

Proposed Guidelines for Board members regarding when to invite an applicant for a oneon-one or split-Board interview.

Catchline: Mr. Henderson requested staff prepare proposed guidelines for Board members regarding when to invite an applicant for a one-on-one interview or a split-board interview. Staff has been unsuccessful to date in getting together for discussion. A meeting is scheduled for May 15th and we hope to have a proposal for the Committee's consideration at the May meeting.

BOARD ACTION: Dr. Kirby explained his procedure for determining what type of interview an applicant should have – if affirmative answers involve quality of care issues applicant should appear for split Board interview. If affirmative answers involve factual issues, i.e. character, a single Board member interview will probably be sufficient.

DWI HISTORY AND NC PHP EVALUATION

Catchline: As a result of discussion at the May 2008 Board meeting the following is proposed.

DWI HISTORY AND NC PHP EVALUATION:

License applicants will be referred for NC PHP assessment under the following circumstances

- 1. Any DWI arrest within the past 5 years.
- 2. Two or more previous DWI arrests over any period of time.
- 3. Any DWI arrest where the BAC (if available) was greater than 0.14.
- 4. In some cases an out-of-state assessment by another state's PHP, which is known and trusted by the Board, will be accepted in lieu of a NC PHP evaluation.

If the license application is otherwise clean, and NC PHP evaluation, performed in compliance with the criteria above, identifies no alcohol or substance abuse problems, no applicant interview will be required with regard to the question of a previous DWI arrest.

BOARD ACTION: Establish the following policy with regard to applicants with DWI history and NC PHP evaluations:

Applicants for license will be referred for NC PHP assessment under any one of the following circumstances:

- 1. Any arrest within the past 5 years for the operation of any vehicle under the influence of any impairing substance.
- 2. Two or more previous DWI arrests, or the equivalent, over any period of time.
- 3. In some cases an out-of-state assessment by another state's PHP, which is known and trusted by the Board, will be accepted in lieu of a NC PHP evaluation.

If the license application is otherwise clean, and NC PHP evaluation, performed in compliance with the criteria above, identifies no alcohol or substance abuse problems, no applicant interview will be required with regard to the question of a previous DWI arrest.

A private letter of concern (PLOC) will be sent to applicants who meet this criteria.
