The North Carolina Medical Board held its regularly scheduled April 2014 meeting at the Board's office located at 1203 Front Street, Raleigh, North Carolina. Paul S. Camnitz, MD, President, called the meeting to order on Friday April 11, at 8:00 a.m. Board members participating were: Cheryl L. Walker-McGill, MD; Ms. Thelma Lennon; Barbara E. Walker, DO; Subhash C. Gumber, MD; Ms. H. Diane Meelheim, FNP; Debra A. Bolick, MD; and Timothy E. Lietz, MD. Also attending were Fred Morelock, Independent Legal Counsel to the Board; R. David Henderson, Executive Director and Thom Mansfield, Board Attorney.

Presidential Remarks:

Dr. Camnitz commenced the meeting by reminding the Board members of their duty to avoid conflicts of interest with respect to any matters coming before the Board as required by the State Government Ethics Act.

HEARINGS:

Brabham, Felicia, MD – Charlotte, NC

The Board was represented by Mr. Brian Blankenship. Dr. Brabham was not present nor was she represented by counsel.

On March 3, 2014, the Board issued charges alleging that Dr. Brabham failed to respond in a reasonable manner to the Board's repeated requests for information; failed to release a copy of a patient's record in a timely manner; and committed unprofessional conduct by illegally entering and using the offices of another medical practice without permission.

At the conclusion of the hearing on April 11, 2014, the Board voted to indefinitely suspend Dr. Brabham's medical license. Dr. Brabham may not reapply for a North Carolina medical license for one year.

The Board voted to accept the proposed Consent Order.
