The November 1993 meeting of the North Carolina Board of Medical Examiners was held at the Board's office, 1203 Front Street, Raleigh, North Carolina, 27609. The meeting was called to order at 7:30 p.m., November 17, 1993 by John W. Nance, M.D., President. Board members in attendance were: John W. Nance, M.D., President; Harold L. Barrett, M.D. Charles Trado, M.D. and Mrs. Martha Walston Appointed Agents were also present in preparation for their anticipated appointment to the Board.

#### Minutes - September 1993 meeting

The first order of business was the adoption of the minutes from the September 1993 meeting of the Board. The Board adopted a motion made by Dr. Stratas and seconded by Dr. Roufail to approve the minutes as presented with the correction to delete Dr. George Johnson from the Board members present at the September meeting.

#### EXECUTIVE SECRETARY'S REPORT

Bryant D. Paris, Jr., Executive Secretary, reported the following items to the Board:

Skip Blackburn, Smith Abbott Company; Brent James, CPA; and Sam Johnson, CS&S were present on November 18, 1993, to give an overview of the computer system. Mr. Paris reported that many lessons have been learned from the PA registration. Another line has been added for the address. The name and address lines have been lengthened. Also added was a constant field to identify each record. Each form is now printed in such a way that window envelopes are usable.

The following employment changes were reported:

1. Perlina Dowling has been helping temporarily with data entry;
2. Anne Goding is helping in the Investigative Department while Jenny Olmstead is on maternity leave;
3. Jenny Olmstead gave birth to a baby boy - Jesse Edward on November 3, 1993;
4. Shirley Carroll is in the receptionist position on a temporary basis; and
5. Melissa Hawkins, Investigative Secretary has resigned effective November 30, 1993.

Director's continue to have weekly meetings. A copy of the minutes from these meetings was presented for review.

The 1994 Registration applications were scheduled for mailing November 18, 1993. In response to questions raised by Dr. Spangler, the Board was informed that daily deposits will be made during the Registration process. The Board adopted a motion made by Dr. Stratas and seconded by Dr. Johnson that the staff is to report to the Board at its May 1994 meeting, the number of forms which were returned incomplete.

The Ad Hoc Committee on Licensure By Endorsement has held its first meeting in Fort Worth, Texas. It was reported that 2 major concerns evolved from the meeting: 1. The question of whether or not the Federation should develop a license by endorsement system that would be suggested for use by various State Medical Board; and 2. Developing a central credentialing agency through the Federation.

Mr. Paris has been asked to speak at the May 1994 meeting of the Federation. The topic of his speech will be North Carolina's experience regarding alternative Medical Care Legislation. The Board will appoint a representative at its January 1994 meeting, to attend the annual Federation meeting.

As a follow up to an item on the July 1993 Administrative Committee report, in which Dr. Spangler questioned the staff regarding temporary licenses having different numbers. The staff was instructed to survey other states to determine how they number the sequence of temporary license. The Staff conducted a survey of the following Medical Boards: South Carolina, Virginia, and Georgia all issue temporary licenses with numbers different from permanent number. Florida does not issue temporary licenses. the permanent number is not assigned until after Florida Board certification and payment of all fees.

#### FEDERATION OF STATE MEDICAL BOARDS

On November 19, 1993, the Board reviewed a Nomination Memorandum from the Federation of State Medical Boards, dated October 22, 1993. As a result of this review, the Board adopted a motion made by Dr. Godwin and seconded by Dr. Spangler that Mr. Paris and Dr. Nance contact Dr. Galusha and Dr. Citron to determine how to proceed with nominating members and becoming active in the Federation.

#### CHIROPRACTIC ROLE

On November 19, 1993, the Board reviewed a letter from Joe Siragusa, M.D. regarding the definition of chiropractic role with regard to ordering medical studies. As a result, the Board adopted a motion made by Dr. Godwin and seconded by Dr. Roufail that the Board write Dr. Siragusa instructing him that the Board in its collective judgement, determined that this is outside the legal definition of the practice of chiropractic medicine and that it is firmly opposed to it.

#### NON-DISSOLVABLE LACRIMAL PLUGS

On November 19, 1993, the Board reviewed a letter from Steven Dingeldein, M.D., requesting the Board's opinion on whether the optometric practice act allows the placement of medical devices into a body orifice. As a result, the Board adopted a motion made by Dr. Godwin and seconded by Dr. Roufail that the Board request a formal position statement from the North Carolina Optometric Society.

#### INVESTIGATIVE/LEGAL COMMITTEE

For several meetings the Board has discussed the possibility of creating a committee to handle investigative issues and make recommendations to the Board. Mr. Paris presented the Board with a proposed flow chart and explanation of how this committee might work. As a result, the Board adopted a motion made by Dr. Stratas and seconded by Dr. Godwin that the proposed process be tried for several meetings to determine its effectiveness.

#### NP RULE HEARING - NCAC 32M .0006 and 32M .0009

It was reported that a Public Hearing was held on November 17, 1993 at the NC Board of Nursing's office to address 32M .0006 - changes proposed will allow for controlled substances to be prescribed in accordance with federal laws; and 32M .0009 - changes proposed would alter written standing orders to include controlled substance drugs, devices, medical treatment and procedures. Dr.

Harold Godwin served as the Hearing Officer. Several persons spoke in favor of the proposed changes. Representatives from the UNC School of Pharmacy and Pharmacy Association spoke against the proposed changes. The board adopted a motion made by Dr. Godwin and seconded by Mrs. Willis to adopt the proposed rules - pending any additional written comments submitted by the deadline of December 1, 1993.

The Board adopted a motion made by Dr. Godwin and seconded by Dr. Barrett that the PA Prescriptive authority be unlimited with the exception of 2, 2N, 3, 3N. That 2, 2N, 3, 3N be limited to a reasonable supply with a seven day limit.

The Board also adopted a motion made by Dr. Godwin and seconded by Dr. Roufail that the proposed rules be taken to a Hearing and that it be scheduled for the earliest possible time.

#### MANAGEMENT OF CHRONIC PAIN

The Board identified that Management of chronic pain is a large percentage of the problem cases with which it deals. The Board adopted a motion made by Dr. Barrett and seconded by Dr. Roufail to ask Dr. Stratas and Dr. Trado to develop a position statement with recommendations/guidelines for the management of chronic pain.

#### SELF ASSESSMENT INSTRUMENT

Mr. Paris gave the Board a review of the items identified by the Directors and upper management as a result of completing the SAI. Dr. Stratas questioned the status of items marked NO or items not answered. Dr. Spangler recommended that all such items need to be identified, evaluated regarding implementation and prioritized for adoption if indicated. Dr. Stratas reminded the staff that the SAI is not meant to replace a consultant, rather to assist in a consultation. The Board adopted a motion made by Dr. Roufail and seconded by Mrs. Willis to put this item on the January 1994 agenda.

DECLARATORY RULING

The Board received a request from the North Carolina Medical Society regarding Registered Nurses performing duties without the supervision of a doctor. The Board adopted a ruling at its previous meeting. Additional wording was suggested for that ruling in order to relate the Declaratory ruling directly to medical practice rather than the practice of Nursing.

SEXUAL IMPROPRIETY - STATE BAR ETHICS

At the September 1993 meeting of the Board of Medical Examiners, Mr. Michael Weddington presented a proposed ethics statement from the State Bar (RPC 159). Mr. Weddington wrote the State Bar on behalf of the Board of Medical Examiners supporting the statement which found it unethical to condition a physician settlement on the condition that the complainant not report the incident to the Medical Board. As a result Mr. Breeze presented the Board with a proposed position statement as follows:

It is the position of the Board of Medical Examiners that it is unethical for a physician to settle any complaint if the settlement contains an agreement by a patient not to complain or provide information to the Board of Medical Examiners.

The Board adopted a motion made by Dr. Stratas and seconded by Dr. Godwin to adopt the proposed position statement.

LIMITED LIABILITY COMPANIES

At the September 1993 meeting of the Board of Medical Examiners, House Bill 923 was presented for the Board's review which require regulation by the Board of limited liability companies. As a result, the staff was instructed to draft proposed rules to enable regulation by the Board. Mr. Breeze presented the following proposed rules:

The Board adopted a motion made by Dr. Roufail and seconded by Dr. Stratas to adopted the proposed rules as presented.

LETTERS OF APPRECIATION

Mr. Paris presented the following letters of appreciation for the Board's review: Robert C. Cefalo, M.D. to Dr. Bondurant; Safi Soliman, M.D. to Dr. Stratas; Robert W. Patterson, M.D. to Dr. Stratas; Beatrice A. Files, M.D. to Dr. Stratas; and L. Allen Kindman, M.D. to Mr. Paris.

PHYSICIAN'S COMPETENCY EVALUATION AND REMEDIAL PROGRAM

Mr. Paris presented the Board with a letter from Robert K. Adams, II, Ph.D., President of the Medical Foundation, East Carolina University, which indicated that the PCERP program identifies the fee of \$10,000 as a retainer form consultative expertise.

ACCESS TO PHYSICIAN RECORDS

Mr. Paris presented the following proposed position statement regarding access

to patient records:

It is the position of the Board of Medical Examiners that notes prepared by the physician in the course of diagnosing and treating patients are primarily for the physician's use and are therefore the property of that physician. The record is a confidential document and should only be released with proper written consent of the patient. Each physician has a duty on the request of a patient to release a copy or a summary of that record to whomever the patient requests whether another treating physician, insurance company, attorney or the patient. The physician may charge a reasonable fee for the preparation or the photocopying of the materials. materials should not be held because an account is overdue or a bill is owed.

Regarding the completion of forms for established patients, it is the position of the Board of Medical Examiners that a physician should complete in a timely fashion any forms such as insurance claims. If the form is simple then the physician should perform this task for no fee. If the form is complex then the physician may charge a reasonable fee.

After review of this statement and some discussion, the Board unanimously adopted a motion made by Dr. Roufail and seconded by Mrs. Willis to adopt the position statement as proposed by staff.

#### FEE SPLITTING

Mr. Paris presented the following proposed position statement regarding fee splitting, for the Board's consideration and adoption.

The Board of Medical Examiners of the State of North Carolina strongly endorses the AMA Code of Medical Ethics Opinions 6.02, 6.03 and 6.04 condemning fee splitting. Fee splitting may be the payment of a kickback for referrals or a referral fee. It is also considered fee splitting when a physician receives any remuneration from a drug or device manufacturer, sales representative or another professional as an incentive for the use of that interested party's product. Further, it is the position of the Board of Medical Examiners that sharing profits between the nonphysician or paraprofessional and a physician partner, except in the instance of a licensed physician practicing psychiatry and a licensed psychologist who may form a professional corporation for the purpose of rendering psychotherapeutic and related services, on a percentage basis is also fee splitting and therefore is grounds for disciplinary action.

After much discussion the Board adopted a motion made by Dr. Stratas and seconded by Dr. Spangler to adopt the proposed position statement. Dr. Roufail voted in opposition of the motion.

#### SEXUAL MISCONDUCT

Mr. Paris presented a proposed position on Sexual misconduct and Washington Department of Health Policy Statement regarding Sexual Misconduct and the Policy of the Medical Disciplinary Board. The Board adopted a motion made by Dr. Godwin and seconded by Dr. Spangler to accept the articles presented as information.

#### ADMINISTRATIVE COMMITTEE

The Administrative Committee met on November 9, 1993, at 10:00 a.m. Present were Dr. Nance, Mr. Paris, Ms. Meelheim, Dr. Spangler (via phone), Dr. Roufail (via phone, and Mrs. Willis (via phone).

The following issues were discussed and presented to the Board on November 18 for approval:

The present Health Insurance policy was discussed. Dr. Spangler reported that the policy is being renegotiated and a new policy should be in place by January 1994.

At its September 1994 meeting, the Board authorized the staff to proceed with the Disability Insurance plan which was present for the Board's review. It was reported that Group America had denied the proposed policy, however, Paul Revere accepted the Board for coverage.

A request was made to create a new secretarial position to handle Malpractice and Complaints. After some discussion, the Board adopted a motion made by Dr. Spangler and seconded by Dr. Roufail to approved the request.

Middle Management is to receive basic management training. Topics have been chosen by the Directors and in-house training will be pursued. Dr. Barrett recommended that the staff consider utilizing the Universities which provide management training in a structured setting.

The deductible for automobile insurance has been increased from \$25 to \$500. The management of the Board's cars will reviewed to possibly have staff use their personal vehicles and the Board will pay mileage.

The Accounting department is preparing for the annual audit. The Board will begin receiving monthly investment statements. The Board is now working in the new budget year as of November 1, 1993.

The FLEX examination scheduled for December 7-9, 1993, will be held in two locations because of the large number of candidates.

Proposals for a Management Consultant are to be submitted to the Board at the January 1994 meeting. The Administrative Committee will decide if a consultation is to be done and by whom. The consultant will be put on notice for the spring, after the current registration is complete.

The Board discussed the way items are tracked from meeting to meeting. As a result the Board adopted a motion made by Dr. Spangler and seconded by Dr. Johnson to create a master list of action items each meeting and the results are to be presented at the following meeting.

Dr. Roufail brought up the issue of the Board having expert witnesses or consultants available on a fee for service basis. The staff is to contact the Medical Society to help develop a panel of specialist who will obligate themselves to be available to the Board. Management will also contact other States to determine what system they use.

The Administrative Committee reviewed a proposal submitted from Smith, Anderson, Blount, Dorsett, Mitchell & Jernigan, Attorneys at Law, in response to the Board desire to have an in-house counsel. The Board adopted a motion made by Dr. Spangler and seconded by Dr. Roufail to proceed with the hiring of a full-time in-house counsel. Notify Mr. Weddington's firm of the Board decision. Monies from the litigation fund are to be used to support the hiring of this position.

Mr. Paris reported that all employee evaluations for 1993 have been completed.

#### PHP COMMITTEE REPORT

The PHP Committee chaired by Mrs. Willis and including Dr. Godwin met and reviewed the cases with Dr. Vanderberry. A written report of 23 cases was presented to the Board for its review. The Board adopted the Committee's recommendation to approve the written report. This is not included as these actions are not public.

COMPLAINT COMMITTEE REPORT

The Complaint Committee chaired by Mrs. Willis and including Dr. Barrett and Dr. Johnson reported on 38 complaint cases. A written report was presented for the Board's review. After some discussion the Board adopted the Committee's motion to approve the report. This report is not included as these actions are not public.

MALPRACTICE COMMITTEE REPORT

The Malpractice Committee chaired by Dr. Spangler and including Mrs. Willis and Dr. Barrett reported on 38 malpractice cases. A written report was presented for the Board's review. The Board adopted the Committee's recommendation to approve the written report. This report is not included as these actions are not public.

EMS REPORT

The EMS Committee chaired by Dr. nance moved that the Board adopted the EMS certifications for the period of August 17, 1993 - October 25, 1993. The Board unanimously adopted the recommendation of the Committee.
