

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF THE STATE OF NORTH CAROLINA

The Blockade Runner Motor Hotel
Wrightsville Beach, North Carolina

October 12-14, 1973

The Board of Medical Examiners of the State of North Carolina met at The Blockade Runner Motor Hotel in Wrightsville Beach, North Carolina, October 12-14, 1973, for the purpose of interviewing applicants for license by endorsement of credentials and other business.

Friday, October 12
8:00 p.m.

The Board convened for business and reviewing credentials. Drs. Bryant L. Galusha, President, Charles B. Wilkerson, Jr., Secretary-Treasurer, Frank Edmondson, Joseph W. Hooper, Jr., Cornelius T. Partrick and E. Wilson Staub were present. Dr. Vernon W. Taylor, Jr. was absent. Present also were Dr. Joseph J. Combs, Executive Secretary, Bryant D. Paris, Jr., Executive Secretary Designate, Mrs. Betty Joe Cooke and Mrs. Diane Freeman.

RE: Dr. Henry O. Williams, Durham, N. C. -- letter from Dr. Cavanaugh.

The President reviewed letter received from Dr. P. J. Cavanaugh, Chief of the Department of Therapeutic Radiology in regard to Dr. Williams' progress and use of his reinstated privileges for writing narcotic prescriptions, as requested by the Board at the June, 1973 Board meeting. After discussion, the Board decided to receive this letter as information and request a report from Dr. Cavanaugh prior to Dr. Williams' completing his training.

RE: Dr. Jarlath MacKenna, Durham, N. C. -- The President reviewed Dr. MacKenna's file as he presently holds a Certificate of Registration for one year to Duke University as a Visiting Professor. He is now applying to take the December, 1973 FLEX and asking that the deadline for presenting his alien registration receipt card be extended as he will not have it available by the time of the examination.

VERDICT: Dr. Edmondson moved that if Dr. MacKenna will have the Department of Justice furnish evidence to the Board that his alien registration receipt card will be issued and it is only a matter of time before it is issued, the Board will give him permission to take the December, 1973 FLEX. Seconded by Dr. Hooper and duly passed.

RE: N. C. Department of Human Resources -- request from Dr. Zarzar.

The President reviewed letter received from Dr. N. P. Zarzar requesting permission from the Board for physicians in a training status to perform duties in community mental health centers as approved by the superintendents of the centers and supervised by the Department of Human Resources. Following Board discussion, the following motion was made:

VERDICT: Dr. Edmondson moved that the Board ask Dr. Zarzar to clarify his statement in the letter pertaining to "community mental health centers" and inform him that the Board's previous policy is that individual's who changed their locale, who were in a training program under supervision, are still considered to be in this training program; and that if this is in fact still part of their training, the Board approve same. Seconded by Dr. Hooper and duly passed.

RE: Dr. Barry McNeil Welborne, Charlotte, N. C. -- letter from Dr. McDowell.

The President reviewed reply from Dr. McDowell in regard to Dr. Welborne and the Board received this as information.

RE: Dr. Ralph C. Reid, Pineville, N. C. -- The President reviewed the file on Dr. Reid and his previous appearances before the Board and the recent report received from the N. C. Board of Pharmacy relative to Dr. Reid's prescribing of amphetamine-type drugs.

VERDICT: Dr. Edmondson moved that Dr. Reid be requested to appear before the Board in December and bring with him any documented evidence he has relative to his use of controlled drugs. Seconded by Dr. Partrick. General discussion

by Board members in regard to Dr. Reid's apparently beginning to prescribe controlled drugs again and his prescribing of certain drugs which he supplies to some pharmacies in his area. Following discussion, motion passed unanimously.

RE: Interviews for License by Endorsement of Credentials --

RE: Dr. Collin F. Baker, Jr. appeared before the Board in August, 1973 with incomplete credentials applying for license by endorsement. He was approved contingent upon satisfactory completion of same, which has now been done.

VERDICT: Dr. Collin F. Baker, Jr. approved for license by endorsement.

RE: Dr. Thomas Michael Bashore appeared applying for license by endorsement of credentials. He is a graduate of Ohio State University in 1972 and holds the National Board certificate.

Dr. Galusha: Dr. Bashore's application is complete. I believe you are a resident now at the University of North Carolina?

- A: Yes, that's right--I will be there for a couple more years, I think.
 Q: Have you ever been convicted of a crime? A. No, I have not

 Q: Is this the first state license you have applied for? A. Yes, sir

VERDICT: Dr. Thomas M. Bashore approved for license by endorsement.

RE: Dr. Gary Sterling Berger appeared applying for license by endorsement of credentials. He is a graduate of the University of Rochester in 1969 and holds National Board certification.

Dr. Galusha: Dr. Berger's application is complete and he will be a resident at Chapel Hill.

 Q: Have you ever used narcotics or barbiturates personally? A. No, I do not
 Q: Have you had any difficulty with medical examining boards? A. No, this is the first license I have applied for.

VERDICT: Dr. Gary S. Berger approved for license by endorsement.

RE: Dr. Robert David Biggers appeared applying for license by endorsement of credentials. He is a graduate of the University of Southern California in 1972 and is a diplomate of the National Board.

Dr. Galusha: Dr. Biggers' application is complete and he is planning to do some part-time emergency room work in North Carolina.

- Q: Have you ever been convicted of a crime? A. No, sir
 Q: Have you ever personally used narcotics or barbiturates? A. Never, sir
 Q: Have you ever used alcohol to excess? A. No, sir
 Q: Have you had any difficulty with state medical boards? A. No, sir
 Dr. Edmondson: Are you in the military?
 A: Yes, sir, at Fort Bragg.

VERDICT: Dr. Robert D. Biggers approved for license by endorsement.

RE: Dr. Robert Elliot Blaik appeared applying for license by endorsement of credentials. He is a graduate of Chicago College of Osteopathic Medicine in 1972 and is licensed in Maryland by examination by the Maryland Board of Medical Examiners.

Dr. Galusha: Dr. Blaik is a Doctor of Osteopathy and his credentials are all in order. What are your plans for North Carolina, Dr. Blaik?

- A: I have accepted a residency offer from the University in Chapel Hill. I will be working in public health and psychiatry also. I'll probably be here about six or seven years.

RE: Dr. Robert Avram Bloomenthal appeared with incomplete credentials applying for license by endorsement. He is a graduate of Vermont University in 1972 and is licensed in Vermont by FLEX in 1973.

Dr. Partrick: Dr. Bloomenthal's application lacks a long-term letter only, and I assume you know about it?

A: Yes, I have talked with your secretary and plan to get one to your office as soon as possible.

Dr. Galusha: Dr. Blumoff is now a resident in General Surgery at N. C. Memorial Hospital and his application is complete.

Dr. Galusha: Dr. Boekelheide will be in Student Health at Chapel Hill, is that right?

A: Yes, sir, that's correct.

Q: Her application is complete. Have you ever been convicted of a crime? A. No, sir

Dr. Galusha: Dr. Boeren is in the military at Fayetteville--for how long?

A: I will be getting out in 1975. I hope to stay in North Carolina and work in Family Practice.

VERDICT: Dr. John J. Boeren, III approved for license by endorsement.

RE: Dr. Gary Lee Broadrick appeared with incomplete credentials applying for license by endorsement. He is a graduate of Emory University in 1969 and is licensed in Georgia and Massachusetts.

Dr. Partrick: Dr. Broadrick's application is incomplete, lacking Massachusetts and the AMA inquiry. He is now in the military and would like to do some practice outside when possible.

Q: Have you ever been convicted of a crime? A. No, I have not

Q: Have you ever used alcohol to excess? A. No, I have not

Q: Have you had any trouble with narcotics or barbiturates? A. No, I haven't

Q: Have you had any trouble with medical licensing boards? A. No, I have not

VERDICT: Dr. Gary L. Broadrick approved for license by endorsement if and when his credentials completed satisfactory to Executive Secretary. (credentials completed)



RE: Dr. Frank Joseph Brown appeared applying for license by endorsement of credentials. He is a graduate of the Medical College of Georgia in 1967 and is licensed in Georgia by examination in 1968.

- Dr. Galusha: Dr. Brown's credentials are all in order, and he plans to work at Broughton Hospital. Dr. Brown, one question: Why did you split your internship?
- A: I had some difficulty in medicine rotation at Columbus with one of the staff members, so I left.
- Q: What difficulty?
- A: Personality conflict between myself and one or two of the members--don't really know what prompted the situation except I was accused of over-medicating a patient in the clinic. I was trying to keep the patient on an out-patient basis rather than re-admitting him to the hospital. I was having to operate rather independently there and had to assume a lot of responsibility.
- Q: Was this leave mutually agreeable?
- A: Yes.
- Q: Any difficulty at Georgia Baptist?
- A: No
- Q: What have you done since this internship?
- A: I took some seminars and then have been in Georgia as a General Practitioner in Atlanta til the present.
- Q: Why do you desire a license in North Carolina?
- A: I have just gotten a divorce last year--rather bitter--and want to locate near my home which is Blowing Rock--so I plan to work at Broughton.
- Dr. Edmondson: What will your status be at Broughton?
- A: I haven't been assigned to a specific post yet as they are going through a lot of changes there now, but probably will be in a unit such as organic brain syndrome.
- Dr. Galusha: Have you ever been convicted of a crime? A. No, I have not
- Q: Have you ever used alcohol to excess? A. No
- Q: Have you personally used narcotics or barbiturates ever? A. No, I have not
- Q: Have you had any difficulty with boards of medical examiners? A. No
- Q: Have you applied for any other medical licenses?
- A: No, I have only applied here--other than my Georgia license.

Dr. Brown was excused and the Board members discussed his interview and recalled him.

- Dr. Galusha: Dr. Brown, you have no personal conflicts presently that would interfere with your work?
- A: No, sir.
- Q: Are you under psychiatric care yourself?
- A: No, I am not.

VERDICT: Dr. Frank J. Brown approved for license by endorsement.

RE: Dr. H. Gunther Bucheleres appeared with incomplete credentials applying for license by endorsement. He is a graduate of the Medical College of Dusseldorf in Germany in 1949 and is licensed in Illinois by examination in 1957 and is a diplomate of the American Board of Pediatrics.

- Dr. Partrick: Dr. Bucheleres has recently purchased property in the Charlotte area and plans to practice in that area. He is a naturalized American citizen. I presume you have talked with the secretary in regard to your missing credentials?
- A: Yes, I believe the only thing missing is the picture, which she has sent to the University in usseldorf.
- Q: Have you ever been convicted of a crime? A. No
- Q: Have you had any difficulty with any boards of medical examiners? A. No
- Q: Have you had any personal trouble with alcohol, barbiturates or narcotics? A. No

VERDICT: Dr. H. Gunther Bucheleres approved for license by endorsement of credentials if and when his credentials are completed satisfactory to the Executive Secretary.

RE: Dr. William Thomas Callahan appeared applying for license by endorsement of credentials. He is a graduate of the Medical College of Georgia in 1971 and is licensed in Georgia in 1972 by examination.

- Dr. Galusha: Dr. Callahan is in the military at Jacksonville, and I assume you plan to do some outside work? His credentials are complete.
- A: Yes, sir, that's right.

Dr. Galusha: Have you ever been convicted of a crime? A. No, sir

Dr. Partrick: Dr. Camargo's specialty is Anesthesiology and he is interested in practicing in the Charlotte area. His file is incomplete right now, lacking his application form and his certified photograph and graduation certification.

VERDICT: Dr. Carlos E. Camargo approved for license by endorsement if and when his credentials completed satisfactory to the Executive Secretary, (credentials completed.) to be limited geographically until citizenship obtained.

Following Dr. Camargo's appearance before the Board, he presented his alien registration receipt card to the Administrative Assistant in the Board's office, Number A 17 634 458.

VERDICT: The Board indicated their appreciation for his coming and advised they were pleased that he was doing well. Dr. Partrick moved that Dr. Gardner be seen in June, 1974. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Gordon M. Wilkins, Charlotte, N. C. -- Pharmacy Board report

Dr. Edmondson reviewed a recent report received from the North Carolina Board of Pharmacy that some of Dr. Wilkin's patients were presenting prescriptions, mostly for amphetamines and Robitussin AC, at pharmacies, some of which would not honor his prescriptions, and when this occurred, the individuals became abusive in their language and actions in the pharmacy.

VERDICT: Dr. Hooper moved that Mr. McAllister be contacted and advised that the Board had reviewed the report and felt that this would be an inappropriate time to see Dr. Wilkins as he is presently facing more serious charges in Charlotte. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Edwin S. Mize, Jr., Charlotte, N. C. --

The President reviewed a report received from the Bureau of Narcotics and Dangerous Drugs that Dr. Mize had been indicted for the fraudulent handling or using of controlled substances in July, 1973 by the Grand Jury in Federal District Court.

VERDICT: Dr. Hooper moved that this information be reconsidered at the next Board meeting following Dr. Mize's trial. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Matthew A. J. Stroup, Jr., Gastonia, N. C. --

The Executive Secretary reviewed the file on Dr. Stroup and the Board's request to the North Carolina Board of Pharmacy asking for a review of the pharmacies in Dr. Stroup's area checking on prescriptions written by him for amphetamines and other controlled substances. This report indicated Dr. Stroup had written no prescriptions for amphetamines in that two-month period reviewed and that a minimum amount of other controlled substances prescriptions had been written.

VERDICT: Dr. Partrick moved that this report be received as information. Seconded by Dr. Edmondson and duly passed.

RE: Dr. E. E. Marlowe, Gastonia, N. C. --

The Executive Secretary reviewed the file on Dr. Marlowe, including his previous appearances before the Board in 1969, and the most recent report from the North Carolina Board of Pharmacy in regard to Dr. Marlowe's writing of controlled substances prescriptions.

VERDICT: Dr. Hooper moved that Dr. Marlowe be asked to appear at the Board's next meeting. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Elisha J. Cain, Goldsboro, N. C. --

The President reviewed Dr. Cain's file and recent letters in his behalf to obtain full narcotic privileges. He currently holds a limited license to Wayne County, N. C.

VERDICT: Dr. Hooper moved that Dr. Cain be asked to appear before the Board at the December meeting and inform him at that time of the Board's expectations should he be granted full privileges for writing of controlled substance prescriptions, and make clear to him that this would be a privilege he had earned. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Khagendra N. Chatterjee, Newark and Union, N. J. --

The Executive Secretary Designate reviewed the request of Dr. Chatterjee to have the certified photograph and certification of graduation waived as part of the credential requirements for taking the December, 1973 FLEX.

VERDICT: Dr. Partrick moved that the Board require Dr. Chatterjee to fulfill all credential requirements prior to being given permission to take the North Carolina examination. Seconded by Dr. Wilkerson and duly passed.



RE: Dr. Roscoe D. McMillan, Red Springs, N. C. --

The Board reviewed a recent letter received from Dr. McMillan advising that he was ill and would be closing his office and that he would be contacting the Drug Enforcement Administration for carrying out the disposal of his controlled substances.

VERDICT: Dr. Wilkerson moved that the Board accept this letter as information, and write Dr. McMillan and wish him happiness in his retirement. Seconded by Dr. Partrick and duly passed.

RE: Dr. Albert Hugh T. Doss, Raleigh, N. C. --

The Board reviewed Dr. Doss' letter of August 20 requesting the Board's consideration and opinion on his FLEX grades and also reviewed letters received in his behalf.

VERDICT: Dr. Edmondson moved that he be given permission to re-take the examination in December, 1973. Seconded by Dr. Wilkerson, and discussion followed.

Substitute motion: Dr. Hooper moved that he be allowed to re-take the clinical competence part of the examination and his grades then be re-evaluated. Seconded by Dr. Partrick and motion failed to carry by vote of four to one. Continued discussion, original motion questioned and passed by vote of four, with one member abstaining from the vote.

RE: Dr. Alimorad Salartash, Wilmington, N. C. --

The Board reviewed Dr. Salartash's file and request to take the written examination prior to receipt of his alien registration receipt card. The Board also reviewed the letter received from the Department of Justice indicating that visa numbers are available for Dr. Salartash and it would/be a matter of time before same are issued. only

VERDICT: Dr. Hooper moved that Dr. Salartash be given permission to take the December, 1973 FLEX on the basis of the letter from the Immigration Service, and that if he passes the examination and is licensed, same be held until he receives his alien registration receipt card. Seconded by Dr. Staub and duly passed.

RE: Reinstatement -- Biennial Registration

The following physicians' licenses were suspended for failure to register as required by North Carolina General Statutes 90-15.00. They have now registered:

VERDICT: Dr. Hooper moved that if all fees and penalties have been paid, the above physicians be duly registered. Seconded by Dr. Staub and duly passed.

RE: Conversion -- Limited to full license

Dr. Edmondson moved that all applicants for conversion of limited to full license be approved for same if all credentials are in order. Seconded by Dr. Staub and duly passed. They are:

Dr. Hooper moved that if and when all credentials are in order for conversion of limited to full license for Ernest Russell Braasch, he be approved for same. Seconded by Dr. Partrick and duly passed.

RE: Dr. James R. Philp -- applying for written examination and Visiting Professor registration

The Board discussed Dr. Philp's letter of October 9 requesting extension of time for submitting credentials for the examination and regarding obtaining the status of a Visiting Professor prior to the examination.

VERDICT: Dr. Hooper moved that Dr. James R. Philp be granted Visting Professor status and be granted permission, if he can meet the requirements, to take the December, 1973 FLEX, extending the deadline for submitting credentials for same until December 3, 1973. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Elizabeth Philp -- applying for written examination

Dr. Hooper moved that Dr. Elizabeth Philp be given permission to take the December, 1973 FLEX, if she can meet the requirements, and that the deadline for submitting credentials be extended until December 3, 1973. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Camillo Thomas Gualtieri -- report

The President reviewed a letter received by the North Carolina Medical Society in regard to Dr. Gualtieri's practices and treatment of patients. Dr. Gualtieri is currently applying for licensure in North Carolina on the basis of endorsement of credentials. Following Board discussion, the following motion was offered:

VERDICT: Dr. Partrick moved that the Board write the Arlington County Medical Society in Virginia and the hospital where Dr. Gualtieri had privileges and inquire about his character and practices, and in addition, request the Department of Psychiatry at the University of North Carolina School of Medicine, where Dr. Gualtieri is presently) to advise this Board if there is any derogatory information on file with their office on Dr. Gualtieri. Seconded by Dr. Hooper and duly passed.

The Executive Secretary Designate was instructed to contact the head of the Department of Psychiatry at the University of N. C. School of Medicine and inquire about Dr. Gualtieri's recommendation letters there, and at that time advise the head of the Department that Dr. Gualtieri is not properly licensed in the State of N. C.

RE: Dr. Robert LaBarbera, Pittsboro, N. C. --

The President reviewed the file on Dr. LaBarbera and his failing to pass the June, 1973 examination, and in particular, the newspaper accounts on the subject of his practicing in Pittsboro. The Executive Secretary reviewed Dr. LaBarbera's medical education and background and his letter of August 15 requesting a special limited license under Section 90-12 of the Medical Practice Act of the State of North Carolina.

VERDICT: Dr. Wilkerson moved that the Board deny Dr. LaBarbera's request for a limited license under Section 90-12 of the Medical Practice Act as he does not qualify for same. Seconded by Dr. Partrick and duly passed.

RE: Dr. J. Ashley, Sparta, N. C. --

The Board reviewed a recent letter received from a registered nurse in Sparta, North Carolina regarding some complaints she had received relative to Mr. Matthew Recchio in Dr. Ashley's office who refers to himself as a "Medical Assistant" or "Dr. Ashley's Assistant."

VERDICT: Dr. Hooper moved that the District Councilor be asked to look into this and report to the Board office in Raleigh by November 1 and if his findings corroborate in any way the facts in the letter, Dr. Ashley be requested to appear before the Board at the next meeting. Seconded by Dr. Partrick and duly passed.

RE: Dr. Merton W. Olson and Dr. Rex LaGrange, Clarkton, N. C. --

The President reviewed Dr. Olson's file and his failing to pass the North Carolina examination (FLEX) in June, 1972 and 1973, and letter received from the District Councilor of the North Carolina Medical Society in response to the Executive Secretary's request regarding Dr. Olson's activities in North Carolina.

VERDICT: Dr. Partrick moved that if the Board is satisfied that they have received sufficient information on this subject, Dr. LaGrange be requested to appear before the Board. Seconded by Dr. Wilkerson. Discussion followed and

substitute motion offered: Dr. Edmondson moved that the Board retain the services of a private investigator to determine the details of the situation with Dr. Olson and Dr. LaGrange after being instructed as to what information the Board needs and desires. Seconded by Dr. Partrick and duly passed.

RE: "Medical Economics" article -- deviant or inappropriate practice of medicine --

The Board reviewed and discussed recent correspondence and information regarding the article on the deviant or inappropriate practice of medicine as previously discussed at the August, 1973 meeting of the Board, and the attorney for the Board reviewed the actions of the North Carolina Medical Society in this regard taken at their September Executive Council meeting. As presented, the North Carolina Medical Society desires the Board of Medical Examiners to appoint two members to meet with a sub-committee of the Society to discuss the problems of dealing with North Carolina physicians who are possibly involved in the deviant or inappropriate practice of medicine, and report on same to be presented by the next meeting of the Society.

The President appointed Dr. Joseph W. Hooper, Jr. and Dr. E. Wilson Staub to meet with the committee from the Medical Society and discuss the problem.

RE: Application for Registration of Visiting Professors -- application for Dr. Jack Medalie, sponsored by the the University of North Carolina School of Medicine, complete. Dr. Staub moved that Dr. Medalie be approved for registration as a Visiting Professor. Seconded by Dr. Wilkerson and duly passed.

RE: Revision of Application for License by Endorsement --

The Board discussed revisions on the application form as presented by the Executive Secretary Designate and indicated on the form.

VERDICT: Dr. Edmondson moved that the revisions indicated on the application form be approved, adding an additional revision that the photograph attached to the form can be certified by the medical school as a true likeness of the physician. Seconded by Dr. Wilkerson and duly passed.

RE: Expenses for San Diego meeting -- Dr. Hooper moved that the Board approve payment of expenses for the trip of the Executive Secretary Designate to San Diego. Seconded by Dr. Partrick and duly passed.

RE: Citizenship status of applicants for license in North Carolina --

The Board discussed the policy of requiring applicants for licensure in North Carolina to be a United States citizen or, if not, that they be required to hold the alien registration receipt card prior to being considered for licensure.

VERDICT: Dr. Staub moved that the citizenship requirement for being considered for license in North Carolina be deleted from the policies of the Board. Seconded by Dr. Partrick and discussion followed. Substitute motion: Dr. Hooper moved that the citizenship requirement information on the application form be removed. No second to this motion and second substitute motion offered: Dr. Edmondson moved that Dr. Staub's motion be tabled for further thorough study as to the future implications and be taken up at the next Board meeting. Dr. Hooper seconded the motion and it was duly passed by a vote of four with one member abstaining from the vote.

RE: October, 1974 Board meeting -- Dr. Edmondson moved that the October, 1974 Board meeting be held at the Blockade Runner Motor Hotel in Wrightsville Beach, North Carolina. Seconded by Dr. Wilkerson and duly passed. Dr. Hooper moved that the October, 1974 Board meeting be held the week-end following the North Carolina Surgical Association meeting (date to be determined). Seconded by Dr. Edmondson and duly passed.

RE: Family Nurse Practitioner --

Dr. Partrick reviewed the recent correspondence from and conversations with the North Carolina Board of Nursing on the actions taken by the Board of Medical Examiners at their August, 1973 meeting in regard to approving the Rules and Regulations for the Family Nurse Practitioner and approving the University of North Carolina's program for training of family nurse practitioners. Following

this discussion, the Board reviewed the application forms drawn up for approval for the family nurse practitioner to complete in her application and the changes desired in the proposed rules and regulations for the nurse practitioner by the North Carolina Board of Nursing.

VERDICT: Dr. Hooper moved that this Board approve the application form for the Family Nurse Practitioner who is a graduate of the University of North Carolina School of Medicine Family Nurse Practitioner Program, and what is to be submitted in that application, and that the inpatient certification be deferred at this time. Seconded by Dr. Wilkerson and discussion followed. Following discussion, motion passed unanimously.


RE: Proposed Budget, 1974 -- The Board reviewed the proposed budget as presented by the Executive Secretary Designate and approved same as amended.

RE: Election of Board officers --

RE: President -- Dr. Partrick nominated Dr. Joseph W. Hooper, Jr. to serve as President of the Board beginning November 1, 1973. Dr. Wilkerson seconded the nomination and moved that the nominations be closed, seconded by Dr. Partrick. Motion to close nominations duly passed, nominations voted on and Dr. Hooper duly elected to serve as President of the Board beginning November 1, 1973 through October 31, 1974.

RE: Secretary -- Dr. Edmondson nominated Dr. Charles B. Wilkerson, Jr. to serve as Secretary-Treasurer of the Board beginning November 1, 1973. Dr. Staub seconded that nomination and moved that the nominations be closed. Motion to close nominations seconded by Dr. Partrick and duly passed. Nominations voted on and Dr. Wilkerson duly elected to serve as Secretary-Treasurer of the Board beginning November 1, 1973 through October 31, 1974.

There being no further business, the meeting was adjourned.
