The Board of Medical Examiners of the State of North Carolina met October 6-8th, 1960 for the purpose of interviewing applicants for license by endorsement of credentials and special limited license and other business, and convened at the Virginia Dare Hotel, Elizabeth City, Thursday, October 6th, and convened for dinner at 7 P. M.

Drs. J. B. Anderson, President, J. J. Combs, Secretary-Treasurer, Thomas W. Baker, L. R. Doffermyre, Edwin A. Rasberry, Jr., Thomas G. Thurston, Carl V. Tyner, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present.

Thursday, October 6th
8:30 P. M.

RE: Dr. John S. Hooker - Dr. Thomas G. Thurston reported that from personal observation and from inquiry, Dr. Hooker seemed to be getting along all right.

RE: License by Endorsement of Credentials - The following resident physicians appeared before the Board of Medical Examiners with incomplete credentials on July 22nd, 1960, applying for limited license by endorsement of credentials and were approved contingent upon completion of credentials, which were held over to this meeting due to the fact that they were not completed prior to the closing of the books following that meeting. These residents have now completed their credentials and the same have been reviewed.

VERDICT: The above physicians were approved for license by endorsement of credentials, limited to their respective hospitals.

The following resident physicians appeared before the Board with incomplete credentials on July 22nd, 1960, applying for limited license by endorsement of credentials and were approved contingent upon completion of credentials, which credentials have not to date been completed, though the secretary has reminded each one of the requirements of the Board:

VERDICT: Dr. L. R. Doffermyre moved that the above resident physicians cease the practice of medicine in any capacity until credentials are completed. This motion was duly seconded by Dr. C. V. Tyner and passed by a vote of five to one.

The credentials for license by endorsement of credentials and special limited license to be interviewed at this meeting were reviewed.

RE: Optometrists, Mooresville, North Carolina - The secretary presented a letter from Dr. L. B. Skeen alleging that two optometrists in Mooresville were practicing medicine. That this matter was referred to Mr. John H. Anderson, Attorney for the Board, who telephoned Dr. Skeen and advised him the proper procedure to present evidence to the Board in this connection.

VERDICT: The secretary was instructed to write Dr. Skeen that he could work with Dr. Thomas G. Thurston in obtaining evidence in this matter.

Friday, October 7th
9 A. M.

RE: Dr. Jesse Robinson Hicks appeared before the Board of Medical Examiners on July 22nd, 1960, and was approved for license by endorsement of credentials, contingent upon his completing his credentials and making definite arrangements for locating in the state for the practice of medicine, which requirements have been met.

VERDICT: Dr. Jesse Robinson Hicks was approved for license by endorsement of credentials.

RE: Dr. Thomas R. Acklen, Jr. appeared with incomplete credentials applying for license by endorsement of credentials in order that he may locate to practice radiology in Roanoke Rapids, where he has a contract with the Roanoke Rapids Hospital.

Dr. Thurston: You plan to go to Roanoke Rapids?

A. Ues

Q. Where have you been since 1953?

A. Internship, a year of medical residency at Methodist, two years in the service, and Radiology Residency at the Medical College of Virginia.

Dr. Anderson: What are you doing in Washington?

A. Locum tenens.

Dr. Combs: When do you want to go to work?

A. They have someone to cover the hospital until I can get there.

Dr. Anderson: You have never had any difficulty with the Narcotic Bureau, have you? A. No sir

Q. Have you ever been convicted of a crime? A. No

Q. Have you ever had any trouble with narcotics, hypnotics? A. No

VERDICT: Dr. Thomas R. Acklen, Jr. was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Charles Glen Adkins appeared applying for license by endorsement of credentials. He appeared in May, 1960 applying for license by endorsement, limited to Duke University School of Medicine, where he was a resident in Anesthesiology, at which time he was approved contingent upon completion of credentials. Dr. Adkins did not complete his credentials and the secretary was advised by Dr. C. R. Stephen, Professor of Anesthesiology, that Dr. Adkins had discontinued his residency training. Dr. Adkins is now applying for full license to practice in the state.

Dr. Charles Glen Adkins continued

Dr. Thurston: You practiced where?

A. In crater, W. Va.

Q. You decided to go into Anesthesiology?

A. Yes

Q. It did not work out?

A. I decided I would rather do general practice.

Q. Had you done general practice?

A. Yes

Q. How much anesthesia did you do?

A. Six months

Q. Where will you practice?

A. East Durham

Q. Do you plan to do some anesthesia?

A. No, I decided I did not want to do it.

Q. Where will you be affiliated?

A. Watts

Q. Will you be associated?

A. No sir, I hope to later.

Q. It took you six months to make up your mind?

A. That was enough, it just did not suite me.

Q. You did not like being in a group?

A. It was completely different from general medicine. Actually the training was good, but anesthesia as I remembered it I liked, but it wasn't enough clinical stuff there for me.

Q. Did you and Dr. Stephen leave in good terms?

A. Fairly good.

Q. Good as far as you were concerned?

A. Yes

Dr. Combs: How about Dr. Stephen?

A. We discussed it several times. He knew I was dissatisfied. I do not suppose there were any hard feelings.

Dr. Thurston: Were they short staffed when you left?

A. I do not think so, about 12, what they actually carry as I understand.

Dr. Combs: At the time you left, was there a conference between you and Dr. Stephen and he knew you would not be back or did you not re-appear?

A. I told the chief resident and the doctor who was on call that I had decided to drop out.

Q. You did not tell Dr. Stephen?

A. No

Dr. Thurston: Who hired you?

A. Dr. Stephen

Q. Ordinarily you would go back to the man that hired you?

A. That is true

Dr. Charles Glen Adkins continued

Dr. Combs: Where were you the last time you were in practice?

A. West Virginia

Dr. Thurston: Have you had any trouble with alcohol or narcotics?

A. No

Q. You have had no serious illness while practice?

A. No

Q. You have never walked out on a patient?

A. That is the first time I have ever done that. I realized it was a mistake, but for some reason I found Dr. Stephen hard to talk to. We had discussed it a couple of times and he would sort of get angry. He was the only person I have ever known I could not talk to. Even though he knew I was dissatisfied he kept trying to get me to stay so I just told the people I knew I decided to go out.

Dr. Combs: Had you made that decision a couple of times before and Dr. Stephen took you back?

A. Yes, he talked me out of it.

Q. Had you failed to report to work when you were supposed to?

A. No, one other time I did not come to work but I told them. There were little problems came up that I found distasteful. I do not like to talk about a person not present. One morning he came in about eight, I had been there since seven. We had been told to use the machines. I set up this machine and he got angry. Actually no one person would keep me from completing a residency. I never ran out on anything before, but I did not like anesthesia regardless who might have been there.

Dr. Thurston : You did not look into Anesthesiology thoroughly enough?

A. I suppose that is the original mistake.

Dr. Anderson: Have you ever been convicted of a crime? A. No

Q. Have you ever had any difficulty with the Narcotic Bureau or a board of licensure? A. No

Q. You say you have had no trouble with narcotics, hypnotics?

A. No sir, I have not.

Q. When do you want to start practice?

A. The first of the year. Mr. Wellons and I are going to build an office. I am going to work in West Virginia until I get set up.

Dr. Combs: All of your work has been in West Virginia? You have not been moving around?

A. No

Dr. Anderson: Were you working under contract?

A. No sir

Dr. Thurston: Did some other doctor take your practice?

A. That is right. I had a small clinic. I will be helping him.

Dr. Anderson: You have your home in Durham?

A. Yes

Q. Your family is living there?

A. Yes and the children are in school.

VERDICT: Dr. T. W. Baker moved that Dr. Charles Glen Adkins be granted license by endorsement of credentials. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. William Ernest Bakewell, Jr. appeared with incomplete credentials applying for license by endorsement of credentials, limited to the University of North Carolina School of Medicine, where he is a resident in Psychiatry.

Dr. Thurston : Where were you between 1949 and 1959?

A. Working for the Government, in the Navy and the Veterans Administration. I had a residency in surgery at the Veterans Hospital, Denver, and practiced in North Dakota in surgery.

Dr. Anderson: Where do you plan to do surgery?

A. I do not plan to do surgery.

Dr. Thurston : How long will it take you to complete your residency?

A. Three years.

Dr. Anderson: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any difficulty with the Bureau of Narcotics or a board of licensure? A. No sir

Q. Have you ever had any difficulty with alcohol, hypnotics or narcotics?

A. No sir

VERDICT: Dr. William Ernest Bakewell, Jr. was approved for license by endorsement of credentials, limited to the University of North Carolina, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Clinton C. Battle appeared applying for license by endorsement of credentials.

Dr. Thurston: Where have you been since 1950?

A. Six years in general practice in Indianapolis. I had to go back on scholarship program. In 1957 surgical residency in Kansas City General Hospital, Kansas City, Missouri, third year in Provident Hospital in Baltimore. I have just completed three years of surgical training.

Q. Where do you plan to locate in North Carolina?

A. Winston-Salem.

Q. Does that qualify you for surgery boards?

A. If I do a preceptorship. I do not know whether I will be financially able to train that much longer.

Dr. Anderson: Did you have a senior residency?

A. No sir

Q. That would not qualify him.

Dr. Thurston : Have you investigated the staff at Kate B. Reynolds Hospital?

A. I have already filed application.

Q. Will your training qualify you to be on the staff there?

A. Yes sir, it is approved by the American College of Surgeons.

Dr. Anderson: Do you plan to work with anyone?

A. I was going to enter practice and if I could get my finances straightened out, I have a family, I probably would do a preceptorship. Some of the fellows mentioned a physician there by the name of Dr. Odham.

Q. Have you talked to Dr. Odham?

A. No

Q. Your activities will be handicapped unless you do ^{make} some arrangements.

Dr. Clinton C. Battle continued

- Dr. Anderson: Have you ever been convicted of a crime? A. No sir
- Q. Have you had any difficulty with the Bureau of Narcotics or any board of licensure? A. No sir
- Q. Have you ever had any trouble with alcohol, narcotics or hypnotics?
- A. No sir
- Q. When are you planning to come to Winston-Salem?
- A. As soon as I can get my license and buy a house. I am going to look while I am in this area now.
- Q. Where is your residence now?
- A. Clarksdale, Mississippi
- Q. Are you practicing now?
- A. I am practicing with a doctor there.

VERDICT: Dr. Clinton C. Battle was approved for license by endorsement of credentials.

RE: Dr. John L. Bond appeared with incomplete credentials applying for license by endorsement of credentials.

- Dr. Doffermyre: When do you separate from the service?
- A. I am leaving officially in January, actually in November, taking a leave to go in practice.
- Q. What type of practice?
- A. General surgery
- Q. You are going to North Wilkesboro?
- A. Yes, to be associated with Dr. R. E. Lewis.

Dr. Bond was advised that it would be necessary to complete credentials within two weeks.

- Dr. Anderson: Have you ever been convicted of a crime? A. No

- Q. You are going to be medical director of the Out-Patient Diagnostic Clinic and to be associated with the Department of Pediatrics at Duke?

- Dr. Anderson: Have you ever been convicted of a crime? A. No sir

RE: Dr. Ilhan Vidinel appeared with incomplete credentials applying for special limited license to the North Carolina Sanatoria. He is on the staff at the Eastern North Carolina Sanatorium. Dr. Vidinel presented his exchange visa.

Dr. Anderson: You are going to be here how long?

A. Two years

Q. Are you going to take the examination again?

A. In March

VERDICT: Dr. Ilhan Vidinel was approved for special limited license to the North Carolina Sanatoria on an annual basis, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Thomas D. Kinney, Chairman of the Department of Pathology, Duke University School of Medicine, a graduate of Duke University School of Medicine in 1937 - Dr. Kinney appeared before the Board of Medical Examiners with reference to obtaining license to practice medicine in this state. He is a diplomate of the National Board of Medical Examiners and has no state medical board by which he may apply for license by endorsement.

Dr. Anderson: When did you come to Duke?

A. By appointment September 1st. This came up rather suddenly and I got caught in the wheels of machinery.

Q. We think it is fine to have you, but it is also irregular.

A. When I graduated from Duke I took the National Boards and was later licensed in Massachusetts and Ohio by endorsement from National Board.

Dr. Kinney informed the Board that he was bringing in about eight men with him, three of whom are fellows.

VERDICT: Dr. C. V. Tyner moved that a special written examination be given to the group in the Pathology Department at Duke. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. Thomas H. Brantley, Concord, North Carolina - To summarize, Dr. Brantley surrendered his narcotic tax stamp May 21st, 1957, following investigation by the Bureau of Narcotics on account of his having purchased an excessive amount of drugs (see records); that he stated all the drugs were used by his wife. In August, 1960, the Nar-

cotic Bureau was advised that Board in session had instructed that recommendation not be made by the Board for reinstatement of the narcotic tax stamp. On September 1st, 1960, in conversation between Dr. Combs and the district office of the Narcotic Bureau, Mr. I. I. Greenfeld stated they would have to issue the narcotic tax stamp and then stated he would try to get a ruling from the Legal Department to the effect if the Board recommended that tax stamp not be issued, they would not issue it. Following this the secretary, after conferring with the president of the Board, requested Dr. Brantley to appear at this meeting.

Dr. Brantley appeared and the Board advised him that due to the fact that he had purchased excessive narcotic drugs in the past, had kept no records, and had admitted administering them to his wife, it had been recommended that his narcotic tax stamp not be reinstated. Dr. Brantley said that he had an associate membership on the staff at the Concord Hospital; that his office was in his home; that he had practiced continuously and was doing urology; that he needed his narcotic tax stamp in his practice and was unable to get any co-operation from his colleagues; that his wife had been off drugs for three years. The Board told Dr. Brantley they felt if he had access to narcotics, it would be a temptation to administer the same to his wife, if she so demanded.

VERDICT: Dr. L. R. Doffermyre moved that the matter remain status quo. This motion was duly seconded by Dr. C. V. Tyner and passed unanimously.

The meeting was adjourned.

RE: Dr. Franklin Stith Kincheloe, Jr., Selma, North Carolina - To summarize, Dr. Kincheloe surrendered his narcotic tax stamp at the direction of the Board of Medical Examiners in March, 1952, on account of drug addiction. When Dr. Kincheloe registered his license his address was given as Richmond, Virginia. On September 8th, 1960, Dr. Kincheloe came to the secretary's office and advised that he had been in Selma since August, 1960, and stated that he desired his narcotic license. Upon inquiry the Virginia Board of Medical Examiners advised that Dr. Kincheloe had been arrested in Richmond on the charge of rape of a 50 year old white woman, tried on this charge, and not convicted. Also upon inquiry, Dr. Geoffrey T. Mann, Chief Medical Examiners for the State of Virginia, reported that he had evidence against Dr. Kincheloe, which he would divulge provided he were subpoenaed for a formal hearing.

Dr. Kincheloe appeared at this time upon the request of the Board. He did not admit he had any trouble in Virginia until approached with the facts, at which time he stated that he was exonerated in court in the rape case; that Dr. Mann had made accusations against him, but no charges had been preferred. (See interview) He said that no charges were justified. Dr. Kincheloe agreed to sign a statement authorizing Dr. Mann to furnish the Board with a report; that if there were a hearing he would like to have his attorney and investigators present.

VERDICT: Dr. T. W. Baker moved that Dr. Kincheloe furnish the Board with a signed statement giving his permission to Dr. Geoffrey T. Mann to furnish this Board with information on file in regard to him

and also authorize to obtain investigating reports by his legal counsel and investigators in regard to charges made against him in Richmond, Virginia; also that he remain under the surveillance of this Board indefinitely; that the Board does not recommend reinstatement of his narcotic license at this time. This motion was duly seconded by Dr. C. V. Tyner and passed unanimously.

RE: Dr. Alton Lane Bullard, Newton Brove, North Carolina - The Board of Medical Examiners received notice from the California Board of Medical Examiners that Dr. Bullard's license to practice medicine in that state was suspended March 5th, 1958, for a period of one year, however, execution of the order of suspension was stayed for a period of five years, during which Dr. Bullard was placed on probation, for alcoholism. That on April 27th, 1960, the probation was terminated and the stay of the execution of the order of suspension cancelled and said suspension of medical license in California put into effect as the terms of the probation had been violated.

The secretary of the Board of Medical Examiners learned that Dr. Bullard had returned to North Carolina and started practice in Newton Grove and he was thereupon directed to appear at this time.

Dr. Bullard appeared and verified the facts as reported by the California Board of Medical Examiners. He said he began practice in Newton Grove September 6th. (See file for complete interview). He stated that he had three months institutional treatment after March 10th, 1960; that he had no alcohol since that time.

VERDICT: Dr. C. V. Tyner moved that Dr. Alton Lane Bullard be placed under the surveillance of the Board for five years, with periodic reports as deemed necessary. This motion was duly seconded and passed unanimously.

The meeting was adjourned.

The Board convened at The Carolinian, Nags Head, North Carolina. Dr. T. G. Thurston was unable to attend the following sessions.

RE: Dr. Charles Heman Gantt, Spruce Pine, North Carolina (See previous Minutes) - The secretary reported that Dr. Gantt advised on July 30th, 1960, by letter that he was complying with the order of the Board as to narcotics; that he was admitted to Duke Hospital on July 31st, 1960 and discharged to the Veterans Administration Hospital in Durham on August 5th, 1960. (See report on file) That Dr. Gantt remained at the Veterans Hospital until September 30th, 1960. The established clinical diagnoses was as follows:

1. Diagnosis undetermined: (Syncopal, black out spells of undetermined etiology)
2. Dissociative reaction (suspected, unproven)
3. Organic brain syndrome of unknown cause (suspected but unproven)

It was suggested that Dr. Gantt return for further study in about three months.

VERDICT: Dr. T. W. Baker moved that judgment in the case of Dr. Charles Heman Gantt be deferred until after his 2½ months check up at the the Veterans Administration Hospital in Durham and that he be discouraged from practicing medicine in the meantime. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. W. Percy Carter, Gastonia, North Carolina - The Board requested Dr. C. V. Tyner to obtain information from the medical profession in Gastonia. Dr. Tyner reported that the information he received was that Dr. Carter had the reputation of having done abortions and the feeling was to leave the matter status quo. This was received as information by the Board.

RE: Dr. John Milton Gambill - The secretary reported that he received a letter from the Veterans Administration Hospital, Salisbury, that Dr. Gambill was admitted as a voluntary patient on August 23rd, 1960.

The meeting was adjourned.

RE: Biennial Registration of Physicians - Reinstatement - The medical licenses of the following physicians were suspended for failure to register as required by G. S. of North Carolina 90-15.1:

The secretary reported that the above physicians have now paid the fees and penalties required by law for registration.

VERDICT: RESOLVED that the medical licenses of the above physicians be reinstated.

RE: Dr. Preston C. Stringfield, Jr. - The secretary reported that he had received notice from Dr. Stringfield's father that he is now employed in a Veterans Administration Hospital in another state. This was accepted as information.

RE: Dr. Paul Vlaanderen was granted license on the basis of written examination in June, 1960. He has now changed his name to Paul Arthur Fleming by court order and has petitioned to have his medical license changed and issued under his new name. The attorney of the Board advised that it is within the discretion of the Board.

VERDICT: Dr. E. A. Raspberry, Jr. moved that the records of the Board be changed to Dr. Paul Arthur Fleming. This motion was duly seconded by Dr. T. W. Baker and passed unanimously.

RE: Dr. Jerry Milton Ingalls - The secretary reported that Dr. Ingalls, a licentiate of this state, had applied for license by endorsement to the State of Oklahoma, but had been advised that since he had made a grade of 73% on one subject, he could not be licensed under the Oklahoma law; that 75% is required in each subject. That he could retake the examination given by the North Carolina Board of Medical Examiners.

VERDICT: The secretary was instructed in such cases that it would be necessary to retake the examination at the next regular examination.

The secretary reported that he had given a talk on narcotics to law enforcement officers at a meeting held by the Institute of Government.

RE: Dr. Alfred H. Sokolowski, who is in military service at Fort Bragg, was approved for license by endorsement of credentials on July 22nd, 1960, on the basis of endorsement from Michigan, contingent upon a letter from his commanding officer stating that it was permissible for him to practice medicine in his off hours, and a letter from the Cumberland County Medical Society stating that his services were needed in the community.

The secretary reported that he received a very belligerent letter from Dr. Sokolowski following his receipt of the Board's verdict, with a request for refund of his fee, which was complied with; that he also received a letter from the secretary of the Michigan Board of Medical Examiners, with copy of letter to that board from Dr. Sokolowski, stating that the North Carolina Board of Medical Examiners does not reciprocate with Michigan, as he was not granted license. The secretary reported that an explanation of this matter had been made to the Michigan Board.

VERDICT: It was the opinion of the Board that if Dr. Alfred H. Sokolowski applies again for license in this state, that the matter should be given very careful consideration.

RE: Dr. Patrick J. O'Shaughnessy took and failed Part II of the written examination in June, 1960. It was reported to the secretary that he died in August, 1960 of pheochromocytoma. Mrs. O'Shaughnessy has requested the Board to issue a license posthumously for posterity.

VERDICT: Dr. E. A. Rasberry, Jr. moved that Dr. Patrick J. O'Shaughnessy's widow be granted medical license posthumously. The motion failed for lack of a second.

The meeting was adjourned.

Dr. Carl V. Tyner advised the Board that he had been nominated for Governor of his Rotary District and it would be impossible for him to attend the meeting of the Board to be held in May, 1961.

VERDICT: Dr. J. J. Combs moved that the Board is honored that Dr. Carl V. Tyner has been nominated Governor of his Rotary District and that he be excused from attending the May, 1961 meeting of the Board with good faith and freedom of worry from the Board. This motion was duly seconded by Dr. E. A. Rasberry, Jr. and passed unanimously.

RE: Dr. W. Clyde Thomas, Siler City, North Carolina - Dr. Thomas was requested to appear before the Board at its June, 1960 meeting with reference to prescribing narcotics for a drug addict, which he failed to do on account of illness. He also failed to report to the office of the secretary of the Board for the same reason.

The secretary reported that he had received a letter from Dr. J. B. Earle of Siler City, who stated that Dr. Thomas suffered a severe coronary three years ago and since that time his practice has been limited; that he is 65 years of age. Due to his physical condition, it was his opinion that it would be an extreme hardship for Dr. Thomas to appear before the Board. This was accepted as information.

RE: Dr. Frank Edward Pollock was granted limited license to Bowman Gray School of Medicine on October 12th, 1957, on the basis of endorsement of credentials. He has located in Winston-Salem for practice and has applied for limited license to be converted to a full license. He has complied with the requirements of the Board.

Dr. Frank Edward Pollock continued

VERDICT: Dr. J. J. Combs moved that Dr. Frank Edward Pollock be granted a full license to practice medicine. This motion was duly seconded and passed unanimously.

RE: Dr. Herman B. Gray - The secretary reported that Dr. Gray, a graduate of Boston Physicians and Surgeons, a grade B medical school, is working at the Community Hospital, Wilmington, as reported by the superintendent of the hospital on August 4th, 1960.

VERDICT: Dr. J. J. Combs moved that the Community Hospital be advised that Dr. Herman B. Gray is not eligible to practice medicine in this state, with a copy to the State Bureau of Investigation and the North Carolina Hospital Association. This motion was duly seconded by Dr. E. A. Rasberry, Jr. and passed unanimously.

RE: Finance Committee - Dr. J. B. Anderson, President, appointed Dr. T. W. Baker, Chairman, and Drs. L. R. Doffermyre and C. V. Tyner as Finance Committee.


The Board approved the expense for flowers for Mrs. LaVoyce H. Harrell while in the hospital.
