## **CALL TO ORDER**

Hector H. Henry, II, M.D., President of the Board of medical Examiners of the State of North Carolina called the meeting to order on Wednesday, September 16, 1992, at 7:30 p.m. The meeting was held at the Embassy Suites Hotel, Raleigh, North Carolina.

## **MINUTES**

On September 19, 1992, during the Agenda report, the Board adopted a motion made by Dr. Patterson and seconded by Dr. Stratas that the minutes of the June 1992 and July 1992 Board meetings be adopted as presented.

## **MEETINGS**

On September 19, 1992, during the Agenda report, the Board reviewed meeting dates for the September 1993 and November 1993 meetings. The Board adopted a motion made by Dr. Stratas that the staff list present meeting dates and propose meeting dates for the rest of 1993, send list to all Board members and proposed Board members. Board members will be asked to look at their calendars and be prepared to make final decisions at the November 1992 meeting.

## **DATA REQUEST**

On September 19, 1992, during the Agenda report, the Board reviewed a request for data from Crumpton Company, Durham North Carolina. The Board adopted a motion made by Dr. Patterson and seconded by Dr. Roufail to deny the request.

## **CAPE FEAR INTERNAL MEDICINE ASSOCIATES**

On September 19, 1992, during the Agenda report, the Board reviewed a request by Ben C. Siy-Hian, M.D. for approval of Cape Fear Internal Medicine, P.A. as a practice name. The Board adopted a motion made by Dr. Patterson and seconded by Dr. Spangler to deny the request.

## **HENDERSONVILLE CARDIOLOGY**

On September 19, 1992, during the Agenda report, the Board reviewed a letter from Mr. Thomas K. Snell, Administrator, Asheville Cardiology Associates, P.A., requesting approval of Hendersonville Cardiology as a corporate name. The Board adopted a motion made by Dr. Patterson and seconded by Dr. Spangler to approve the request.

## **PCERP - CLINICAL ENHANCEMENT PROGRAM**

On September 19, 1992, during the Agenda report, the Board reviewed a proposal from Dr. Duckett regarding the PCERP - Clinical Enhancement Program. The Board adopted a motion made by Dr. Stratas and seconded by Dr. Roufail that the Board accept the proposed program to determine if doctor needs additional training and fund the program for an initial fee of \$10,000.

## **RULE HEARING - USMLE**

On September 19, 1992, during the Agenda report, Mr. Paris reported that a Rule Hearing regarding USMLE was scheduled for November 2, 1992, 1203 Front Street, Raleigh, North Carolina and requested that the Board appoint a Hearing Officer to conduct the Hearing. Dr. Henry indicated that he would contact Mr. Paris after the meeting regarding his availability as a Hearing Officer.

## **PHEP - PROPOSED 1993 BUDGET - In**

ON September 17, 1992, during the PHEP report, the Board reviewed the proposed 1993 Budget. The proposed budget for PHEP notes an increased BME contribution from \$221,311 in 1992 to \$358,823 in 1993. Dr. Vanderberry discussed proposed budget with the Board and advised that the substantial increase is due to the need for an Assistant Medical Director. Contributions from the Medical Society are decreasing, Medical Mutual and the Hospital Association are steady contributors, but the BME is the main source of funds for the program. Efforts are being undertaken to solicit donations from malpractice carriers, and participants are being encouraged to contribute to the program. Dr. Stratas mentioned that in the long run an increase in licensing fees and a billing procedure for participants is where the funds will come from.

The Board adopted a motion made by Dr. Patterson and seconded by Dr. Stratas that Representatives from the Finance Committee are to consult with the Chairman of the Administrative Committee and make a recommendation on the proposed budget.

## **PHEP PLANNING RETREAT**

On September 17, 1992, during the PHEP report, Dr. Stratas reported on the PHEP retreat held in July. Priorities for the future include: 1) an assistant to Dr. Vanderberry - assistant medical director; 2) organization. The Medical Society and the BME need to revisit the original organization and come up with a new entity, similar to the Foundation, that will "house" PHEP. Dr. Fleury will appoint a committee to consider this matter and make recommendations.

The Board adopted a motion made by Dr. Spangler and seconded by Dr. Patterson that the Board endorse in principle the conclusions reached by the PHEP Board and offer support to further the enhancement of the implementation of those plans.

#### **PHEP BY-LAWS CHANGED**

On September 16, 1992, Dr. Vanderberry reported that the by-laws were changed to eliminate all ex officio members from the PHEP Board of Directors. Dr. Vanderberry presented Mr. Paris with a plaque in recognition of his service on the PHEP Board from 1989 - 1992.

#### **REGULATION OF EXTENDERS IN NEIGHBORING STATES**

On September 19, 1992, during the Attorney's report, Bill Breeze reported that neighboring States routinely require that physician assistants practice only when a physician is on site except in exceptional circumstances. The Board accepted this as information.

#### **KIM, Young Cue**

On September 19, 1992, during the Attorney's report, Bill Breeze reported that Dr. Kim may be applying for licensure in Maryland and that information is being shared with that State. The Board accepted this as information.

#### **LEGISLATION UPDATE**

On September 19, 1992, during the Attorney's report, Bill Breeze reported that an Amendment adding Chapter 90-400 through 90-403- providing that health care providers may not compensate or reward a person or firm or corporation for recommending or securing patients for the provider. The Board accepted the recommendation of Dr. Stratas that Bill Breeze provide the Board members with a copy of this legislation.

#### **DENIAL FOR LICENSURE BASED ON ANTICIPATED CONDUCT**

On September 19, 1992, during the Attorney's report, Bill Breeze reported that applicants who qualify for licensure cannot be denied based on anticipated misconduct. Dr. Stratas asked if the doctors intentions raise questions about his psychiatric status can the Board ask for a psychiatric evaluation?

#### **LETTERS OF CAUTION**

On September 19, 1992, during the Attorney's report, Bill Breeze reported that the Board should use letters of caution instead of Non-public letters of reprimand. The Board accepted the proposal to caution instead of reprimand so that disciplinary terms are not used.

**INFORMAL AGREEMENTS NOT TO PRESCRIBE**

On September 19, 1992, during the Attorney's Report, Bill Breeze presented a proposed form for agreement between the Board and a doctor to be executed through the Board for a gentlemen's agreement. The Board did not approve the proposed form, but adopted a motion that all surrenders and restrictions would be reported.

**HEARING CARE PROFESSIONALS**

On September 19, 1992, during the Attorney's Report, Bill Breeze presented a letter Ray Bedsaul, Association of Hearing Care Professionals, with concerns about the terms used by Hearing Aid professionals in their ads. The Board adopted a motion to refer this letter the the Hearing Aid Dealers Board.
