The patient's CT scan showed widespread bleeding in the space surrounding the brain from a leak from a ballooned and weakened area in a blood vessel (ruptured brain aneurysm). MD's failure to appropriately diagnose and rectify a thrombus complication intraprocedurally is noted. Immediately after the procedures, a CT scan showed dead brain tissue as a result of the decreased cerebral blood flow and the patient subsequently died. While the patient received medication to decrease her blood's clotting ability and thrombus, the Board's expert opined that the dose was insufficient to increase the activated clotting time to a therapeutic range. The patient filled three prescriptions for Oxycodone tablets at three different pharmacies on the same day in amounts of 120, 180, and 180 tablets. Due to concerns regarding MD's prescribing practices, the Board submitted five of MD's patient records to an independent reviewing expert who found that MD's care for four of the five patients failed to conform to the standards of acceptable and prevailing medical practice.
