NOTE

Definition of Prejudicial and Non-Prejudicial

PREJUDICIAL ACTION

Actions by the Board resulting from the behavior, performance, or condition of licensees that require correction and/or discipline under the Medical Practice Act.

NON-PREJUDICIAL ACTION

Action by the Board resulting from the Board's positive decision regarding licensees or issues involving licensees. These actions often relate to satisfactory progress by those against whom prejudicial actions were previously taken, to structuring the reentry of licensees to practice after a period away from practice, or to the dismissal of charges.
