## **North Carolina Medical Board**

The North Carolina Medical Board held its regularly scheduled October 2014 meeting at the Board's office located at 1203 Front Street, Raleigh, North Carolina. Paul S. Camnitz, MD, President, called the meeting to order on Thursday October 16, 2014, at 8:06 a.m. Board members participating were: Cheryl L. Walker-McGill, MD; Pascal O. Udekwu, MD; Timothy E.
