

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF THE STATE OF NORTH CAROLINA

Grove Park Inn, Asheville, North Carolina

August 12 - 14, 1971

The Board of Medical Examiners of the State of North Carolina met at the Grove Park Inn, Asheville, North Carolina August 12-14, 1971, for the purpose of interviewing applicants for license by endorsement, certifying examination grades and other business.

Thursday, August 12th
6:00 P. M.

The Board convened for dinner. Drs. H. Lee Large, Jr., President, Joseph J. Combs, Secretary-Treasurer, Frank Edmondson, Bryant L. Galusha, Joseph W. Hooper, Jr., Cornelius T. Partrick, William H. Sprunt III, Louise J. McNeill, Administrative Secretary, and Mrs. Betty Joe Cooke, were present. Dr. Vernon Williams Taylor, Jr., who is to succeed Dr. William H. Sprunt III at the close of this meeting, was also present.

RE: Dr. Donald Richard Bailey appeared before the Board of Medical Examiners in June, 1971, applying for license by endorsement of credentials, at which time the secretary was instructed to procure information relative to possible alcoholic problem.

The secretary reported at this time that he had received verbal information that Dr. Bailey had had some alcoholic problems but he did not receive any information in writing nor did he receive verbal information that this problem was current. The secretary was advised by Dr. W. D. James of Hamlet that he was ready to have Dr. Bailey come to Hamlet for the practice of medicine as soon as he becomes licensed.

VERDICT: Dr. Joseph W. Hooper, Jr. moved that Dr. Donald Richard Bailey be requested to appear at the October, 1971 meeting of the Board. This motion was duly seconded by Dr. Frank Edmondson and passed.

RE: Dr. Joseph Kreplick, Cherry Hospital, Goldsboro, North Carolina - (See previous Minutes) - The secretary presented letter from Dr. Kreplick in which he petitioned the Board to convert his license limited to the North Carolina Department of Mental Health to a full license.

VERDICT: Dr. Frank Edmondson moved that the license of Dr. Joseph Kreplick continue to be limited to the North Carolina Department of Mental Health. This motion was duly seconded by Dr. Cornelius T. Partrick and passed.

RE: Dr. Robert Edward Gardner, Cherry Hospital, Goldsboro, North Carolina - (See previous Minutes) - Dr. Gardner, who is a patient at Cherry Hospital for narcotic addiction, advised the secretary on June 18th, 1971, that he is currently staff physician at O'Berry Center and unit director of the Crippled Children's Hospital.

VERDICT: Dr. Joseph J. Combs moved that this report from Dr. Robert Edward Gardner be received as information. This motion was duly seconded and passed.

RE: Dr. William A. Moody, Greenville, North Carolina - (See previous Minutes) - The secretary reported that he had interviewed Dr. Moody on June 30th and it was explained to him that the Board recommended that he be in institutional practice; that he stated unless he could get a job sufficient to pay his indebtedness to I. R. S. within the next four or five years, he was afraid he would go back into a depressed state.



Dr. Moody continued

The secretary submitted the following report on Dr. Moody dated July 8th, 1971 from Dr. Moody's physician: Final Diagnosis: Dilaudid addiction improved, depressive neurosis improved, passive aggressive personality improved. This physician stated he was relocating in another state and that Dr. Moody would continue his treatment as soon as he could find another qualified therapist.

VERDICT: Dr. Frank Edmondson moved that Dr. William A. Moody be requested to appear before the Board at its next meeting and ask if he has had psychiatric treatment since Dr. Walter P. Savage left Greenville. This motion was duly seconded and passed.

Minutes for the June, 1971 meeting were approved as read.

RE: Dr. Joseph C. Fesperman, Stanley, North Carolina - Dr. Fesperman was requested to appear at this meeting and the secretary presented letter dated July 30, 1971 from Dr. Fesperman's secretary, dictated by Dr. Fesperman, that he would be unable to appear at this time for a routine interview due to hospitalization in the Gaston Memorial Hospital. The secretary reported that he had communicated with his physician who stated that Dr. Fesperman had been taking large doses of talwin; that he had multiple abscesses from many puncture wound, for which he was treating him; that he was trying to get him off injectable medicine and confine him to talwin orally.

VERDICT: Dr. Frank Edmondson moved that letter from Dr. Joseph C. Fesperman be received as a matter of information; that due to his illness, the Board hold in abeyance action on the judgment of the Board; that the secretary be instructed to advise Dr. Fesperman to abstain from practice and that he be requested to appear before the Board at its next meeting in October, 1971. This motion was duly seconded by Dr. Cornelius T. Partrick and passed unanimously.

RE: North Carolina Board of Pharmacy - The secretary presented letter from the secretary of the Pharmacy Board soliciting assistance in the solution of writing prescriptions on the part of physicians. He stated that with the new Federal Controlled Substances Act that will go into effect January 1st, that this would be the time to begin a campaign to that end.

VERDICT: Dr. Frank Edmondson moved that if the secretary of the Pharmacy Board wants to rewrite or edit this letter and he would not object, that it be put in the news letter of the State Medical Society and a copy sent to the county medical societies. This motion was duly seconded by Dr. Cornelius T. Partrick and passed.

RE: Flex Examination - Dr. Bryant L. Galusha moved that the secretary check with Flex and if possible to procure grades to set the meeting for August 3-5, 1972. This motion was duly seconded by Dr. Cornelius T. Partrick and passed.

RE: Dr. W. A. Y. Sargent, Burnsville, North Carolina, surrendered his narcotic tax stamp in February, 1966 due to the fact that he had become involved with some known addicts and written prescriptions for a large amount of drugs. The secretary received letter from the local medical society with regard to the new narcotic law and the fact that Dr. Sargent had no narcotic tax; that there was dire need for more medical service in the community. The Board advised at that time it would endorse Dr. Sargent for approval of drugs under narcotic classification 3, 4 and 5.

Dr. Sargent appeared for routine interview at the request of the Board. He said that he was doing well in his practice; that he felt he could practice satisfactorily with drugs under classification 3, 4 and 5; that he did not dispense any drugs from his office.

VERDICT: Dr. Frank Edmondson moved that Dr. W. A. Y. Sargent be commended for the way he has abided by the judgment of this Board; that it is hoped he will continue to be observant of the laws and regulations relative to control drugs; that the Board approve application for drugs under classification 3, 4 and 5. This motion was duly seconded and passed.

RE: Dr. James Richard Hughes, Newport, North Carolina - The secretary presented letter from Dr. W. M. Bethune of Cherry Hospital dated July 28th, 1971, with regard to Dr. Hughes, who stated that Dr. Hughes returned to the hospital after his escape in very poor physical condition, using barbiturates very heavily; that he was not at that time ready to go into practice.

VERDICT: Dr. Bryant L. Galusha moved that the Board thank Dr. W. M. Bethune for his information and that progress report be procured for the October, 1971 meeting. This motion was duly seconded and passed.

RE: Dr. Lewis B. Bolin, Gastonia, North Carolina - The secretary presented from the Pharmacy Board that it had received a number of calls from parents of teenage boys alleging that Dr. Bolin was giving prescriptions for "questionable" drugs. This report related that investigation did not substantiate the allegations. This report was received as information.



RE: Dr. W. N. Corpening, Granite Falls, North Carolina - Dr. Corpening was requested to appear before the Board of Medical Examiners pursuant to a report from the Narcotic Bureau, which reported that he was grossly deficient in keeping records. It was reported from the Narcotic Bureau's office in Greensboro that due to a technicality in drawing the warrant all drugs confiscated from Dr. Corpening had been returned and all charges dropped. The report from the Narcotic Bureau stated that Dr. Corpening alleged he had inherited patients who were habituated to controlled substances, particularly amphetamines, and he had been unsuccessful in alleviating their habituation.

Dr. Corpening appeared and stated he had a large practice, many patients inherited from his father, who practiced until the age of 87; that he felt the investigation was directed at his father; that the warrant drawn by the narcotic agents was not in his name. He said that he had many patients taking drugs whom he had inherited, some of whom were abusing the same; that he had used many drugs, but had cut down, and was prescribing very few drugs since the investigation. He related that all matters were dealt with through his attorney; that the narcotics were returned and he has kept them sealed and the matter was dropped.

VERDICT: Dr. Bryant L. Galusha moved that Dr. W. N. Corpening be informed that he has unintentionally abused the use of drugs by our standards. This motion was duly seconded and passed. The president advised Dr. Corpening of the action of the Board.

RE: Dr. John Henry Bumgarner, Newton, North Carolina - Pursuant to a report from the State Bureau of Investigation that Dr. Bumgarner was treating drug addictions with methadone, dilaudid and Levo-Dromoranx, he was requested to appear before the Board. Dr. Bumgarner stated that he was attempting to assist drug addicts by treating them; that he had been advised Lexington was closing; that he was trying to keep the number to a minimum; that he had called in the State Bureau of Investigation to report that he was treating these patients.

VERDICT: The Board directed the president to tell Dr. Bumgarner that it was interested in keeping him out of trouble and in having him give the best care to any group he was treating; that he would be required to register these patients with the State Board of Health and get the authority to participate in the methadone treatment. Dr. Bumgarner was so advised and directed to write a letter to the Board indicating what action had been taken and when carried out.

RE: Dr. James Valentine Thomas, Eden, North Carolina - Dr. Thomas' license to practice medicine was reinstated on probationary status and he appeared for a routine interview at the request of the Board. He stated that he was doing well in his work; that he is associated with two other doctors; that they have a good working arrangement and he feels that he has support. The Board directed that he be seen in six months.

RE: Dr. A. Smith Kinne, Elgin, Illinois, appeared in September, 1969 applying for license by endorsement and at that time had no definite plans as to when he would begin practice here. His application was approved contingent upon his coming into the state for practice, within one year. He has now advised that he has purchased a home in Burnsville, North Carolina and planned to move there in October of this year and establish permanent residence shortly thereafter.

The Board ruled that Dr. A. Smith Kinne might be permitted to answer by letter the questions routinely asked applicants for license by endorsement of credentials in lieu of another appearance.

Skeen, Mooresville, North Carolina - Report from Dr. Skeen was presented that he had reported to the Bureau of Narcotics and Dangerous Drugs with regard to the addicts he is treating with methadone stating that he would not take any more for treatment and was proceeding with a program of withdrawal for those under treatment.
