Philip Arzt Kees, M.D., Raleigh, North Carolina

The Board adopted a motion that Dr. Kees be denied a resident's training license.

Lewis William Hagna, M.D., Marion, North Carolina

Following review of information presented, the Board adopted a motion to institute the proper procedures to prefer charges against Lewis William Hagna, M.D., that he be so notified in writing, and that he be advised that he will be given a hearing on such charges that will be presented against him.

FLEX Test Committee Findings

Dr. Galusha reported to the Board that the failure rate for FLEX with regard to first-time U.S. graduates is 1.3%. He further stated that North Carolina is not actually recognizing two examinations because FLEX and National Board are equivalent.

American University of the Caribbean

The Board reviewed information concerning this school. The Board adopted a motion that the Executive Secretary check with Ray Casterline regarding the American University of the Caribbean and that no further action be taken at this time.

A hearing was held before the Board of Medical Examiners of the State of North Carolina upon and concerning charges and accusations preferred by the Board in this matter at the Grove Park Inn, Asheville, North Carolina, on Friday, August 15, 1980, at 1:00 p.m., at which hearing Dr. Mize did appear and was represented by counsel. After consideration of the evidence and testimony presented at such hearing, such Board made and entered the following: Respondent, Edwin Sims Mize, M.D., consumed and administered to himself daily over a long period of time in 1979 and 1980 quantities of Talwin and Phenergan, controlled substances, without any medical reason for so doing and solely for the purpose of satisfying his dependence upon and addiction to the use of Talwin. It was therefore ordered that respondent's license to practice medicine be revoked.

Dr. Pagter, Bob Bailey, and Mark Eddinger reported to the Board on the hearing held on July 31, 1980. The Board adopted a motion that the former EMS regulations be repealed and that the new Regulations with typographical errors corrected and changes in language as worked out with the Executive Secretary and the Board's Attorney be adopted. The Board adopted a motion that the new EMS Rules be distributed to all Board members along with memorandums to secure positive responses from Board members. The Board adopted a further motion that the EMS certificates be changed to show "approval." The Board adopted a motion that the Office of Emergency Services be requested to draw up stipulations concerning Knotts Island as well as encouraging Cardiac Technicians to upgrade their preparation, and that these stipulations be submitted to the Executive Secretary of the Board of Medical Examiners, so that these recommendations may be reviewed by the Board at the October meeting. The Board adopted a motion that the new Rules and Regulations include some provision for special situations that may develop and that may not be in total compliance with the Regulations. The Board adopted a motion that the Joint Subcommittee be allowed to review MICN applications as long as the Board of Medical Examiners is ultimately responsible. The Board adopted a motion that an MICN who is currently certified will not have to meet initial certification requirements in future recertification.


