

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF THE STATE OF NORTH CAROLINA

The Board of Medical Examiners of the State of North Carolina met at The Winston-Salem Hyatt House, Winston-Salem, North Carolina, August 8-12, 1974 for the purpose of interviewing applicants for license by endorsement of credentials and other business.

Thursday, August 8
5:00 p.m.

The Board convened for business and reviewing of credentials of applicants for license by endorsement. Drs. Joseph W. Hooper, Jr., President, Charles B. Wilkerson, Jr., Secretary-Treasurer, Frank Edmondson, Bryant L. Galusha, Cornelius T. Partrick, E. Wilson Staub and Vernon W. Taylor, Jr. were present. Also present were Mr. Bryant D. Paris, Jr., Executive Secretary, Mrs. Betty Joe Cooke, and Mrs. Diane Freeman.

RE: June 1974 FLEX -- Certification of grades --

Dr. Partrick moved that all candidates obtaining a FLEX Weighted Average of 75.0 or higher be approved as passing the examination and approved for licensure in North Carolina.
Seconded by Dr. Wilkerson and duly passed.

DEA regarding Dr. Payne's not keeping accurate records of controlled substances and not taking inventories of same. Dr. Edmondson moved that Dr. Payne be written and advised that the Board had received report on his not keeping accurate records and the Board receive this as information. Friday, August 9
9:00 a.m.

RE: Dr. Arthur Travis Abbott appeared applying for license by endorsement of credentials. He is a graduate of Harvard Medical School in 1971 and is a diplomate of the National Board in 1972.

Dr. Hooper: You plan to practice here in North Carolina late this summer, I believe?

A: Yes, sir.

- Q: Any particular place yet?
- A: Spruce Pine area.
- Q: In private practice?
- A: Yes, sir, I presume so. I'll start out several general practitioners in the area and presume I'll start in my own practice soon.
- Q: How did you decide to pick that area?
- A: Well, I was raised in Asheville--fourth grade through high school and it is really my home.
- Q: Have you ever been convicted of a crime? A: No, sir--none other than traffic violations.
- Q: Have you had any difficulty with a medical licensing board? A: No, I've never applied for a state license.
- Q: Have you ever personally used alcohol, narcotics or habit forming drugs? A: Not habit forming drugs--have used alcohol some--socially.

VERDICT: Dr. Arthur T. Abbott approved for license by endorsement..

RE: Dr. Sezer Aksel appeared applying for license by endorsement of credentials. He is a graduate of Duke University School of Medicine in 1970 and is a diplomate of the National Board in 1971.

Dr. Hooper: Presently, you hold a resident's training license and wish to get a full license?

- A: Yes, sir.
- Q: Plan to continue to work at the hospital?
- A: I'm on the faculty there. They told me since I am on the faculty that the resident's license would not apply.

- A: Ob-Gyn
- Q: Have you ever been convicted of a crime? A: No

RE: Dr. Maria Todor Alexandrov appeared applying for license by endorsement of credentials. She is a graduate of Ivan Pavlov School of Medicine of Plovdiv University in Bulgaria in 1964, and holds a Pennsylvania license on the basis of FLEX exam in 1973.

Dr. Edmondson: Do you hold any other state licenses?

- A: I have just recently applied for and received a Massachusetts license, this year.
- Q: Are you aware of the incomplete credentials in your application?
- A: You mean the long term letter? When my husband came before the Board in June, he had a letter from Dr. Kishev written for himself and for me, and I thought there was a copy of that letter in my file--the original is in my husband's file. He also wrote a letter for my husband and myself to certify that he knew us both as medical students in Bulgaria since we have not been able to get original certification of graduation--we are political refugees.
- Dr. E: All right, we'll certainly check on that letter when the staff gets back to the office. We do have the letter about your medical education here now. Do you have your alien registration receipt card?
- A: Yes, sir, right here.
- Dr. Alexandrov presented same, No. A 19 233 888, and the photo compared with the individual present.
- Q: Where are you living now, Dr. Alexandrov?
- A: In Webster, Massachusetts.
- Q: What are your plans for North Carolina?
- A: I have an offer in Wake County and will open an office for General Practice after my practice is established.
- Dr. Galusha: Have you ever been convicted of a crime? A: No
- Q: Have you ever used alcohol to excess? A: No, not at all
- Q: Have you ever used narcotics or barbituates personally? A: No

Q: Have you had any difficulty with any medical licensing boards?

VERDICT: Dr. Maria T. Alexandrov approved for license by endorsement if and when her credentials are completed satisfactorily to the Executive Secretary, (Credentials complete) same to be limited geographically until citizenship obtained.

RE: Dr. Joseph Bronislaw Bikowski, Jr. appeared applying for license by endorsement of credentials. He is a graduate of George Washington University in 1971 and holds National Board certification in 1972.

Dr. Hooper: Dr. Bikowski is in the army at Ft. Bragg and his credentials are complete and wants to practice in the local emergency rooms when he's off duty. How much time do you have in the Army?

A: One year left.

Q: Have you thought at all about locating in North Carolina?

A: I've applied to UNC and Bowman Gray both and will interview here at Bowman Gray this afternoon.

Q: What's your specialty?

A: Internal Medicine and Dermatology. I hope to teach, eventually, Internal Medicine at a medical school.

Q: Have you ever been convicted of a crime?

A: No, sir

Q: Have you had any difficulty with any medical licensing board?

A: No, sir.

Q: Have you used alcohol, narcotics or habit forming drugs at any time?

A: I have used alcohol, but not excessively.

VERDICT: Dr. Joseph B. Bikowski, Jr. approved for license for endorsement

RE: Dr. William Keith Bishop appeared applying for license by endorsement of credentials. He is a graduate of Case Western Reserve School of Medicine in 1969 and is licensed in Ohio by endorsement with National Boards.

A: Yes, sir, I believe she said some routine inquiries, like to the AMA.

A: I will be in the program in Charlotte for about 4 years and guess I'll decide sometime near the end of my training where I'll practice.

RE: Dr. William James Belliveau appeared applying for license by endorsement by credentials which are incomplete. He is a graduate of the University of Indiana in 1948 and is licensed in Indiana by exam and in New Jersey and California by endorsement.

Dr. Edmondson: Dr. Belliveau, are you aware of what you lack in your file?

A: Yes, I believe your secretary said it was an inquiry to the California Board.

Q: What are your plans for North Carolina?

A: I would like to practice in the Pinehurst area--I'm in New Jersey now and we're getting a little tired of the New York area.

Q: What's your specialty?

A: General Practice

Q: Have you ever been convicted of a crime?

A: No

Q: Have you ever used alcohol to excess?

RE: Dr. William Edward Blackburn appeared applying for license by endorsement with incomplete credentials. He is a graduate of the University of Kentucky in 1969 and is licensed in Kentucky by exam in 1969.

Dr. Edmondson: Do you hold any other state license?

A: No, sir.

Q: You are presently in the Army?

A: Yes sir, at Fort Bragg.

Dr. Edmondson: Dr. Blackburn lacks only his long-term letter of recommendation.

RE: Dr. Michael Wenley Stannard appeared applying for a Certificate of Registration as a Visiting Professor to the University of North Carolina School of Medicine. He is a graduate of the University of London in 1966.

Dr. Staub: Dr. Stannard will be a visiting professor at UNC and will be there for one year, I believe that's been explained to you?

A: Yes, that's right.

Q: Have you ever been convicted of a crime? A: No, sir.

Q: Have you ever taken alcohol to excess? A: No

Q: Do you personally take narcotics or habit forming drugs? A: No

Q: Have you had any difficulty with any licensing boards? A: No

Dr. Taylor: What Department are you in?

A: Radiology.

Dr. Staub: Then you do plan to go back after one year.

A: Yes, that's the plan eventually. All being well, I might want to spend a second year in Pediatric Radiology.

Q: In this state, or some other part of the country?

A: Well, that would depend on opportunities.

Q: You will be on the faculty?

A: Yes, that is correct.

Q: Do you have any questions of the Board, or about the license?

A: Well, it would be nice to know that if I could decide to do my pediatric radiology option in North Carolina, it would be nice to know that there wouldn't be any problems in obtaining licensure for a further year. Would that be any problem?

Dr. Staub: Well, we have had a problem with that. The purpose of this license has been for a visiting professor, for one year or less, which we do not intend to be renewable on that level. Now, if you were going to go back into training, a resident's training license I'm sure would be granted. I think there might be a problem and I think that we would have to bring it up before the entire Board whether a license at the level of a Visiting Professor license isn't mandatory the second year.

A: The kind of thing I would think of would be something that was nearer a resident or a fellow.

Dr. Staub: Well, I think that probably the difference in the situation would be that if you were granted a resident's training license you could not charge a fee, certainly you would be paid a salary, at that level. The intention of this license is that it be good only for one year.

VERDICT: Dr. Michael W. Stannard approved for a Certificate of Registration for a Visiting Professor for one year. (If he follows through with second year of Pediatric Radiology training, should apply for resident's training license.)
