## North Carolina Medical Board

### April 15-16, 2010

1203 Front Street Raleigh, North Carolina The April 15-16, 2010, meeting of the North Carolina Medical Board was held at the Board's Office, 1203 Front Street, Raleigh, NC 27609. The meeting was called to order at 8:00 a.m., Thursday, April 15, 2010, by Donald E. Jablonski, DO, President. Board members in attendance were: Ms. Pamela Blizzard; John B. Lewis, Jr., LLB; Ralph C. Loomis, MD; Peggy R. Robinson, PA-C; Paul S. Camnitz, MD and Thomas R. Hill, MD. Also attending were Thomas Moffitt, Independent Counsel; R. David Henderson, Executive Director and Thom Mansfield, Board Attorney.

#### PANEL HEARINGS:

DUNN, Lawrence, MD – Durham, NC Disciplinary

Judge Lewis commenced the Hearing by reading from the State Government Ethics Act, "ethics awareness and conflict of interest reminder." No conflicts were reported.

Dr. Dunn was charged with unprofessional conduct for alledgedly practicing below the standard of care with regard to his treatment of seven patients.

A Panel Hearing was held on April 15-16, 2010.

Members of the Panel were: Judge Lewis, Ms. Robinson, Dr. Loomis & Dr. Hill. Thomas Moffitt served as Independent Counsel.

Dr. Dunn was represented by Robert Clay and Joseph Williford. The Board was represented by Patrick Balestrieri and Thomas Mansfield.

PANEL FINDINGS: The Panel found that Dr. Dunn's care of Patients A through G departed from or failed to conform to the standards of acceptable and prevailing medical practice with the meaning of N.C. Gen Stat §90-14(a)(6).

PANEL RECOMMENDATION: The Panel recommended that Dr. Dunn's medical license be suspended indefinitely. Dr. Dunn shall not reapply for a North Carolina Medical license sooner than 6 months.

Final arguments in this case are scheduled to be heard at the North Carolina Medical Board's May 19, 2010, meeting or as soon thereafter as possible.

REECE, Donald, MD – Morehead City, NC Disciplinary

Dr. Jablonski commenced the Hearing by reading from the State Government Ethics Act, "ethics awareness and conflict of interest reminder." No conflicts were reported.

Dr. Reece was charged with unprofessional conduct for alledgedly practicing below the standard of care with regard to his treatment of seven patients, lack of professional competence to practice medicine with a reasonable degree of skill and safety based on a comprehensive evaluation by CPEP, and failing to provide adequate coverage for his patients at times when he planned to be unavailable.

A Panel Hearing was held on April 15, 2010.

Members of the Panel were: Dr. Jablonski, Dr. Camnitz and Ms. Blizzard. Thomas Moffitt served as Independent Counsel.

Dr. Reece was represented by Daniel Flebotte. The Board was represented by Todd Brosius.

PANEL FINDINGS: The Panel found that Dr. Reece's care of patients A through H departed from or failed to conform to the standards of acceptable and prevailing medical practice within the meaning of NC Gen. Stat. § 90-14(a)(6). The Panel also found that Dr. Reece's lack of medical knowledge and clinical reasoning constituted a lack of professional competence to practice medicine with a reasonable degree of skill and safety to patients and failure to maintain acceptable standards of one or more areas of professional physician practice with the meaning of NC Gen. Stat. § 90-14(a)(11). Additionally, the Panel found that by failing to provide adequate coverage for his patients in times that he planned to be unavailable, Dr. Reece engaged in unprofessional conduct within the meaning of NC Gen. Stat. § 90-14(a)(6).

PANEL RECOMMENDATION: The Panel recommended that Dr. Reece's medical license be revoked.

Final arguments in this case are scheduled to be heard at the North Carolina Medical Board's May 19, 2010, meeting or as soon thereafter as possible.

The Board was represented by Marcus Jimison. Dr. Bowman was present and was represented by Beth Fleishman.

The Board voted to accept the proposed Consent Order in resolution of the August 24, 2009 Notice of Charges and Allegations with the modification that Dr. Bowman attend a minimum of 10 hours of continuing education approved by the Office of Medical Director..

KEYES, Booker, MD - Jacksonville, NC<sup>´</sup>

The Board was represented by Brian Blankenship. Dr. Keyes was not present nor was he represented by counsel.

The Board voted to accept the proposed Consent Order in resolution of the September 30, 2009 Notice of Charges and Allegations.

KRAMER, James, MD - Greensboro, NC

The Board was representated by Brian Blankenship. Dr. Kramer was present and was represented by Richard Vanore.

The Board voted to accept proposed Consent Order in resolution of the September 9, 2009, Notice of Charges and Allegations.

NISBETT, Donald, MD – Laurinburg, NC

The Board was represented by Brian Blankenship. Dr. Nisbett was present and was represented by José Coker.

The Board voted to accept the proposed Consent Order in resolution of the August 5, 2009, Notice of Charges and Allegations.

RIVERA-ORTIZ, Epifanio, MD - Huntersville, NC
