# North Carolina Medical Board

December 10, 2015

1203 Front Street Raleigh, North Carolina The North Carolina Medical Board held its regularly scheduled December 2015 meeting at the Board's office located at 1203 Front Street, Raleigh, North Carolina. Pascal O. Udekwu, MD, President, called the meeting to order on Thursday December 10, 2015, at 8:05 a.m. Board members participating were: Pascal O. Udekwu, MD; Cheryl Walker-McGill, MD; Mr. Michael Arnold; Ms. H. Diane Meelheim, FNP; Debra A. Bolick, MD; Barbara Walker, DO; Bryant Murphy, MD; and Ralph A. Walker, LLB. Also attending were Fred Morelock, Independent Legal Counsel to the Board; and Brian L. Blankenship, Deputy General Counsel.

#### Presidential Remarks:

Dr. Udekwu commenced the meeting by reminding the Board members of their duty to avoid conflicts of interest with respect to any matters coming before the Board as required by the State Government Ethics Act.

#### **Proposed Settlements**

#### MANKIN, Keith Pinkney, MD – Raleigh, NC

The Board was represented by Mr. Brian L. Blankenship. Dr. Mankin was not present, but was represented by Mr. Jerry Allen, who agreed to allow Mr. Blankenship to present the proposed settlement ex parte.

Dr. Udekwu was recused. Immediate Past President, Dr. Walker-McGill presided.

The Board voted to accept proposed Consent Order.

#### **HEARINGS**

#### FOSTER, James William, MD – Tennessee

The Board was represented by Mr. Marcus Jimison. Dr. Foster appeared pro se.

Dr. Foster was charged with conduct constituting a violation of a law involving the practice of medicine within the meaning of N.C. Gen Stat. 90-14(a)(7) and unprofessional conduct within the meaning of N.C. Gen Stat. 90-14(a)(6) relating to his violations of the standards of acceptable and prevailing medical practice provided to Patients A through C.

Following the hearing, the Board found that Dr. Foster aided and abetted the unlicensed corporate practice of medicine constituting a violation of a law involving the practice of medicine within the meaning of N.C. Gen. Stat. 90-14(a)(7). The Board further found that Dr. Foster agreed to become a sole shareholder of a professional corporation which enabled it to provide care that departed or failed to conform to standards of acceptable and prevailing medical practice within the meaning of N.C. Gen. Stat. § 90-14(a)(6). The Board voted to reprimand Dr. Foster's license to practice medicine.

#### **Attorney's Report:**

A motion passed to close the session pursuant to N.C. Gen Stat. §143-318.11(a) to prevent the disclosure of information that is confidential pursuant to Sections 90-8, 90-14, 90-16, 90-21.22 of the North Carolina General Statutes and not considered a public records within the meaning of Chapter 132 of the General Statutes and/or to preserve attorney/client privilege.

A written report on 69 pending cases and 32 executed cases was reviewed by the Board. The specifics of these matters are not included as they are non-public. The Board accepted the report as presented. Additionally the Board reviewed information regarding three matters involving outside litigation. The specifics of this report are not included because these matters are not public information.

A motion was passed to return to open session.
