MEETING OF THE BOARD OF MEDICAL EXAMINERS

OF NORTH CAROLINA

Mid Pines Club, Southern Pines, North Carolina

January 5 - 6th, 1968

The Board of Medical Examiners of the State of North Carolina met at the Mid Pines Club, Southern Pines, North Carolina, January 5-6th, 1968, for the purpose of interviewing applicants for license by endorsement of credentials for special limited license and for other business.

Friday, October 5th 6:00 P. M.

The Board convened for dinner. Drs. W. Boyd Owen, President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, Frank Edmondson, H. Lee Large, Jr., Clark Rodman, Vernon W. Taylor, Jr., and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present.

Credentials for license by endorsement of credentials and special limited license were reviewed by the Board.

- RE: <u>Written Examination</u> Dr. Joseph J. Combs moved that the written examination for December be held December 2-5th, 1968. This motion was duly seconded and passed unanimously.
- RE: Narcotic Talk Dr. Joseph J. Combs moved that Dr. H. Lee Large, Jr. make the narcotic talk for the June, 1968 examination applicants. This motion was duly seconded and passed unanimously.
- RE: Meeting January, 1969 Dr. Joseph J. Combs moved that this meeting be held at the Mid Pines Club, Southern Pines, North Carolina, January 10-12th, 1969. This motion was duly seconded and passed unanimously.
- RE: <u>Written Examination Grades</u> The grades of examinees for the December 1969 written examination were reviewed and certified by the Board.
- VERDICT: Dr. Joseph J. Combs moved that the candidates taking the written examination in December, 1967, having attained satisfactory grades, be granted license to practice medicine in the State of North Carolina. This motion was duly seconded and passed unanimously.
- RE: <u>Dr. William M. Bethune</u>, <u>Jr.</u> (See previous Minutes) Dr. Joseph J. Combs reported that Dr. Bethune is still a patient at Cherry Hospital.
- RE: <u>Investigations</u> Dr. James E. Davis moved that the secretary's office be instructed when a physician licensed to practice in this state leaves under questionable circumstances, to immediately exert all efforts to procure information as to the circumstances under which he left; that the information then be presented to the Board of Medical Examiners for consideration of action. This motion was duly seconded and passed unanimously.
- RE: <u>Dr. Charles R. Burbacher</u>, Coral Gables, Florida The secretary presented letter from Dr. Burbacher stating that he had a home in Avery County; that he is practicing medicine in Florida and that he desired a license to practice in North Carolina; that what work he would do in that county would be of a charitable nature.
- VERDICT: Dr. James E. Davis moved that Dr. Charles R. Burbacher be notified that the Board had considered his request and if he could produce evidence that this area would need his services on a part-time basis, the Board would be glad to consider the matter further. This motion was duly seconded by Dr. Vernon W. Taylor, Jr. and passed unanimously.

RE: <u>Dr. Palmer W. Fant</u>, Galax, Virginia - The secretary pesented letter from Dr. Fant, who lives in a border town, requesting information as to license by endorsement in order that he and the radiologist in Surry County, North Carolina might reciprocate in occasional coverage in the event of sickness or vacation.

VRRDICT: Dr. James E. Davis moved that Dr. Palmer W. Fant be notified that the Board had considered his request and if he could produce evidence that this area would need his services on a part-time basis, the Board would be glad to consider the matter further. This motion was duly seconded by Dr. Vernon W. Taylor, Jr. and passed unanimously.

RE: <u>Hearing Legislative Commission</u> - The secretary reported to the Board that the president and he responded to the invitatikn from the Legislative Commission and attended the hearing in Raleigh on January 5th, 1968. Some statistics were filed by the Board with the Commission and it was informed that our Board stood ready to assist in any manner it could.

RE: Office Equipment - The secretary advised that it has become necessary to purchase an additional typewriter as a new part-time secretary had been added to the personnel, the price of which was \$403.26.

VERDICT: Dr. James E. Davis moved that the Board of Medical Examiners approve of the expenditure for the purchase of the above office equipment. This motion was duly seconded and passed unanimously.

RE: Federation of State Medical Boards of the United States - The secretary presented certain proposed amendments to the by-laws to be voted on at the 1969 meeting; also report of the committee appointed to study feasibility of increasing the annual dues.

VERDICT: Dr. Clark Rodman moved that the members of this Board who attend the meeting of the Federation of State Medical Boards of the United States in Chicago act as delegates to represent the Board as a whole in voting on any proposals that are drawn up. This motion was duly seconded and passed unanimously.

A letter was presented from the secretary of the Federation with regard to endorsement relations between the state medical boards, upon which no action was taken.

RE: <u>Dr. George Hancock Nutt</u> was licensed to practice medicine in North Carolina in 1964. He has presented certified copy of court order that his name be changed to George Hancock Nutt Adams.

VERDICT: The secretary was instructed to change the records of the Board to bear the name George Hancock Nutt Adams and charge the fee for duplicate license.

RE: <u>Dr. Franklin S. Kincheloe, Jr.</u> - (See previous Minutes) - The secretary reported that Dr. Franklin S. Kincheloe, Jr. had appealed the judgment of the Board of Medical Examiners to the United States Supreme Court as of December 27th, 1967; also that the North Carolina Supreme Court had stayed the execution of the judgment of the Board.

RE: <u>Biennial Registration</u> - <u>Reinstatement</u> - The license to practice medicine of the following physicians were suspended for failure to register as required by General Statute of North Carolina 90-15.00 and they have now registered:

RESOLVED that the medical licenses of the above physicians be reinstated.
