

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Carolina Inn, Chapel Hill, North Carolina

July 20 - 21st, 1967

The Board of Medical Examiners of the State of North Carolina met at the Carolina Inn, Chapel Hill, North Carolina, July 20 - 21st, 1967, for the purpose of canvassing and certifying the grades of the annual written examination for medical licensure, to interview applicants for license by endorsement of credentials, for special limited license, and for other business.

Thursday, July 20th
6:00 P. M.

The Board convened for dinner. Drs. James E. Davis, President, Joseph J. Combs, Secretary-Treasurer, Frank Edmondson, H. Lee Large, Jr., W. Boyd Owen, Clark Rodman, Vernon W. Taylor, Jr., and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present.

Credentials for license by endorsement of credentials and special limited license were reviewed by the Board.

RE: Dr. James Leo Green, graduated by Duke University School of Medicine, took Part I of this Board's written examination upon completion of his sophomore year in 1962. After graduation he obtained Tennessee license on the basis of endorsement of Part I and written examination there. He is now applying for license by endorsement from the Tennessee Board of Medical Examiners on Part II of the examination as he is planning to return to his "home state" in the near future to engage in general practice.

VERDICT: Dr. Clark Rodman moved that the Board of Medical Examiners consider Dr. James Leo Green's application. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RESOLVED THAT the medical license of Dr. Louis Edwin Underwood be reinstated.

RE: OSTEOPATHS - Mr. John H. Anderson, Attorney for the Board came to Chapel Hill at the Board's request to report on the activities in the recent Legislature in regard to licensing of osteopaths. He reported there were two bills introduced to allow the osteopaths to practice as medical doctors. Mr. Anderson informed the Board that there should be a study made before the next meeting of the Legislature and recommended to the Board that a letter be prepared and sent to each osteopathic school asking them if they would agree to inspection and evaluation of their schools by either of the following methods:

1. State Board of Medical Examiners
2. Representatives appointed by the State Board of Medical Examiners
3. Accreditation Committee that examines the medical schools

VERDICT: Dr. Frank Edmondson moved that the attorney's recommendation be adopted and that the secretary, with the aid of the attorney, frame a letter to each of the osteopathic schools. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Special Limited License Renewal - The Board approved applications for renewal of special limited license presented by the secretary.



RE: Dr. Edgar Lee Marston was granted license limited to Bowman Gray School of Medicine in 1953 to cover him as a resident there. He has appeared at this time applying for conversion of limited to full license as he is locating in Yadkinville with Dr. James R. Cleary for the practice of medicine and surgery.

Dr. Marston: I am going into practice probably in Yadkinville and probably seeing a few patients in Forsyth. (He stated in letter he would be commuting from Forsyth County to Yadkinville.)
I want to have my limited license extended to full license.

Dr. Davis: Where have you been since 1953?

A. 1953-59 Bowman-Gray residency and research, went to Silver Spring, District of Columbia area, returned to the state in 1964. I have been at Bowman Gray since 1964 as a fellow doing research combination medical and surgical cardiovascular.

Q. The last $2\frac{1}{2}$ years seeing patients?

A. An occasional neighborhood patient or referral to hospital, this was uncommon.

Q. When do you anticipate opening an office in Yadkinville?

A. I will be associated with Dr. James Cleary, association established.

Q. Have you ever been convicted of a crime? A. No

Q. Have you ever faced disciplinary action by any state medical board? A. No

Q. Have you ever used narcotics personally? A. No

Q. Have you ever taken alcohol or barbiturates to excess?

A. I used to take some alcohol, have quit that.

Q. Have you ever been treated for alcohol?

A. On one occasion developed epileptic (?) seizure, which cleared up in a week.

Q. How long since you had a problem with alcohol?

A. A year, if you call drinking a week or so and then quitting.

Q. You have not drunk for a year?

A. No

Dr. Combs: Did you have any trouble with alcohol during residency?

A. Yes, I was instructor in surgery, but left to go in practice.

Dr. Taylor: Did Dr. Cleary contact you to come to Yadkinville?

A. Yes sir

Dr. Davis: You feel confident alcohol will not pose any problem to your practice?

A. You can not treat patients drunk.

VERDICT: Dr. W. G. Taylor, Jr. moved that the limited license of Dr. Edgar Lee Marston be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Henry van Peters Wilson III was granted license limited to Bowman Gray School of Medicine October 9th, 1964 to cover him for training there. He is now going with the Mecklenburg Surgical Clinic, Charlotte, and has applied for conversion of limited to full license, for which he was approved.
