MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA
Asheville Country Club and the Battery Park Hotel,
Asheville, North Carolina

July 21-24th, 1960.

- - - -

The Board of Medical Examiners of the State of North Carolina met at the Asheville Country Club and the Battery Park Hotel, Asheville, North Carolina, for the purpose of certifying to the grades of the annual written examination for medical license, to interview applicants for license by endorsement of credentials, and for special limited license, and for other business.

Thursday, July 21st.

The Board convened and credentials for license by endorsement and for special limited license were reviewed.

Drs. J. B. Anderson, President, J. J. Combs, Secretary-Treasurer, Thomas W. Baker, L. R. Doffermyre, Edwin A. Rasberry, Jr., Thomas G. Thurston, Carl V. Tyner and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present.

Friday, July 22nd -

9 A. M. - The following physicians were interviewed for license by endorsement of credentials:

RE: Dr. Charles Glenn Adkins appeared May 9th, 1960, with incomplete credentials, which are still incomplete. The secretary reported that Dr. C. R. Stephen, Professor of Anesthesiology at Duke University School of Medicine, had advised Dr. Adkins had terminated his residency there.

VERDICT: Dr. T. G. Thurston moved that fee be refunded to Dr. Charles Glenn Adkins, with deduction. This motion was duly seconded and passed unanimously.

RE: Dr. Thomas Rector Bass appeared with incomplete credentials applying for license by endorsement of credentials.

Dr. Thurston: What are your plans?

A. I plan to go to Clayton.

Q. General practice?

A. Yes

Dr. Anderson: When do you plan to go to Clayton?

A. Either August or September.

Q. Will you be associated?

A. No

Dr. Thurston: You are a native of Alabama?

A. I was born there. I have lived in North Carolina most of my life.

Dr. Anderson: Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any difficulty with narcotics, barbiturates or alcohol? A. No sir

Q. Have you had any difficulty with a licensing board or the Bureau of Narcotics? A. No sir

Dr. Thomas Rector Bass continued

VERDICT: Dr. Thomas Rector Bass was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. William Roseboro Beach III, a native of North Carolina and a resident in Pathology at Bowman Gray School of Medicine, appeared with incomplete credentials applying for license by endorsement of credentials.

- Dr. Thurston: Do you plan to stay at Duke?
- A. I plan to stay at Duke for now.
- Dr. Anderson: Have you ever been convicted of a crime? A. No sir
- Q. Have you had any difficulty with narcotics, barbiturates or alcohol? A. No sir
- Q. Have you had any trouble with a licensing board or the Bureau of Narcotics? A. No sir

VERDICT: Dr. Henry Francis Bongardt, Jr. was approved for license by endorsement of credentials, limited to Duke University School of Medicine, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Montague Delano Brantley appeared with incomplete credentials applying for license by endorsement of credentials. He is a native of North Carolina.

Dr. Thurston : You have been practicing in South Carolina, Darlington, and you wish to practice here?

A. I am going to my home town Wilmington.

Q. Bring us up to date since 1955.

A. Internship, Poughkeepsie, six months residency, then practice in Darlington. I am yielding to my mother to go home.

Dr. Anderson: When do you want to go to wilmington?

A. October.

Q. Have you ever been convicted of a crime? A. No sir

Q. Have you had any difficulty with narcotics, barbiturates or alcohol? A. No sir

Q. Have you had any difficulty with a licensing board or the Bureau of Narcotics? A. No sir

VERDICT: Dr. Montague Delano Brantley was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Ying Tak Chan appeared with incomplete credentials applying for license by endorsement of credentials. She presented naturalization certificate number 7759310.

Dr. Thurston : Dr. Chan has been at the Veterans Administration Hospital in Salisbury and I have been advised by the physicians there they had been pleased with her service; that she is very competent and they are sorry to lose her.

Dr. Baker: Where do you plan to practice?

A. It depends on how well I get. I like Salisbury very much. My friends have tried to persuade me to move back to Washington, D. C. I hope I get well enough to stay. The locate, I like the whole North Carolina, it attracts me so I do not want to leave.

Q. What field is your interest in?

A. In the Veterans Administration, physical medicine. In China you are pushed into obstetrics and gynecology. I call myself a general practitioner.

Dr. Anderson: You have been in Salisbury how long?

A. About a year. I came from Kansas.

Q. How long in Kansas?

A. A year with the Veterans Administration.

Q. With the veterans Administration all this time?

A. Three years, before that Washington and before that Chicago Lying-in two years.

Q. Have you ever been convicted of a crime? A. No

Q. Have you had any difficulty with narcotics, barbiturates or alcohol? A. No sir

Q. Have you had any trouble with a licensing board or the Bureau of Narcotics? A. No sir

Q. You think you are going to locate in Salisbury when you get well?

A. I hope to.

Dr. Ying Tak Chan

Dr. Anderson: When you decide, write the secretary where you are going to stay.

A. Right now I would say Salisbury. That is where I will be if I stay in North Carolina.

Q. When do you anticipate you are going to be well from your illness?

A. I suppose a few months, part time.

VERDICT: Dr. Ying Tak Chan was approved for license by endorsement of credentials, if and when credentials are completed satisfactory to the secretary and when she locates for private practice. (Credentials completed, requirements met)

RE: Dr. Thomas Glenn Cooper appeared applying for license by endorsement of credentials, limited to the State Hospitals, where he is a resident in Psychiatry.

Dr. Thurston : What other training have you had?

A. state Hospital in Columbia, South Carolina, two years.

Q. Do you plan to stay in the State Hospital system after you finish your residency there?

A. Yes

Q. Are you in the training program through Chapel Hill?

A. Yes sir

Dr. Anderson: Have you ever been convicted of a crime? A. No sir

Q. Have you had any difficulty with narcotics, barbiturates or alcohol? A. No sir

Q. Have you had any difficulty with a licensing board or the Bureau of Narcotics? A. No sir

VERDICT: Dr. Thomas Glenn Cooper was approved for license by endorsement of credentials, limited to the State Hospitals.

Dr. Cox was directed to complete credentials right away or there was a possibility he would be asked to stop work.

A. This year sometime, the sooner the better. I just completed my internship June 30th. I plan to go and visit with my brother and stay there unless it will take too long to finish this. If not, I will remain in Siler City.

Q. Have you ever been convicted of a crime? A. No sir

RE: Dr. George B. Dysart appeared with incomplete credentials applying for license by endorsement of credentials.

Dr. Tyner: You plan to begin practice in Brevard in August with Drs. Newlan, Folger and Wells?

A. Yes sir

Q. What have you been doing since 1955?

A. Interned in Richmond, one year residency in Medicine in Richmond, two years in the Air Force and I am complete a year of residency in general practice in Greenville, South Carolina.

Q. You want to go to work right away?

A. August 1st if possible.

Dr. George B. Dysart continued

Dr. Anderson: Have you ever been convicted of a crime? A. No sir

Q. Have you had any difficulty with the Narcotic Bureau or a licensing board? A. No sir, I have never had a narcotic license.

Q. Have you had any difficulty with narcotics, hypnotics or alcohol? A. No sir

A. I would like to join a group in North Carolina. There are two in mind, one in Fayetteville and one in Statesville. I am particularly interested in the one Statesville at the Davis Hospital.

Q. You have been practicing in Pennsylvania since 1944?

A. No, part in residency, part in service. I have been practicing consecutively since 1951.

Dr. Thurston: What type of practice?

A. Internal medicine, primarily chest diseases with the state. I developed a minimal chest lesion when I was at Duke, so I have been in this, but I prefer the general field of medicine.

Q. How did you happen to decide to come to North Carolina?

A. I did not intend to stay in Philadelphia as long as I did. I went there with pneumothorax and I wanted to be some place where it was easy to be reaspirated and I stayed on. I intended to get in group practice. The years went by and I kept postponing it. The years went by and I decided the time had come to do this. I like this part of the country more than I do the north. I have spent sometime here and was impressed with the state.

Dr. Thurston: What hospital did you work in?

A. Landis Hospital, which the state took over to convert to pulmonary disease hospital.

Dr. Anderson: How long since you have had trouble with your chest?

A. I had the trouble in 1947, took pneumothorax until 1951. I have been stable since then. I did private practice too. For a number of years I have worked 65-70 hours a week. This was just at the hospital during the past year.

Q. Have you ever been convicted of a crime? A. No sir

 Dr. Huseyir Turkoglu, graduate of University of Istanbul, Turkey, 1947 - City Memorial Hospital

The following physicians appeared with incomplete credentials applying for special limited license to the respective hospitals. These physicians will take the examination of the Educational Council for Foreign Medical Graduates in September, 1960. They were approved for special limited license to December 30th, 1960, which will be extended to July, 1961, if they receive the certificate of the ECFMG. If they fail to receive this certificate in September, 1960, their special limited licenses will terminate December 30th, 1960:

Dr. Manuel Bonnemaison, graduate of University of San Marcos, Peru - Watts Hospital
 Dr. Marcelina M. Cruz, graduate of University of Santo Tomas, Philippines - Watts Hospital
 Dr. Fernando T. Garcis, graduate University del Valles, Colombia, South America, 1958 - University N. C. School of Medicine
 Dr. Carlos V. Serrano, graduate of National University of Colombia, South America, 1954 - University N. C. School of Medicine

Dr. Doffermyre: This permit allows you to obtain training in North Carolina. In order to do this, it will be necessary to obtain the certificate of the ECFMG. You who have it will be granted permission to continue training in North Carolina for a year. You who do not have the ECFMG certificate will have to take the examination in September and pass the same in order to continue after December 30th, 1960, provided your other credentials are completed. These permits are renewable after a period of one year, provided your work is satisfactory and you are recommended to this Board by the chief of your service.

SPECIAL LIMITED LICENSE - STAFF PHYSICIAN - FOREIGN GRADUATE

RE: Dr. Aydogan Ugur, graduate of the University of Istanbul, Turkey, 1951, appeared applying for special limited license to the Eastern N. C. Sanatorium, where he is on a training basis. He presented his exchange visa. Dr. Ugur was approved for special limited license on an annual basis.

RE: Dr. J. R. Medlin, Jr. appeared for a routine interview as stipulated in the order of the Board on June 20th, 1960. The secretary presented letter from Dr. Angus C. Randolph, psychiatrist at Bowman Gray School of Medicine, who stated that he was continuing good progress. He reported that Dr. Medlin had an appendectomy two weeks ago. Dr. Medlin said he was getting along all right and that he did not to his knowledge receive any narcotics during his recent hospitalization; that his surgeon was aware of his problem.

VERDICT: Dr. T. G. Thurston moved that if favorable report received from Dr. Angus C. Randolph, that Dr. J. R. Medlin, Jr. be allowed to see Dr. Carl V. Tyner, member of the Board, in lieu of the appearance at Elizabeth City. This motion was duly seconded by Dr. E. A. Raspberry, Jr. and passed unanimously.

The meeting was adjourned.

Friday, July 22nd, 1960
2:30 P. M.

RE: Dr. W. A. Hoover, Murphy, North Carolina - On May 2nd, 1959, Dr. Hoover was placed on probation for five years on account of narcotic addiction and instructed to surrender his narcotic tax stamp, which was done. On June 17th, 1960, Dr. Hoover wrote the secretary inquiring as to reinstatement of narcotic tax stamp. He was requested to appear for an interview at this time.

Dr. Hoover stated that he had not taken any drugs since February, 1959, other than lodesats for sleep once or twice a week. He said that he was doing well in his practice and carrying a full patient load; that he had not experienced too much difficulty practicing without his narcotic license.

VERDICT: Dr. L. R. Doffermyre moved that the Board of Medical Examiners not recommend reinstatement of Dr. W. A. Hoover's narcotic tax stamp at the present time. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

Dr. Hoover was acquainted with the verdict of the Board.

RE: Dr. Charles Heman Gantt, Spruce Pine, North Carolina - Upon receipt of reports from the medical profession in Spruce Pine, the secretary requested an investigation by the State Bureau of Investigation, which investigation was accomplished and report made on July 18th, 1960. This report revealed the purchase of an excessive amount of narcotic drugs, for which Dr. Gantt had kept no record. It was also revealed that he had been found in comatose and semi-comatose states on occasions and that he had been deprived of his hospital privileges on February 15th, 1960.

Dr. Gantt was requested to appear before the Board at this time. Several of his colleagues were also asked to appear and they confirmed the information set out in the report of the State Bureau of Investigation. (See file for complete interviews)

After due consideration the Board passed the following verdict; Dr. L. R. Doffermyre moved that consideration of preferring charges and accusations against Dr. Charles Heman Gantt for revoking his license to practice medicine in the State of North Carolina be postponed on the following conditions:

Dr. Charles Heman Gantt continued

That Dr. Charles Heman Gantt surrender his narcotic tax stamp, together with his narcotic order forms and all narcotics on hand to a member of the Narcotic Bureau immediately.

That within one to two weeks from this date that Dr. Charles Heman Gantt be admitted as a patient for a complete evaluation of any mental or physical illness which might effect his ability to practice medicine and stay at such institution until he has been discharged by his physician in charge and that he sign a statement releasing the report of such an examination to this Board for its consideration. That further he advise this Board of his compliance with these requirements.

That upon receipt of this information the Board will further consider the question of whether or not charges will be preferred against him for the revocation of his license to practice medicine.

This motion was duly seconded by Dr. Carl V. Tyner and passed unanimously. (See p. 55 these Minutes)

The meeting was adjourned.

Saturday, July 23rd, 1960

RE: Dr. John Milton Gambill, Snow Hill, North Carolina - Dr. Gambill came in without an appointment. He said that he had come to ask the Board for advice and help; that he had had no medicine or whiskey since May 10th until the past week-end, when he got drunk and went to jail. The Board advised him to report to his neuropsychiatrist and be admitted to an institution for a long period of treatment; that he would not receive any consideration for license anytime soon; that he would have to prove that he could control himself.

RE: Certification of Grades on Written Examination - The Board canvassed the grades of the written examination given June 20-23, 1960.

There were no failures on averages for Part I and the grades were certified.

All applicants made a passing average of 75% or more on Part II of the examination, with the following exceptions, and the grades were certified:

VERDICT: The above physicians will be required to repeat Part II of the written examination in order to obtain license.

RE: Dr. W. Percy Carter, Gastonia, North Carolina - (See May, 1960 Minutes at which time the Board postponed its decision)

VERDICT: Dr. T. W. Baker moved that the medical license of Dr. W. Percy Carter not be reinstated at this time. This motion was duly seconded by Dr. L. R. Doffermyre and passed by a vote of five.

RE: Dr. F. Y. Sorrell, Wadesboro, North Carolina - Due to the circumstances surrounding Dr. A. S. Warakowski moving to Wadesboro before receiving license and being found ineligible for license, the Board at its June, 1960 meeting instructed the secretary to request Dr. Sorrell to appear before the Board at this time.

The secretary reported that he followed the instruction of the Board and requested Dr. Sorrell to appear; that upon the recommendation of Dr. T. W. Baker that it would be detrimental to Dr. Sorrell's health to be required to appear and upon the instruction of the president of the Board, he advised Dr. Sorrell that he would not be required to keep the appointment.

VERDICT: Dr. Carl V. Tyner moved that the Board approve the action of the officers of the Board in connection with Dr. F. Y. Sorrell's appearance before the Board. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

RE: Dr. W. Clyde Thomas, Siler City, North Carolina - Dr. Thomas was requested to appear before the Board at its June, 1960 meeting with reference to report from the State Bureau of Investigation that he had prescribed narcotics for a drug addict. Dr. Thomas stated at that time he was ill and unable to appear. The Board thereupon instructed the secretary to request that he report to the secretary's office for an interview. Dr. Thomas replied to this request that he was not physically able to do so.

VERDICT: The secretary was instructed to request Dr. W. Clyde Thomas to submit a report from his physician as to when he would be able to report to him.

RE: Dr. John S. Hooker, Carboro, North Carolina - Dr. T. G. Thurston reported that he had not seen Dr. Hooker; that he has recently married; that he talked to his son and the druggist, who reported that he is working hard and getting along all right.

VERDICT: Dr. T. G. Thurston moved that Dr. John S. Hooker be requested to appear before the Board at its January, 1961 meeting. Dr. T. W. Baker duly seconded this motion and it was passed unanimously.

RE: Dr. Willard W. Griggs, Norwood, North Carolina - Dr. T. W. Baker moved that Dr. Willard W. Griggs be requested to appear before the Board at its January, 1961 meeting. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

RE: Dr. James Arthur Brown, Cleveland, North Carolina - Dr. Thurston moved that Dr. James Arthur Brown be requested to appear before the Board at its January, 1961 meeting. This motion was duly seconded by Dr. T. W. Baker and passed unanimously.

RE: Dr. William Benson McCutcheon, Jr., a native of North Carolina, was granted license by endorsement of credentials, limited to the University of North Carolina School of Medicine July 29th, 1955 to cover him as a resident. He has now applied for full license and is ready to open his office in Durham for general and thoracic surgery. He has met the requirements of the Board.

VERDICT: Dr. J. J. Combs moved that the limited license of Dr. William Benson McCutcheon, Jr. be converted to full license. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

RE: Dr. George Charles Thrasher, Jr. was granted license by endorsement of credentials, limited to the University of North Carolina School of Medicine October 12th, 1957, to cover him as a resident. He has now applied for full license and stated that he has joined the staff of Dorothea Dix Hospital. He has met the requirements of the Board.

VERDICT: Dr. T. W. Baker moved that the limited license of Dr. George Charles Thrasher, Jr. be converted to full license. This motion was duly seconded by Dr. Carl V. Tyner and passed unanimously.

RE: Dr. W. A. Strowd - (See previous Minutes - license to practice medicine suspended June 20th, 1955) The secretary presented letter from Dr. Strowd requesting that his license be reinstated.

VERDICT: Dr. T. W. Baker moved that Dr. W. A. Strowd be advised that the Board of Medical Examiners declined his request to reinstate his license to practice medicine in the State of North Carolina. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

RE: Dr. Evan Charles Fowler - On January 18th, 1954 Dr. Fowler was granted special limited license to the State Hospitals. He had taken the written examination of the Missouri Board of Medical Examiners but did not meet the requirements for license by endorsement of credentials as his grade on Anatomy was below the minimum required by this Board. Dr. Fowler took the examination on Anatomy given by this Board in June, 1960 and made a passing grade. He has now met the requirements for license by endorsement of credentials.

VERDICT: Dr. T. G. Thurston moved that Dr. Evan Charles Fowler be granted license by endorsement of credentials. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

RE: Dr. Teodoro Braganza has applied to have his special limited license extended to John Umstead Hospital, where he stated that he would continue training towards his Psychiatry Boards. Dr. James L. Cathell, Superintendent, reported that Dr. Braganza had been appointed to the staff there. He now has the temporary certificate of the ECFMG.

VERDICT: Dr. T. G. Thurston moved that the special limited license of Dr. Teodoro Braganza be extended to the John Umstead Hospital to January 1st, 1961; that he be required to take the examination of the ECFMG in September, 1960 and have the permanent certificate for any further extension. This motion was duly seconded by Dr. E. A. Raspberry, Jr. and passed unanimously.

RE: Biennial Registration of Physicians - Reinstatement - The medical license of the following physician was suspended for failure to register as required by General Statute of North Carolina 90-15.1:

Dr. Robert Reed Smith

The secretary reported that Dr. Smith has now paid the fees and penalties required by law for registration.

VERDICT: RESOLVED that the medical license of Dr. Robert Reed Smith be reinstated.

RE: Dr. Charles Heman Gantt - Dr. T. W. Baker moved that the secretary be instructed to pay mileage @ 10¢ per mile and \$10.00 per day for witnesses who appeared in regard to Dr. Gantt. This motion was duly seconded and passed unanimously. (See pp. 45-47 these Minutes)

Park Niceley and John Dougherty stated they had observed him and he practiced a good, ethical brand of urology; that he did a lot of charity work and a lot of children's urology; that he did use alcohol heavily in the evening, but his usage had declined considerably in the past year.

VERDICT: Dr. L. R. Doffermyre moved that Dr. George Edward Murray be granted license by endorsement of credentials. This motion was duly seconded and passed unanimously.

RE: Dr. Alfred Herbert Sokolowski - (See p. 31 of these Minutes) - VERDICT: Dr. T. G. Thurston moved that when Dr. Sokolowski is discharged from the Army and locates in Fayetteville that he be approved for license by endorsement of credentials, with the exception that if the situation in Fayetteville is urgent that he practice in his off hours, he will be required to furnish a letter from the Cumberland County Medical Society to the effect that his services are needed and a letter from the commanding officer stating that he is granted permission to practice in his off hours; that if these requirements are met, that he be granted license to practice medicine at this time. This motion was duly seconded by Dr. E. A. Rasberry, Jr. and was passed unanimously.

RE: Hospital Residents - The secretary was instructed to advise those hospital residents who did not appear at this meeting to complete all credentials and appear at the next meeting of the Board on October 7th, 1960, or they would be directed to cease work.

The meeting was adjourned.


