

MEETING OF THE BOARD OF MEDICAL EXAMINERS  
OF NORTH CAROLINA

Mayview Manor, Blowing Rock, North Carolina

July 24-27th, 1958

- - - - -

The Board of Medical Examiners of the State of North Carolina met at the Mayview Manor, Blowing Rock, North Carolina, for the purpose of certifying to the grades of the annual written examination for medical license, to interview applicants for license by endorsement of credentials, and for special limited license, and for other business.

Thursday, July 24th

The Board convened for dinner at 7 P. M. Drs. Carl V. Tyner, President, Joseph J. Combs, Secretary-Treasurer, J. B. Anderson, Thomas W. Baker, L. R. Doffermyre, Edwin A. Rasberry, Jr., and Thomas G. Thurston were present.

RE: Dr. Alfred W. Hamer, Morganton, North Carolina - Dr. Clyde R. Hedrick stated that from what he could ascertain quietly, Dr. Hamer was doing satisfactorily.

Credentials for license by endorsement and for special limited were reviewed by the members of the Board.

RE: Dr. Lawrence Stickney Van Blaricom - Dr. J. B. Anderson reported that Dr. Van Blaricom, neurosurgeon, had contracted to go to work with Dr. M. F. McKeel in Asheville; that he was not rotated out of service in time to take the written examination, though he had expected to; that he had not been able to take the examination of another state before this time. That Dr. McKeel is the only neurosurgeon in Asheville and Dr. Van Blaricom's services are needed. (See p.15, 55 these Minutes.)

RE: Dr. John Milton Gouldin, Elm City, North Carolina - Dr. Edwin A. Rasberry reported that Dr. Gouldin had an accident wherein the frontal lobes were injured. That it had been called to his attention that Dr. Gouldin was planning to begin practice again and it was alleged that he was not competent to do so; that Dr. Gouldin has a legal guardian. The secretary was directed to procure certified copy of court record in this connection.

The Minutes were approved as read.

The meeting was adjourned.

RE: Dr. John H. Caughran appeared applying for license by endorsement and stated that he will be associated with the Charlotte Orthopedic Clinic, Charlotte, North Carolina.

Dr. Tyner : Have you ever been convicted of a crime? A. No sir

Q. Have you been addicted to the use of narcotics or barbiturates? A. No sir

Q. Have you had any difficulty with the Narcotic Bureau?

VERDICT: Dr. John H. Caughran was approved for license by endorsement of credentials.

RE: Dr. Robert Ray Franklin appeared applying for license by endorsement of credentials. He stated that he would be out of service in 10 months. That he wanted a license so he could go and help Dr. Richardson in New Bern; that he would begin practice there upon getting out.

Dr. Combs: You are definitely going to locate with him?

A. As far as I know. It looks that way now.

Dr. Tyner : What type of work?

A. Obstetrics and Gynecology.

Q. Are you going to work at Havelock?

A. I am planning to. Dr. Sherrill, who will practice there now, is favorable to me helping him for the week-ends and off hours. It is all right with the General as long as I do not put my name up, but he does not want to write an o. k.

Dr. Doffermyre: I have had several calls. Dr. Sherill, is he in practice there?

A. He has a house and equipment and is going to practice there. He has been an anesthesiology resident at Bowman Gray, practiced general practice, and decided to practice there.

Q Is the medical situation critical?

A. Right now there is no doctor there. There are 5,000 civilians who have to go 20 miles for medical care until Dr. Sherrill starts and when he does he will be the only one.

Dr. Tyner: The general policy is that license is not issued until the doctor locates and definitely establishes himself. That leaves the question that you will be in military service 10 months.

Dr. Doffermyre: The situation is after telephone calls and personal interview, I promised I would help to try to find somebody. Dr. Franklin and Dr. Hamilton are the only two medical officers there. The 5,000 civilians and officer's wives use the dispensary. The hospital is strictly for military personnel. If they have an emergency with the civilians, they usually have to take them in at the dispensary since the civilian doctor has gone. There is perhaps too much work for one and not quite enough for two. What they want is this boy to help him.

Dr. Franklin: The General said he would approve it on a limited basis, but would not write that he would furnish a doctor; that he did not disapprove, which that we could practice.

Dr. Doffermyre: In essence or principal this was approved by the Surgeon General's office.

Dr. Combs: I understand you want to practice and to go to New Bern.

A. It is both to help out and go to New Bern.

Q. The policy of the Board is that we do not issue license to military personnel to locate in the state.

A. I do not want to do anything out of the ordinary. We were asked at Havelock. Everybody got the idea we would compete with civilian doctors. That is not what we have in mind.

Dr. Tyner: Have you ever been convicted of a crime? A. No

Q. Have you had any difficulty with narcotics? A. No

Q. Have you been addicted to the use of narcotics or barbiturates? A. No

VERDICT: Dr. J. J. Combs moved that Dr. Robert Ray Franklin be approved for license by endorsement of credentials, limited to Craven County, North Carolina. This motion was duly seconded by Dr. E. A. Rasberry, Jr. and passed unanimously.

RE: Dr. Edward Russell Green appeared with incomplete credentials applying for license by endorsement. He stated that he had taken the Pennsylvania Board this month; that he is a resident at Charlotte Memorial Hospital.

Dr. Combs: It is not the policy of the Board to grant full license until applicant is ready to begin practice. That if upon completion of training and recommendation from the

hospital, you can apply for full license.

Dr. Tyner: Do you have an idea where you might locate?

A. Not right now, no sir.

Q. Have you been convicted of a crime? A. No sir

Q. Have you had any difficulty with the Narcotic Bureau?

A. My brother is there and we plan to practice together - internal medicine.

Rasmussen has been approved by the staff of Duplin County Hospital subject to obtaining license in North Carolina. He has a California license obtained in 1950, is board eligible in surgery, had a five-year residency at Bellevue, is a graduate of the College of Medical Evangelists. Dr. Rasmussen has agreed to go to Kenansville pending getting license in North Carolina.

Dr. Rasmussen: I was in general practice one year, then in service, then in training.

Dr. Tynner: Have you ever been convicted of a crime? A. No sir

A. Since 1940 China one year, Prison Camp three years in the Phillipines. I came back to the states and did general practice under a doctor practicing in Hooker, Okla, where my wife's parents live. I went back to China in March, 1947. I had to get out in 1948 because of the Communists. I had a year of internship then

went into the Veterans Administration with the idea of going back to China. My wife had polio four years ago and is completely helpless. I am going to do general practice with the hope of getting help there more easily than where we are now. I was in Big Spring, Texas one and one-half years.

Dr. Tyner: Have you ever been convicted of a crime? A. No sir

Q. Have you had any difficulty with the Narcotic Bureau?

A. I have never applied for a narcotic license in the states. in the V. A. I did not have to have one.

Dr. Thurston: Have you not had to drop out on account of illness?

A. No, it was surgery the last six years. The last year I was carrying a heavy load and they put me in administrative partly.

Dr. Combs: What was your recent illness?

A. Flu two years ago. I missed a few days in the last several years. I have never been really sick and for any length of time since I was in high school. I plan to go to Laurel Hill as soon as everything goes through, probably before school starts.

Dr. Combs: Are you definitely coming to North Carolina?

A. I do know of an opportunity in Georgia. I am considering.

Dr. Tyner: The policy of the Board is that license not be granted until location is obtained.

Dr. Combs: There is no prejudice, but if you are going to Georgia you won't need license here.

VERDICT: Dr. Philip Stephen Woodbury was approved for license by endorsement of credentials when he locates in the state; that if he has not located within one year and applies, he will be required to make another appearance.

RE: Dr. Lawrence Stickney Van Blaricom - (See p. 1 of these Minutes) - Dr. Van Blaricom appeared with regard to obtaining license in order to go to practice as soon as possible. Dr. M. F. McKeel appeared with him. Dr. Van Blaricom was graduated by Dalhousie University, Canada, has New Hampshire license, and Alabama, on the basis of endorsement from Canada.

Dr. McKeel: I do not like to be in a position to ask an unusual favor. I am in desperate need of some help. Dr. Van Blaricom comes with qualifications as good or better than mine. He is in the unfortunate position of not having had a sister state examine him. I had hoped and had every reason to think he would be out before June 15, 19th. He arrived in New York June 27th. He would be able to be examined by New Hampshire September 15th. He could meet that requirement at that time. To deny him the privilege of a limited license at this time is going to work a hardship on this man who is without a job, not to mention I am unable to cover the work in the Asheville area by myself.

Dr. Van Blaricom: I was ready to process final papers for citizenship when I went overseas. Citizenship was then not processed as I had to come back and establish residency in the states. I have cleared this and they can process the final citizenship papers in September, 1958 through the courts in Asheville.

Dr. Combs moved that this matter be discussed at a later session of this meeting and advise. This motion was seconded by Dr. J. B. Anderson and passed. (See p. 1, 55 these Minutes)

Dr. Robinson was approved for special limited license on an annual basis contingent upon completion of credentials satisfactory to the secretary.



Dr. Doffermyre: You are applying to this Board to continue your medical training in the State of North Carolina. This permit will not allow you to prescribe or dispense narcotic drugs. It is issued on an annual basis, will be renewable without another appearance before the Board, provided you apply in writing with a recommendation from your chief. This permit in no way implies that it can be converted to a full license in North Carolina until such time that you have taken our state board or some other state board which we can endorse. Then you would be eligible to receive full license. The graduates who are from foreign medical schools will be required after July 1st, 1959 to have the certificate of the ECFMG to continue in residency training in North Carolina.

You will be given 30 days to complete credentials or you may be instructed to cease work until credentials are completed.

APPLICANTS FOR SPECIAL LIMITED LICENSE - POSTGRADUATE FOREIGN EXCHANGE RESIDENTS

RE: Dr. Hae Sok Kim, graduate of Seoul National University, appeared applying for special limited license to the State Hospitals where he is a resident. He presented his student exchange visa. Dr. Kim was approved for special limited license on an annual basis to the State Hospitals.

RE: Dr. Shaotsu Lee, graduate of the National Taiwan University, appeared applying for special limited license to Duke University School of Medicine, where he is a resident in Anesthesiology. He furnished photostatic copy of certificate of the ECFMG as of March 25th, 1958 and presented his student exchange visa. Dr. Lee was approved for special limited license on an annual basis to Duke University School of Medicine.

RE: Dr. Jose R. Ombao, graduate of the University of Santo Tomas, appeared applying for special limited license to Lincoln Hospital, where he is a resident in Obstetrics and Gynecology. He presented his student exchange visa. He was approved for special limited license to Lincoln Hospital on an annual basis.

The above physicians were advised that in order to continue in training after July 1st, 1959, they would be required to present certificate of the ECFMG. They were also advised that the special limited license is granted on an annual basis and that they would not be permitted to obtain a narcotic stamp.

RE: Dr. Armulfo C. Aldama, graduate of the University of Santo Tomas, appeared with incomplete credentials applying for special limited license to Watts Hospital, where he is a resident in Urology. He presented his student exchange visa. He was approved for special limited license to Watts Hospital on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Jose A. Q. Amado, graduate of the University of San Carlos, appeared with incomplete credentials applying for special limited license to Watts Hospital, where he is on a rotating internship. He presented his student exchange visa. He was approved for special limited license to Watts Hospital on an annual basis, contingent upon completion of credentials satisfactory to the secretary.



RE: Dr. Luis R. Arrue, graduate of Havana University, appeared applying for special limited license to Watts Hospital, with incomplete credentials. He is a resident in Pediatrics. He presented immigration visa. Dr. Arrue furnished photostatic copies of medical school records and advised that due to political conditions in Cuba that he would be unable to obtain certification direct from his dean. He said that the Medical School of Havana is not functioning due to the fact that it is the focus of the disturbance. The photograph on file was compared with that on his passport. Dr. Arrue was approved for special limited license on an annual basis to Watts Hospital and his credentials accepted under the circumstances.

RE: Dr. Erdogan Atasoy, graduate of the University of Istanbul, appeared with incomplete credentials applying for special limited license to Watts Hospital, where he is a resident in Surgery. He did not present his passport. Dr. Atasoy was approved for special limited license on an annual basis to Watts Hospital.

RE: Dr. Bienvenido P. Cabotaje, graduate of the University of Santo Tomas, appeared applying for special limited license to Duke, where he is a resident in Anesthesiology. He presented his student exchange visa. Dr. Cabotaje was approved for special limited license to Duke on an annual basis.

RE: Dr. Chee-chiem Chu, graduate of the National Taiwan University, appeared with incomplete credentials applying for special limited license to Watts Hospital where he is a resident in Medicine. He presented his student exchange visa. Dr. Chu was approved for special limited license to Watts Hospital on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Mithat Coruh, graduate of the University of Istanbul, appeared with incomplete credentials applying for special limited license to Duke University School of Medicine, where he is a resident in Pediatrics. He presented his student exchange visa. Dr. Coruh was approved for special limited license to Duke University School of Medicine on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Robert Ibarra, graduate of the University of San Carlos, appeared with incomplete credentials applying for special limited license to Watts Hospital, where he is a rotating interne. He presented his student exchange visa. Dr. Ibarra was approved for special limited license to Watts Hospital on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Tirso E. Joson, graduate of Manila Central University, appeared with incomplete credentials applying for special limited license to Lincoln Hospital, where he is a resident in Surgery. He presented his student exchange visa. Dr. Joson was approved for special limited license to Lincoln Hospital, contingent upon completion of credentials satisfactory to the secretary.

Dr. Doffermyre: This special limited license is a permit to continue your training in the State of North Carolina. It in no way implies that it will ever be converted to a full license. It is granted on an annual basis and in order to be renewed it is necessary to take the examination of the ECFMG, if you have not already taken it. It will be given in September and again in March. It will be necessary that you



take and pass this screening examination before special limited license can be continued beyond July, 1959. Those who have taken and passed this can renew the special limited license for another year by applying and recommendation from your chief.

RE: Dr. Manorcher Moin, graduate of the University of Geneva, appeared with incomplete credentials applying for special limited license to City Memorial Hospital, where he is a resident in Pediatrics. He presented his student exchange visa. Dr. Moin was approved for special limited license to City Memorial Hospital on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Dowlat Nikfar, graduate of Teheran University, appeared with incomplete credentials applying for special limited license to Watts Hospital, where he is a resident in Obstetrics and Gynecology. He presented his student exchange visa. Dr. Nikfar was approved for special limited license to Watts Hospital on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Andres Avelino Ramos, graduate of the National University, appeared applying for special limited license to Watts Hospital where he is a resident. He presented immigration visa. RE: Dr. Wilson Rocha, graduate of the University of Miras Gerais, appeared with incomplete credentials applying for special limited license to Duke University School of Medicine, where he is a resident in Pediatric Allergy. He presented exchange visa. Dr. Rocha was approved for special limited license to Duke University School of Medicine on an annual basis, contingent upon completion of credentials satisfactory to the secretary.

Samuel, graduate of Andhra University, appeared with incomplete credentials applying for special limited license to the University of North Carolina School of Medicine, where he is a resident in Neurology. RE: Dr. Kshetrabasi Tripathy, graduate of Calcutta Medical College, appeared with incomplete credentials, applying for special limited license to Duke University School of Medicine where he is a resident in Medicine. He presented exchange visa. Dr. Tripathy was approved for special limited license on an annual basis to Duke University School of Medicine, contingent upon completion of credentials satisfactory to the secretary.

RE: Dr. Ayyildiz Vedi, graduate of the University of Istanbul, appeared with incomplete credentials applying for special limited license to Watts Hospital, where he is a resident. He presented exchange visa. Dr. Vedi was approved for special limited license to Watts Hospital on an annual basis contingent upon completion of credentials satisfactory to the secretary.

Dr. Doffermyre: This special limited license is a permit to allow you to continue training in North Carolina. It in no way implies that it can ever be converted to full license to practice in this state. Neither does it give you permission to write or prescribe narcotics for patients. This license is renewable yearly upon written application and upon letter of reference from your chief of service. That, however, applies only to those who after July 1st, 1959, have taken the examination of the Educational Council for Foreign Medical Graduates and passed it.

APPLICANTS FOR SPECIAL LIMITED LICENSE - GRADUATES FOREIGN MEDICAL SCHOOL - STAFF STATE INSTITUTIONS

RE: Dr. Alstair James Taylor, graduate of the University of Aberdeen, Scotland, M. B. Degree, appeared applying for special limited license to the State Sanatoria to cover him as a staff physician. He presented immigration visa. Dr. Taylor was approved for special limited license to the State Sanatoria on an annual basis.

Dr. Doffermyre: You will not be able to prescribe or dispense narcotics. You will not be able to get a narcotic permit or do private practice outside of the Sanatorium. You will be required to take and pass the examination of the Educational Council for Foreign Medical Graduates, if you wish to remain there after one year and take our written examination.

RE: Dr. Vera Emma Louise McBryde appeared with incomplete credentials applying for license by endorsement of credentials.

Dr. Combs: When you desire to begin practice?

A. In the matter of a week or two. I was waiting the decision of the Board.

Dr. Tyner: Where do you plan to locate?

A. Durham

Dr. Tyner: Have you ever been convicted of a crime? A. No, I haven't.

VERDICT: The above physicians will be required to repeat Part II of the written examination in order to obtain license.

RE: Dr. Willard Griggs, Norwood, North Carolina - (See previous Minutes) - The following is report on Dr. Griggs submitted by Dr. Thomas W. Baker:

"Dr. Willard Griggs and his wife were interviewed in my office on July 19, 1958. His general appearance was good, and his sensorium appeared normal. He stated that he had not taken any opiates during the past three months and had not prescribed any opiates for any patient during this time. He admits that he takes from one to two nembutal or seconal capsules nightly, and takes about three Miltown tablets daily. He denies taking any alcohol. Mrs. Griggs substantiates all of the above statements.

"He states that his practice has depreciated considerably and that he is now seeing from 10 to 20 patients in the office daily, whereas a year ago he was seeing from 20 to 40 patients daily. He states that he has had no hospital practice during the past three months. His wife states that he is beginning to take a little more interest in social affairs.

"Previous telephone conversation with Dr. W. L. McLeod of Norwood, North Carolina, had given me much the same information. Dr. McLeod states that he did not believe

"Dr. Griggs had had any patients in the hospital for the past three months, and that while he was generally in the office, he believed his practice had deteriorated considerably. He stated that his narcotic addiction was generally known. He had checked with the Norwood Drug Store and stated that he was writing only one to two prescriptions daily and had written for no narcotics during the past three months. Dr. McLeod stated that he did not mingle with the other physicians, attended no medical meetings, and had generally remained aloof socially."

This report was received as information by the Board.

RE: Social Security - The secretary reported that as per the direction of the Board he had consulted the Director of the Social Security Agency for the State of North Carolina and ascertained that the members of the Board are not eligible for coverage under Social Security on their per diem pay.

RE: Dr. Lawrence Stickney Van Blaricom - (See pp. 1 and 15 of these Minutes) - VERDICT: Dr. L. R. Doffermyre moved that Dr. Van Blaricom come to Raleigh to sit the written examination and that such papers be graded within a period of four days and that said grades be returned to the office of the secretary. That should he receive a passing average, that he be given license to practice in North Carolina. This motion was duly seconded by Dr. Thomas W. Baker and passed unanimously. (Dr. Van Blaricom took and passed the written examination and was licensed.)

RE: Office of the Secretary - Dr. L. R. Doffermyre moved that the secretary have the authority to employ a full-time secretary to replace Mrs. Charlotte Newman, who is now on half-time. This motion was duly seconded by Dr. Thomas W. Baker and passed unanimously.

The meeting was adjourned.

RE: Dr. Samuel Albert Rhyne - On September 24th, 1956, Dr. Rhyne's license to practice medicine in the State of North Carolina was revoked, sentence suspended for two years on the condition that he remain of good behavior, et cetera.

Dr. Rhyne appeared at the request of the Board due to the fact that his probation will end in September, 1958. He furnished letters from outstanding citizens of the community reporting a good record during his probationary period. Dr. Rhyne stated that he was taking no medication of any kind. He was commended by the Board on his rehabilitation.

VERDICT: Dr. J. B. Anderson moved that the Board not recommend reinstatement of Dr. Samuel Albert Rhyne's narcotic stamp. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.



RE: Dr. E. Gaine Cannon, Brevard, North Carolina  
 (See previous Minutes, May, 1958) - Due to alleged narcotic irregularities and upon investigation a shortage in his narcotic supply, when Dr. Cannon moved from South Carolina to Brevard, the Board declined to recommend him for narcotic stamp. Dr. Cannon thereupon requested that he be granted an interview before the Board.

Dr. Cannon came in and petitioned the Board to recommend him for narcotic license. He stated that the investigation in South Carolina was precipitated by a faction against the Pickens Hospital and that an income tax investigation was also started on the same basis. He alleged that he was unable to produce records required; that they had had some employees in the hospital who were addicted and that he missed a few drugs from time to time, which was the only way he could account for the shortage of drugs. That he did not keep his drugs separate from those of the hospital. He said that he was working part of the week in Brevard and part of the week in Balsam Grove; that he had given the land and a small hospital was under construction at Balsam Grove and that it is his intention to practice there full-time upon completion of the hospital; that he had made this plan two to three years ago. (See file for complete interview)

VERDICT: Dr. J. B. Anderson moved that Dr. E. Gaine Cannon's petition for recommendation of narcotic stamp be denied. This motion was duly seconded by Dr. Thomas W. Baker and passed unanimously.

Dr. Cannon was advised the verdict of the Board.

RE: Dr. Shirley Marilyn Gallup (See previous Minutes) - The secretary reported that the South Carolina Board of Medical Examiners advised Dr. Gallup's South Carolina medical license was revoked as of June 24th, 1958, following hearing and testimony given by the Narcotic Agent.

RE: Dr. Oliver Wayne Williamson, Waggner, South Carolina - Dr. Williamson was subpoenaed to appear following conviction in the Federal Court of violation, Conspiracy to Violate Narcotic Laws. Certified copy of judgment of the Federal Court was introduced by Attorney Anderson.

The Board was represented by Attorney John H. Anderson and the defendant was represented by Attorney G. T. Carswell.

The following charges of the Board were read by Attorney Anderson:

"1. That on the 17th day of September, 1957, you were charged by a Grand Jury in the United States District Court for the Western District of North Carolina, Charlotte Division, with having, during the period from September 1, 1956 to and including April 9, 1957, in the Western District of North Carolina, the Eastern District of South Carolina and other Federal districts within the jurisdiction of said Court, unlawfully, knowingly, willfully and feloniously conspired,

"combined, and confederated and agreed together with John Alfred Johnson and several other individuals named in said charges of the Grand Jury, to unlawfully purchase, sell, dispense and distribute narcotic drugs, not in or from the original stamped packages, and to unlawfully sell, barter, exchange and distribute such narcotic drugs without a written order upon a form issued for that purpose by the Secretary of the Treasury, and unlawfully to purchase, sell, dispense and distribute narcotic drugs for other than legitimate medical purposes, in violation of Title 18, U. S. Code, Sec. 371, and by conspiring to violate 26 U. S. Code, Sec. 4704 (a) and 4705 (a) of the Internal Revenue Code of 1954. In said indictment and charges presented against you by said Grand Jury you were further charged with having committed 23 overt acts in pursuance of the conspiracy with which you were charged and with having agreed to sell and having sold quantities of morphine sulphate tablets, dolophine tablets, codeine tablets and other narcotic drugs not in or from the original stamped packages and not for legitimate medical purposes in violation of the Narcotic Laws of the United States and of the Internal Revenue Laws of the United States, as follows:

1. That you agreed on about September 1, 1956 to sell such drugs to John Alfred Johnson, knowing at the time that said Johnson would use such drugs in supplying the illicit narcotic trade in the State of North and South Carolina.
2. That you sold narcotic drugs on or about October 18, 1956 to John Alfred Johnson in violation of said laws.
3. That you sold such drugs to said Johnson on or about October 25, 1956.
4. That you sold such drugs to said Johnson on or about January 30, 1957.
5. That you sold such drugs to said Johnson on or about February 18, 1957.
6. That on or about September 1, 1956 and between said date and April 9, 1957 you sold large quantities of such narcotic drugs to John Alfred Johnson and various other persons named in the charges and indictment of the Grand Jury.
7. That between September 1, 1956 and April 9, 1957, you sold such drugs to Berman Ward Walters, Jesse William Watson, Bessie Law Foulk, Harry Lee Gray and others in violation of said laws.

"II. That on the 11th day of April, 1958, you entered a plea of guilty to the foregoing charges preferred against you in the United States District Court for the Western District of North Carolina, whereupon it was adjudged by said Court that you had been convicted upon your plea of guilty of the offense of violation of Title 371, Conspiracy to Violate Narcotic Laws, as charged in Count One of the foregoing Bill of Indictment, and as set forth in Paragraph I of these charges

"and accusations, and you were given a sentence of three (3) years imprisonment, which was suspended and you were placed on probation for five years and fined the sum of \$10,000.00.

"III. That you committed the acts and made the sales of narcotic drugs hereinabove set forth in Paragraph I in violation of the Laws of the United States, and not for legitimate medical purposes.

"IV. That in the foregoing respects you have been guilty of having committed a felony, of having been convicted of committing a felony, and of unprofessional conduct unworthy of and affecting the practice of your profession, and grounds exist for the revocation of your license to practice medicine in the State of North Carolina.

"You are further given Notice that a Hearing upon the foregoing charges and accusations will be held before the Board of Medical Examiners of the State of North Carolina on the 16th day of June, 1958, at 3:30 P. M. o'clock at the Sir Walter Hotel, Raleigh, North Carolina, at which time and place you will be given an opportunity to be heard, to cross-examine witnesses, and to present evidence on your own behalf, personally or through counsel, and that you may file with the undersigned for presentation to the Board any answer you may desire to make to the foregoing charges, although you are not required to file any answer.

Attorney Carswell stated that it was agreed that they would enter a plea of conspiracy to establish a mandatory sentence.

Mr. Carswell made a plea for Dr. Williamson and said that he practiced in a rural community and was doing well; that he enjoyed an excellent reputation, to which outstanding citizens testified in the Federal Court. Dr. Williamson admitted that he had acted in a vvery foolish manner; that he was acting in good faith and attempting to rehabilitate an addict whom he did not know and who did not live in his community. That he was dispensing 100 one-half grain morphine tablets at the time and directing the patient as to dosage and to cut down. He said he had no idea the patient was selling it, but that he finally became suspicious. That he had not charged exorbitant prices for the same.

A statement from the South Carolina Board of Medical Examiners was presented advising that Dr. Williamson's medical license in South Carolina was revoked as of June 24th, 1958.

Dr. Williamson said he had heard that at a later session the South Carolina Board agreed that he might be allowed to practice at the State Hospital in South Carolina. (License to practice in the State Hospital of South Carolina not required) (See file for complete hearing)

JUDGMENT: At the conclusion of the evidence, the unanimous vote of the Board of Medical Examiners was that Dr. Oliver Wayne Williamson is guilty as charged and that the judgment of the Board is that his license to practice medicine in the State of North Carolina be revoked.

Dr. Williamson was advised the verdict of the Board and he surrendered his license to practice medicine to the secretary of the Board.

RE: Dr. George Melchior - (See previous Minutes) -

Dr. Melchior came in with some plans towards procuring employment. He said that Dr. M. M. Vitols, Superintendent of the State Hospital at Goldsboro, advised he would take him with the understanding he would work as any other staff physician. That he had applied to the Veterans Administration Hospital in Fayetteville and that they were receptive. That they have a job but that the application will have to be processed through Atlanta and then go to Washington with explanation of the circumstances. After a lengthy discussion the following resolutions were made:

Dr. J. B. Anderson moved that the Board advise Dr. George Melchior to go to the Veterans Administration. This motion was duly seconded by Dr. Thomas W. Baker.

Substitute Motion: Dr. Edwin A. Rasberry, Jr. moved that Dr. George Melchior be allowed to work at the State Hospital at Goldsboro under permit, on probation and under supervision of Dr. M. M. Vitols, Psychiatrist and Superintendent, for a period of 12 months. This motion was duly seconded by Dr. T. W. Thurston. This motion failed to pass.

The minority members desired further discussion and the matter was held open for the same.

The vote on the original motion was unanimous.

The meeting was adjourned.

RE: Dr. George Melchior - Following further discussion the decision previously voted on above held.

RE: Dr. Claude Raymond Nichols, Jr. was granted limited license by endorsement of credentials to Duke University School of Medicine October 31st, 1955, to cover him as a resident. He is now applying for full license as he has accepted a position on the staff in the Department of Psychiatry at Duke. His credentials are in order.

VERDICT: Dr. J. J. Combs moved that the limited license of Dr. Claude Raymond Nichols, Jr. be converted to full license. This motion was duly seconded by Dr. J. B. Anderson and passed unanimously.

RE: Dr. Wilson Crunk Rippey, Jr. was granted limited license by endorsement of credentials to the University of North Carolina School of Medicine September 24th, 1956, to cover him as a resident. He is now applying for full license as he has accepted a position on the staff at the State Hospital at Butner.



VERDICT: Dr. J. B. Anderson moved that the limited license of Dr. Wilson Crunk Rippey, Jr. be converted to full license.

RE: Dr. Claude Raymond Nichols, Jr. - see page 69

RE: Dr. Peter Van Dooren was granted limited license following written examination in 1957, as he had not obtained citizenship. He has requested extension of his geographic limitation in order that he might practice in Hendersonville, North Carolina.

VERDICT: Dr. J. B. Anderson moved that the limitation of Dr. Peter Van Dooren's license be extended to Henderson County, North Carolina. This motion was duly seconded and passed unanimously.

RE: Dr. Frederick Kratter - (See previous Minutes) - The secretary reported Dr. J. W. Murdoch, Superintendent of the State Hospitals Board of Control, advised Dr. Kratter left the State Hospital on June 30th, 1958 and was to sail on July 10th, 1958.

RE: Dr. Everett Bruce Liggins, Wadesboro, North Carolina - The secretary presented report of the State Bureau of Investigation, which revealed that the Narcotic Agent had reported that Dr. Liggins had on May 21st, 1957 surrendered his special tax stamp and his unused narcotic order forms; that this was precipitated by Dr. Liggins' excessive purchase of narcotic drugs. That since that time the Bureau of Narcotics has received notice that Dr. Liggins is writing prescriptions for what was considered an excessive amount of narcotics. That the SBI agent was told by Dr. A. E. Perry, negro physician there, that Dr. Liggins had been using narcotics.

VERDICT: Dr. J. B. Anderson moved that the report of the State Bureau of Investigation be received as information and hold for action of the court. This motion was duly seconded and passed unanimously.

RE: Written Examination - Failures - Dr. J. B. Anderson moved that the number of failures on the written examination be published. This motion was duly seconded by Dr. L. R. Doffermyre. It was passed unanimously.

RE: Dr. Walter Winslow Hamilton made application for license by endorsement and paid fee for same on April 12th, 1958. Dr. Hamilton advised on July 6, 1958 that he has been ill for several months with chronic bronchial pneumonia and bronchiectasis. He has asked that his fee for endorsement be refunded.

VERDICT: Dr. Thomas G. Thurston moved that the fee in full be refunded to Dr. Walter Winslow Hamilton. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. John Hill, Marine Base, Cherry Point, North Carolina, a graduate of the University of Edinburgh, Scotland in 1950, has requested information with regard to license to practice in this state.



VERDICT: The Board instructed the secretary to advise Dr. John Hill that the policy of the Board is that certification of the Educational Council for Foreign Medical Graduates is a requisite for taking the examination for license in this state.

RE: Dr. James F. Donnelly - The secretary presented reports of the State Bureau of Investigation under dates of March and April, 1958. It was alleged that Dr. Donnelly forged the name of a physician in order to obtain narcotic drugs. On July 7th, 1958 report was received from the State Bureau of Investigation that Dr. Donnelly, through his attorney, entered a plea of nolo contendere in the Recorder's Court of Dunn; that judgment was two years in jail assigned to work under the State Prison Department, suspended for three years under the following conditions: (1) Pay fine of \$20.00 and costs; (2) That during said three years he shall not at any time take any drugs of any type unless prescribed by a doctor; (3) shall not forge or attempt to forge or obtain any drugs in an illegal manner; (4) that during said three years he is to take any treatment that Dr. Richard Proctor should deem advisable and necessary to control the habit of taking drugs and co-operate with said doctor.

VERDICT: Dr. J. B. Anderson moved that Dr. James F. Donnelly be requested to appear before the Board for an interview. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: Dr. Jack W. Sohler, resident at Watts Hospital - Dr. Sohler was granted special limited license to Watts Hospital September 24th, 1956 and terminated his service on June 30th, 1957. Dr. Sohler has now applied for renewal of his special limited license where he has resumed his surgical training. He plans to be there until June, 1959. Mr. Sample B. Forbus, Director, has furnished a letter of recommendation on behalf of Dr. Sohler.

VERDICT: Dr. L. R. Doffermyre moved that the special limited license of Dr. Jack W. Sohler be extended to cover his training at Watts Hospital, on an annual basis, and that he will be required to be certified by the Educational Council for Foreign Medical Graduates if he plans to remain there after July 1st, 1959. This motion was duly seconded by Dr. Thomas G. Thurston and passed unanimously.

RE: Dr. Nakhleh Zarzar, resident at the University of North Carolina, has applied for renewal of his special limited license. He advised that he is on the five year plan of training in Psychiatry at the University of North Carolina School of Medicine and will spend the last two years, July 1959-June, 1961 at the Butner State Hospital.

VERDICT: Dr. J. J. Combs moved that the special limited license of Dr. Nakhleh Zarzar be extended for one year and that he be instructed to obtain the certification of the Educational Council for Foreign Medical Graduates prior to July, 1959. This motion was duly seconded by Dr. Thomas G. Thurston and passed unanimously.


