The July 1993 meeting of the North Carolina Board of Medical Examiners was held at the Embassy Suites, 4700 Creedmoor Road, Raleigh, North Carolina. The meeting was called to order at 7:30 p.m., July 28, 1993, by Nicholas E. Stratas, M.D., President. Board members in attendance were: Dr. Stratas, John W. Nance, M.D., President-Elect; Ernest B. Minutes - May 1993 meeting

The first order of business was the adoption of the minutes from the May 1993 meeting of the Board. The Board adopted a motion made by Dr. Roufail and seconded by Dr. Godwin to approve the minutes as presented with no corrections.

STATE HEALTH DEPARTMENT

Thad Wester, M.D., State Health Department meet with the Board on Wednesday night to discuss the State Health Departments views on the HIV status. As a result of the discussion the Board's staff will research and develop a proposal for a system to notify other State Boards when a doctor leaves the State while under investigation by the State Health Department.

EXECUTIVE SECRETARY'S REPORT

Bryant D. Paris, Jr., Executive Secretary, reported to the Board the following items.

Statistics on the disciplinary actions taken by the Board from 1987 until the present. (Attachment A) This data is compiled in the Board's office on an ongoing basis and will be supplied for the Board's review at each meeting.

Mr. Paris reported that the Board's conversion begun January 1993 from the WANG computer system to the IBM Novelle Network is progressing.

Mr. Paris noted that a problem had been identified with the assignment of license numbers. Some years in the past individuals on the staff had randomly assigned numbers and the Board now is in danger of assigning duplicate numbers. To prospectively avoid this problem the staff has developed and implemented a system of numbering which will incorporate the year of assignment in the number (93-XXXXX). The numbers will begin at 00001 each year and then return to that sequence during the next century. This will prevent any duplication for several hundred years. The Board approved this proposal.

Mr. Paris informed the Board that the staff has reviewed in detail all materials to be presented at this meeting. The Board's annual bulletin is at the printer and will be mailed within the next month. A copy of committee and officer task descriptions has been included for reference by the members in the materials prepared for this meeting.

Regarding Board staff items, Mr. Paris noted that staff has identified a need to develop several positions, a licensing credentials clerk, data entry clerk and a network manager for the computer system. Financial constraints are the limiting factors.

The licensing process and department have generated several complaints and these were addressed by Mr. Paris. The system of application is being reviewed and results will be reported to the Board.

Efforts to improve the efficiency of the telephone system have been initiated, although the main constraint is the SPIRIT AT&T system which is limited in flexibility. Board members were urged to continue to use the 800 access number to facilitate cost savings.

Mr. Paris reported on the progress of the PA Task Force appointed by the Board and tasked with the responsibility of developing rule proposals which will govern the approval and functioning of PAs. The task force met on June 18, 25 and July 25, 1993. The meetings have been productive and the November deadline appears to be within reason. The next meeting will be in August.

Items presented by Mr. Paris and requiring Board action follow:

1. The Board approved the change in licensing numbering sequence.
2. The Board authorized a reduction in the numbers of documents photocopied and mailed to each Board member prior to the interview of licensing applicants. Materials to be sent are: a memo from staff which will include who the letters of recommendation are from, a cover sheet which will also include a photocopy of or one of the original photos, the application form and documentation of "yes" answers to questions.
3. The Board requested that all materials concerning licensure be mailed separately from general information in order to avoid confusion for the members.
4. Dr. Johnson asked that as the application form is revised that chronological data be organized to proceed from the present to the past. The Board approved this request and so instructed Mr. Paris.
5. Mr. Paris requested that the Board approve a fee increase for the USMLE to reflect the administrative costs from \$250 to \$400. With this increase the total cost to the applicant for the USMLE will be \$700. This motion was made by Dr. Johnson, seconded by Dr. Godwin and approved by the Board unanimously.
6. Mr. Paris asked that the Board increase the application fee for a VIP license be increased to reflect the administrative costs from \$50 to \$150. The motion was made by Dr. Godwin, seconded by Dr. Roufail and approved unanimously by the Board. Mr. Paris was instructed to make the necessary rule changes.
7. Mr. Paris recommended that rosters of physicians no longer be provided without an additional fee at the time of registration in order to reflect the publication cost. The motion was made by Dr. Godwin, seconded by Dr. Johnson and approved unanimously by the Board that the roster be provided at a reasonable fee, \$25.00 and that this be indicated on the registration application form. Mr. Paris was so instructed.

8. Mr. Paris requested that the fee for registration of PAs be increased to \$70 from \$35 to reflect the addition of the PAs to PHP following the recent legislative change in the peer review statute. Dr. Godwin moved that this matter be referred to the PA task force for consideration. Dr. Nance seconded this motion which was approved unanimously by the Board. Mr. Paris was instructed to inform the PA task force of this additional responsibility.

BOARD NAME CHANGE

Dr. Barrett recommended that the Board consider changing its name to the North Carolina Medical Board to better reflect its function. The Board adopted a motion made by Dr. Barrett and seconded by Dr. Godwin that this issue will be added to the Board's agenda for the next long session of the Legislature. The Board unanimously approved this motion.

LICENSING APPLICATIONS

Dr. Stratas instructed the licensing staff to attach a note to all applications being mailed in the future indicating that the Licensing Department is in a transition period and the Board apologizes for any "glitches" that may occur. This instruction was made in order to improve public relations with applicants.

FEE INCREASE

The Board discussed the fact that the Legislature approved an increase in the number of Board members to 12. However, the proposal to increase the Registration fee for doctors was not passed by the Legislature. Dr. Stratas is to communicate with the Governor difficulty regarding failure of the fee increase proposal in light of four additional members and the additional cost that the Board will incur with these new members.

ORIENTATION OF NEW BOARD MEMBERS

Dr. Barrett and Dr. Johnson will asked to work closely with the staff to develop a more indepth and formal orientation process for new Board members.

LOBBYING - LEGISLATIVE ISSUES

Dr. Stratas requested that Michael E. Weddington, Esquire Board Attorney draft instructions regarding methods by which a quasi judicial agency may communicate concerns and needs to the Legislature. Additionally, the staff is to communicate with the Attorney General's office to determine the scope allowed by statute with respect to communicating with the Legislatures.

PHOTOGRAPHS FOR LICENSURE

The Board adopted a motion made by Dr. Spangler and seconded by Dr. Godwin to allow applicants who are not able to obtain a certified photograph, to provide a passport or admission card to Medical School which will be presented to a Board member for approval in lieu of the certified photograph.

AGENDA - PUBLIC

The Board members were provided with a proposed 1995 meetings schedule. Board members were requested to notify staff of conflicts.

The Board adopted a motion made by Dr. Godwin and seconded by Dr. Nance to accept the Resolutions as information.

The Board adopted a motion made by Dr. Spangler and seconded by Dr. Nance to adopt the proposed position statement regarding Advanced Care Directives and Patient Autonomy. (Attachment C)

The Board adopted the proposed position statement regarding the Availability of Physicians After Hours. (Attachment D)

EMS REPORT

The EMS Committee chaired by Dr. Nance moved that the Board adopt the EMS certifications for the period of April 24, 1993 - June 30, 1993. The Board unanimously approved this committee.

ADMINISTRATIVE COMMITTEE

The Administrative Committee met on June 22, 1993, at 1:30 p.m., Present were Dr. Spangler, Dr. Nance, Ms. Meelheim and Mr. Paris.

The following information was discussed and presented to the Board on June 29, 1993, for approval:

Dr. Spangler reported that a review of the Board's insurance coverage revealed that no coverage is available to the Board and staff for defamation or invasion of privacy. The staff is being educated regarding confidentiality of Board records. Additionally, Dr. Spangler reported for the Board's information that adjustments to the insurance policy have been made to provide coverage for the new computer equipment and software.

The Administrative Committee provided the Board with a comparison of benefits offered to State employees, Rex Hospital employees, Board of Realtors employees and Board of Medical Examiners employees. A request for more information from Medical Boards in Virginia, South Carolina and Tennessee have been made, and will be distributed prior to the September 1993 meeting of the Board. Dr. Spangler reported to the Board that all employees are given an accounting of their true benefit package monthly.

The Board's staff continue to have weekly Director meetings and monthly staff meetings. Minutes from these meetings are distributed to all Board members. The Committee requested that this information continue to be distributed.

Dr. Spangler voiced his concern that temporary licenses continue to have a different number. The staff was instructed to survey other states to determine how they number the sequence of temporary licenses.

The Committee discussed the benefit and cost of the Self Assessment Questionnaire and reported that the report is being completed.

Much discussion took place regarding the problems encountered with the licensing process. The staff will continue its efforts to develop a unified system in consultation with Dr. Barrett and Dr. Johnson. Prior to finalizing a system, a proposal is to be circulated to the Board members. Also, the staff is to consider identifying the major institutions and invite key persons from the staff to the Board's office to be briefed on the Board's system.

The Committee recommended that Board adopt its recommendation to terminate the present contract with Mrs. Bobbi Furr, CPA. The new CPA is to be approved by the President and the Executive Secretary before hiring. The Board unanimously adopted the recommendation.

The Administrative Committee recommended that the Board approve its request to move funds allocated for PHEP to hire an Assistant Medical Director into a special discretionary fund at the end of the second and forth quarter to be used in such accounts as temporary help. The Board unanimously adopted the recommendation.

The Committee recommended that a letter of appreciation be sent to the members of the PA Task Force in conjunction with the certificate of appreciation being drawn up at the request of Dr. Stratas.

Dr. Spangler requested that materials be located which would teach the Board members how to be better hearing officers. Ms. Meelheim will find references from North Carolina.

PHEP COMMITTEE

The PHEP Committee chaired by Mrs. Willis and including Dr. Godwin met and reviewed the cases with Dr. Vanderberry. A written report of 34 cases was presented to the Board for its review. The Board adopted the Committee's motion to approve the written report. This is not included as these actions are not public.

COMPLAINT COMMITTEE

The Complaint Committee chaired by Mrs. Willis and including Drs. Barrett and Johnson reported on 54 complaint cases. A written report was presented for the Board's review. After discussion the Board adopted the Committee's motion to approve the report. This is not included as these actions are not public.

MALPRACTICE COMMITTEE

The Malpractice Committee chaired by Dr. Spangler and including Mrs. Willis and Dr. Barrett reported on 52 malpractice reports. A written report was presented for the Board's review. The Board adopted the Committee's motion to approve the written report.

Request for Board Opinion re: Physician Extenders declaring a patient's death.

The Board adopted proposal #1 of the Committee which Physician Extenders pronouncing a patients death as long as this is in the standing orders of the extender. (Attachment E)
