

MEETING OF THE BOARD OF MEDICAL EXAMINERS OF
THE STATE OF NORTH CAROLINA

The Velvet Cloak Inn and
Nelson Hall, North Carolina State University
Raleigh, North Carolina

June 11-14, 1973

The Board of Medical Examiners of the State of North Carolina met at The Velvet Cloak Inn and Nelson Hall at North Carolina State University, Raleigh, North Carolina, June 11-14, 1973 for purposes of interviewing applicants for license by endorsement of credentials, administering examinations and other business.

Monday, June 11
8:00 p.m.

The Board convened for business and reviewing credentials. Drs. Bryant L. Galusha, President, Charles B. Wilkerson, Secretary-Treasurer, Frank Edmondson, Cornelius T. Partrick, Joseph W. Hooper, Jr., E. Wilson Staub and Vernon W. Taylor, Jr. were present. Dr. Joseph J. Combs, Executive Secretary, Bryant D. Paris, Jr. Executive Secretary Designate, Mrs. Betty Joe Cooke, Administrative Assistant, Mrs. Diane Freeman and Mrs. Deborah Holland were present also.

RE: Family Nurse Practitioner - The Board reviewed the status of the proposed Rules and Regulations regarding the Family Nurse Practitioner and the most recent correspondence received from the North Carolina Board of Nursing in regard to those rules and regulations.

VERDICT: Dr. Wilkerson moved that Mr. John Anderson, Attorney for the Board of Medical Examiners, contact the attorney for the Board of Nursing to work out the final rules and regulations for the Family Nurse Practitioner and a report on this meeting shall be made at the next Board meeting. Seconded by Dr. Edmondson and duly passed.

RE: Request for Roster - E. C. Wong, Master Acupuncturist, requested a directory of licensed physicians in this state in order to check on licensure of a physician prior to accepting him in an Acupuncture Seminar.

VERDICT: Dr. Partrick moved that a Roster of Registered Physicians in North Carolina be sent to E. C. Wong upon payment of appropriate fee. Seconded by Dr. Taylor and duly passed.

RE: Dr. Floyd Deen, Morven, N. C. - The Executive Secretary reviewed recent correspondence received from Dr. W. R. Hudson, Chairman of the Ad Hoc Medicaid Peer Review Committee of the N. C. Medical Society in regard to the Board's action on Dr. Deen at the March, 1973 Board meeting.

VERDICT: Dr. Partrick moved that Dr. Hudson be permitted to forward correspondence and action of the Board to the Department of Social Services of the State of North Carolina. Seconded by Dr. Hooper and passed on vote of five for and one against.

RE: Dr. John Gladieux, Morganton, N. C. - The President reviewed the most recent correspondence received from Dr. Gladieux in regard to his voluntarily surrendering his Wisconsin medical license. This was received as information by the Board.

RE: Dr. N. R. Karve, Goldsboro, N. C. - The Executive Secretary reviewed correspondence received from Dr. Karve, who took and passed the North Carolina FLEX examination in June, 1972, regarding further geographical extension of his medical license and also the letter from the Executive Secretary to Dr. Karve stating that geographical extensions are made only after the physician has decided on the location for his practice.

VERDICT: Dr. Partrick moved that the Board accept the letter written by the Executive Secretary to Dr. Karve regarding geographical extensions for a limited license as sound advice to the physician. Seconded by Dr. Hooper and duly passed.



RE: Dr. L. R. Staton, Hayesville, N. C. - The President reviewed the most recent correspondence between the Board's office and Dr. Staton in regard to his health and physical condition, his ability to continue to practice medicine, and his handling of prescriptions for controlled substances.

VERDICT: Dr. Partrick moved that the Executive Secretary reply to Dr. Staton's letter thanking him for his prompt reply and stating that the Board is pleased that he is doing well and progressing so well. Seconded by Dr. Hooper and duly passed.

RE: Dr. Robert M. Wilhoit, Asheboro, N. C. - Dr. Frank Edmondson reported on his conference with Dr. Wilhoit in regard to his handling and ordering of controlled substances. Dr. Edmondson stated a written report would be made to the Board prior to the next meeting in regard to Dr. Wilhoit. The Board accepted this report as information prior to receipt of the written report.

RE: Dr. Francis O. Glover, Salisbury, N. C. - The Executive Secretary reviewed the file on Dr. Glover regarding his practices of handling of narcotics as indicated in a report received from the Rowan-Davie County Medical Society.

VERDICT: The Executive Secretary was instructed to write Dr. Glover, thank him for appearing before the Board and inform him that on the basis of information at hand, the Board of Medical Examiners sees no reason to take any action at this time, but that he should be very cautious in the prescribing of demerol for his wife.

RE: Dr. John C. Wiggins, Sr., Winston-Salem, N. C. - The Executive Secretary reviewed the file on Dr. Wiggins, including report of his appearance before the Board in March, 1971 and also the most recent report received from the Bureau of Narcotics and Dangerous Drugs on Dr. Wiggins' prescribing practices and record-keeping practices of controlled substances.

VERDICT: Dr. Partrick moved that if the Board can satisfy itself that Dr. Wiggins has not applied for renewal of his BNDD registration, no action should be taken. If he has applied for renewal, Dr. Wiggins is to be seen again at the next appropriate Board meeting. Seconded by Dr. Hooper and duly passed.

RE: Application for Registration of Visiting Professors - Dr. Frank Martin Hull, London, England; application complete; sponsored by the University of North Carolina School of Medicine. Dr. Charles B. Wilkerson moved that Dr. Hull be approved for registration as a Visiting Professor. Seconded by Dr. Partrick and duly passed.

RE: Assistants to Physicians -

RE: Dr. Marvin John Short, Morganton, N. C. - application for Adrian B. Boone, complete. Dr. Hooper moved that Adrian B. Boone be approved for registration as an assistant to a physician. Seconded by Dr. Staub and duly passed.

RE: Dr. John W. Nance, Clinton, N. C. - application for Richard Van Benthuisen, Jr. to work as an assistant to a physician for the Clinton Medical Clinic, Inc. and be supervised by the six physicians in that group. VERDICT: Dr. Partrick moved that the Clinton Medical Clinic, Inc. be advised that the N. C. Board sees no problem in the assistant to a physician serving as an assistant for the group as long as a formal application is completed, with complete job description, and one physician in the group must assume complete responsibility for the assistant. Seconded by Dr. Wilkerson and duly passed.

RE: Reinstatement - Biennial Registration -

The following physicians' licenses were suspended for failure to register as required by N.C. G.S. 90-15.00. They have now registered:

Dr. Galusha: Dr. Baum, I believe your plans are for Taylorsville, N. C.?

A: No, sir, my plans are for Mooresville, about the middle of this month. I plan to move then.

A: I hope to practice Internal Medicine in Lenoir, North Carolina.

Dr. Galusha: Dr. Carson, what are your plans for North Carolina. I see you now hold a resident's training license.

A: Yes, I do. I will be staying on at Chapel Hill on the staff at N. C. Memorial.

Q: Have you ever been convicted of a crime? A. No

Q: Have you ever used alcohol to excess? A. No

Q: Have you had any difficulty with boards of medical examiners? A. No

Q: Have you ever used narcotics or barbiturates personally? A. No, sir

VERDICT: Dr. Ted J. Carson approved for license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary.

RE: Dr. David Airey Chadwick appeared applying for license by endorsement of credentials. He is a graduate of the University of Manchester in England in 1946 and is licensed in New York, Connecticut, Arizona, Virginia and Tennessee.

Dr. Edmondson: Dr. Chadwick is a board certified anesthesiologist and a naturalized citizen of the United States. What are your plans for North Carolina, sir?

A: I had negotiated with a hospital in North Carolina and that was why I originally initiated my application. Meanwhile, nothing satisfactory turned out and I was recently appointed as Chairman of the Department of Anesthesiology in a hospital in Tennessee. As this is a neighboring state, I therefore decided I would still go ahead with my North Carolina license application, although I have no immediate plans for practice in North Carolina.

Q: You won't be coming across the line doing any practice?

A: No, no--this is a full time position I have.

Dr. Edmondson: Dr. Chadwick I believe all your credentials are in order.

Q: Have you ever been convicted of a crime? A. No

Q: Have you had any difficulty with state medical boards? A. No

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever personally used narcotics or barbiturates? A. No, never

VERDICT: Dr. David A. Chadwick approved for license by endorsement.

RE: Dr. Robert Louis Chevalier appeared applying for license by endorsement of credentials. He is a graduate of the University of Chicago in 1972 and is a diplomate of the National Board.

Dr. Galusha: What are your practice plans for North Carolina, doctor?

A: I will be completing my pediatric training at Chapel Hill and plan to stay in the state and practice.

Q: Have you ever been convicted of a crime? A. No--no felonies

Q: Have you had any difficulty with state medical boards? A. No, I have not

Q: Have you ever used alcohol to excess? A. No, I do not

Q: Have you ever personally used narcotics or barbiturates? A. No, I do not

VERDICT: Dr. Robert L. Chevalier approved for license by endorsement.

RE: Dr. Il Whan Chung appeared with incomplete credentials applying for license by endorsement. He is a graduate of Seoul National University in Korea in 1963 and is licensed in Vermont by FLEX in 1972

Dr. Galusha: Dr. Chung, do you have your alien registration receipt card?

A: Yes, I have it here.

Dr. Chung presented his card, # A 17 745 439 and the picture compared favorably with the individual present.

Q: What are your plans for this state?

A: I would like to practice Urology here--I have been looking at some towns in the western part of the state.

Q: Any specific place and time?

A: Yes, I have looked at Sylva, North Carolina and would like maybe to practice there in about one month. I will finish my training the end of this month.

Dr. Galusha: Dr. Chung, we do not have your certified photograph and statement from your medical school about your graduation, and we cannot grant you a license until we get that. As soon as you receive it, mail it to this office. You might have to be held over until the next meeting, in August. Your license will be limited geographically to the county in which you will be practicing until you become a U.S. citizen, do you understand that?

A: Yes, but may I move if I need to?

VERDICT: Dr. Ted J. Waller approved for license by endorsement.

RE: Dr. David William Watson appeared applying for license by endorsement of credentials. He is a graduate of the State University of New York in 1964 and is licensed in New York by endorsement with the National Board.

Dr. Wilkerson: You have been in private practice in New York?

A: Well, not actually in private practice. My time since graduation has been in training.

Dr. Galusha: Have you ever been convicted of a crime? A. No, sir

Q: Have you had any difficulty with boards of medical examiners? A. No, sir

Q: Have you ever used narcotics or barbiturates personally? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

VERDICT: Dr. David William Watson approved for license by endorsement.

RE: Dr. Robert Kent Webb appeared applying for license by endorsement of credentials. He is a graduate of West Virginia University in 1967 and is a diplomate of the National Board.

Dr. Galusha: Dr. Webb is presently at the V.A. Hospital in Minneapolis and will be at Duke, when, sir?

A: Beginning July first. I will be a fellow--Nephrology.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever used narcotics or barbiturates personally? A. No

Q: Have you had any difficulty with boards of medical examiners? A. No

VERDICT: Dr. Robert K. Webb approved for license by endorsement.

RE: Dr. Richard M. Weismer appeared applying for license by endorsement of credentials. He is a graduate of Hahnemann University in 1971 and is licensed in Pennsylvania by endorsement with the National Board.

Dr. Wilkerson: I see you are in the military now, Dr. Weismer. Why do you want a full North Carolina license?

A: I would like to do some extra work while I'm at Fayetteville.

Dr. Galusha: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

Q: Have you ever personally used narcotics or barbiturates? A. No, sir

Q: Have you had any difficulty with medical licensing boards? A. No

VERDICT: Dr. Richard M. Weismer approved for license by endorsement.



RE: Dr. Terry Lane Whipple appeared with incomplete credentials applying for license by endorsement of credentials. He is a graduate of the University of Virginia in 1971 and is licensed in Virginia by examination and in Texas by endorsement.

Dr. Galusha: What are your plans relative to North Carolina?

A: I will be stationed at Camp Lejeune about the first of July and hope to help cover the medical needs in that area during my off-duty time. Following my tour of duty, I hope to take some training at the University of North Carolina--I have already submitted an application there. Hope to be a surgery resident there.

Q: Have you ever been convicted of a crime? A. No
 Q: Have you had any difficulty with any medical licensing board? A. None at all
 Q: Have you ever used alcohol to excess? A. No, sir
 Q: Do you use narcotics or barbiturates personally? A. No, sir

VERDICT: Dr. Terry L. Whipple approved for license by endorsement of credentials if and when same are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Dr. Lucien Sanders Wilkins appeared applying for license by endorsement of credentials. He is a graduate of the Medical College of Virginia in 1967 and is licensed in Virginia by examination and also is a diplomate of the National Board.

Dr. Wilkerson: Dr. Wilkins, you are interested in practicing in North Carolina?

A: Yes, I am planning to associate with Wilmington Health Associates.

Q: What is your specialty?

A: Gastroenterology, sir.

Dr. Galusha: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever used alcohol to excess? A. No, sir

Q: Have you ever personally used narcotics or barbiturates? A. Never have

Q: Have you had any difficulty with boards of medical examiners? A. None at all

VERDICT: Dr. Lucien S. Wilkins approved for license by endorsement.

RE: Dr. James W. Walsh appeared applying for license by endorsement with incomplete credentials. He is a graduate of Northwestern University in 1972 and is a diplomate of the National Board.

Dr. Edmondson: Dr. Walsh is presently an intern at Memorial Hospital in Chapel Hill. You are aware of the credentials that are lacking?

A: Yes, I was told it was my picture--to come from my medical school.

Q: What do you plan to do with this license, Dr. Walsh?

A: I plan to be practicing here now in my training. I will be working at Prospect Hill in the clinic there.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you ever had any difficulty with boards of medical examiners? A. No

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever used barbiturates or narcotics personally? A. No, I have not

VERDICT: Dr. James W. Walsh approved for license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary.

RE: Dr. Susan Wolschina appeared applying for license by endorsement with incomplete credentials. She is a graduate of New York University in 1970 and is licensed in New York on the basis of National Boards.

Dr. Edmondson: You presently hold a resident's training license and are in Chapel Hill? What are you planning to do with a full license?

A: Yes, I'm planning to move over to Duke and be in Pediatric Allergy there.

Q: Have you ever been convicted of a crime? A. No

Q: Have you ever had any difficulty with medical licensing boards? A. No

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever used narcotics or barbiturates personally? A. No

VERDICT: Dr. Susan Wolschina approved for license by endorsement if and when her credentials are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Dr. Robert Paul McFarland appeared applying for license by endorsement of credentials with incomplete application. He is a graduate of Case Western Reserve University in 1962 and is licensed in Ohio by examination in 1962.

Dr. Edmondson: Dr. McFarland, what are your plans?

A: I am going to do Family Practice here in North Carolina and would like to begin practicing as soon as possible with a boys' camp just outside of Asheville.

Q: Have you ever been convicted of a crime? A. No, sir

Q: Have you had any problems with boards of medical examiners? A. No

Q: Have you ever used alcohol to excess? A. No

Q: Have you ever used barbiturates or narcotics personally? A. No

VERDICT: Dr. Robert Paul McFarland approved for license by endorsement if and when his credentials are completed satisfactory to the Executive Secretary. (credentials completed)

RE: Consumer Protection Division of the Department of Justice -- complaint reports.

Mr. Bryant Paris reviewed five reports of complaints received in the Board's office from the Consumer Protection Division from various citizens of the state in regard to physicians in North Carolina and their practice procedures.

The Board instructed Mr. Paris to contact the Consumer Protection Division, by phone and in writing, to advise that office that the Board of Medical Examiners feels these complaints, when received by the Consumer Protection Division, should be forwarded to the Grievance Committee of the various local, county medical societies.

RE: Hospital-Medical Coverage -- increase in employer contribution.

VERDICT: Dr. Hooper moved that this employer contribution for hospital-medical insurance coverage for the staff of the Board of Medical Examiners be approved. Seconded by Dr. Taylor and duly passed.

RE: June, 1974 Board meeting -- VERDICT: Dr. Hooper moved that Mr. Paris be given authority to locate a site for the June, 1974 Board meeting, including a location for administration of the examination. Seconded by Dr. Partrick and duly passed.

RE: Revision of applications forms for license by endorsement --

The Board discussed possible revisions to the present application form for License by Endorsement of Credentials in North Carolina. The President instructed the office staff to mail to each Board member prior to the August meeting a copy of the application form, as amended, for their review and additional suggestions, to be presented at the August meeting.

RE: License by endorsement -- applicants appearing with incomplete credentials

The Board discussed the appearance of applicants for their personal interview with the Board when they have incomplete or no credentials on file prior to their appearance.

VERDICT: Dr. Wilkerson moved that the Board not accept any applicants for personal interview without a completed application and certified photograph and graduation. General discussion by the Board followed this motion and a second motion was introduced: VERDICT: Dr. Hooper moved that no applicant be granted a personal interview without submitting at that time two photographs of himself. Seconded by Dr. Partrick. General discussion followed this motion. Addendum to motion: Applicant shall be told at the time he requests a personal appearance date before the Board that if his credentials are not complete, he must present the two photographs of himself, and if this is not done, this interview will not be considered as meeting the requirement for a personal interview before the Board and the applicant must make another appearance before the Board. Addendum accepted and motion voted on and duly passed.

RE: Interviews for license by endorsement -- Dr. Hooper moved that the entire Board endorse all of the completed applications of physicians appearing for personal interviews this date for license by endorsement and that the Board endorse all of those incomplete applications of physicians appearing for personal interviews this date for license by endorsement if and when their credentials are completed satisfactory to the Executive Secretary. Seconded by Dr. Wilkerson and duly passed.



RE: Dr. Frank Barr, Charlotte, N. C. -- The President reviewed the information on Dr. Barr's prescribing of certain medications for weight reduction and the Board's action at the May, 1973 meeting.

VERDICT: Dr. Edmondson moved that the President of the Board be granted authority by the Board to contact Dr. Frank Barr in person in regard to this situation and then report back to the Board on the results of his discussion with Dr. Barr. Seconded by Dr. Partrick and duly passed.

Wednesday, June 13
9:30 a.m.

RE: Bureau of Narcotics and Dangerous Drugs -- issuance of narcotic numbers to physicians in North Carolina. The Board discussed the system of issuing narcotic numbers to physicians in North Carolina and means of checking on physicians who have limited BNND privileges.

VERDICT: Dr. Hooper moved that a list of all physicians who have had, and still have, limited BNDD privileges be obtained from the Board's office records. Seconded by Dr. Taylor. Discussion followed this motion relating to the Board's responsibility and the Bureau of Narcotics' responsibility in regard to this problem. Following this discussion, the motion was voted on and passed unanimously.

RE: Foreign medical graduates in state institutions -- meeting with Mr. David Flaherty, Secretary, North Carolina Department of Human Resources. Following this meeting with Mr. Flaherty to discuss the physician shortage in North Carolina, and particularly in North Carolina state institutions, the Board discussed Mr. Flaherty's ideas and proposals.

VERDICT: Dr. Staub moved that candidates for full licensure in North Carolina in state mental hospitals be allowed to take the first two available examinations, with 70% as an acceptable grade to be made on the first examination, and the second examination must conform to the standards of FLEX acceptable for licensure in North Carolina, that is 75%. Seconded by Dr. Hooper and duly passed.

VERDICT: Dr. Hooper moved that this Board advise Mr. Flaherty what this Board's standards are for licensure and to enable him to secure graduate physicians who meet those standards, the Board shall send him a list of the top ten foreign medical schools whose graduates have met those standards during the past five years most successfully and would encourage any program by the Department of Human Resources that would be beneficial to the delivery of medical care in this state. Seconded by Dr. Wilkerson and duly passed.

RE: Dr. Thomas O. Wheless, Louisburg, N. C. -- appeared for a routine interview. Dr. Wheless advised that he was doing well and was having no personal problems. A few problems existed in his practice as the result of his not being able to write prescriptions for hard narcotics. He stated he has taken no drugs since his last appearance before the Board, even none since 1966. Dr. Wheless stated he felt if the Board felt he were eligible for reinstatement of his narcotic privileges, they would so advise him.

VERDICT: Dr. Edmondson moved that the Board advise Dr. Wheless they are proud of the way he has conducted himself since his last encounter with drugs and it is better now to pursue the same course of action rather than to reinstate his full narcotic privileges. Seconded by Dr. Hooper, duly passed and Dr. Wheless so advised. Dr. Wheless is to be seen again before the Board in one year.

RE: Dr. James Richard Hughes, Raleigh, N. C. -- appeared for a routine interview. Dr. Hughes stated he was doing very well and feeling very well, physically. He advised he has no personal problems nor any problems with alcohol or drugs. He said he does not feel threatened in any way by drugs now, but would continue to avoid getting involved with them in any way whatsoever, as he is now enjoying living too much, in addition to enjoying his work.

VERDICT: The Board advised Dr. Hughes they were pleased to see him looking so well and were glad he was doing well in his work and personal life. Dr. Hughes is to be seen in December, 1973.



RE: Dr. William M. Bethune, Jr., Goldsboro, N. C. -- appeared for a routine interview. Dr. Bethune stated he had made a study of himself and his personality and believed that he was depressive, but he had now learned to live with it and how to handle it, by placing himself in the care of a physician and not resorting to drugs and alcohol. He has been traveling out of the country with the Department of Justice, talking with law enforcement groups, and has been offered a position as Psychiatric Director with the Duplin County Mental Health Center and is seriously considering it. He now does some private practice and counseling at Seymour Johnson Air Force Base in addition to his work out of the country. He is on no medication except Lithium. He tries to avoid emotional highs and lows and believes depression is a very real disease. He stated he was treated for depression in the hospital in April, 1973 and while there was on Stelazine and Mellaril.

VERDICT: The Board commended Dr. Bethune for his progress and advised him they would like to talk with him in about six months. (December, 1973)

RE: Dr. Lonnie Marcus Little, Statesville, N. C. -- appeared at request of the Board following a report received from the North Carolina Board of Pharmacy that he appeared to be prescribing large amounts of amphetamines, many of the prescriptions being picked up by young people who did not appear to have a weight problem, and many of the people having out of town addresses. Dr. Little stated he had never prescribed any amphetamine-type drug for anyone who was not overweight. He stated he did not feel the number of prescriptions written as compared with the number patients seen was "very much out of line." Dr. Little said he never prescribed any of these drugs without a physical examination, but he admitted that possibly he maintained patients too long on these drugs, in that possibly he was too easily swayed by his patients. Dr. Little also admitted that possibly he had not paid enough attention to the new information on the dangers of amphetamine usage. He advised that the first of June he had placed a sign in his office, "No Diet Pills" and since that time has not written any prescriptions for same (since receiving the request to appear before the Board) and stated he did not dispense any of these drugs in his office.

VERDICT: Dr. Little was told that this Board is very concerned with this problem, particularly when young people are involved and that despite the fact of how many patients he saw, he was prescribing many more of these amphetamines than most physicians. The Board advised that they were pleased he had abandoned the use of these drugs and would take his word as to what he plans to do in this regard. He was told that he would still be closely watched and if things appeared to be out of line again, he would be recalled before the Board, with possibly more stringent action being taken.

RE: Dr. Bennie Brooks Ward, Shallote, N. C. -- Dr. Ward was requested to appear before the Board following receipt of information by Board member that he might be having some trouble with drugs again. Dr. Ward advised that this was not true, that he was well and very busy. He stated he has used no drugs and has had no illnesses, except for high cholesterol. Dr. Ward said he had been hospitalized at Wake Memorial Hospital for depression by Dr. Harper and was on some medication in the hospital for about four days, but this depression was not the result of drugs, although he had been drinking some. He advised that when he felt depressed or had a problem, he was seeking consultation for it, but he did not feel he had any serious problems.

VERDICT: Dr. Ward was advised that the Board was glad the information received in relation to his having some trouble with drugs was wrong. They wanted him to realize that the Board wanted to help him with any problems he might have and to please let the Board know if he had any problems. Dr. Ward was instructed to have Dr. Harper furnish the Board a report of his stay at Wake Memorial Hospital in Raleigh and was further admonished not to let alcohol cause him any problems.

RE: Dr. Matthew A. J. Stroup, Gastonia, N. C. -- Dr. Stroup appeared at the request of the Board following receipt of report from the North Carolina Board of Pharmacy that Dr. Stroup was prescribing a large amount of amphetamines, 232 prescriptions for 9,632 units during a two month, 10 day period. Dr. Stroup advised that about one third of his practice was with overweight patients and these drugs were used for them, until they were no longer available. He advised he had taken Desbutal, one or two, ever so often, since 1952, following severe dizzy and weak spells. He stated the reason for prescribing for large numbers of these drugs at the time was when he found out the drug would be taken off the market, he was trying to build up a supply so he could gradually get off the drugs himself. He also said he had prescribed dexamyl and desbutal for

purposes other than weight loss, such as "feeling tired and feeling run-down generally", for some of his patients. He said he had not considered these drugs as dangerous until the last couple of months when he realized they were being taken off the market. He stated he did not feel he was addicted to amphetamines himself and was not dependent on these drugs and did not feel he had gotten any patients dependent on them. Dr. Stroup said he does not feel amphetamines are a habituating drug--he has stopped at times and can stop any time. He said he has diabetic neuropathy of the feet and he becomes very tired and would have these drugs on hand if needed.

Dr. Stroup said he does have an in-hospital practice, works about two hours in the office at a time and then has to rest and returns to the office in the afternoon and at night. His practice is Internal Medicine. He said his taking Desbutal was no problem as he can do without it when he has to, as there is none available now. He stated he is not giving these drugs as mood elevators now.

VERDICT: Dr. Stroup was advised that the Board was extremely worried at his laissez-faire attitude toward this type of drug and felt that possibly he does not know the dangers of this type of drug. He was told that he would be monitored very closely and if any drugs were prescribed that were even related to amphetamines, more punitive action would have to be taken. The Secretary advised Dr. Stroup that the Board was concerned that a physician would encourage people in the use of amphetamines for mood elevators and that he should not even look for non-controlled drugs for this type of use. He was told that he may be called back before the Board. He was advised to review the BNDD schedule and possibly check with a reliable pharmacy or the Board of Pharmacy or a BNDD agent as to drug classification for his own benefit as well as that of his patients.

The Executive Secretary was instructed to request the Board of Pharmacy to carry out a prescription check on Dr. Stroup for a two-month period beginning July 1, 1973 through August 31, 1973 and report at the October Board meeting on the results of same.

RE: Dr. Henry Oldham Williams, Durham, N. C. -- appeared for a routine interview. Dr. Williams stated that, personally and professionally, things were going quite well for him. He stated his family life was going well now and that he would not have planned a family if he had not expected his life to continue that way. He advised he has now settled on radiation therapy for his practice and has one more year of training. Dr. Williams said he has no doubts about the future with the exception of concern over what effect his record with drugs in North Carolina would have on his future practice of medicine in other states. He has used no drugs and has had no occasion or desire to do so, and has had no problem, ever, with alcohol. He has been appointed Chief Resident and is assuming more responsibilities in his department and advised that at times, his inability to write prescriptions for narcotics has caused him some embarrassment and problems, although full narcotic privileges are not absolutely necessary in his work. He advised the Board that he would never again write a prescription for narcotics for himself and would never take any drugs--narcotics--again. He stated he sees his psychiatrist infrequently now, about every few months, and the visits are routine.

VERDICT: Dr. Taylor moved that Dr. Henry O. Williams' BNDD privileges be reinstated and he be given the privilege of re-applying for same and should be seen again before the Board in six months. At that time, Dr. Cavanaugh is to be requested to let the Board have a report on Dr. Williams and his progress and Dr. Cavanaugh is to be advised the action taken by this Board. Seconded by Dr. Staub and duly passed.

Dr. Williams was advised of this action and instructed Dr. Williams to continue his psychiatric therapy as he and his physician felt necessary and he should plan to return before the Board every six months for the next three periods.

RE: Dr. J. R. Medlin, Jr., Garner, N. C. -- appeared at request of Board following information received as to Dr. Medlin's possible involvement with drugs again, particularly Talwin. Dr. Medlin advised that he had had many family problems with his brother and his family and had found himself caught in the middle. He stated his brother had straightened himself out in regard to his problems, and that since then, his (Dr. J.R.) life had improved and he is no longer having tension and depression. He stated he had taken Talwin during





this period, writing prescriptions for himself, at night or on week-ends, for eight or nine months, by mouth and injection. He stated he is only taking Elavil now, 100 mg. at night, and is seeing his psychiatrist now regularly. Dr. Medlin said he feels now that all of his problems have been resolved and since his brother's problems have straightened out, things are going much better in general.

VERDICT: The Board informed Dr. Medlin that they were extremely disappointed that he had had no trouble for eight years and had again subjected himself to drugs. He was warned that if this happens again, more punitive action might have to be taken. He was instructed to plan to appear before the Board at every meeting until advised otherwise.

The Executive Secretary was instructed to request Dr. Medlin to have his psychiatrist mail a report of his progress to the Board.

There being no further old or new business for discussion, Dr. Edmondson moved that the meeting be adjourned. Seconded by Dr. Staub and duly passed.
