

MEETING OF THE BOARD OF MEDICAL EXAMINERS  
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 13-17th, 1965

- - - - -

The Board of Medical Examiners of the State of North Carolina met at the Sir Walter Hotel, Raleigh, North Carolina, for the purpose of giving the annual written examination, interviewing applicants for license by endorsement of credentials and special limited license, and other business.

Sunday, June 13th  
2:30 P. M.

The Board convened for business and Drs. H. Lee Large, Jr., President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, Frank Edmondson, W. Boyd Owen, Ralph G. Templeton, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present. Dr. Clark Rodman was not able to be present. (He was present for all sessions beginning June 14th.)

RE: Dr. Alejandro V. Gatmaitan appeared petitioning for the privilege of taking the written examination. He was graduated by the University of the Philippines in 1944.

Dr. Templeton: Did you do your internship in the Philippines?

A. Yes

Q. When did you first come to the states?

A. 1948 - I am at present engaged in laboratory and research work at the North Carolina Sanatorium.

His present immigrant card and photograph was compared.

Dr. Large: What are your plans?

A. I plan to work in an institution like McCain for awhile. I am interested in chest diseases and tuberculosis.

Dr. Owen: Do you think you will want to stay in an institution?

A. I believe so for a few years.

Dr. Combs: What was your original interest in North Carolina?

A. I did my training at James Walker, Wilmington, and met my wife, we got married, stayed in the Philippines 10 years. Because of my wife and children we decided to come here and my wife wanted to be with her mother who is ill. My wife is from Pollocksville.

Dr. Edmondson: What type of work did you do in the Philippines?

A. General practice

Dr. Large: If you are permitted to take the examination, your license will be geographically limited to the county in which you are practicing at that time, and if you wish to move, you would have to get in touch with the Board and ask for extension of license to that area. If within six years you achieve full citizenship, you may apply for full license, provided you are living in North Carolina at that time.

Dr. Combs: You probably plan to stay in North Carolina?

A. Practically indefinitely. I hope it won't happen, but if I am unfortunate enough to not pass, I hope I can keep my job.

Q. What are you doing now?

A. I am in laboratory research.



Dr. Gatmaitan continued

Dr. Combs: You are not practicing medicine?

A. No sir

Q. The Board would have no control if you are not practicing medicine.

VERDICT: Dr. James E. Davis moved that Dr. Alejandro V. Gatmaitan be granted permission to take the written examination, license to be limited geographically until citizenship obtained. This motion was duly seconded and passed unanimously.

RE: Dr. Elizabeth Pascher Kanof was granted special limited license to Duke University School of Medicine in 1963 to cover her in residency training. She is now applying for license by endorsement of credentials from the New York Board of Medical Examiners and plans to practice Dermatology in Raleigh. Her grades in the basic science subjects do not meet the requirements of the Board of Medical Examiners and she was requested to appear at this time.

Dr. Edmondson: You have finished your residency in Dermatology?

A. Yes

Q. You are board eligible?

A. Yes, I took the written examination last Monday.

Q. Were you aware of your grades on the National Board examination?

A. Yes, for National the passing was 70. I had the certificate giving the grades.

Dr. Large: Have you ever been accused of a crime? A. No sir

Q. Have you ever had any difficulty with alcohol, barbiturates, narcotics? A. No sir

Q. Have you ever had any difficulty with an examining board in medicine? A. No sir

VERDICT: Dr. Joseph J. Combs moved that Dr. Elizabeth Pascher Kanof be given the privilege of taking the examination of this Board in either one or both of the subjects in which she was deficient on the National Board examination. This motion was duly seconded and passed unanimously. (See page 59 these Minutes)

RE: Dr. Ramon V. Canent, graduate of the University of Santo Tomas, Philippines, 1957, appeared applying for the privilege of taking the written examination. He presented immigrant visa and photograph was compared. He stated that he planned to go on the staff at Duke if he passed the examination.

Dr. Large: If you receive license, you should understand that it will be limited geographically for six years, and at that time the Board would expect that you had become a citizen and you should write the Board and request full licensure, provided you are living in the state.

A. If I am permitted to have this license in Durham County, this would allow me to see private patients?

Dr. Davis: Just so you did not leave the confines of Durham County.

Dr. Combs: If you decided you wanted to move, we would change the limitation.

VERDICT: Dr. James E. Davis moved that Dr. Ramon V. Canent be approved to take the written examination, license to be limited geographically until citizenship obtained. This motion was duly seconded by Dr. Ralph G. Templeton and passed unanimously.

The Board of Medical Examiners reviewed the credentials for license by endorsement of credentials and special limited license.

RE: Dr. Ralph C. Reid, Pineville, North Carolina - The chairman of the Committee of the North Carolina State Medical Society to work with the North Carolina Industrial Commission, furnished copy of minutes with regard to the handling of four cases by Dr. Reid, following an interview with him by his committee. He stated it was felt by the committee that this matter should be presented both to the Grievance Committee of the Medical Society and the Board of Medical Examiners.

VERDICT: Dr. W. Boyd Owen moved that Dr. Ralph C. Reid be requested to appear before the Board of Medical Examiners at the July, 1965 meeting of the Board; that he be requested to bring the same films referred to and any other pertinent information. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.



RE: Dr. Charles Warren Williams - (See Minutes May, 1965) VERDICT: Dr. James E. Davis moved that instead of obtaining information from the district councilor of the State Medical Society, that Dr. H. Lee Large, Jr. be asked to obtain information on Dr. Williams periodically.

RE: National Board of Medical Examiners- At the May, 1965 meeting of the North Carolina Board of Medical Examiners, the Medical Practice Act was reviewed and it was decided th at the discretion of the Board of Medical Examiners, the license of another may be recognized for endorsement, even though it was obtained on the basis of examination given by the National Board of Medical Examiners.

RE: Narcotic Program for Written Examination- Dr James E. Davis moved that the program be continued for narcotic speech and film, which is to be left up to Dr. H. Lee Large, Jr. This motion was duly seconded and passed unanimously.

RE: Dr. Alton Lane Bullard - See Minutes May, 1965) - The secretary reported that Dr. Bullard's license certificate to practice medicine was forwarded to the office of the secretary with a letter stating that he was voluntarily surrendering the same. The secretary also presented letter from Dr. Bullard dated June 5th, 1965, stating that he was admitted to John Umstead Hospital on May 6th, 1965 and discharged on June 4th, 1965; that he would appreciate a hearing or whatever procedure necessary for the return of license at whatever time it could be arranged.

VERDICT: Dr. James E. Davis moved that Dr. Alton Lane Bullard's letter be received as information and that the Board not interview Dr. Bullard to consideration reinstatement of his license to practice medicine prior to June, 1966. This motion was duly seconded and passed unanimously.

The meeting was adjourned.

Monday, June 14th

Registration of applications for Part I and Parts I and II of the written examination, following which the examination was begun.

RE: Dr. Richard Paul Hancock appeared in May, 1965, applying for license by endorsement of credentials. He was approved for special limited license to cover him as a resident until he could furnish further information with regard to difficulty in which he became involved while an undergraduate student. Judge Lee Garrett of the Superior Court of Pima County, Tucson, Arizona, wrote a letter confirming information given by Dr. Hancock with regard to charges, court trial, and probation. He stated that he made a mistake; that he had kept in close touch him during the probation period, in person, and through the Probation Department; that he became an exceptional student and was never in any further trouble of any kind and completed his probationary period without faltering. He commended Dr. Hancock very highly.

Dr. Large: Are you now in active residency training at Bowman Gray?

A. Yes, Baptist Hospital in Surgery

Q. How long?

A. Resident General Surgery and one more year after that for the thoracic program.

Q. Your ultimate plans?

A. My wife is from Newton and we had thought of going somewhere near there.

VERDICT: Dr. Frank Edmondson moved that Dr. Richard Paul Hancock be approved for license by endorsement of credentials.

RE: Dr. James R. Ballew appeared following the request of the Board of Medical Examiners pursuant to report being received that he had taken an overdose of medication following difficulty with law enforcement officers and admission to hospital and subsequently to Dorothea Dix Hospital.

The secretary presented reports from Dorothea Dix Hospital, North Carolina Memorial Hospital about an admission in 1963 requested following peculiar behavior at Rex Hospital, and report from Dr. Ballew's psychiatrist dated June 11th, 1965.



Dr. Ballew continued

The concensus in all reports was that Dr. Ballew was injured several years ago; that most of his difficulty is associated with brain trauma as a result of that injury, which makes him sensitive to the use of alcohol and drugs; that he has episodes of grand mal seizures, which are controlled with anti-convulsants.

Dr. Ballew was questioned by the Board as to recent and past difficulties and he said it was necessary that he take a drug following his injury which controlled his blackouts; that he could not drink distilled alcohol, which was the cause of the episode that occurred recently; that he understood fully that he could not take distilled alcohol and would not do so again. He was admonished by the Board for this conduct and strongly urged to continue on his treatment and see his psychiatrist when indicated and was advised that the Board could not allow such action repeated as it was responsible to the citizens of this state.

Dr. Ballew is to remain under surveillance and be seen in one year.

RE: Dr. Fountain Stewart Clare III appeared petitioning for conversion of limited to full license. He has completed his third year of residency training in Pathology at the University of North Carolina School of Medicine and will begin the fourth year July 1st, 1965. He stated he wishes to work in Wilson doing Pathology during his vacation; that he had no other area in mind for such work as he could not be away from the hospital except during this vacation. Dr. Clare's wife is a native of North Carolina and he said they planned to remain in the state after he completed his training.

VERDICT: Dr. James E. Davis moved that the medical license of Dr. Foutain Stewart Clare III be converted to full license if he furnished letter from his chief of service at the University of North Carolina School of Medicine that his residency has been satisfactory and that he expects to continue another year. This motion was duly seconded and passed unanimously. (Requirements met)

The meeting was adjourned.

RE: Dr. J. R. Medlin - (See previous Minutes)- Dr. Medlin appeared for a routine interview at the request of the Board. He stated he had been doing well personally and busy in his practice. His psychiatrist gave a good report on him.

RE: Dr. Harry Kerrick Daugherty was granted license by endorsement, limited to Charlotte Memorial Hospital in 1963, to cover him as a resident. He is to join Drs. Sanger and Robicsek, Charlotte, July 1st, 1965, in the practice of Thoracic Surgery and has applied for conversion of limited to full license. He has met the requirements of the Board.

VERDICT: Dr. James E. Davis moved that the limited license of Dr. Harry Kerrick Daugherty be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Martha Ann Mahanes Claxton was granted license limited to Watts Hospital in 1963, to cover her as a resident. She has been appointed to the staff at Murdoch Center beginning July 1st, 1965, and has applied for conversion of limited to full license. She has met the requirements of the Board of Medical Examiners.

VERDICT: Dr. James E. Davis moved that the limited license of Dr. Martha Ann Mahanes Claxton be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Joseph Walter Stiefel was granted license limited to Duke University School of Medicine in 1960, to cover him as a resident. He has been appointed to the senior staff at Duke University School of Medicine beginning July 1st, 1965, and has applied for conversion of limited to full license. He has met the requirements of the Board of Medical Examiners.

VERDICT: Dr. James E. Davis moved that the limited license of Dr. Joseph Walter Stiefel be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Richard Dennis Hill was granted license limited geographically in June, 1959 until citizenship obtained. He has presented evidence of naturalization and applied for conversikn of limited to full license.

VERDICT: Dr. Frank Edmondson moved that the limited license of Dr. Richard Dennis Hill be converted to full license. This motion was duly seconded and passed unanimously.



RE: Dr. Armando de Moya was granted license limited geographically in June, 1960 until citizenship obtained. He presented evidence of citizenship. Dr. de Moya's petition for full license was not granted at the meeting of the Board in May, 1965 due to the fact that he was practicing outside of the state. However, it was called to the attention of the Board, at this time, that he is a graduate of a North Carolina medical school and the Board reconsidered its decision.

VERDICT: Dr. Frank Edmondson moved that Dr. Armando de Moya's limited license be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. Tong Su Kim was granted special limited license in June, 1964 to the Western Carolina Center until he could take the written examination in 1965. He has not received immigration visa and is, therefore, not eligible to take the 1965 examination. Information was presented from the Immigration and Naturalization Service as of May 12th, 1965, that Dr. Kim was assured of attaining immigrant status on or about July 1st, 1965.

VERDICT: Dr. Ralph G. Templeton moved that the special limited license of Dr. Tong Su Kim be extended until he can take the written examination in 1966, provided, he obtains immigration visa by June, 1966. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

A. Residency in Surgery at Meharry, in the Army two years.

Q. Where will you locate?

A. Winston-Salem

Q. When do you plan to go to Winston-Salem?

A. To-day

Q. Did you bring your discharge?

A. I was separated and it will be six months before I am discharged. He presented release from active duty.

Dr. Combs: it is not the policy of the Board to grant license for locum tenens.
