

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 16-20th, 1963

- - - -

The Board of Medical Examiners of the State of North Carolina met at the Sir Walter Hotel, Raleigh, North Carolina, for the purpose of giving the annual written examination, interviewing applicants for license by endorsement of credentials and special limited license, and other business.

Sunday, June 16th
2:00 P. M.

Dr. H. Lee Large, Jr. met with the representative from Winthrop Chemical Company for a preview of two narcotic films and selected one to show to the examinees.

3:00 P. M.

The Board convened and Drs. Frank Edmondson, President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, H. Lee Large, Jr., W. Boyd Owen and Clark Rodman were present. Dr. Ralph G. Templeton was detained and came in later in the afternoon.

The following physicians appeared petitioning to take the written examination:

RE: Dr. Hans J. Peters, graduate of the Free University of Berlin, Germany, in 1953, now in the Department of Pathology at the Medical College of Georgia.

- Dr. Combs: We want to know what your plans are as to North Carolina. I believe you stated you had some contact with Charlottte Memorial Hospital. Have you come to an agreement?
- A. No, the contract originally offered to me I have turned down because of certain contractual terms. I have submitted an alternative, which I do not know.
- Dr. Combs: If you do not go to Charlotte Memorial are you still interested in North Carolina?
- A. I am interested in the City of Charlotte. I think it is a very nice city to live.
- Q. When were you at Duke?
- A. 1955, six months.
- Dr. Edmondson: Have you made any other contact in North Carolina?
- A. No sir, I have made no contact. This was an offer and I have not made any other contact.
- Q. In what states do you have license?
- A. South Carolina, Georgia, Florida, Maine examination, in South Carolina, Florida, Maine.
- Dr. Large: When would you like to go to Charlotte if it works out?
- A. Originally we had discussed the first of August. Of course, this



Dr. Peters continued: this might be postponed for quite sometime as I have certain contractual relations which I can not break on that short notice. It might have to be the first of the year or later.

Q. How much time do you have to give?

A. Usually the contract runs from year to year. I am in a little bit of a bind. I would have to stay on for a while.

Dr. Edmonson: What position do you hold?

A. As of this coming July 1st I will be an associate professor of Pathology.

Q. Do you do any teaching?

A. Yes

Dr. Combs: You are a naturalized citizen?

A. Yes. Dr. Peters presented naturalization paper #7926485, dated April 7th, 1959. His photograph compared with that on his passport.

Q. If you do^{not}/go to Charlotte, would you be interested to move into North Carolina to practice Pathology?

A. I would say yes.

Dr. Edmondson: Have you ever had any difficulty with excessive use of alcohol, or use of barbiturates or narcotics? A. No sir

Q. Have you ever had been convicted of any crime? A. No sir

Q. Have you ever had any difficulty with any examining board? A. No sir

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Hans J. Peters be granted the privilege of taking the written examination. This motion was duly seconded and passed unanimously.

RE: Dr. Theodore Ferdinand Hahn, Jr., graduate of Yale School of Medicine in 1931, of Deland, Florida.

Dr. Combs: How long have you owned property in Haywood County?

A. Five or six years.

Dr. Edmondson: What type of practice do you contemplate doing?

A. I was coming up to a limited practice around Cove Creek, but Dr. Higgins has offered me work in public health in the Yancey-Mitchell area, they need a director. So far as I know there has been no change in the plans, if I can pass the examination, he will offer me the position.

Q. What type of practice have you done in Florida?

A. Internal medicine for the last thirty-five years. For the 10 years I knew Dr. Higgins I did tuberculosis and venereal diseases with the Board of Health.

Dr. Owen: Did you build a house?

A. Yes, on 284 going to Cove Creek Gap.

Q. Is that land registered in your name?

A. It has a tobacco allotment, I pay half the taxes, taxes on the house, him on the land.

Dr. Edmondson: Have you had any difficulty with any examining board since you have been in practice? A. No sir

Q. Have you ever been convicted of a crime? A. No sir

Q. Have you ever had any difficulty with excessive use of alcohol, narcotics or barbiturates? A. No sir

Dr. Edmondson: Is it your intention to move to North Carolina and practice the year round or practice in the summertime and go back to Florida?

A. No sir, I have sold my home, my office, my equipment and am moving my furniture next week, even if I sit in the mountains and do nothing but write.

VERDICT: Dr. Joseph J. Combs moved that Dr. Theodore Ferdinand Hahn, Jr. be granted the privilege of taking the written examination. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.

RE: Dr. James Joseph Rascher appeared requesting the privilege of taking the written examination before completing all the requirements of the Board of Medical Examiners with regard to credentials. Dr. Rascher stated that he wished to locate in Franklinton with another physician, who is a licentiate of this Board.

Dr. Combs: Dr. Rascher wrote to apply to take the written examination after the deadline for applying, at which time it was too late to get credentials in. I was advised by a physician in Louisburg that he desired to go to practice in Franklinton this summer. Therefore, Dr. Rascher was requested to appear at this time to petition to take the examination without credentials, with the understanding that if he takes and passes the same, that all requirements would be met.

Q. You are interning where?

A. St. Elizabeth Hospital, Youngstown, Ohio.

Q. Have you been to Franklinton?

A. No, I have not.

Q. What doctors do they have there?

A. There is one I understand who does not do much. I understand they have built a clinic, which is not in use.

Dr. Edmondson: Are you planning to use the clinic?

A. No

Q. What hospital will you be affiliated with?

A. Louisburg, 10 miles.

Dr. Rodman: What prompted you to consider Franklinton?

A. Dr. Tyree, who went to Bowman Gray. He wanted me to go to a small town, preferably in North Carolina. He liked what he saw in Franklinton. I came into the picture when they told him they could use a second man and I was looking for something like that and enjoyed working with him in the hospital.

VERDICT: Dr. Clark Rodman moved that Dr. James Joseph Rascher be approved for written examination and that his grades will not be certified if all credentials are not completed. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Written Examination- Charles Thomas McLees and Donald Drake McNeill, Jr.

The secretary presented letter from Dr. W. R. Berryhill, Dean of the University of North Carolina School of Medicine stating that the above captioned students were candidates for Part I of this written examination; that their promotion to the third year is being delayed pending additional work; since that neither of the subjects requiring additional work are included in Part I of this examination, that these two students be permitted to take Part I and that notification of the results be delayed until their promotion to the third year.

VERDICT: Dr. H. Lee Large, Jr. moved that Charles Thomas McLees and Donald Drake McNeill, Jr. be permitted to take Part I of the written examination and that they be notified of the results of the examination upon notification from the University of North Carolina School of Medicine. that they have been promoted to the third year. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.

The members of the Board reviewed credentials for license by endorsement of credentials and special limited license.

The meeting was adjourned.

Monday, June 17th

8:30 A. M.

Applicants for Part I and Parts I and II of the written examination were registered.

10 A. M. - RE: Dr. Franklin S. Kincheloe, Jr., Selma, North Carolina -

Dr. Kincheloe appeared with his attorney, W. I. Godwin, Esquire, of Selma.

John H. Anderson, Esquire, representing the Board, read the following charges made against Dr. Kincheloe by the Board of Medical Examiners under date of May 11th, 1963:

" RE: FRANKLIN S. KINCHELOE, JR., M. D. -CHARGES AND ACCUSATIONS

" TO: FRANKLIN S. KINCHELOE, JR. M. D.

"You are hereby notified that the following charges have been and are preferred against you by the Board of Medical Examiners of the State of North Carolina, to-wit:

"1. That on December 29, 1962 you did perform a surgical procedure upon Mrs. Dorreen Willoct Hendrickson for the purpose of interrupting a pregnancy and causing an abortion and that by means of said surgical procedure you did interrupt a pregnancy and brought about an abortion without first determining that such procedure was necessary to save the life of Mrs. Hendrickson or that the same was necessary to safeguard her health or for any other proper medical reason, all in violation of law and of the ethics of your profession.

"2. That on December 29, 1962 you undertook to perform a surgical procedure upon Mrs. Dorreen Willoct Hendrickson at night in your office without the presence of any medical or nurse assistant, during the course of which you administered to her sodium pentothal, perforated the uterus, penetrated the peritoneal cavity and engaged in elective procedures which should not have been performed in your office and under such circumstances, and that you did engage in such procedures and attempt to perform the same under the same circumstances which indicated a heedless disregard of the safety of your patient and of sound medical and surgical judgment, and an indifference to the standards of conduct of your profession.

"That in the above respects you have been guilty of unprofessional and dishonorable conduct unworthy of and affecting your profession, and grounds exist for the revocation of your license to practice medicine.

"You are further notified that a hearing will be held concerning the foregoing charges and accusations before the Board of Medical Examiners at its regular meeting at the Sir Walter Hotel, Raleigh, North Carolina, on the 17th day of June, 1963, at 10:00 A. M. o'clock, at which time you will be given an opportunity to cross-examine any witnesses who may be pre-



Dr. Kincheloe continued:

"sented, personally or through your counsel, and to present evidence on your behalf, and that in the meantime you will be privileged to make a written reply to the foregoing charges, although you are not required to do so.

"By order of the Board of Medical Examiners of the State of North Carolina.

" This 11th day of May, 1963.

No answer was filed with the Board by the defendant.

Dr. Edmondson: Do you wish to make any reply relative to these charges?

Mr. Godwin: Dr. Kincheloe will attempt to answer any question and explain the accusations that are made against him and denies that is guilty of the allegations.

Mr. Anderson: I will present the witness:

Dr. Frank Edward Barnes, Jr. of Smithfield, North Carolina, witness for the Board of Medical Examiners, was duly sworn, and testified with regard to the patient referred to in the charges.

Dr. Kincheloe was duly sworn, testified, and was cross-examined by members of the Board.

After discussion and consideration of the evidence and testimony, the Board in executive session, rendered the following verdict and decision:

Dr. W. Boyd Owen moved that action on Charge 1 of the Charges and Accusations with regard to Dr. Franklin S. Kincheloe, Jr. be deferred. This motion was duly seconded by Dr. Clark Rodman and passed unanimously.

Dr. James E. Davis moved that the Board of Medical Examiners find Dr. Franklin S. Kincheloe, Jr. guilty of Charge 2 of the Charges and Accusations as stated. This motion was duly seconded by Dr. H. Lee Large, Jr. and passed unanimously.

Dr. James E. Davis moved that Dr. Franklin S. Kincheloe, Jr. be found guilty of unprofessional and dishonorable conduct, unworthy of and affecting his profession in his treatment of and in the performance of the medical and surgical procedures upon and in his care of Mrs. Dorreen Willoct Hendrickson and as charged and that an order be entered revoking his license to practice medicine in the State of North Carolina accordingly. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

The meeting was adjourned.



Tuesday, June 18th

Applicants for license by endorsement were interviewed as follows:

RE: Dr. David R. Beckham, Jr. appeared applying for license by endorsement of credentials, limited to Bowman Gray School of Medicine, where he is a resident in Anesthesiology.

Dr. Edmondson: Do you anticipate practicing in North Carolina?

A. I may eventually.

Q. Have you ever had any difficulty with any examining board?

A. No sir

Q. Have you ever used alcohol, barbiturates or narcotics excessively?

A. No sir

Q. Have you ever been convicted of a crime? A. No sir

VERDICT: Dr. David R. Beckham, Jr. was approved for license by endorsement of credentials, limited to Bowman Gray School of Medicine.

RE: Dr. James N. Blackerby appeared applying for license by endorsement of credentials. He is a diplomate of the American Board of Surgery.

Dr. Edmondson: When does your service terminate?

A. The 30th of this month.

Q. Will this constitute all of your service?

A. I nope so.

Q. Where are you contemplating locating in North Carolina?

A. New Bern

Dr. Davis: Are you going with Simmons Patterson?

A. Yes

Q. When you receive your Army discharge, it will be necessary for you to furnish your office with a photostatic copy.

Q. Have you ever had any difficulty with any examining board?

A. No, I have not.

Q. Have you ever used alcohol, narcotic drugs or barbiturates to excess? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. James N. Blackerby was approved for license by endorsement of credentials.

RE: Dr. Teddy Fuqua Burton appeared applying for license by endorsement of credentials.

Dr. Edmondson: Where is your home?

A. Vinton, Virginia

Q. Where are you now?

A. Still in Richmond at the Medical College.

Q. Where do you contemplate locating in North Carolina?

A. New Bern

Q. What type of work will you do?

A. Obstetrics and Gynecology

Dr. Burton continued:

Dr. Edmondson: What formal training have you had in Obstetrics and Gynecology?

A. I will finish my residency at Medical College at the end of this month, a three year program.

Q. You will be eligible for your boards?

A. Yes

Q. Are you going in with a group or on your own?

A. I am going in practice with Dr. R. C. Houghton.

Q. When will you complete your work?

A. At the end of this month.

Q. And you contemplate going to New Bern right away?

A. Yes

Q. Have you ever had any difficulty with any examining board?

A. No, I have never applied anywhere else.

Q. Have you ever used alcohol excessively? A. No

Q. Have you ever used narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. Teddy Fuqua Burton was approved for license by endorsement of credentials.

RE: Dr. James Lidell Elmore, Jr. appeared with incomplete credentials applying for license by endorsement of credentials, limited to Duke University School of Medicine, where he is a resident in Psychiatry.

Dr. Edmondson: Where are you now?

A. Presently at the Veterans Administration Hospital, associated at Duke in first year of Psychiatry residency.

Q. What do you contemplate doing this coming year?

A. Continuation of my residency, first and second years.

Q. How long?

A. A total of three years.

Q. Do you contemplate practicing in North Carolina?

A. I have not decided at this time.

Q. Have you ever had any difficulty with any examining board? A. No sir

Q. Have you ever used alcohol to excess? A. No sir

Q. Have you ever used narcotic drugs or barbiturates? A. No sir

Q. Have you ever been convicted of a crime? A. No sir

VERDICT: Dr. James Lidell Elmore, Jr. was approved for license by endorsement of credentials, limited to Duke University School of Medicine, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Orion Townsend Finklea appeared applying for license by endorsement of credentials. He stated that he planned to go to Charlotte to join the Hawes Urology Clinic.

Dr. Edmondson: Where are you now?

A. Iowa City, I finish my residency this month.

Q. When do you contemplate coming to North Carolina?

A. About the middle of July if everything is in order.

Dr. Finklea continued:

Dr. Edmondson: Have you ever used alcohol to excess? A. No sir

Q. Have you ever used narcotic drugs or barbiturates? A. No sir

Q. Have you ever had any difficulty with any examining board? A. No sir

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. Orion Townsend Finklea was approved for license by endorsement of credentials.

RE: Dr. R. John Hallberg appeared applying for license by endorsement of credentials:

Dr. Large: What have you done since medical school?

A. Internship one year at St. Luke, residency, Air Force, five years at Stockbridge, Massachusetts, to the present. I took some training in Psychiatry and worked on the staff at Austin Reeves Center.

Q. Where are you now?

A. In Chapel Hill. I have been offered a position there at the University in the Department of Psychiatry.

Q. Are you going to be on the teaching staff?

A. Yes sir

Q. When do your duties commence?

A. Well it depends on the action of this Board. I am sort of waiting around to begin work with patients, meanwhile have supervised students and residents.

Dr. Edmondson: You have moved to Chapel Hill?

A. Yes

Q. Have you ever used alcohol to excess or narcotic drugs or barbiturates? A. No

Q. Have you ever had any trouble with any examining board? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. R. John Hallberg was approved for license by endorsement of credentials.

RE: Dr. Clifford Bruce Harden, appeared with incomplete credentials applying for license by endorsement of credentials. Dr. Harden has completed a one year's internship at James Walker Memorial Hospital and will enter the Army at an undetermined date next year. He desires a license in order to work as house physician at Community Hospital, Wilmington, to cover the interim.

Dr. Davis: You have had a rotating internship?

A. Yes

Q. When do you think the Army will call you?

A. I really do not know. That is why I made this application. I suddenly started to worry. I applied for July 23rd and have not heard. As it approaches closer it seems less likely I will get in then. The job involves a small hospital, 70 beds, half full, 90% charity. They have one Cuban refugee in the day. From 9:00 P. M. to 8 A.M. there is no one there. It is the Community Hospital in Wilmington. At the present if an emergency comes in they send him to James Walker, he is given treatment and sent back to Community if it is necessary to admit him. The internes at James Walker can not leave orders at Community. I have talked to them at Community and they are eager to have anyone for any length of time.



Dr. Harden continued:

Dr. Edmondson: You have not made any plans other than to take care of this work at the Community Hospital in Wilmington until you are called into service?

A. No sir, I have not made any plans.

Q. Do you have a family?

A. No sir

Q. Have you ever had any difficulty with an examining board?

A. No sir

Q. Have you ever used alcohol in excess? A. No sir

Q. Have you ever used narcotics or barbiturates? A. No sir

Q. Have you ever been convicted of a crime?

Q. This Board wants to know whether or not your practice would consist entirely of hospital work. You are not contemplating maintaining an office?

A. It will be entirely hospital, I will be paid a salary.

Q. Is your request to this Board that you be granted limited license to this hospital?

A. That is my request.

VERDICT: Dr. Clifford Bruce Harden was approved for license by endorsement of credentials, limited to Community Hospital, if and when his credentials are completed satisfactory to the secretary. (Credentials completed)

RE: Dr. Albert Roberts Howard appeared applying for license by endorsement of credentials. He is an anesthesiologist and is going to locate in Burlington September 1st.

Dr. Davis: What are you doing in Augusta?

A. Group practice in Anesthesiology. I completed my residency in August, 1962.

Q. Are you board qualified?

A. Yes, I have taken the first part.

Q. Which hospital will you be in Burlington?

A. It is still being worked out, possibly both hospitals.

Dr. Edmondson: You say your plans are not complete?

A. Pretty well unless something comes up I can not foresee.

Q. Will you be with a group?

A. My arrangement is for a specified amount I will direct the department, administrative work, et cetera. In addition to that and according to our board requirement, I will have to derive 50% from private practice. This arrangement is practiced in the State of North Carolina in a number of places.

Q. Have you ever had any difficulty with any examining board? A. No

Q. Have you ever used alcohol to excess? A. No

Q. Have you ever used narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. Albert Roberts Howard was approved for license by endorsement of credentials, when he locates in the state for practice, within one year.

RE: Dr. William Barlow Inabnet, Jr. appeared with incomplete credentials applying for license by endorsement of credentials. He is a resident in Otolaryngology.

Dr. Large: Where do you plan to practice?

A. I do not have any definite plans. I am thinking about Greensboro.

Q. When will you complete your specialty boards?

A. Next February

Dr. Edmondson: Have you made any contacts in Greensboro?

A. I have made contacts. I intend to have a solo practice. I have been there several times. I do not have definite plans, but I do intend to come.

Q. Are you not planning to come until after February ?

A. That is right.

Q. Have you ever had any difficulty with any examining boards?

A. No

Q. Have you ever used alcohol excessively? A. No

Q. Have you ever used narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. William Barlow Inabnet, Jr. was approved for license by endorsement of credentials, if and when his credentials are complete and if and when he locates in the state for practice, within one year.

RE: Dr. Julius Rutledge Lawson appeared applying for license by endorsement of credentials. He stated that he planned to practice Pediatrics in Wilson.

Dr. Rodman: Will you join a group there?

A. Yes, Carolina General

Dr. Edmondson: When do you contemplate coming to Wilson?

A. I have moved now, then I will have to go back to Charleston to tie up things there.

Q. Have you ever had any trouble with an examining board? A. No

Q. Have you ever used alcohol to excess? A. No

Q. Have you ever taken narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. Julius Rutledge Lawson was approved for license by endorsement of credentials.

RE: Dr. Donald Dean Leonard appeared applying for license by endorsement of credentials. He stated that he planned to do Pathology in Greensboro.

Dr. Rodman: What has been your activity since 1956?

A. Residency in Cleveland and finishing up a residency in Virginia.

Q. When do you intend to come to North Carolina?

A. July 5th

Q. Will you go with one of the hospitals?

A. Cone Hospital with Dr. Lund

Q. Are you qualified for your boards?

A. I already have the boards.

Dr. Leonard continued:

Dr. Large: In both clinical and anatomical?

A. Yes sir

Dr. Edmondson: Have you ever had any difficulty with an examining board?

A. No sir

Q. Have you ever used alcohol to excess? A. No

Q. Have you ever used narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No

VERDICT: Dr. Donald Dean Leonard was approved for license by endorsement of credentials.

RE: Dr. James Wallace Myers appeared applying for license by endorsement of credentials, limited to Duke University School Medicine, where he is a resident in Medicine.

Dr. Edmondson: Have you ever had any difficulty with an examining board?

A. No

Q. Have you ever used alcohol to excess? A. No sir

A. Have you ever taken narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No sir

VERDICT: Dr. James Wallace Myers was approved for license by endorsement of credentials, limited to Duke University School of Medicine.

RE: Dr. William Markley McKinney appeared applying for license by endorsement of credentials. Dr. McKinney's grades on two of the basic subjects do not meet the requirements of this Board and Dr. McKinney has been advised. Dr. McKinney stated at this time that he took re-examination given by the Virginia Board and that the secretary will report the same.

Dr. McKinney stated that he planned to join the staff on the Neurology Service at Bowman Gray School of Medicine July 1st, as an instructor; that he received his training in Neurology at the University of Virginia.

Dr. Edmondson: Have you ever had any difficulty with any examining board?

A. No sir

RE: Dr. Edgar Allan Proctor appeared applying for license by endorsement of credentials. His grades on the basic science subjects of the Georgia Board did not meet the requirements of this Board as he did not make passing average. Dr. Proctor was given an opportunity of taking the written examination on Pathology and Bacteriology, which examination was in session, which raised his average to passing.

Dr. Large: Are you serving an internship? A. Yes

Q. Where do you plan to locate?

A. High Point

Q. Do you have specific plans as to when you wish to go there?

A. July 1st

Q. Are you going with a group or solo practice?

A. Solo practice - I plan to take the office of the late Dr. Murray Davis.

Q. You will do general practice?

A. Yes

Q. How long have you been in residency?

A. I am completing first year of residency.

Dr. Edmondson: Have you ever had any difficulty with an examining board?

A. No, I haven't.

Q. Have you ever used alcohol to excess? A. No

Q. Have you ever used narcotics or barbiturates? A. No

Q. Have you ever been convicted of a crime? A. No

Applicants for Part II of the written examination were registered.

RE: Dr. S. J. Gray, colored, Wilmington, North Carolina - At the May, 1963 meeting of the Board the attorney, John H. Anderson, Jr. discussed with the Board a matter referred to him which he outlined with regard to colored patients who had been in accidents who had insurance, being admitted to James Walker Memorial Hospital and being discharged with no injuries; that the patients would then go to Dr. Gray, he would admit them to a colored hospital for several weeks and give a diagnosis of traumatic weeping eyes, build up the cases and send a bill for a large amount; that there was a large volume of such cases; that he appeared to have a pattern of reporting injuries and collecting large amounts of insurance. The Board at that meeting directed that Dr. Gray be requested to appear at this time.



Dr. Gray continued

Dr. Gray was interviewed. He stated that due to some court experiences he had made a form, on his letter-head, taken from insurance company forms, which gave a fuller report. He presented a copy of this form, together with a summary of his position in this regard, which are on file. A complete copy of the interview is also on file.

Dr. Gray said that in many instances patients who had been in accidents could not be admitted to James Walker Memorial Hospital due to lack of facilities and were sent home; that they later came to him and needed hospital treatment. He denied that he had ever admitted a patient to the hospital, who in his opinion did not need hospital treatment. He stated that in his 23 years of practice he had never presented a bill for his medical service unless he was asked for it; that he often was not paid for his medical services; that he had attempted to practice ethical medicine.

The Board advised Dr. Gray that when criticism was brought to it that it was necessary to make an investigation. He was urged to be prudent in all matters and practice ethical, honest medicine. He was also advised that the Board would keep this matter under surveillance and if necessary, further investigation would be made.

This interview was received as information.

RE: Dr. Jacqueline C. Hijmans, graduate of a foreign medical school and a non-citizen, licensed by examination and granted license limited geographically, was requested to appear before the Board to explain why she had not obtained citizenship.

Dr. Edmondson: Would you give this Board the status of your citizenship?

A. I am a permanent resident of the United States, but I am not a citizen.

Q. Have you made application?

A. No sir

Q. Do you contemplate making application?

A. I am eligible, but one has to be a domicile for six months. Last year on account of family circumstances I had to go home on two occasions. At the moment I could send it in. However, I am about to go to Europe again to see my parents, who are aged.

Q. Would it be possible to turn it in and then go to Europe?

A. I think I can.

Q. In order that we can clarify this situation, are you in a position to institute these papers?

A. Yes, I have them, I can send them in.

Dr. Templeton: Are you practicing medicine?

A. I am working at Memorial Hospital.

Dr. Edmondson: Primarily it is our feeling that it puts the Board in somewhat a precarious situation with other individuals in your same status and that is why we want to encourage you to complete your papers and stop continuation of extension of getting your naturalization papers. You are contemplating doing this pretty soon?

Q. How long does it take if you send in?

A. I guess it depends on how big their demand.

Q. In order to clarify our records, when you send your papers in and have your complete naturalization, would you notify our office?

A. I will.



RE: The Board directed that Dr. Jacqueline C. Hijmans be followed up in one year.

RE: Dr. T. H. Brantley, Concord, North Carolina - Dr. Brantley appeared before the Board petitioning for recommendation of reinstatement of his narcotic tax stamp, which was surrendered in May, 1957. At that time he had not kept office records on use of narcotics and his wife was alleged to be addicted to narcotics.

Dr. Brantley stated that his practice had been affected because he was unable to prescribe narcotics; that he did no hospital practice; that his wife had been all right four years and was taking no drugs; that he had never taken narcotics. He said he only desired narcotic privileges in order to be able to write prescriptions; that he would not keep it in his office.

VERDICT: Dr. R. G. Templeton moved that the Board of Medical Examiners recommend reinstatement of the narcotic tax stamp of Dr. T. H. Brantley. This motion was duly seconded by Dr. James E. Davis. This motion was passed by a vote of four, two abstained from voting, and one against the motion.

Dr. Brantley was advised the action of the Board and was instructed by the president to keep the records required by law and he was warned as to the danger of ever administering any narcotics to his wife. He said he would never give his wife another narcotics.

RE: Dr. Edward Frederick Doehne III was granted license by endorsement of credentials, limited to the University of North Carolina School of Medicine, where he was a resident in Psychiatry. He has now joined the medical staff of Broughton Hospital and has applied for conversion to full license. He has met the requirements of the Board.

VERDICT: Dr. H. Lee Large, Jr. moved that the limited license of Dr. Edward Frederick Doehne III be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. John David Fletcher was granted license by endorsement of credentials, limited to Bowman Gray School of Medicine, where he was a resident in Pediatrics. VERDICT: RESOLVED that the medical license of the above physician be reinstated.

The Minutes were approved as read.

The meeting was adjourned.

RE: Dr. Farid Aalam, Scotland Neck, North Carolina, holds a license limited geographically due to the fact that he has not obtained citizenship. He petitioned the secretary to extend his license to Tyrrell County. Due to the fact that there had been considerable friction in the two counties in which he holds limited license, Halifax and Edgecombe, the secretary declined any further action until Dr. Aalam was interviewed by the Board in session. He did not request an appointment to appear in Asheville in May, 1963. A delegation from Columbia, Tyrrell County, were present at that time to appeal for extension of his license. The Board declined any action and instructed the secretary to request him to appear at this time. At the appointed time a telegram was received from Dr. Aalam stating that he was withdrawing his application to extend his limited license to Tyrrell County; that he would remain in Scotland Neck, and he did not think it necessary to appear. The secretary was instructed by the Board to telephone him and tell him to come at once.



Dr. Farid Aalam continued

Dr. Aalam was interviewed by the Board and stated that he had operating facilities in his office, where he had two beds, but that only one bed was ever occupied by a patient remaining in the office; that he had no surgical assistant and no registered nurses; that he had practical nurses and an orderly; that he did major surgery in this facility. He described some of his difficulties in Scotland Neck.

Dr. Aalam stated at this interview that he wished to withdraw his application for extension of license to Tyrrell County.



The Board of Medical Examiners of the State of North Carolina met at the Mayview Manor, Blowing Rock, North Carolina, July 25-27th, 1963, for the purpose of certifying the grades of the annual written examination for medical license, to interview applicants for license by endorsement of credentials, for special limited license, and for other business.

Thursday, July 25th

The Board convened for dinner and Drs. Frank Edmondson, President, Joseph J. Combs, Secretary-Treasurer, James E. Davis, H. Lee Large, Jr., W. Boyd Owen, Ralph B. Templeton and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer, were present. Dr. Clark Rodman was absent for the entire meeting due to illness.

8:30 P. M. - Credentials for license by endorsement of credentials and special limited license were reviewed by the Board.

The secretary advised that he had ordered flowers sent to Dr. Clark Rodman, who is in the hospital, in the amount of \$10.00, which was approved by the Board.

Dr. Thomas appeared at this time and stated that he left Broughton Hospital and had been a patient at John Umstead Hospital from December 12th, 1962 to June 22nd, 1963; that he had been at Appalachain Hall for the past two weeks. He said his physician at Appalachain thought he might be able to go to work in a hospital.

Dr. Thomas stated that he and his wife had separated and he was with his mother in Florence, South Carolina; that he wanted to know the status of his North Carolina license as he would like to attempt to work in a government or state hospital in South Carolina and wanted to consider applying for license by endorsement there. (See complete interview in file)

Dr. James L. Cathell, Superintendent at John Umstead Hospital, reported that Dr. Thomas left the hospital against their advice.

VERDICT: Dr. James E. Davis moved that Dr. James Valentine Thomas be informed that this Board feels it can not take any action at this time; that it would require psychiatric evaluation by his psychiatrists at John Umstead Hospital, countersigned by Dr. James L. Wheless, Louisburg, North Carolina - The secretary reported he had received report of the State Bureau of Investigation dated July 18th, 1963; that Dr. Wheless admitted to the investigating agent that he had been administering demerol to himself since January, 1963; that he had not kept a record of dispensation of his narcotics since June 24th, 1962; that examination revealed since May 27th, 1963, he had received and dispensed 1,742 cc of Demerol.

RE: Dr. Frank Houston Bassett III was granted license limited to Duke University School of Medicine July 25th, 1958, to cover him as a resident. He has completed his training and is remaining on the Orthopaedic staff there and has applied for conversion of limited to full license.

VERDICT: Dr. James E. Davis moved that the limited license of Dr. Frank Houston Bassett III be converted to full license. This motion was duly seconded and passed unanimously.

RE: Dr. James Caulie Gunnells, Jr. was granted license limited to Duke University School of Medicine July 25th, 1958 to cover him as a resident. Dr. Gunnells has advised that he is now on the senior staff at Duke University School of Medicine and planned to practice internal medicine there. He has applied for conversion of limited to full license.

VERDICT: Dr. Ralph G. Templeton moved that the limited license of Dr. James Caulie Gunnells, Jr. be converted to full license, if and when he meets the requirements of the Board. This motion was duly seconded by Dr. James E. Davis and passed unanimously.

RE: Dr. Needham Lapsley Long was granted license limited to Bowman Gray School of Medicine July 28th, 1961 to cover him as a resident. Dr. Long has advised that he has tentative plans to return to North Carolina for the practice of medicine September 1st, 1963, and if his plans are accomplished he desires conversion of limited to full license. He has not met all requirements.

VERDICT: Dr. Ralph G. Templeton moved that the limited license of Dr. Needham Lapsley Long be converted to full license, if and when he meets the requirements of the Board. This motion was duly seconded by Dr. James E. Davis and passed unanimously.

RE: Dr. Roscoe Ross Robinson was granted license limited to Duke University School of Medicine on July 29th, 1955. He has advised that he is now an associate professor of Medicine at Duke University School of Medicine and has applied for conversion of limited to full license.

VERDICT: Dr. James E. Davis moved that the limited license of Dr. Roscoe Ross Robinson be converted to full license. This motion was duly seconded by Dr. W. Boyd Owen and passed unanimously.

RE: Dr. Allan Watson Downie was granted license limited to the University of North Carolina School of Medicine on June 20th, 1957 until citizenship obtained. He has submitted proof of citizenship and applied for conversion of his limited to full license.

VERDICT: Dr. James E. Davis moved that Dr. Allan Watson Downie's limited license be converted to full license. This motion was duly seconded by Dr. Ralph G. Templeton and passed unanimously.

RE: Dr. Ferenc Robicsek was granted license limited to Mecklenburg County, North Carolina, on June 19th, 1958 until citizenship obtained. He has submitted proof of citizenship and applied for conversion of his limited to full license. VERDICT: Dr. H. Lee Large, Jr. moved that Dr. Ferenc Robicsek's limited license be converted to full license. Motion duly seconded by Dr. James E. Davis and passed unanimously.

RE: Dr. Andres J. Valdes was granted license limited to Durham County, North Carolina, in June, 1962 until citizenship obtained. He has now associated with a group of pathologists at the Memorial Hospital, Danville, Virginia, who are applying for license in order to do Pathology in Leaksville, North Carolina. Dr. Valdes has asked that his limited license be extended to cover Rockingham County, North Carolina.


