MEETING OF THE BOARD OF MEDICAL EXAMINERS OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

June 19 - 23, 1960

The Board of Medical Examiners of the State of North Carolina convened at 6:00 o'clock P. M. at the Sir Walter Hotel, Raleigh, North Carolina, Sunday, June 19th. The following members of the Board were present: Drs. J. B. Anderson, President, Joseph J. Combs, Secretary-Treasurer, L. R. Doffermyre, Edwin A. Rasberry, Jr., Thomas G. Thurston, Carl V. Tyner, and Mrs. Louise J. McNeill, Assistant Secretary-Treasurer. Dr. Thomas W. Baker was absent from the entire meeting due to illness.

The following foreign medical graduates appeared petitioning for the privilege of taking the written examination:

RE: Dr. Ursula M. Anderson, graduate of the University of Liverpool, England, M. B. Degree, 1952, appeared applying for permission to take the written examination. She hold the certificate of the Educational Council for Foreign Medical Graduates. She plans to practice with the State Board of Health.

Dr. Combs: Do you hold license in Connecticut?

- A. Yes
- Q. How did you get that license?
- A. I took the examination in 1959
- Q. Where have you been working?
- A. At Yale
- Q. Have you had a narcotic license?
- A. Yes
- Q. Have you had any trouble with narcotics?
- A. No
- Dr. Rasberry: What work will you do with the State Board of Health?

 A. In the capacity of a pediatrician. The details have not been worked out.
- Dr. Thurston: How did you get interested in North Carolina?

 A. I was recommended from Yale to Dr. Norton one year ago.
- Dr. Anderson: Do you have a license any where besides Connecticut? A. No, I have only been in this country two years.
- Dr. Combs: Should the Board grant you permission to take the examination, it will be geographically limited until you get citizenship. You would probably be limited to the Board of Health. If you left there, we would change it up until the time you became a citizen. We give you six years to get citizenship and if you have not gotten citizenship at that time the Board may take up your license.

VERDICT: Dr. J. J. Combs moved that Ursula M. Anderson be granted permission to take the written examination and if she passed the license to be limited to the State Board of Health. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: <u>Dr. Joseph U. Toglia</u> appeared applying for permission to take the written examination. He was graduated by the Medical University of Rome, Italy, in 1950 and holds the certificate of the Educational Council for Foreign Medical Graduates. He is married to a native of North Carolina and presented his immigration card. He received his residency training at Bowman Gray School Medicine.

Dr. Combs: What are your plans as to North Carolina?

- A. I was hoping to be an instructor in Neurology at the University of North Carolina. I have learned since that it is research and I am not interested. So I have had to give up this. I will be in Charlotte this year as a neurologist. I have received an interview from several doctors, including Drs. Coffey and Culbreth and Drs. Fisher and Gage helping me in starting to be associated with the clinic.
- Dr. Rasberry: Where have you been?
- A. I was three years in North Carolina at Bowman Gray in Neurology. I left Bowman Gray in 1958. I was required to go abroad for a period of two years to return as an immigrant.
- Dr. Anderson: Did you tak training in Neurology or Neurological Psychiatry?
- A. I was in Neurology.
- Q. Do you have any other license besides special limited license?
- A. In Canada.
- Q. Have you had any difficulty with a licensing board or the Narcotic Bureau?
- A. No, I do not have a narcotic license in the United States.

 I understand there may be a position at the Veterans Administration Hospital in Salisbury. Dr. Gage said he would be glad to help.

VERDICT: The Board voted four to one to grant Dr. Joseph U. Toglia the privilege of taking the written examination and if successful to be granted limited license until citizenship obtained.

RE: <u>Dr. Jan de Bakker</u>, graduate of the Medical College of Virginia and an immigrant, appeared applying for the privilege of taking the written examination. Dr. de Bakker received his first two years of medicine at Duke University School of Medicine. He presented immigration visa. He is a native of Holland.

- Dr. Combs: Why did you transfer from Duke to Medical College of Virginia?
- A. I had a contract for two years and that was not renewed.
- Dr. Tyner: What kind of contract?
- A. This was an arrangement with the dean that I should transfer to another school. They did not have enough vacancies. They supported me when I finished my first two years.

Dr. Anderson: What are your plans?

I am to take an interneship at the Medical College of Virginia. I plan to come to North Carolina for specialty in surgery. Probably western North Carolina. I spent a good deal of my time in western North Carolina. I lived in Elkin three years. I went to school there and Maryville, Tennessee. I worked for Dr. Tate. After three years I went to Maryville College. I tried to get in at the University of North Carolina and could not on account of my citizenship status. I came in this country in 1948 by jumping ship. In 1942 I joined the underground movement in Holland. Then I joined the Marines, then I came back from Indonesia where I fought against the rebels. I came to Holland and tried to immigrate, so I tool the short end around, became a sailor and jumped ship. I had a friend in North Carolina. He said he would see what he could do. I came to North Carolina and joined him. From there I went to BannerElk. 1949 they issued a statement by the Federal Government saying all aliens should report. I had a legal battle of eight years. After a long drawn up process, I got a job with Dr. Farmer. I went to the Bahamas and came through Florida.

VERDICT: Dr. Jan de Bakker was unanimously approved to take the written examination and if successful, to be granted limited license until citizenship obtained.

RE: <u>Dr. Richardo Galbis-Beltran</u> appeared applying for permission to take the written examination. He was graduated by Bowman Gray School of Medicine. He presented his immigration card. He is a native of Cuba.

Dr. Anderson: What are your plans as to North Carolina?

- A. I like Greensboro. I know many people there. I guess, if I practice in North Carolina, I would practice in Greensboro.
- Q. What type of practice will you be interested in?
- A. I like dermatology and orthopedics.

Dr. Rasberry: Where are you going to interne?

- A. That is one thing I must consider. I am going to Cuba in one week. Something disagreeable has occurred. You can not inherit from your parents if you are out of the state. They would have to transfer this during their life. Then I will work in Psychiatry at Bowman Gray for the rest of the summer. I do not know whether I will stay here or go to the District of Columbia General or come back.
- Q. Do you not have to have an interneship by a certain time?
 A. Yes, if I had routinely followed through, but I have to finish up this problem in Cuba first. Then I will come back here.
 I will be in the Psychiatric Service at Bowman Gray. Then afterwards I plan to go to the District of Columbia for interneship.
 My uncle is there. I will return eventually.

VERDICT: <u>Dr. Richardo Galbis-Beltran</u> was unanimously approved to take the written examination and if successful, to be granted limited license until citizenship obtained.

The president related that he had reviewed all questions for the written examination.

RE: Dr. John M. Gambill, Snow Hill, North Carolina - To summarize, Dr. Gambill was formally heard by the Board on charges January 10th, 1960, license to practice medicine in North Carolina was revoked, and the judgment and revocation was suspended upon certain conditions. (See Minutes January, 1960) The Order and Judgment set out that upon receipt of evidence or information satisfactory to the Board or its officers of the violation of any of the terms and conditions of this suspension, the judgment and revocation of the license of Dr. John M. Gambill to practice medicine in the State of North Carolina would become effective immediately.

The secretary stated that the reports required in the Order and Judgment on the 15th day of each month were not received in May, 1960. The secretary further reported that he received verbal reports from the sheriff of the county, the Chief of Police of Snow Hill, and direct information from a physician and the councilor of that district of the State Medical Society that the said Dr. Gambill had violated the terms of the suspension in that he had taken barbiturates and imbibed alcohol to the extent that on at least one occasion he was found by the night policeman in an unconscious state as a result of imbibing alcohol and/or barbiturates, between April 15th and May 15th, 1960.

VERDICT: Upon motion duly made by Dr. T. G. Thurston and seconded by Dr. L. R. Doffermyre, it was resolved that the action of the Board at its last meeting in ordering that the previous judgment of the Board revoking Dr. Gambill's license to practice medicine be put into effect upon confirmation of the information previously received, be and the same is hereby confirmed and ratified, and that the license of Dr. Johm M. Gambill to practice medicine be revoked.

The meeting was adjourned.

Monday, June 20th

8:30 A. M. - Registration for Part I and Parts I and II of the examination.

RE: <u>Dr. Franklin Bailey Wilkins</u>, Winston-Salem, North Carolina - (Native of Mars Hill, North Carolina)

A report was received from the California Board of Medical Examiners that the license of Dr. Franklin Bailey Wilkins to practice medicine and surgery was revoked as of April 27th, 1960; that the effectiveness of the order was stayed for a period of three years, during which time he was placed on probation and subject to certain conditions. (See file) The action of the California Board was taken after Dr. Wilkins was convicted in the Municipal Court in Los Angeles County, California, where he entered a plea of guilty and was convicted of violation of sections of the law regulating narcotics in that he did issue a prescription for demerol and failed to make records as to name and address of patient, character and quantity of narcotics involved, and the purpose for the prescription. The California Board did not find him guilty of narcotic addiction.

On interview Dr. Wilkins stated that he had been very ill; that he had had a stroke, malignant melanoma, amnesia and taxia. That he had been under competent medical care; that he had received narcotics during his illness and he denied narcotic addiction. He stated that he came to the attention of the Narcotic Bureau when he reported that his office had been entered and all narcotics taken and that he

was subjected to investigation, trial by court and by the California Board of Medical Examiners and that he was not convicted of narcotic addiction. He said that he was doing general surgery in California. He said that he was now at Bowman Gray School Medicine as assistant resident in surgical pathology and that he had related to Dr. R. P. Morehead, Professor of Pathology, the circumstances that had occurred in California.

Dr. George Leiby (Colonel) appeared on behalf of Dr. Wilkins. He advised that he is Dr. Wilkins' brother-in-law; that he had the opportunity to observe him during his illness and at one period he was at the Veterans Administration Research Hospital in Chicago, of which hospital he was manager; that he saw him when was first taken ill in Long Island, New York, and later in California. Dr. Leiby stated that in his opinion Dr. Wilkins was qualified to practice; also that he had never been addicted to narcotics. He presented letter from Dr. Walter C. Ralston, internist of Anaheim, California, who had treated Dr. Wilkins. Dr. Ralston advised that Dr. Wilkins had responded well and that he had encouraged him in his present plans.

Dr. Wilkins was questioned as to his compliance with the conditions of the suspension of the California Board and he informed the Board that he had sent his quarterly report to the Board; that he would continue to do so and would appear before the Board in one year.

VERDICT: Dr. J. J. Combs moved that the president instruct Dr. Franklin Bailey Wilkins that in view of the conference we have had, he will be considered on probation in North Carolina and that the Board feels his decision to go in surgical pathology is a good one and we wish him the best of luck in his medical practice. This motion was duly seconded by Dr. C. V. Tyner and passed unanimously.

Dr. L. R. Doffermyre moved that the secretary be instructed that in the event application for narcotic tax stamp is made that the secretary not approve the same. This motion was duly seconded by Dr. C. V. Tyner and passed unanimously.

Dr. E. A. Rasberry, Jr. moved that in compliance with instructions of the California Board of Medical Examiners, whereas he has to make quarterly reports, that he send carbon copies to this Board. This motion was duly seconded and passed unanimously.

RE: <u>Dr. W. C. Perry</u>, Louisburg, North Carolina - Upon receipt of report from the Narcotic Bureau under date of April 29th, 1960, Dr. Perry was requested to appear before the Board. His narcotic tax stamp was surrendered January 25th, 1960.

Dr. Perry appeared and stated that he was admitted to Westbrook Sanatorium where he remained for six weeks; that he has not had any narcotic since that time (January 25th, 1960); that he has been health officer since June, 1959. He stated that he does not need a narcotic tax stamp in his work. (See file for complete interview)

VERDICT: Dr . L. R. Doffermyre moved that Dr. W. C. Perry be instructed not to apply for reinstatement of narcotic license until he appeared before this Board and had permission to do so because we would reject it if he does; that he be congratulated for withdrawal from the use of narcotics and wish him well; that he be advised the Board will keep him under observation and might request him for another appearance. This motion was duly seconded by Dr. C. V. Tyner and passed unanimously.

RE: <u>Dr. Thomas O. Wheless</u>, Louisburg, North Carolina - Upon report from the Narcotic Bureau dated May 12th, 1960, Dr. Wheless was requested to appear before the Board. His narcotic tax stamp was surrendered April 7th, 1960. He admitted having taken dilaudid from July, 1959 to December, 1959. He stated that he went to Westbrook Sanatorium for treatment January 3rd, 1960, and was there approximately six weeks; that he had no narcotics since December, 1959. He stated that he is doing a general practice and that his practice has been effected some. (See file for complete interview)

VERDICT: Dr_{to} L. R. Doffermyre moved that Dr. Thomas O. Wheless be instructed not/apply for reinstatement of narcotic license until he has appeared before this Board and had permission to do so because we would reject it if he does; that he be congratulated for withdrawal from the use of narcotics and wish him well; that he be advised the Board will keep him under observation and might request him for another appearance. This motion was duly seconded by Dr. C. V. Tyner and passed unanimously.

RE: Dr. Miriam N. Muldrow, Whiteville, North Carolina- Pursuant to the judgment of the Board in June, 1958, Dr. Muldrow made a routine appearance to continue the surveillance of the Board. She stated that she is doing very well, working in her office two hours in the morning and two hours in the afternoon; that she had a transfusion in April for anemia and was out of the office two weeks. She stated that she was getting along all right without writing narcotic prescriptions; that if she had a very sick or painful patient she sent him to the hospital. She presented letters of recommendation from representative persons in her community.

The meeting was adjourned.

June 20th, 1960 2:30 P. M.

The secretary presented reservations as confirmed from the Carolinian for the October 6-9th,1960 meeting of the Board.

RE: <u>January, 1961 Meeting</u> - The Board originally set January 19-22nd, 1961 for the meeting at the Mid Pines Hotel. Due to previous committments the hotel was not able to grant reservations at that time. The Board elected to meet January 5-8th, 1961.

RE: June, 1961 Meeting - The dates June 18-22nd, 1961, were set for the written examinations.

RE: Biennial Registration of Physicians - Suspension

Following notice given by mail to those who failed to register as required by law, that they appear before the Board of Medical Examiners at 2:30 P. M. o'clock June 20th, 1960, at the Sir Walter Hotel, Raleigh, North Carolina, the following list has failed to register as required by law. Upon motion and second, it was resolved that the license of the physicians listed as follows, be suspended for failure to register as required by General Statutes of North Carolina 90-15.1:

Grant, Willis Jackson III

The secretary reported that Dr. Grant has now paid the fees and penalties required by law for registration.

VERDICT: RESOLVED that the medical license of Dr. Willis Jackson Grant III be reinstated.

RE: <u>Dr. J. R. Medlin. Jr</u>., Rural Hall, North Carolina - (See previous Minutes - Narcotic addiction)

On October 27th, 1959, Dr. Medlin went voluntarily to the United States PublicHealth Service Hospital at Lexington, Kentucky for treatment of demerol addiction. His narcotic stamp was surrendered April 22nd, 1959.

Following indictment and conviction of violation of the narcotic laws in the Forsyth County Superior Court, the Board directed on May 7th, 1960 that charges be made against Dr. Medlin looking to revocation of his license to practice medicine in the State of North Carolina.

Dr. Medlin filed no answer to the charges made against him and appeared without counsel. The Board was represented by John H, Anderson, Attorney.

The evidence presented against Dr. Medlin was as follows:

Certified copy of the Bill of Indictment, which was as follows:

"3895 INDICTMENT - OBTAINING NARCOTIC DRUGS BY FRAUD STATE OF NORTH CAROLINA, FORSYTH COUNTY SUPERIOR COURT March 7 Term, A. D. 1960

The Jurors for the State Upon Their Oath Present that D_r . J. R. Medlin, Jr. late of the County of Forsyth on the 12th day of February in the year of our Lord one thousand nine hundred and sixty, with force and arms, at and in the county aforesaid, unlawfully, wilfully, and feloniously did obtain a narcotic drug, to-wit, 30 cc of Demerol by the forgery of a prescription for the said narcotic drug and by forging the name of C. T. Medlin, M. D., on the said prescription."

"3895-A INDICTMENT - OBTAINING NARCOTIC DRUGS BY FRAUD STATE OF NORTH CAROLINA, FORSYTH COUNTY SUPERIOR COURT March 7 Term, A. D. 1960

The Jurors for the State Upon Their Oath Present, that Dr. J. R. Medlin, Jr. late of the County of Forsyth, on the 14th day of February in the year of our Lord one thousand nine hundred and sixty, with force and arms, at and in the County aforesaid, unlawfully, wilfully, and feloniously did obtain a narcotic drug, to-wit, 30 cc of Demerol by the forgery of a prescription for the said narcotic drug and by forging the hame of C. T. Medlin, M. D., on the said prescription."

Certified copy of the judgment of the court, which was as follows:

"State vs Dr. J. R. Medlin, Jr.

T. D. #3895 - Indictment, Obtaining Narcotics by Fraud, March 7, 1960, Term T. D. #3895A-Indictment, Obtaining Narcotics by Fraud, March 7, 1960, Term

The defendant comes into open Court and through his counsel Eugene H. Phillips, enters a plea of guilty to Obtaining Narcotics by Fraud as charged in the Indictment in case #3895, and enters a plea of nolo contendere to obtaining narcotics by fraud as charged in the indictment in case #3895-A.

In case No. 3895, it is the judgment of the Court that the defendant be confines in the Central Prison, Raleigh, for a period of not less than one (1) nor more than three (3) years and be assigned to do labor as provided by law. This prison sentence is suspended for a period of five (5) years on conditions:

- l. That he pay a fine of \$500.00 and costs;
- 2. That he remain of good behavior and not violate any of the laws of this state, and particularly that he not violate any of the provisions of the State Narcotics Drug act which includes G. S. of N. C. section 90-86 through 91-13.7, or any of the provisions of the State Narcotic Drug act. In event the defendant violates any of the terms of this judgment, capias and commitment to issue.

"In No. $3895 \div A$, by consent of the defendant in open Court prayer for judgment is continued from term to term for a period of five (5) years and specifically until the April Term, 1965."

The following charges were made against Dr. Medlin May 14th, 1960:

"You are hereby given notice that the Board of Medical Ex aminers of the State of North Carolina has presented and does hereby present against you the following charges and accusations, to-wit:

- "1. That in the Superior Court of Forsyth County, North Carolina, at the March 7, 1960 Term a true bill was rendered against you by the Grand Jury upon the charge that on the 14th day of February, 1960 in said county you did unlawfully, willfully and feloniously obtain a narcotic drug, to-wit 30 ccs of Demerol by the forgery of a prescription for the said narcotic drug and by forging the name of C. T. Medlin, M. D., on the said prescription, and also that on the 12th day of February, 1960, in said county you unlawfully, willfully and feloniously obtained 30 ccs of Demerol by the forgery of a prescription for the same and by forging the name of C. T. Medlin, M. D. on the said prescription.
- "2. That on April 11, 1960, you were tried upon the foregoing charges and bills of indictment, and through counsel you did then and there enter a plea of guilty to the charge, that you did obtain narcotics by fraud, and by the signing and forging of a prescription for the same in the name of C. T. Medlin, M. D., on the 12th day of February, 1960, and you then and there entered a plea of nolo contendre to obtain narcotics by fraud on the 14th day of February, 1960, as set forth in the foregoing bill of indictment.
- "3. That upon the foregoing pleas the court rendered judgment that you be confined in the Central Prison in Raleigh, for a period of not less than one nor more than three years and be assigned to labor as provided by law, that said prison sentence was suspended for a period of five years upon the condition that you pay a fine of \$500 in costs

"and that you remain of good behavior and not violate any of the laws of this State and particularly that you not violate any of the provisions of the State Narcotics Drug Act, which includes G. S. of North Carolina, Sec. 90-86 through 91-13.7, or any of the provisions of the State Narcotics Drug Act. That you did unlawfully obtain narcotic drugs on the 12th day of February, 1960, and on the 14th day of February, 1960, by forging the name of C. T. Medlin, M. D., to prescriptions for the same and after obtaining the same you consumed said narcotic drugs yourself.

- "4. That on February 25, 1960, you issued a prescription for and obtained 30 ccs of Demerol upon a prescription signed J. R. Medlin, Jr., M. D., without having a license and without having a Federal Narcotic Tax Stamp permitting you to obtain narcotic drugs or issue prescriptions for the same, and that you did consume the said 30 ccs of Demerol yourself.
- "5. That you have been and are addicted to the use of narcotic drugs.
- "6. That in the foregoing respects you have benn guilty of dishonorable conduct unworthy of and affecting the practice of your profession, and grounds exist for the revocation of your license to practice medicine in the State of North Carolina.
- "7. You are further notified that a hearing upon the foregoing charges and accusations will be held before the Board of Medical Examiners of the State of North Carolina on June 20, 1960, at three p. m. at the Sir Walter Hotel, Raleigh, North Carolina, at which time you will be given an opportunity to be heard, to cross-examine witnesses yourself, or through counsel, and to present witnesses or evidence upon your own behalf; and that following said hearing the Board of Medical Examiners of the State of North Carolina will render its verdict upon the foregoing charges and will take such action as the facts and findings of the board may warrant and justify in accordance with the duties and powers set forth in General Statute 90-14.

See transcribed record of this hearing in the file)

- Dr. Medlin stated that he was making an effort to rehabilitate himself; that he had joined the Alcoholic Anonymous and was under the care of Dr. A. C. Randolph, Psychiatrist at Bowman Gray School of Medicine.
- Dr. C. T. Medlin, brother with whom he is in partnership, appeared with him. Upon being prompted by his brother, Dr. J. R. Medlin admitted that he, had taken demerol three weeks ago.
- Dr. C. T. Medlin was interviewed by the Board and he stated that Dr. J. R. Medlin was off demerol for about 18 months and returned to the use of the same after his narcotic tax stamp was reinstated. He said that as he understood it, Dr. Medlin did not have the characteristics of a true addict; that he would go for weeks without taking any. He said Dr. Medlin was a fine doctor, had a keen mind and worked hard; that he had a good doctor-patient relationship. He said that he had protected his brother, Dr. J. R. Medlin, asfar as he could; that he was going to help him, but would report any irregularity to the Board.

"FINDINGS

"The Board of Medical Examiners of the State of North Carolina following the presentation of evidence in the above matter at its regular meeting on June 20th, 1960, at the Sir Walter Hotel, Raleigh, North Carolina, pursuant to notice to Dr. J. R. Medlin, Jr. of charges and accusations and of hearing, and after full consideration of all the evidence, concluded as follows upon the charges and accusations dated May 14th, 1960:

- "1. The Board finds Dr. J. R. Medlin, Jr. guilty as to charge set forth in Paragrap h one of such charges and accusations.
- "2. The Board finds Dr. J. R. Medlin, Jr. guilty as to charge set forth in Paragraph two of such charges and accusations.
- "3. The Board finds Dr. J. R. Medlin, Jr. guilty as to charge set forth in Paragraph three of such charges and accusations.
- "4. The Board finds Dr. J. R. Medlin, Jr. guilty as to charge set forth in Paragraph four of such charges and accusations.
- "5. The Board's decision was reserved as to charge set forth in Paragraph five of such charges and accusations.
- "6. The Board finds Dr. J. R. Medlin, Jr. guilty as to charge set forth in Paragraph six of such charges and accusations.

"This the 20th day of June, 1960."

The following is the Order and Judgment of the Board upon the findings:

"Following the decision and findings of the Board of Medical Examiners of the State of North Carolina of June 20th, 1960, on the Charges and Accusations dated May 14th, 1960, the Board unanimously rendered the following judgment and order:

"That the license of Dr. J. R. Medlin, Jr. to practice medicine in the State of North Carolina is hereby revoked.

"That this judgment and revocation shall be and is suspended upon condition that for a period of five years he remain of good behavior, that he violate no law, local, state or Federal, that he place himself under psychiatric therapy as frequently as his psychiatrist feels he should, and for his psychiatrist to submit reports to this Board prior to each meeting of the Board.

"And Further, that he appear before the Board in person at each meeting of the Board, unless excused by the Board.

"That in the event Dr. J. R. Medlin, Jr. violates any of the terms or conditions upon which this judgment is suspended, the judgment and sentence will be put into effect."

RE: <u>Dr. Louis D. Hayman</u>, <u>Jr.</u>, Jacksonville, North Carolina - On May 10th, 1960, Dr. Hayman petitioned for recommendation that his narcotic tax stamp be restored and he was given an appointment to appear at this time.

Dr. Doffermyre: Gentlemen, you are applying to this Board for a sped al limited license, which will entitle you to continue your medical training within the bounds of North Carolina. You are graduates from approved schools, but you do not have license which we can recognize. This permit, which you will receive, does not permit you to prescribe or dispense narcotic drugs within the hospital. This permit can not be converted to license. You can only receive that by taking our Board or some board which we endorse, as a means of securing license in North Carolina. It is renewable on a year to year basis, provided your work is satisfactory and certified by the chief of your service and you yourself make application for same. You will be allowed to complete credentials by the July 22nd meeting. If you have not completed credentials by that date, I am sure you will be asked to cease work until you can complete credentials.

RE: <u>Dr. George W. Melchior</u> - Dr. E. A. Rasberry, Jr. reported to the Board that Dr. E. T. Beddingfield had advised that Dr. Melchior has been offered a position with Dr. Thomas Dooley to go to the Far East for 15 months to assist in training the natives. Dr. Beddingfield asked that the Board write a letter with regard to Dr. Melchior.

VERDICT: Dr. E. A. Rasberry, Jr. moved that a letter with regard to Dr. George W. Melchior be written. This motion was duly seconded and passed unanimously.

RE: <u>Dr. Tine Strobos</u> was granted license on the basis of written examination June 21, 1956, limited to Forsyth County, North Carolina, until citizenship obtained. Dr. Strobos has presented citizenship certificate #8177473 dated June 10th, 1960.

RE: State Bureau of Investigation report of June 8th, 1960, which involved the following physicians, who had prescribed narcotics for addicts, a man and his wife:

RE: Dr. Robert Lee Felton, Jr., Carthage, North Carolina- Dr. Felton appeared for an interview and he stated thathe was completely fooled; that the woman asked for demerol for her mother, who was dying with cancer and that they were trying to get her in a nursing home; that he had learned everything she told him was fictitious. He said he did not see the man. He said each time he said he would go to see the mother there was some excuse. He stated that he did not prescribe for addicts and that he had not previously prescribed for a patient whom he had not seen.

Dr. Felton was advised by the Board to abide by the narcotic laws.

RE: <u>Dr. Cordon Spaulding Fuller, Jr.</u>, Pittsboro, North Carolina.-Dr. Fuller stated that the man had been a problem for about 10 years; that he had had many illnesses and he had him in and out of the hospital; that he did not know he had become addicted; that they changed one prescription to demerol which he had written.

 $\ensuremath{\text{Dr.}}$ Fuller was advised to be more careful in writing his prescriptions.

RE: <u>Dr. Andrew Albert Vanore</u>, Robbins, North Carolina - Dr. Vanore stated that he also was completely fooled; that the woman did not give him the impression of an addict and told him the many stories about her mother. He denied having written all the prescriptions which were alleged to be signed by him and that the amounts in some were incorrect.

RE: <u>Dr. William Louis Patman</u>, Siler City, North Carolina - The report of the State Bureau of Investigation revealed that Dr. Patman had written two prescriptions for the addicts and did not have a narcotic tax stamp. He admitted this and stated that he was fooled by the patient; that he thought he was doing a human thing. That he knew he had done wrong.

Dr. Patman was advised that he could be indicted by the Narcotic Bureau för writing prescriptions for narcotics without a narcotic tax stamp

RE: Dr. George David Pleasants, Siler City, North Carolina - Dr. Pleasants was reported by the State Bureau of Investigation, after having signed a prescription for Dr. Patman. Dr. Pleasants admitted that he signed this prescription carelessly as it was included in some of his own prescriptions. He said that he was not taken in by the addicts.

Dr. Pleasants was advised to be more careful in the future.

RE: <u>Dr. William Clyde Thomas</u>, Siler City, North Carolina was reported by the State Bureau of Investigation for having written one prescription for demerol without having seen the patient.

Upon being requested to appear before the Board at this time, $\mathtt{Dr}.$ Thomas replied that he was ill.

VERDICT: Dr. E. A. Rasberry, Jr. moved that Dr. William Clyde Thomas be directed to come to the secretary's office for an interview. This motion was duly seconded by Dr. L. R. Doffermyre and passed unanimously.

RE: <u>Dr. R. D. Patterson</u>, Liberty, North Carolina, was reported by the State Bureau of Investigation for having written one prescription for demerol without having seen the patient. It was learned by the secretary that Dr. Patterson was critically ill following a stroke and he was not requested to appear.

The above referred to addicts were arrested and sent to the State Hospital. The man has expired and the woman is now a patient.

RE: <u>Biennial Registration</u> - The secretary presented a letter of criticism with regard to this registration, which the writer requested the editor to run in the State Medical Journal.

The secretary was instructed to make another statement for the Journal in regard to Biennial Registration, the importance, and cite about one physician violating the law in another state.

RE: \underline{Dr} . Willard W. Griggs - Dr. T. W. Baker reported by phone on June 15th, 1960 that Dr. Griggs had been a patient at Charlotte Memorial Hospital in March, with kidney stones, and he did exceptionally well asfar as narcotics were concerned, no more than normal. That Dr. Griggs had reported the week before that he had recurrent stones and infection and might have to return to the hospital; that he was doing well with narcotics.

The Board accepted the above report as information.

RE: <u>Dr. Alfons Stanley Warakomski</u> appeared in May, 1960 applying for license by endorsement of credentials. He had already moved to Wadesboro, where he planned to practice. Unfavorable information had been received from one of his former locations and he had furnished insufficient recommendations. Dr. Warakomski was requested to obtain additional recommendations and the secretary of the Board was directed to make further investigation.

The secretary advised the Board that Dr. Warakomski had not furnished the additional recommendations. That one telegram had been reeived, but he was advised this form of recommendation was not acceptable. The secretary also advised that he had received no additional information upon further requests.

Dr. Alfons Stanley Warakomski continued

VERDICT: Dr. C. V. Tyner moved that Dr. Alfons Stanley Warakomski not be granted license by endorsement of credentials. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

Dr. L. R. Doffermyre moved that Dr. F. Y. Sorrell be requested to appear before the Board for an interview at its next meeting. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

The secretary was instructed to inform Dr. Alfons Stanley Warakomski of the action by the Board by telegram, which was done.

RE: <u>Dr. Harold Preston Burbage</u> appeared before the Board in May, 1960, applying for license by endorsement. He had accepted the position as health officer of Granville County, North Carolina and had already begun work.

The Board at that time had received information from the Narcotic Bureau that Dr. Burbage had been addicted to the use of narcotic drugs and had been treated for the same at the United States Public Health Service Hospital, all of which was denied by Dr. Burbage. He admitted having surrendered his narcotic special tax stamp.

The secretary was instructed to obtain further in formation.

The secretary thereupon asked the director of the County Health Department of the State Board of Health to instruct Dr. Burbage to furnish this office with a statement to the United States Public Health Service Hospital to give this office any information it might desire with regard to his stay there, which permit was given by Dr. Burbage. The secretary presented a report from the United States Public Health Service Hospital at Lexington, Kentucky verifying the fact that Dr. Burbage was a voluntary patient there from January 31st, 1940 for the treatment of drug addiction until July 13th, 1940. (See file)

VERDICT: Dr. C. V. Tyner moved that license by endorsement of credentials be denied to Dr. Harold Preston Burbage. This motion was duly seconded by Dr. L. R. Doffermyre and passed by a vote of four. One member abstained from voting.

RE: <u>Dr. George W. Melchior</u> - The Board at the May, 1960 meeting instructed the secretary to obtain a report from Dr. M. M. Vitols, Superintendent of the Cherry Hospital, with regard to Dr. Melchior in view of the report received at this time.

The secretary presented Dr. Vitols' report under date of May 30th, 1960, which stated that Dr. Melchior had recently had some emotional disturbance. That aside from this episode he had been getting along all right. That his work was satisfactory. Dr. Vitols recommended that he be allowed to continue his work there.

VERDICT: Dr. L. R. Doffermyre moved that Dr. George W. Melchior's special limited license be renewed on an annual basis. This motion was duly seconded by Dr. T. G. Thurston and passed unanimously.

The Board was reminded that the grades are to be in the secretary's office not later than July 13th.

RE: Dr. Marion B. Roberts, Hillsboro, North Carolina - The State Bureau of Investigation revealed that a number of prescriptions for narcotics had been written for narcotic addicts. Dr. Roberts stated to the State Bureau Agent that these prescriptions were forged. Dr. Roberts on interview stated that he had seen the child of these addicts on one occasion and may have given them a prescription but that he had never written narcotic prescriptions for them; that he did not write narcotic prescriptions for transients.

Dr. Marion B. Roberts failed to register his license to practice medicine in January, 1960, and after due notification the same was suspended. He was advised that he had been practicing medicine without a license since May 9th, 1960. Dr. Roberts stated that he had not opened his mail and was unaware of this fact. The law was explained and he paid fee of \$5.00 and penalty of \$10.00 at this time.

VERDICT: Dr. C. V. Tyner moved that Dr. Marion B. Roberts' license to practice medicine be reinstated. This motion was duly seconded by Dr. J. J. Combs and passed unanimously.

Following the last examination on the morning of June 23rd, 1960, the meeting was adjourned.
