The North Carolina Medical Board held its scheduled June 2025 meeting at its offices at 3127 Smoketree Court, Raleigh, NC 27604.

Devdutta G. Sangvai, M.D., J.D., MBA, President and Presiding Officer, called the meeting to order on Thursday, June 26, 2025, at 8:04 a.m. Board members participating were: Devdutta G. Presidential Remarks:

Dr. Sangvai commenced the meeting by reminding the Board members of their duty to avoid conflicts of interest with respect to any matters coming before the Board as required by the State Government Ethics Act.

No recusals were noted for the record.

<u>HEARINGS</u>

OENBRINK, RAYMOND JOSEPH, D.O. - DAYTONA BEACH, FL

The Board was represented by Mr. Adam Moyers. Dr. Oenbrink was present and represented himself.

Dr. Oenbrink was charged with unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6).

The Board previously granted summary judgment against Dr. Oenbrink, finding that there were "no genuine issues as to any material fact regarding Dr. Oenbrink's commission of the acts set forth in the Notice of Charges and Allegations and that such acts constitute unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6)." During the hearing, the Board considered the final disposition of Dr. Oenbrink's case.

Following the hearing, the Board voted to revoke Dr. Oenbrink's license to practice medicine in North Carolina.

SETTLEMENT PROPOSALS

WHITE, DIANE CAROL, M.D. - FAYETTEVILLE, NC

The Board was represented by Mr. Marcus Jimison. Dr. White was represented by Mr. Landon White.

The Board heard presentations by Mr. Jimison and Mr. White in open session.

The Board went into closed session pursuant to Section 143-318.11(a) of the North Carolina General Statutes to prevent the disclosure of information that is confidential pursuant to Sections 90-8, 90-14, 90-16, 90-21.22 of the North Carolina General Statutes and not

considered a public record within the meaning of Chapter 132 of the General Statutes and/or to preserve attorney/client privilege to discuss the proposed settlement.

The Board returned to open session.

The Board voted to accept the inactivation of Dr. White's license in lieu of further discipline.

ADIX, MICHAEL LEE, D.O. - HOLIDAY, FL

The Board was represented by Mr. Marcus Jimison. Dr. Adix was not present but previously agreed to Mr. Jimison presenting the Consent Order *ex parte*.

After the presentation by Mr. Jimison in open session, the Board voted to accept the Consent Order.
