

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

ROBERT E. LEE HOTEL, Winston-Salem, North Carolina

November 20-21, 1969

The Board of Medical Examiners of the State of North Carolina met at the Robert E. Lee Hotel, Winston-Salem, North Carolina, November 20-21, 1969, for the purpose of interviewing applicants for license by endorsement of credentials, for special limited license and for other business.

Thursday, November 20th
2:00 P. M.

RE: Dr. Rayford Lee Weinstein - Dr. Weinstein was served with Charges and Accusations for a hearing to be held on September 26th, 1969, for which his attorney procured a continuance until this date.

Dr. Weinstein, as well as his attorney, were duly advised of the time and place of this meeting.

The hearing was called at 2:00 P. M. on this date. Mr. John H. Anderson, Attorney at Law, appeared on behalf of the Board. Dr. Weinstein was paged in the hotel, to which page there was no answer. Mr. Anderson, Attorney, advised that Mr. N. L. Britt, Attorney for Dr. Weinstein, had acknowledged to him that Dr. Weinstein received notice of the hearing to be held at this time.

Attorney Anderson read the Charges and Accusations, which were as follows:

"1. That your mental condition renders you unable safely to practice medicine."

Dr. R. L. Rollins, Jr., Superintendent of Dorothea Dix Hospital, appeared and testified that in his opinion Dr. Weinstein was mentally incompetent to practice medicine. (Complete testimony in file)

Dr. Frank Edmondson moved that Dr. Rayford Lee Weinstein be found guilty of the charge and accusation as set forth against Dr. Weinstein and that the facts be found that he does not possess the mental capacity to safely practice medicine. This motion was duly seconded by Dr. Joseph J. Combs and passed unanimously.

VERDICT: Dr. Joseph W. Hooper, Jr. moved that the license to practice medicine of Dr. Rayford Lee Weinstein be revoked. This motion was duly seconded by Dr. Bryant L. Galusha and passed unanimously.

RE: Professional Corporation Act - The attorney for the Board, John H. Anderson, reviewed the professional Corporation Act passed by the Legislature of 1969. He presented rules, regulations and forms, which he recommended that the Board pass.

The Board approved and adopted the rules, regulations and forms by unanimous vote. (These rules and regulations are in the file)

RE: State Government Reorganization - The secretary presented letter from Governor Robert W. Scott in this regard.

RE: Quorum - In the last revision of the Medical Practice Act the regulation as to the constitution of the quorum was stricken out.

VERDICT: Dr. Joseph J. Combs moved that the Board of Medical Examiners adopt the regulation and file with the Secretary of State that five members of the Board shall constitute a quorum; that four members present shall be agreeable to the qualifications of any applicant for licensure. This motion was duly seconded by Dr. Cornelius T. Partrick and passed unanimously.



RE: December 1969 Examination - Dr. Combs moved that the grades for this examination be in the office of the secretary by December 20th, 1969, which motion was duly seconded and passed unanimously.

RE: Dr. John Jamieson Stewart, Jr., applicant for license by endorsement of credentials, who did not meet the requirements of the Board, was granted a special limited license to cover his residency training. He has posed the question of taking an examination in order to procure license by endorsement.

VERDICT: Dr. H. Lee Large, Jr. moved that Dr. John Jamieson Stewart, Jr. be given the privilege of taking a make-up examination on Part II. This motion was duly seconded by Dr. Joseph W. Hooper, Jr. and passed unanimously.

The meeting was adjourned.

RE: Flex Examination - The secretary reported that Dr. Bryant L. Galusha had accepted the assignment to the Testing Committee.

RE: August, 1970 Meeting
The secretary advised that due to inability to procure reservations for this meeting as set by the Board, that he and the president had set the date for August 20-23rd, 1970.

VERDICT: Dr. H. Lee Large, Jr. moved that the Board of Medical Examiners approve the action of the president and secretary in regard to the above meeting. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. Laurence Grundy - The secretary reported that Dr. Grundy was granted license limited to Durham County until citizenship obtained; that he petitioned for extension to Buncombe County to do locum tenens for the radiologist there from December 1-6th, 1969. Dr. Grundy is a resident at Duke University School of Medicine.

VERDICT: Dr. Frank Edmondson moved that Dr. Laurence Grundy's license be extended to Buncombe County for December 1-6, 1969. This motion was duly seconded and passed unanimously.

RE: Finance Committee - The president of the Board appointed Drs. H. Lee Large, Jr., Chairman, and Drs. Frank Edmondson and Joseph W. Hooper, Jr. to the Finance Committee.

RE: Conversion of limited to full license - A motion was made, seconded and passed unanimously that the following doctors' limited licenses be converted to full license:

Dr. James Elliott Thomas Laningham was approved for conversion of limited to full license when he meets the requirements of the Board of Medical Examiners.

RE: Dr. William Murphy Bethune, Jr. - (See previous Minutes) - The secretary advised the Board that he has received confirmation from the superintendent of Cherry Hospital that he had offered Dr. Bethune a position there; that Dr. Bethune's license was reinstated according to the order of the Board that he confine his practice to the limits of the hospital; that he refrain from the use of alcohol, narcotics, barbiturates or other drugs, except upon the prescription of another licensed doctor of medicine; that he violate no State or Federal law, and that he otherwise remain of good behavior.



RE: Copy Machine - Dr. Joseph W. Hooper, Jr. moved that the secretary make the best purchase of a copy machine within his discretion. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

Dr. V. W. Taylor, Jr. appointed Drs. Frank Edmondson, Chairman, and Dr. Joseph W. Hooper, Jr. to represent the Board as set out above.



SPECIAL LIMITED LICENSE - HOSPITAL RESIDENTS

RE: Dr. Charles D. Ebert, Jr. resident at the University of North Carolina School of Medicine in the Department of Surgery, was requested to appear at this time, which he failed to do.

VERDICT: Dr. Cornelius T. Partrick moved that Dr. Charles D. Ebert, Jr. be instructed not to practice further until he appears before the Board. Dr. H. Lee Large, Jr. seconded this motion, which was passed by a vote of four to one. One member abstained from voting. Dr. Bryant L. Galusha voted against the motion.

RE: Dr. Ismael R. Goco was granted license limited geographically on June 21st, 1962, until citizenship obtained, within a period of six years. Notice was received that Dr. Goco's license in Virginia had been revoked for failure to attain citizenship. Dr. Goco was requested to appear at this time to show cause why he had not met the requirement of the Board with regard to citizenship.

Dr. Taylor: Will you tell us what happened about your citizenship?

A. I completely forgot your letter of January, 1962 and the next thing I knew it was your letter of October, 1969 advising me of that limitation. Of course, I work on my citizenship. I do not have any intention to ignore the limitation set in 1962. In June, 1968 I was trying to get citizenship at that time. I never did file my application, one of those little things I missed to do. Since your letter of 1969 I have filed it all the way. I have letters from the Immigration and Naturalization Service. Perhaps this will clear I am to get my citizenship. I had my examination October 24th. I was advised I will get my citizenship December 5th.

Dr. Combs: Have you had any trouble with any other state about not getting citizenship?

A. About a year ago I heard from Virginia. I had no intention of practicing in Virginia so they have not put pressure on me.

Q. They revoked your license.

A. No, they did not revoke it.

Dr. Goco said he had received no notice of the revocation of his license in Virginia.

VERDICT: Dr. H. Lee Large moved that the limited license of Dr. Ismael R. Goco be extended through December, 1969. This motion was duly seconded and passed unanimously.

SPECIAL LIMITED LICENSE - HOSPITAL RESIDENTS - FOREIGN MEDICAL GRADUATES

RE: Dr. Najiva Khuri appeared in September, 1969, with incomplete credentials applying for special limited license to cover him as a resident at the University of North Carolina School of Medicine, in Pediatrics. He is graduated by the American University of Beirut in 1968. His credentials were approved and he was granted special limited license on a biennial basis.

RE: Dr. Wolfgang Johannes Mergner, graduate of the University of Giesen, Germany in 1961, appeared in September, 1969, with incomplete credentials applying for special limited license to cover him as a fellow in Experimental Pathology at Duke University School of Medicine. His credentials were approved and he was granted special limited license on a biennial basis.

RE: Dr. Erik Martin Ritzén, graduate of the Karolin Ska Institute, Sweden, 1968, appeared applying for special limited license to the University of North Carolina School of Medicine, where he is a resident in Endocrinology, for which he was approved on a biennial basis.

RE: Dr. Yalcin Dincman held special limited license to the State Sanatoria from 1958 to 1962 to cover him as a resident. He has returned to this country as an immigrant and is petitioning for special limited license to cover him for the staff at the Western North Carolina Sanatorium until he can take the written examination.

Dr. Taylor: You are petitioning to take the written examination in June, 1970?

A. Yes

He presented alien registration receipt card A18 49535 dated September 24th 1969.



VERDICT: Dr. Yalcin Dincman was approved for special limited license to cover him for staff at Western North Carolina Sanatorium until he can take and pass the June, 1970 written examination.

VERDICT: Dr. Yalcin Dincman was approved for the June, 1970 written examination.

RE: Dr. Antonio V. Escueta, graduate of the University of Santo Tomas, Philippines in 1963, appeared to petition for the privilege of taking the written examination. He currently holds a special limited license to Duke University School of Medicine, where he is a fellow in Neurology. He presented alien registration receipt card A13 419 295.

Dr. Patrick: Where are you located?

A. I am a fellow doing research at Duke.

Dr. Edmondson: What are your plans if you take the state board?

A. I have almost definite plans at the University as soon as I can get license.

Q. You plan to stay in research?

A. To do both research and clinical.

VERDICT: Dr. Antonio V. Escueta was approved for the June, 1970 written examination.

The Minutes were approved as read.

The meeting was adjourned.
