

MEETING OF THE BOARD OF MEDICAL EXAMINERS
OF NORTH CAROLINA

Sir Walter Hotel, Raleigh, North Carolina

November 30 - December 4, 1970

- - -

The Board of Medical Examiners of the State of North Carolina met at the Sir Walter Hotel, Raleigh, North Carolina, November 30-December 4th, 1970, for the purpose of interviewing applicants for license by endorsement, giving the written examination (at the Raleigh Memorial Auditorium) and other business.

Monday, November 30th
6:30 P. M.

The Board convened and Drs. H. Lee Large, Jr., Joseph J. Combs, Secretary-Treasurer, Frank Edmondson, Joseph W. Hooper, Jr., Cornelius T. Partrick and William H. Sprunt III, a new member, Mrs. Louise J. McNeill, Assistant Secretary, and Mrs. Betty Joe Cooke, were present. Dr. Bryant L. Galusha was absent from the meeting.

The credentials for license by endorsement of credentials and resident's training license were reviewed by the members of the Board.

RE: Medical Society Building - Dr. William H. Sprunt III moved that the Board have carpet for the new offices. This motion was duly seconded by Dr. Frank Edmondson and passed by a vote of four.

RE: Cecil B. Jackson, D. O. - The secretary reported that the judgment of the Board was forwarded to Dr. Jackson on October 23rd, 1970, and no appeal or reply has been received as of this date.

RE: Dr. James S. Lambert, Swannanoa, North Carolina - (See previous Minutes) The secretary related that he had received an inspection report as of October 30th, 1970, from the Pharmacy Board which stated that some narcotic prescriptions were in evidence, but not to any extent. This was received as information.

VERDICT: Dr. Frank Edmondson moved that the Board of Medical Examiners request another report in one year from the Pharmacy Board. This motion was duly seconded and passed unanimously.

RE: Dr. B. G. Weathers, Sr. North Carolina
Dr. B. G. Weathers, Jr., Stanley - The secretary presented letter dated November 23rd, 1970, from the Pharmacy Board reporting that these physicians had prescribed for an exorbitant amount of stimulants and depressants.

VERDICT: Dr. Frank Edmondson moved that Dr. B. G. Weathers, Sr. and Dr. B. G. Weathers, Jr. be requested to appear before the Board of Medical Examiners. This motion was duly seconded and passed unanimously.

RE: Dr. Albert Kodack, Asheville, North Carolina - The secretary presented report dated October 30th, 1970, from the Pharmacy Board which indicated a large amount of narcotics being prescribed.

VERDICT: Dr. Joseph W. Hooper, Jr. moved that Dr. Albert Kodack be requested to appear before the Board of Medical Examiners at its January, 1971 meeting. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. Harry B. Dittmore, Marshall, North Carolina - The secretary presented report from the Pharmacy Board dated October 30th, 1970, that revealed that he had prescribed a large amount of narcotic drugs.

VERDICT: Dr. Cornelius T. Partrick moved that Dr. Harry B. Dittmore be requested to appear before the Board of Medical Examiners at the January, 1971 meeting. This motion was duly seconded by Dr. Joseph W. Hooper, Jr. and passed unanimously.



RE: Dr. Joseph Claude Fesperman, Stanley, North Carolina - On October 22nd, 1970, Dr. Fesperman, as directed by the Board, surrendered his narcotic tax stamp and unused order forms to Federal agents and said he had no narcotic drugs on hand.

The secretary presented report from Drs. Thomas H. Wright and Jack B. Hobson of the Durwood Medical Clinic under date of November 16th, 1970 stating that Dr. Fesperman had been under their care in Charlotte Memorial Hospital; that his dolophine was withdrawn and that he remained in the hospital four or five days without any medicatinn; that he was on no medication at the time of discharge; that he should be monitored very closely for the next several months or a year.

VERDICT: Dr. Joseph W. Hooper, Jr. moved that the secretary get in touch with the councilor and ask that he let the Board have a report and have him report in January, 1971. This motion was duly seconded by Dr. Frank Edmondson and passed unanimously.

RE: Dr. Michael L. Wolk / Los Angeles, California - The secretary presented evidence that Dr. Wolk's license to practice medicine in California had been revoked as of May 19th, 1970; that execution of said order of rev ocation was stayed and defendant placed on probation for a period of five years. (See file for details)

VERDICT: Dr. Cornelius T. Partrick moved that the Board of Medical Examiners revoke the medical license of Dr. Michael L. Wolk, which motion was seconded by Dr. William H. Sprunt III.

Substitute motion: Dr. Joseph h W. Hooper, Jr. moved that steps be taken to revoke the license to practice medicine of Dr. Michael L. Wolk, which motion was duly seconded by Dr. Joseph J. Cmms and passed unanimously.

RE: Dr. George S. Kleris, graduate of the University of Athens, Greece, in 1968, was granted the privilege of applying for license by endorsement of credentials. He stated that he has passed the Flex examination in Indiana. He does not have the certificate of the ECFMG.

VERDICT: Dr. Joseph W. Hooper moved that Dr. George S. Kleris' request to apply for license by endorsement of credentials be granted. This motion was duly seconded and passed by a vote of five to one.

RE: Examination Subject - Dr. William H. Sprunt III, who took office November 1st, 1970, was assigned Obstetrics-Gynecology for his examination subject.

The other member of the Board who was elected to a six-year term to begin November 1st, 1970, was Dr. Frq nk Edmondson, who will continue on the Board.

The secretary reported that he had a very satisfactory meeting with the representatives of the Pharmacy, Nurses' and Dental Boards, together with either the attorney or other representatives of the Board, looking toward certain uniformity of records. It was the agreement among all present that the Boards should co-operate in their respective fields.

RE: Dr. Dru Van Wilkes - The secretary reported that Dr. Wilkes is now registered and her license has been reinstated.

RE: Narcotic Film and Talk - The Board ruled that the same be abandoned as the schedule of the Flex examination does not allow the time.

RE: Written Examination - Dr. Joseph J. Combs moved that the Board hold the examination in December, 1971, in Raleigh. This motion was duly seconded by Dr. Joseph W. Hooper, Jr. and passed unanimously.

RE: Interviews - Dr. Joseph W. Hooper, Jr. moved that the secretary be instructed that personal interviews be held the first day of the written examination. This motion was duly seconded and passed unanimously.

RE: Applicants for License by Endorsement of Credentials - Dr. Joseph W. Hooper, Jr. moved that the time for interviewing these applicants be staggered at the discretion of the secretary. This motion was duly seconded and passed unan-
imously.



The meeting was adjourned.

Q. Have you ever had difficulty with a medical examining board? A. No sir

Q. Have you ever used narcotics? A. No sir

Q. When will you go to work?

VERDICT: Dr. Lillis Flatman Altshuller was approved for license by endorsement of credentials.

RE: Dr. William Joseph Arnold appeared applying for license by endorsement of credentials.

Dr. Large: Have you ever been convicted of a crime? A. No

Galusha moved that Dr. Elisha Judkin Cain be granted license by endorsement of credentials, limited to Wayne County Memorial Hospital, provided he is endorsed by the Louisiana Board of Medical Examiners, with the stipulation that the Board receive a report from a board certified psychiatrist of his progress at no less than yearly intervals; that he report to this Board in person in six months with a progress report. This motion was duly seconded by Dr. Cornelius T. Partrick and passed unanimously. (continued on next page)



Dr. Cain continued

Dr. Cain has completed his credentials.

VERDICT: It was moved, seconded and passed unanimously that the motion be amended to read that we have psychiatric report at no more than yearly intervals.

RE: Dr. Stanley Earl Chartier appeared applying for license by endorsement of credentials. He stated that he would locate in the Asheville area.

Dr. Large: Near Fletcher?

A. Yes, they wanted me to come to Fletcher.

A. I have my house up for sale, for four months, real estate is moving slowly. It might be a couple of months after I sell my house.

RE: Dr. Wesley Allen Cook, Jr. appeared applying for license by endorsement of credentials. He was granted special limited license in 1964 for training. He plans to complete his training in Neurosurgery in July, 1971 and join the staff at Duke at that time.

Q. Is this part-time while in the military?

A. In the evenings and on Saturday.

Q. Is this in conjunction with the local clinic or private?

A. Private at this point. I would like to find out what practice is like, getting referrals from the general area rather than work with the clinic.

Dr. Large: Have you ever been convicted of a crime?

A. A building built for the community which has been unstaffed. While they are looking for a permanent physician some of the physicians from Cherry Point will staff it.

VERDICT: Dr. Martin Saul Krumerman was approved for license by endorsement of credentials, if and when his credentials are completed satisfactory to the secretary.

RE: Dr. Eugene Robert Keller Leiter appeared applying for license by endorsement of credentials.

Dr. Hooper: You plan to establish residence in North Carolina, where?

A. Probably in Wilmington

Q. What is your specialty?

A. Internal medicine, I am not certified.

Q. Have you ever been accused of a crime?

A. Drunkenness on one occasion in San Antonio in 1967. I got into a foolish argument and was arrested and fined \$15.00.

Q. Have you ever been convicted of any crime other than breaking this law?

A. Just speeding

Q. Were you drinking when involved with speeding?

A. No sir

Q. Have you ever had any difficulty with any medical examining board? A. No sir

Q. On any other occasion have you had difficulty with alcohol?

A. Yes, I consider myself an alcoholic and belong to Alcoholic Anonymous.

Q. How long have you had difficulty with alcohol?

A. One has trouble before recognizing it.

Q. Does it interfere with you in the Air Force?

A. I did not think so. I got a letter of reprimand. I asked to be hospitalized on my own volition. I recognized it had become a problem and I asked for hospitalization.

Dr. Combs: Did that have anything to do with your retirement?

A. No

Dr. Hooper: You were discharged last month?

A. Saturday, retirement

Q. Have you had any trouble with other habit forming drugs?

A. No

Dr. Edmondson: Has this alcohol problem affected your family life?

A. I would say no, but certainly a problem like that does influence it. We have a good family life.

Dr. Combs: There has been no separation?

A. No sir



Dr. Leiter continued

Dr. Combs: Did you do any training when on duty in the Air Force?

A. Yes

VERDICT: Dr. Cornelius T. Partrick move that Dr. Eugene Robert Keller Leiter be granted license. This motion was duly seconded and passed unanimously.

Substitute motion: Dr. Joseph W. Hooper, Jr. moved that Dr. Eugene Robert Keller Leiter be granted license without limitation but that he be advised by the president the Board wants to help him and will follow his practice in North Carolina with interest. This motion was duly seconded by Dr. Cornelius T. Patrick and passed unanimously.

RE: Dr. Paul Alan Lusman appeared applying for license by endorsement of credentials. He is a fellow in Pediatric Allergy at Duke University School of Medicine.

The Finance Committee recommended the acceptance of the auditor's report for the year ending October 31, 1970 and this was unanimously.


