

# **MINUTES**

**North Carolina Medical Board**

**April 14 - 15, 2011**

**1203 Front Street  
Raleigh, North Carolina**

The North Carolina Medical Board held its regularly scheduled April 2011 meeting at the Board's office located at 1203 Front Street, Raleigh, NC 27609. Janice E. Huff, MD, Board President called the meeting to order on Thursday, April 14, 2011, at 8:00 a.m. Board members in attendance were: William A. Walker, MD, Secretary/Treasurer; Ms. Pamela Blizzard; Thomas R. Hill, MD; John B. Lewis, Jr., LLB; Paul S. Camnitz, MD; Eleanor E. Greene, MD; and Peggy R. Robinson, PA-C. Also attending were Tom Moffitt, Independent Legal Counsel to the Board; R. David Henderson, Executive Director and Thom Mansfield, Board Attorney.

#### Presidential Remarks:

Dr. Huff commenced the meeting by reading from the State Government Ethics Act, "ethics awareness and conflict of interest reminder." No conflicts were reported.

#### Hearings:

##### **Gualteros, Oscar M., MD** Southern Pines, NC

Dr. Gualteros surrendered his North Carolina license to practice medicine as of February 18, 2006 via a Consent Order dated January 20, 2006 due to a boundary violation. At its September 2010 meeting, the Board denied Dr. Gualteros' application for reinstatement of his license. This hearing was to determine whether to reinstate Dr. Gualteros' license.

The Board was represented by Marcus Jimison. Dr. Gualteros was represented by James R. VanCamp.

The Board voted to uphold its decision to deny Dr. Gualteros' application for a North Carolina medical license. Dr. Hill was recused.

##### **SWAIM, Mark W., MD – Jackson, TN**

Dr. Swaim was charged with unprofessional conduct relating to having a license to practice medicine restricted or acted against by a licensing authority.

The Board was represented by Todd Brosius. Dr. Swaim was not present and was not represented by counsel.

The Board voted to accept a Public Letter of Concern in resolution of this matter. Dr. Hill was recused.

#### Attorney's Report:

A motion passed to close the session pursuant to Section 143-318.11(a) of the North Carolina General Statutes to prevent the disclosure of information that is confidential pursuant to Sections 90-8, 90-14, 90-16, 90-21.22 of the North Carolina General Statutes and not considered a public record within the meaning of Chapter 132 of the General Statutes and/or to preserve attorney/client privilege. Fred Morelock, Independent Legal Counsel to the Board, was not present for this report.
