Note: NC law requires all licensees to renew their license. License application fees do **NOT** count towards the first renewal fee. Perfusionists must renew biennially prior to the license expiration date. Provisional Perfusionists must renew annually prior to license expiration. All other licensees, including physicians, physician assistants, and anesthesiologist assistants, must renew annually within 30 days of their next birthday, even if their birthday occurs shortly after their license is issued.
